## Precinct redistricting plan detailed

### (Proposed redistricting Plan 2A - Robert Lee)

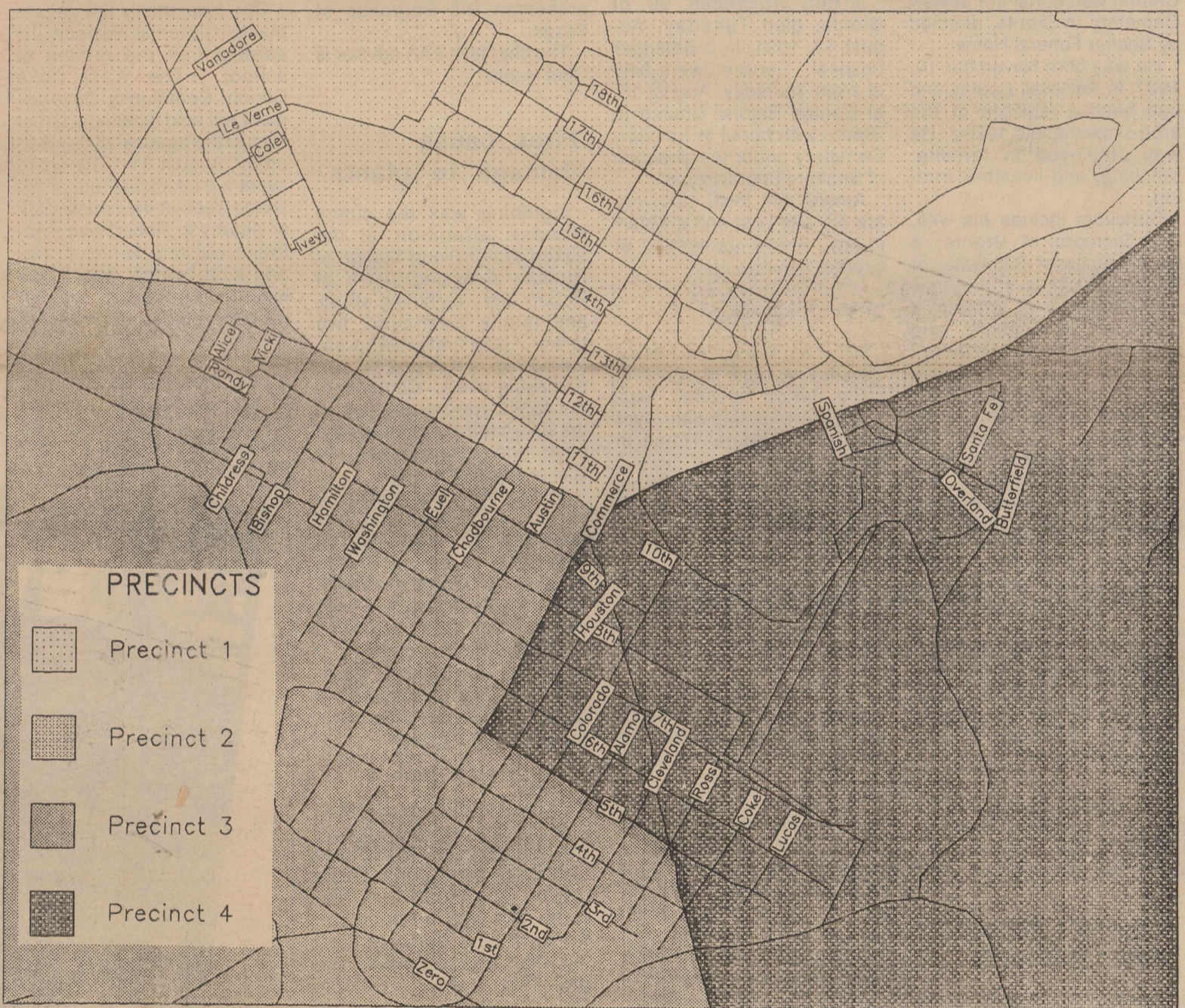
Approximately twenty-five people braved the rain and stormy skies Monday afternoon to attend a public hearing on redistricting the county's precincts.

Sue Glover, a representative of Allison & Associates, presented a program explaining the most recent in a series of five proposed plans. Austin-based Allison & Associates is the firm the commissioners hired to help with the complex redistricting project.

There are two factors which must be considered when re-drawing precinct lines. The first is the constitutional requirement of one person - one vote. Every person's vote needs to be as effective as it possibly can be. The second factor is the 1964 Voting Rights Act. The purpose of this act is to make certain that minority representation is strengthened and not diluted.

Every ten years, the population is counted in the nation-wide census. This year's census figures showed Coke County's deviation percentages rising to 44.8%, way above the allowed 10%. Current precinct population figures are Precinct #1 - 851, Precinct #2 - 847, Precinct #3 - 1,055, and Precinct #4 - 671. The ideal population figure for each precinct is 856. This number is determined by dividing the total county population of 3,424 by 4. Precincts #1 and #2 fall within the 10% deviation. However, Precincts #3 and #4 are well above the 10% limit.

Under the most recent proposed plan, Plan 2A, the

**Payne attends national FFA conference**

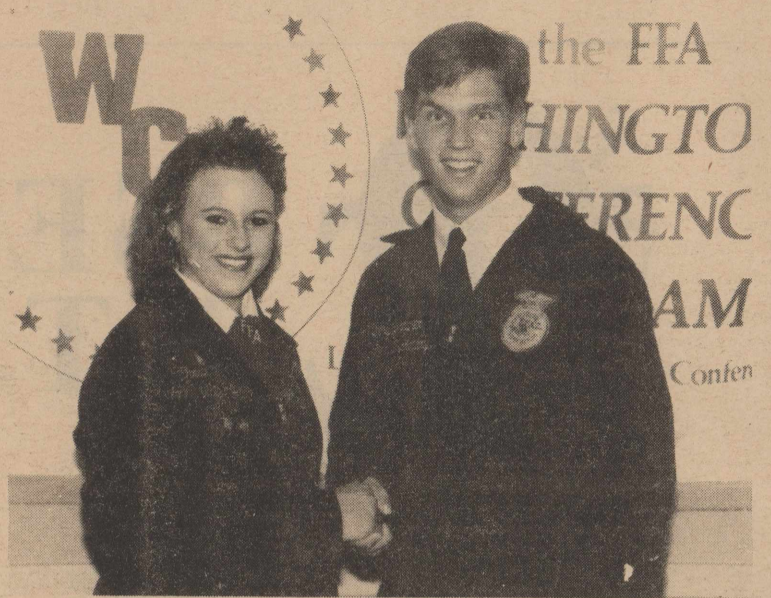
Christie Payne of the Robert Lee FFA Chapter attended the 1991 Washington Conference Program in the nation's capital.

## Bronte to begin classes August 19

Students in grades K-6 at Bronte Elementary will report directly to their classrooms the first day of school, August 19. After the first day of school, elementary students will meet in the gym bleachers until tutorials begin.

Classes will begin each morning at 8:15 am. Students in grades K-2 will be dismissed at 2:15 pm each day. Students in grades 3-6 are dismissed at 3:15 pm. Students in grades K-2 that ride the bus will be kept in a bus recess until the bus runs at approximately 3:20 pm.

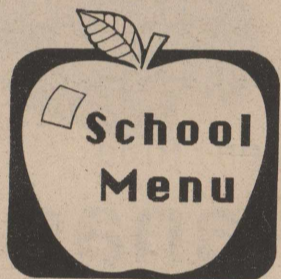
Breakfast will be served each morning beginning at 7:45 am. Breakfast prices for elementary students are 60¢ for a regular price breakfast

and 25¢ for a reduced price breakfast. Regular price lunches are \$1 for K-5 students and \$1.25 for 6th graders. Reduced price lunches for K-6 are 40¢. All students who were on free or reduced price meals last year will start the year out that way until new applications are approved for the 1991-1992 year. Applications for free and reduced price meals will be sent home the first day of school. Parents need to see if they qualify for these, then fill out these applications completely, and return them to the elementary office as soon as possible. Applications that contain incomplete information will not be processed until all information asked for is completed, therefore, delaying approval.

All elementary parents (K-6) need to be aware that a lot of information about their classes and the school in general will be sent home the first few days of school. Some of the

information will require that papers be signed and returned to the school as soon as possible. Be on the look out for this type of information.

"The sand game is much different from the indoor game," said Connie. "Besides battling your opponent, you must also deal with the wind, sun, and heat."

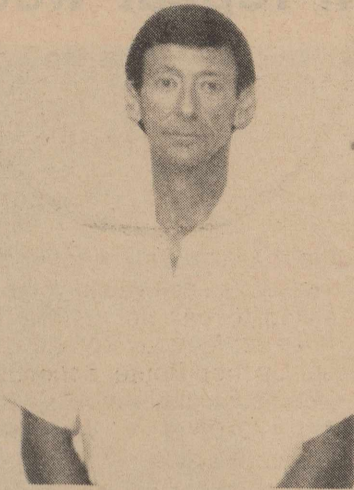
According to Tim, who prefers the sand to indoors, the sand is much more challenging.

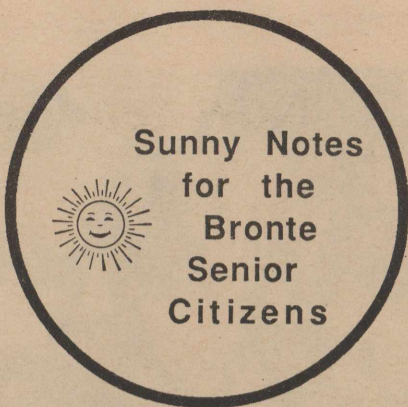

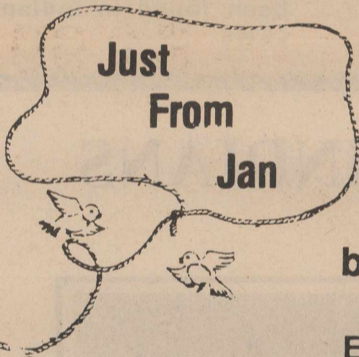

The most painful part of your annual cleaning may be the trip to the store to purchase the variety of cleansers needed to do the job thoroughly. And that trip can be painful not only to your pocketbook but to the environment as well.

Fortunately, there are environment and cost conscious options that you can make yourself.

- Carpet deodorizer - To eliminate carpet odors, use a sifter to sprinkle rugs with baking soda or a mixture of one cup Borax and two cups cornstarch.

- Drain cleaner - To clear a clogged drain, pour a handful of baking soda and one-half cup of white vinegar down the drain. Cover the drain tightly for a few minutes and then flush with water.

- Window cleaner - Mix equal parts of white vinegar and water. You may need to wipe the windows with alcohol to remove residue from previous cleaners before using your homemade cleaner the first time.

- Furniture polish - Three parts olive oil and one part vinegar will produce a beautiful shine. Plain, old fashioned mayonnaise works great, too.

- Toilet bowl cleaner - For routine cleaning, pour a little vinegar in the toilet bowl and scrub with a brush. To remove stains, sprinkle with baking soda, moisten with vinegar, and scrub with a brush. For tougher stains, wet the area with water, rub in a paste of Borax and lemon juice, and let stand for two hours. Then scrub.
- All-purpose cleaner - Mix vinegar and water in a spray bottle. If an abrasive cleaner is needed, mix vinegar and salt or baking soda. One-half cup of Borax dissolved in a gallon of water is also good.

Ms. Frazee has guided Planned Parenthood of West Texas, Inc. staff and board through incredible expansion over the past four years.

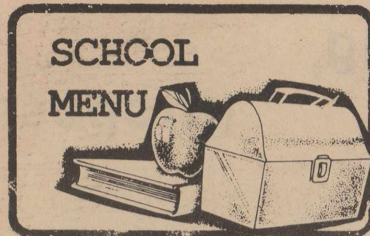
Ms. Frazee and her family are relocating to Colorado. She will remain active in the

population figures will be Precinct #1 - 851, Precinct #2 - 864, Precinct #3 - 853, and Precinct #4 - 856. This will be a total deviation of only 1.51%, well under the federal guideline limit.

Keeping all precincts near the same population level is the main reason for the upheaval, although it may not be the most difficult phase of the process. That comes with satisfying minority requirements. Coke County has a total minority population percentage of 13.06%. The Justice Department requires that minorities have a higher concentration of voters in one precinct if the total county minority percentage is over 13.00%. Currently, the minority percentages by precinct are Precinct #1 - 8.81%, Precinct #2 - 11.45%, Precinct #3 - 18.29%, and Precinct #4 - 12.22%.

The minority percentage figures under Plan 2A, which is expected to be approved by the commissioners, will be Precinct #1 - 8.81%, Precinct #2 - 7.06%, Precinct #3 - 17.58, and Precinct #4 - 19.04%. Thus Precinct #4 will satisfy this requirement.

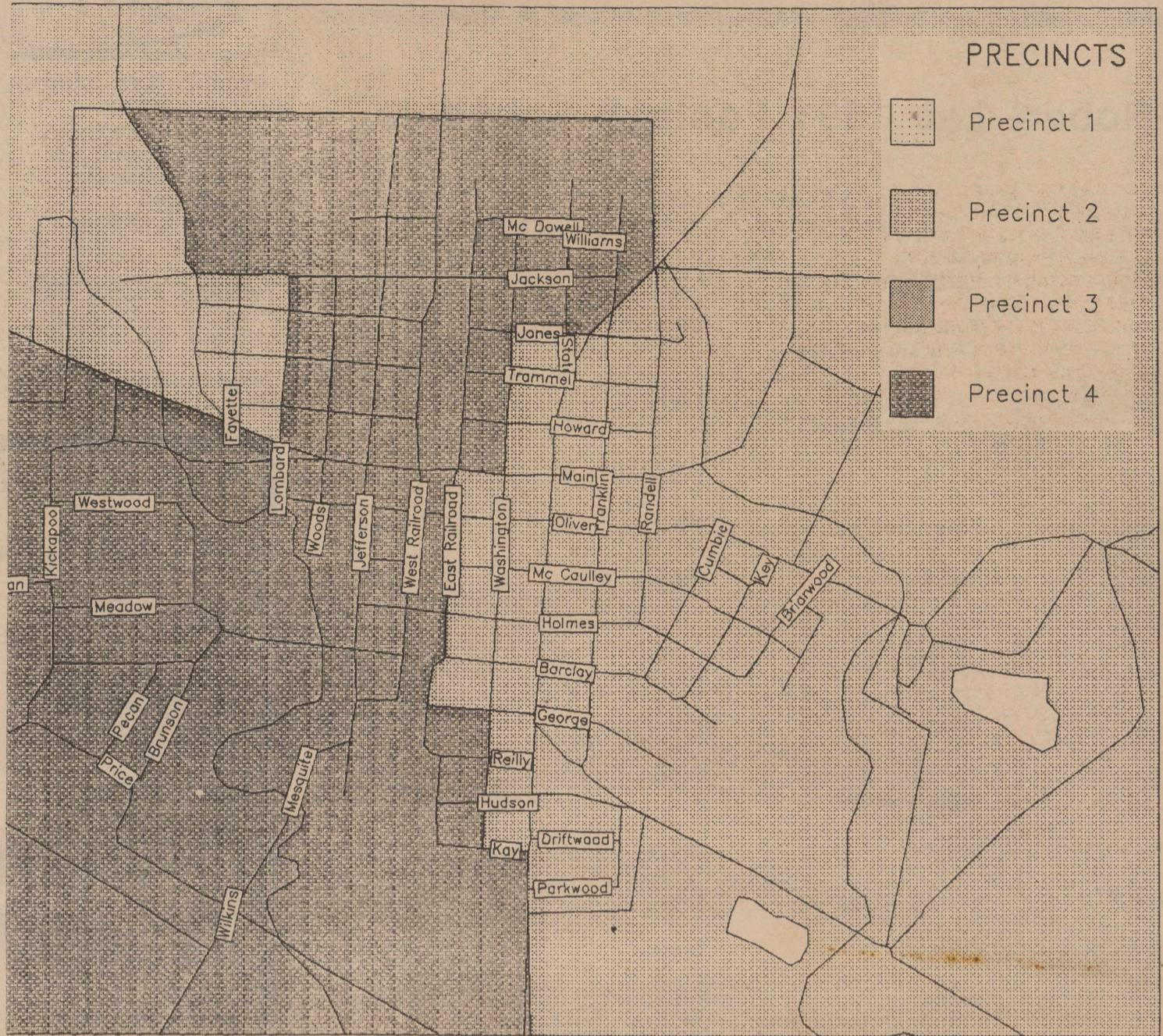
Proposed precinct lines under Plan 2A will have Precinct #4 lines extending along Hwy. 158 in Robert Lee west to Commerce Street, then south along Commerce to 5th Street and follow 5th back to Hwy. 208 South. This leaves Robert Lee's main business districts and recreational centers in West Coke County Precincts #1 and #3.

Ms. Glover explained to the people in attendance, the majority of whom were county and city officials, that in order to obtain the necessary population numbers needed for Precinct #4, the lines had to, in some way, extend into Robert Lee. There are just not enough people in the rural areas of this section of the county to make up such a large difference. She also explained the reason the lines travel visible roadways is because they now have to go according to census blocks. County Tax Collector Kristi Roe commented that this was very effective when advising people as to what precinct they live in during voter registration.

Questioned as to why Coke County chose to redistrict when other counties chose not to, Miss Glover said that if we hadn't we could be sued for ignoring constitutional requirements. She further added that many West Texas legal aid societies are watching all counties very carefully. These organizations watch for discrepancies in minority percentages and upon finding these proceed to file suit on those counties. These suits usually subject the concerned county to a large judgment and also to tremendous legal fees.

Once Plan 2A is approved by the Commissioners, it will be submitted to the Justice Department by October 1 and should be returned by December 1, 1991. It would then become effective officially January 2, 1992.

### Oryx production to increase

Oryx Energy Company today announced that its natural gas production in the North Sea will increase substantially as a result of a redetermination of interests in the unitized Audrey Gas Field.

"The redetermination of interests in the Audrey Unit becomes effective October 1, increasing Oryx Energy's working interest from 24 to 33.6%," said James E. McCormick, president and chief operating officer. "And the redetermination is retroactive, allowing Oryx Energy to take approximately 42% of production until past shortfalls are made up, probably for the remainder of the field life."

Production for the upcoming contract year, commencing October 1, is expected to be approximately 100 million cubic feet per day (MMcf/D) net. Production during the current contract year (ending September 30) is estimated at about 70 MMcf/D.

Oryx Energy will pay approximately \$25 million for the additional working interest, which represents approximately 10 million barrels oil equivalent (BOE) of reserves adds, or \$2.50 per BOE.

The price for Audrey production averaged \$2.38 per thousand cubic feet during the second quarter. The recent decision by the redetermination expert is provisional and will be finalized August 2.

### PUBLIC NOTICE COKE COUNTY COMMUNITY DEVELOPMENT FUND TEXAS COMMUNITY DEVELOPMENT PROGRAM

Coke County is planning to file an application with the Texas Department of Commerce (TDOC) for a Texas Community Development Program (TCDP) grant under the Community Development Fund. This application will be submitted to TDOC on or before August 30, 1991.

A public hearing concerning the proposed grant application will be held at 6:00 o'clock p.m. on the 20th of August, 1991, Commissioners Court Room, Coke County Courthouse, Robert Lee, Texas. The purpose of this public hearing is to review Coke County's proposed 1991 request for TCDP funds to construct street improvements and includes a discussion of the scope and location of proposed project activities. No displacement of residents is expected as a result of the proposed 1991 TCDP project.

All citizens are encouraged to attend this public hearing and present their views on this proposed project. Written comments will be accepted by the County up until the time that the County's application is submitted to TDOC. A copy of the County's application will be available for inspection during normal business hours at the Coke County Courthouse, Robert Lee, Texas, or by making an appointment with Royce Lee, County Judge.

The basic intent of the TCDP grants is to provide programs to benefit low and moderate income persons, to prevent or eliminate slums and blights and to meet other urgent community development needs. Eligible activities include improved streets and drainage, utility systems and other public facilities improvements. Housing improvement programs are also eligible as are certain public service activities which meet one of the three primary TCDP basic intents noted above.





Texas railroad crossings lacking an active warning device will have reflective strips added to them under new rules adopted today by the State Highway and Public Transportation Commission.

The reflective strips will be in place by August, according to State Department of Highways and Public Transportation Engineer-Director Arnold Oliver.

"The commission adopted the rules on an emergency basis in April, and now the rules are permanent," Oliver said. "We feel that the additions are necessary to ensure travelers' safety. Crossings without a bell or flashing light need this visual enhancement."

Costs for installation at crossings on and off the state highway system will be covered by the department, Oliver said.
