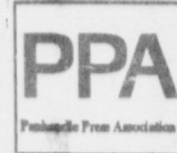

Board approves software purchase

Muleshoe Area Health District board members Thursday voted to purchase a \$16,595 data system that will bring the Muleshoe HealthCare Center up to federal regulations.

The data software is compatible with the HealthCare Center's current equipment, and will permit quicker, electronic transmission of patient records and care plans and financial reports to federal medical agencies.

Karen Cook, business office manager at the HealthCare Center, said the system will allow faster updates in patient status and will expediate Medicaid reimbursement.

"It will just be a whole lot faster and less paper work," Cook said.

The HealthCare Center is required by the Health Care Financing Administration, a division of the U.S. Department of Health and Human Services, to implement the system by Jan. 1, 1997.

Board members voted to purchase the system in full.

Interim hospital administrator Jim Bone said that the hospital budget will have to be reviewed before a method of payment can be determined. He noted that the hospital would obtain money from a local bank if needed.

The data system can be installed within two weeks of purchase.

In other business, board members voted to replace 907 yards of carpet in the hospital corridors.

"I think new carpet would give the interior of the hospital a pretty good face-lift," said Tim Campbell, president of the hospital board of directors. "I think it would improve the attitude of both the people working here, and the patients. We've been talking about this since the hospital re-opened, and it (the carpet) is in even worse shape now than it was then."

Bone presented two proposals of \$14,963.38 and \$16,683

City taking bids on Marr's home

The City of Muleshoe is now accepting bids on a house purchased from City Manager Dave Marr as part of a severance package approved by the City Council June 13.

The house, located at 1808 West Avenue I, was purchased by the city for \$61,000 — the appraised value of the home.

Marr's resignation will become effective Aug. 15.

"Dave did not want to be burdened with a house in Muleshoe and be in East Texas," said Muleshoe Mayor Robert Montgomery. "It was something we felt that we could do and not be a cost to the City. It is difficult to administer the sale of a house after you've relocated — that was the thinking behind that."

The purchase was made in return for Marr's completion of several ongoing City projects, including the establishment of the City's budget, the paving project in the "flats,"

Survival rate at rural hospitals declining

Editor's note: This is the first in a series of stories on the Muleshoe Area Health District.

Plowed under by progress, rural hospitals are joining the Main Street general store and corner garage in the scrap heap of days gone by.

It wasn't that long ago when all three were cornerstones of service in small towns, when narrow two-lane highways bridged islands of civilization in the sea of sagebrush and sand of West Texas.

Now, it's no more than an afterthought to hop in a car and drive an hour to Lubbock for a doctor's appointment. Twenty years ago, it was a dreaded, day-long trip.

Specialization steals away their patients. Reduced Medicare and Medicaid payment schedules chip away their profit margin. Meeting federally-mandated staffing and standards further depletes finances.

All leave rural hospitals like Muleshoe Area Medical Center, a 31-bed general care facility, scrambling for ways to survive.

"Rural hospitals have been forced into a role of a first aid station," said Marshall Cook, the hospital administrator from 1962-1981.

Among the saviors for the Muleshoe Area Medical Center was the creation of a hospital district in 1989, which also includes a 50-bed nursing home and a thriving home health agency.

"From the things I've looked at since I've been here, the

hospital isn't in bad shape," said Jim Bone, interim hospital district administrator since June and a rural hospital consultant for Methodist Hospital in Lubbock. "It's not in the best shape, but most rural hospitals aren't. But the hospital is in a reasonably sound position."

Bone credited staff reductions two years ago and the continuing adaptation toward increasingly cost-effective outpatient services as the main contributors to the hospital and the district operating in the black since 1995.

Few rural hospitals can survive without tax support, according to Bone.

Tax levies make up a little less than five percent of the total operating revenue for the Muleshoe Area Hospital District, which had \$6.3 million in operating expenses in 1995.

Civil war erupts over creation of hospital district

Bailey County's first attempt at forming a hospital district in 1970 proved divisive.

Financially strapped with an outdated facility, the West Plains Hospital Board wanted to build a new hospital that would meet more stringent Medicare requirements. They also believed the new facility would attract new doctors.

So they proposed the creation of the Bailey County Hospital District and a \$950,000 bond for construction of a new facility.

Backers of the proposal felt that a modern facility would also attract people from the southern parts of the county, who had traditionally sought medical services in either Morton or Lamb County.

Opponents were extremely vocal in their opposition, contending they shouldn't have to pay for something they don't use.

More than 1,400 voters turned out for the May 16th election, with both proposals passing by almost 300 votes.

A measure of south county voters' displeasure with the proposal — the vote failed by a margin of 277-62 at a ballot box in Needmore, which loosely served as the dividing line in the county.

"We didn't feel we should pay for something we wouldn't

Ag tour chronicles latest technology

The Bailey County Agricultural Extension Service will display several agricultural experiments underway in four counties during the 1996 Llano Estacado Farm Tour Friday.

The tour will make stops at farms in Parmer, Castro, Lamb, and Bailey County that demonstrate BT corn, irrigation scheduling for sugarbeets, 15" cotton plot and harvest aids, and BXN and Roundup Ready Cotton.

Curtis Preston, Bailey County Agricultural Extension Agent, said the BT corn will exhibit genetically engineered corn that includes insect control through the use of *Bacillus Thuringiensis*, a microbe used as an insecticide.

Preston said the corn is very similar to BT cotton, which is specifically engineered to kill boll-worm larvae as they feed on the leaves, stalk, and square of the cotton.

The tour will also exhibit a farm that uses 15" planting rows. Preston said the farm's cotton is planted with a wheat

drill with every other planter box blocked, and requires no plowing after planting.

"Once you plant you don't go back," Preston said. "It uses a pesticide treatment before planting to control initial weeds. Yes, you do need more seed per acre to get a better canopy, but it requires no cultivating. Very few weeds can grow in the shade. The cotton will make about three bales per acre."

The Roundup Ready and BXN cotton is also genetically engineered so that can be sprayed early with Roundup or Bucril pesticides without being harmed by the spray.

The tour will also address new corn herbicides and weed control, as well as rates of disease pressure on cotton seedlings and various fungicide treatments.

The tour will begin at Flagg Fertilizer, located six miles west of Highway 385 on FM 1524. For more information, call Preston at 272-4583.

Fallen tree limb cause of Thursday's power outage

Nearly 700 Southwestern Public Service customers on the west side of Muleshoe were without power on two separate occasions Thursday night.

The first outage occurred at approximately 7 p.m., when a tree limb fell across power lines in an alley in the 1700 block of Avenue B. The outage lasted about an hour.

About fifteen minutes after power was restored, SPS voluntarily shut off the electricity to ensure the safety of employees working on the downed lines.

Bill Crenshaw, spokesman for SPS in Amarillo, said full power was then restored one section at a time.




Tax levies of \$550,000 and another \$200,000 in Medicaid rebates were the difference between operating in the black or the red.

"Hospital districts are what makes the difference at rural hospitals," Bone said.

MAHD's tax rate of 25¢ per \$100 of property value is considerably lower than surrounding rural hospitals, which are in the 35-40¢ per \$100 range.

Community support is also a necessity.

"Utilizing the services that are offered goes a long way toward ensuring the services will be there in the future," Bone said. "We don't need to be another Johns Hopkins. But we do need to be a service to the people in the community."

The hospital has been on shaky financial footing for almost three decades, closing for almost a year in the mid 1980s when a California-based management firm running the hospital and nursing home declared bankruptcy.

In late 1984, financially strapped West Plains Medical Center, Inc. contracted with Westworld Community Healthcare to first manage then lease the hospital and nursing home. Worldwide took over in May of 1985. Eighteen months later, without warning, Westworld locked the hospital doors and declared bankruptcy.

"Everybody thought Westworld was a bunch of crooks," said longtime hospital board member Bob Finney. "But it was just a business that didn't work out. They left a whole lot more than they took."

The hospital remained closed for almost a year while the West Plains board of directors tried to find alternative financing (the nursing home remained open).

The first attempt to create the Muleshoe Area Health District in 1987 failed. The proposal was rejected during a special session of the Texas Legislature that summer, partly because the Lamb County Commission strongly objected to Southwestern Public Service's Tolk Station being included in the health district. The Tolk Station is located in the western edge of Lamb County.

All the while, the hospital remained open for the next two

years, operating on a shoestring budget with a skeleton crew and mostly volunteer help, until a new health district proposal, excluding the Tolk Station, passed through the legislature in 1989 and was approved by voters.

"There was a very large tax liability for payroll taxes," Finney said, who estimated the owed taxes to be in excess of six figures. The hospital district is also responsible for repayment of a long-deliquent Farmers Home Administration loan (about \$500,000) borrowed in the mid 1970s to build the current hospital. The debt has limited any major renovations or projects.

Basically, the health district includes Bailey County to just below Needmore, and the southeastern corner of Parmer County.

Most of southern Bailey County is conspicuously absent from the health district, but Muleshoe civic leaders were painfully aware that their southern neighbors wanted no part of belonging to the health district.

Two decades earlier, a civil war nearly erupted over the creation of the Bailey County Hospital district.

Bailey County voters approved the health district and a \$900,000 bond to enlarge the current facilities in May of 1970. But less than a month later, a group of citizens in southern Bailey County filed a lawsuit contesting the vote.

Most of the population in the southern part of the county used health facilities in either Morton or Lamb County, and didn't want to pay for something they felt they wouldn't use.

Even though several judges ruled in favor of the district in the course of the next year, the lawsuit effectively stalled the implementation of the district long enough so that the hospital district was dissolved within a few years. Just one tax was levied — to cover the legal costs of the hospital board.

Cook remembers the facility being woefully inadequate at the time, making it increasingly harder to meet Medicare requirements. The hospital was also having difficulty attracting doctors.

"We were down to two doc-

tors," Cook said. "I don't think by any stretch of the imagination you could call it a nice layout. The handwriting was on the wall."

With the hospital facing extinction, the board raised nearly \$450,000 in private donations, secured for a \$700,000 FHA loan and a matching federal grant, to build a \$1.9 million hospital. The addition was added on to the existing facility that was built during the World War II area by the legendary Dr. L.T. Green, who delivered his fair share of Bailey County baby boomers. The new hospital, opened in June of 1976 and still called West Plains Medical Center, was basically built around the old hospital.

Bailey County was in its infancy when the first doctors arrived. Most worked out of offices along Main Street in Muleshoe, the county seat.

In 1941, the first clinic was established by Dr. L.T. Green on Main Street in the building

use," said Richard Black of Circle Back, who also carried on a Letter to the Editor campaign in opposition for nearly a year. "We weren't against the hospital, we just didn't think we should have to pay for it."

Within a month, a lawsuit with about 300 petitioners was filed contesting the election.

One hundred and ninety-two witnesses were subpoenaed for the trial, which lasted a day-and-a-half. The judge ruled in favor of the hospital district.

The plaintiffs appealed to a higher court, and lost, but the damage had been done.

The petitioners were trying to tie up the election in court

long enough so the hospital district would miss a deadline for a matching federal grant and long enough to gain some seats on the board during the next election.

They succeeded.

"We knew we weren't going to win," Black remembered.

"We just wanted to stall long enough to gain control of the board."

"And we did," Black said, with a certain sense of satisfaction.

After a couple of years, the district was dissolved after levying just one tax — to cover the legal costs of the lawsuit.

Muleshoe FB practice starts Aug. 7

New Muleshoe High School football coach David Wood gets his first full look at this year's team when the Mules start two-a-day practices Aug. 7.

Wood is trying to turn around a team that finished 0-10 and has won three games in the last three years.

"I'm excited like everyone else," said Wood, who came over from Amarillo Randall High School.

Wood said he expects between 85-90 players from 9-12 grade to come out this year, a significant jump in participation from previous years. Last year, about 50 players came out.

Muleshoe will also play complete freshman and junior varsity schedules for the first time in years.

Two-a-day practices run from 8-10:30 a.m. and from 11:30 a.m. to 1:30 p.m. through Saturday.

An intrasquad scrimmage is scheduled for Saturday, Aug. 17. MHS has scrimmages scheduled against Morton and Floydada Aug. 22 and Aug. 29.

The Mules open the season Sept. 6 at Portales (NM).

The Mules have three new coaches.

Flint Bigham, a former Texas Tech defensive back, will take over as defensive coordinator, plus coach defensive ends and help with the offensive line. He comes from the Randall school system, where he was the junior high school football coordinator.

Jesse Russell, a veteran coach from Cireno High School in East Texas, will coach the defensive line and is the junior varsity defensive coordinator.

Among the returning coaches, Ralph Mason will serve as offensive coordinator and call most of the plays. Wood said he will be very involved with the offense, especially the passing game.

Ron Welch is the offensive line coach and junior varsity offensive coordinator.

Brad Hill is the freshman coach.

Ted Johnson continues as the junior high school coordinator, Jimmy Orr coaches the eight-graders and Jesse Inman takes over the seventh-graders. Inman comes from Pecos.

The junior high begins practice the first day of school, Aug. 15.

In other MISD athletic news, Kim Zollinger was hired as the head girls track and cross country coach, and will also be the girls junior varsity basketball coach.

car load of chaff!

Sometimes the address is more interesting than the actual letter. One came addressed to "Owner & Proprietor, 16th & D Church of Christ." That would be God, I suppose. Just last week, I came to address to "Mr. C. H. Christ." Hmm.

As I was busily trashing bulk mail one day, I came to an interesting letter from a congregation in a distant state.

After a polite salutation, the letter, obviously an appeal for funds, began, "We have begun a renovation of our building." The writer then detailed his church's plans to replace an inadequate heating system and to build a fellowship hall which he hoped would, among other things, provide the group's

young people with a place to meet.

Then came the line that stopped me cold: "The building here is also used for the deceased . . ."

In the moment before I finished that sentence my mind conjured up images of a black-clad preacher droning on and on to a congregation sparsely scattered over several pews, worshipers leaning this way and that, all stone cold dead! (Has any preacher ever been sued for throwing a member of his congregation into a fatal coma?)

I was somewhat relieved when the next line explained that their building served also as a mortuary for their very small rural community. For a moment, though, I thought I was reading a letter from the first church I'd ever heard of actually admitting to being a church for the dead!

It is a sad fact that there are some (and size has precious little to do with it). But seven little words from the pen of the Apostle Peter are the best safeguard I've ever heard against filling up a church with the spiritually dead: "Love one another deeply from the heart" (1 Peter 1:22).

No church practicing that imperative will ever become a congregation for the deceased!

several grant programs, and the HOME program.

"The severance package was in return for his completion of those projects," Montgomery said. "In situations like this, these packages are not uncommon."

The City is required by law

to sell the house by means of a bidding process.

"We are required to advertise in the local paper the sale of the house two consecutive times, and then wait 14 days," Montgomery added. "And so that's what we're doing."

Bids will be received no later

than Aug. 6. The City Council will review the bids at a meeting Aug. 7. The minimum cash bid will be \$61,000.

"The severance package will just make the transition a whole lot smoother and better for everybody," Montgomery said. "We both benefitted from it."

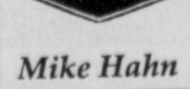

NAP offers assistance for grain producers

Small grain forage producers in Bailey County who suffered drought losses have been granted assistance through the Non-Insured Assistance Program (NAP).

Grain forage lost from September 1995 through June 1996 is the only crop eligible for the program. Producers who suffered losses due to the drought should have reported their acres, losses, evidence of production, and all other information required to determine their eligibility for NAP to the Bailey County Farm Service Agency.

ley County Farm Service Agency.

The late-filing deadline for eligibility for the program is Aug. 30. All acreage reports, notices of loss, applications for payment, and records of historical and current year production must be filed by the deadline.

Requests for NAP filed after the deadline will not be approved.

Seeded small grain forage includes fields seeded to wheat, barley, oats, rye, triticale, or

any combination of those crops.

Seeded small grain forage acreage eligible for NAP includes: acreage planted and reported with an intent of full season grazing, acreage planted and reported with an intent of fall and winter grazing only, followed by grain production in the spring, acreage planted and reported with an intent of spring grazing only, and small grain forage interseeded in an existing stand of grass.
