



My ambition when I was a boy was to make money. I hit upon many plans. I seined Willis Creek, yes and a lot of Pecan Bayou. I mowed yards in Brownwood, sold just a few marbles that I played 'keeps' for, raised some vegetables, sold a few banties and eggs. I can remember my first five dollar bill, my first ten spot, and I had a twenty dollar bill before I was 11 years old. I picked cotton, but I don't count that - I had to buy school clothes with that.

I remember one year hitting upon a plan to make a little extra money and I planted navy beans - those small kind, the white ones. During the planting of the crops, I asked my father to let me plant four rows down through the field. I took good care of those beans, too. I hoed them and they were plowed with the rest of the crop. The fall of the year came and I didn't want anyone to help me.

After frost and before they got too dry, I rolled those bean vines up into big balls, 4 to 5 feet tall. They dried in the field for another week and each day I would break them to see if they were ready for threshing. I didn't want to share my proceeds with anybody so I faithfully looked after the beans by myself.

After a few days I rolled a big roll up to the barn, got me a large stick about the size of an ax handle and started threshing my bean crop. I was elated. I made approximately 1 1/2 gallons of beans out of the first huge roll. I was in business and the dollar marks kept appearing before my eyes.

I caught a good wind out of the north and got up on a shed barn and I cleaned those beans by winding them out. There was no dirt in those beans. There was no rocks in them. SEE PAGE 2

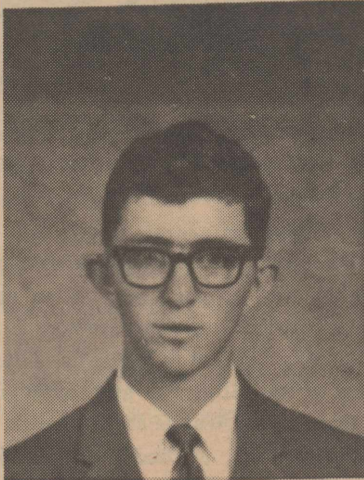

Editorial

Texas Highway Patrolmen, Kenneth Selman, Phil Upton and Clayton Koonce, reported their year's activity this past weekend for 1970. The big news of course for the year there were only five highway fatalities in Gaines County, the most of them unusual accidents.

For the year the department investigated 142 cases. Of the 40 accidents where there were injuries, 71 people were injured. Nineteen hundred thirty six traffic violations were handed out, plus 74 drivers charged with driving while intoxicated. Of the 74, 68 were found and / or pleaded guilty, 1 not guilty and 5 trials are pending.

There are several reasons that death loss has dropped, according to local patrolmen. (1) The driving behavior of people has improved. (2) Publicity of nasty wrecks. (3) Breath-a-lyzer tests. (4) Extra radar units. (5) Extra car and extra patrolman. (6) Blood tests, if they ask for them at their own expense. (7) Hard work. (8) The help of Mr. Average Citizen.

OIL COMPANIES PAY ?

In the latest action by Atlantic Richfield Co., Amerada division of Amerada Hess Corporation and Mobil Oil Corporation versus Gaines County and Gaines County officials, the three companies have paid what they consider to be their rightful share of taxes.

The following amounts and payments have been made by plaintiffs to the court to be held in escrow until case is decided, Atlantic Richfield Company - \$27,181.24, Amerada Division of Amerada Hess Corporation - \$442,736.97 and Mobil Oil Corporation \$106,340.79. These amounts represent approximately one half of the taxes that said properties were assessed for. (Other oil companies did not enter into suit.)

The plaintiff brought about the suit to restrain the county and the following officials from

collecting the tax - County Judge Chester Browne, County Commissioners - A. C. Stanley, Travis Bagley, Barry Norton, Robert Matthews; and Mary Baldwin, Gaines County Tax Assessor-Collector.

The case, No. 6127, states on the plaintiff's behalf that the ratio of assessment favored assessments of local rural real properties including various farms and ranches within the county by only half as much as oil companies were assessed. The companies complain "... the complete failure of defendants to perform their respective functions and duties imposed upon them by the Texas statutes and Constitution...."

The temporary injunction was denied in 106th District Court by Judge Truett Smith. Hence, this suit for a permanent restraining order.

FROM PAGE 1 They were clean and besides that, everybody ate them.

I found a 55 gallon wooden barrel that my parents said would be good to put them in and I started adding to the barrel. I got 10 gallons in there, I got 15. I got half a barrel and I had half the crop left in the field. Oh, if I could just fill that barrel full -- 55 gallons of beans!

I don't know how many hours I worked on it, but it must have been days and the work must have been satisfying because I stayed with it and filled that barrel completely full.

My mother asked, "Son, can we eat some of the beans?" and I told her, "they'er not to eat" and I started on my selling tour.

I guess all the neighbors must have raised beans that year. "Beans for sale? Why, we've got more beans than we can eat." I tried the stores. Did you ever see an eleven year old boy trying to sell beans? I've never forgiven some of those Brownwood store managers for not buying that 400-500 pounds of beans, but they just would not buy them.

My hopes, my hard labor went down the drain. But if you think that I suffered over the harvest of those beans and the non-sale of them, that was no comparison to the suffering that followed. I made the great confession to my mother that I couldn't sell the beans and she in turn started cooking them for the family.

A barrel of white navy beans, I'm convinced, would have fed a large ship during the war. When we went to the table and beans were the main course my brothers gave me that terrible stare. They were afraid to say anything. I ate those beans and didn't say a word but they said plenty to me after the meals were over. I doubt that any one of them eats them till this good day. I didn't make a sale but I gave a lot of them to my married sisters and made sure that there was none available for planting the following season.

A barrel of navy beans for one family will go a long long way. It'll go farther than that. It can just nearly ruin the relationship of brothers. Supply and demand may govern some things but the demand was not much for those beans, but the supply was finally gone. I don't recall my brothers mentioning the bean crop in years and years but I recall vividly the terrible things they said to me. (I want to hear some of the stories you brothers are going to tell, trying to get out of this.)

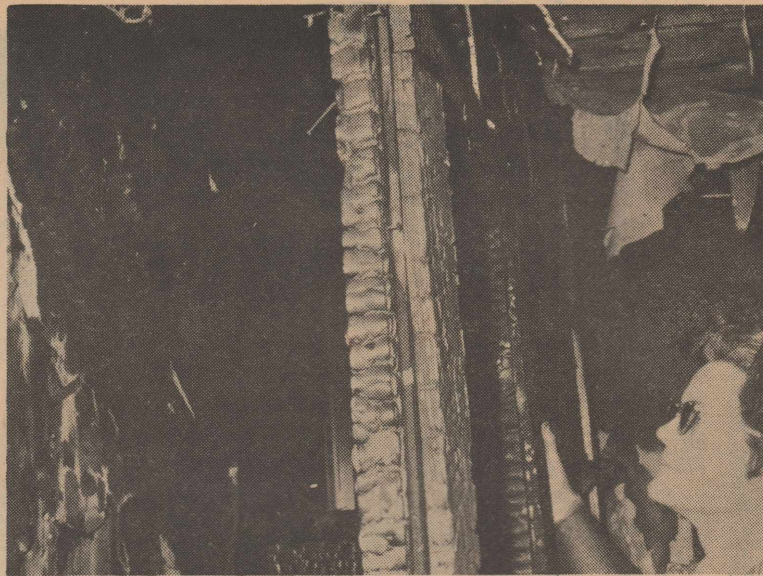

THE OLD TIMER

CONTINUED FROM LAST WEEK -

To start with I was getting \$75.00 per month. I said, "Mr. Sloan, I have enjoyed working for you and hate to quit but I have always wanted to go to Texas and this is my opportunity." But when I got up home my parents just had to have me lead the hands again and make a crop and I finally agreed to stay. My muscles had gotten flabby and weak after five years in the city and pulling that cross cut saw and swinging a chopping ax again was a chore. So on August 16th I left for Dallas, Texas to make a new start and the hot winds were blowing and searing the crops and it was 114 degrees August 17 when I landed in Dallas, and I could not find a job so there was a prosperous looking man standing on the sidewalk. I walked up and introduced myself and asked him if he was a farmer and rancher and he said he was. I said, "Do you need a hand?" He looked me over and said "What can you do?" I said I could do anything that any big man could do and a little more. He said "I have worked several Georgia boys; they don't know much but they are willing to learn."

We went to gathering corn and I would gather three loads a day and his big son would get two loads. He would say, "I don't see how in the devil you grab that corn so fast." Then we went to picking his cotton. He would take one row and I would take two and reach over and help him up so I could talk to him. He said "You can beat me gathering corn and picking cotton but wait until we go to the woods to get winter fire wood." We finally went six miles to timber land and started on an oak tree about 20 inches through and I soon cut into the heart and sat down. He asked me what I was quitting for and I said I was through. He came around and looked and said "How in the devil did you do it so quick?" I told him I had had an ax in my hand most of the time since I was a little boy and I made every lick count.

I was watching for ads in the papers and finally one came that appealed to me, "Gents Furnishing man wanted that has had experience buying as well as selling, come to Seminole, Texas, 70 miles North West of Midland, Texas." I sent copies of recommendations from past employers. After many questions, Mr. Sims with the firm of Williams Brothers and Sims wrote me that out of 127 applications for the job he had decided to try me first and to come to Midland, Texas and catch a mail car to Seminole, Texas at 7 in the morning and would get to Seminole at five in the afternoon and I thought a lot of my employer when I arrived. Jim Williams was in the bank and Andy was ranching out where two of the boys are still carrying on, Jiggs and Monty. In 1912 I bought Mr. Sims out and it was Williams Brothers and Pittman. They sent me to Saint Louis twice a year after I arrived here, to do the buying. I was carried away with this country and friendly people when I arrived and started out at \$40.00 per month. I had to start all over again but it was worth it. I will tell you later how he told me to sell goods to anyone during that depression in Atlanta, Georgia.

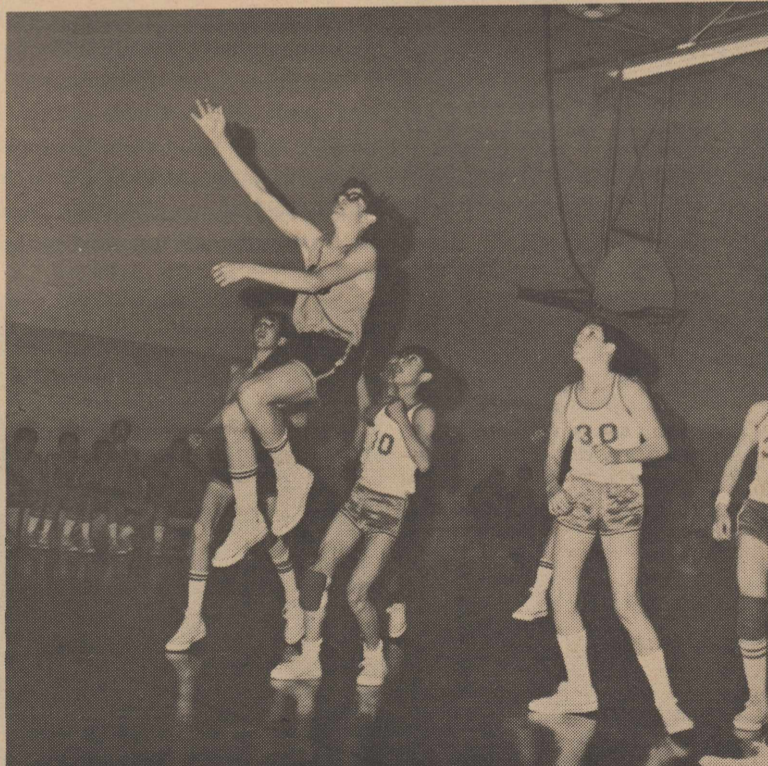

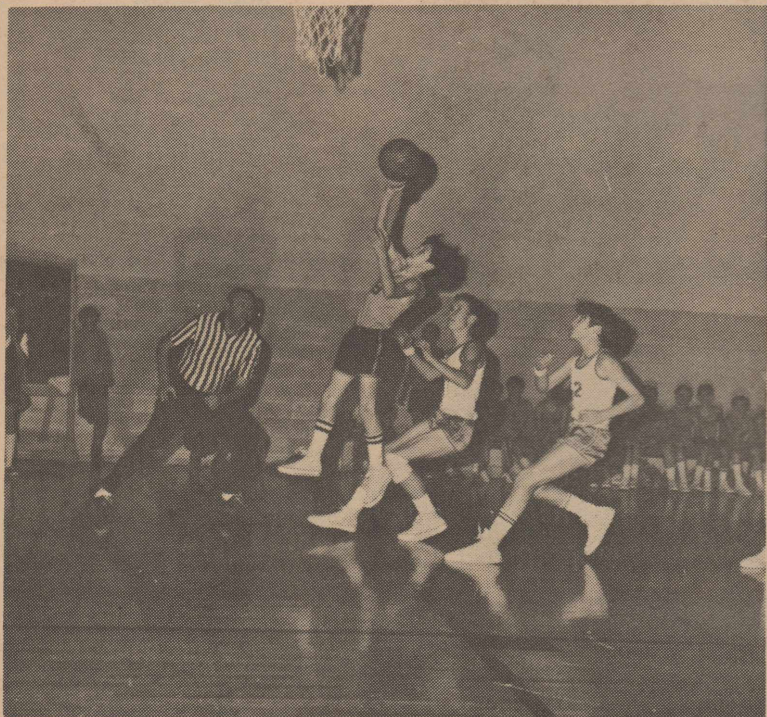

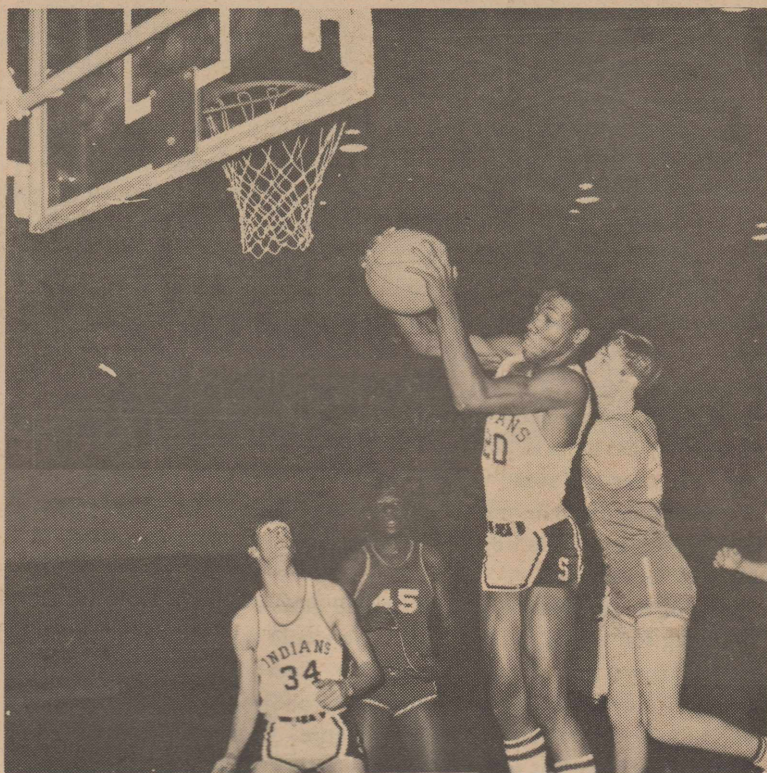

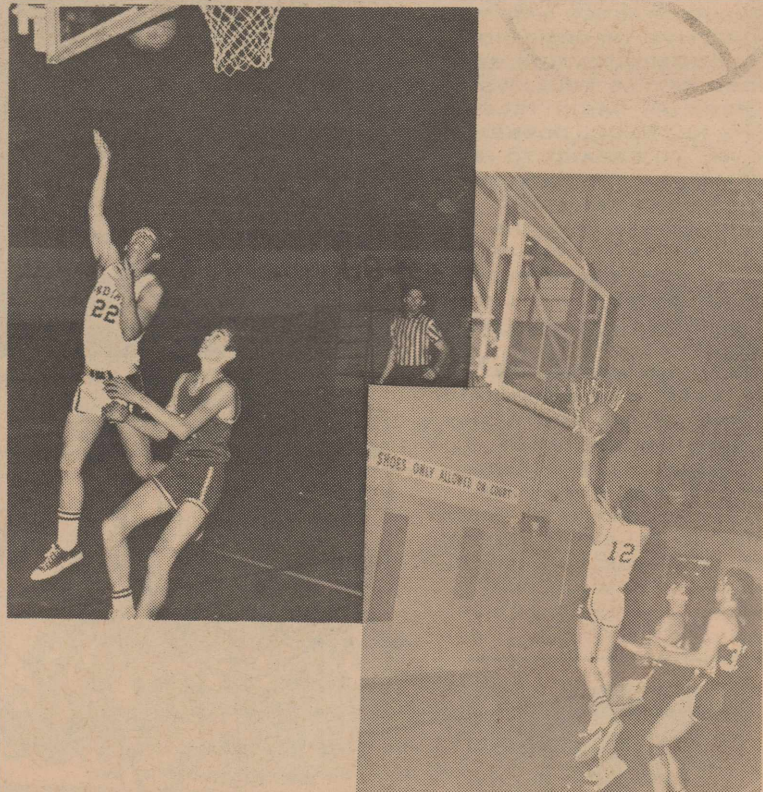

Nelson, #22, steals the ball and goes in for a lay-up against Hobbs last Saturday.



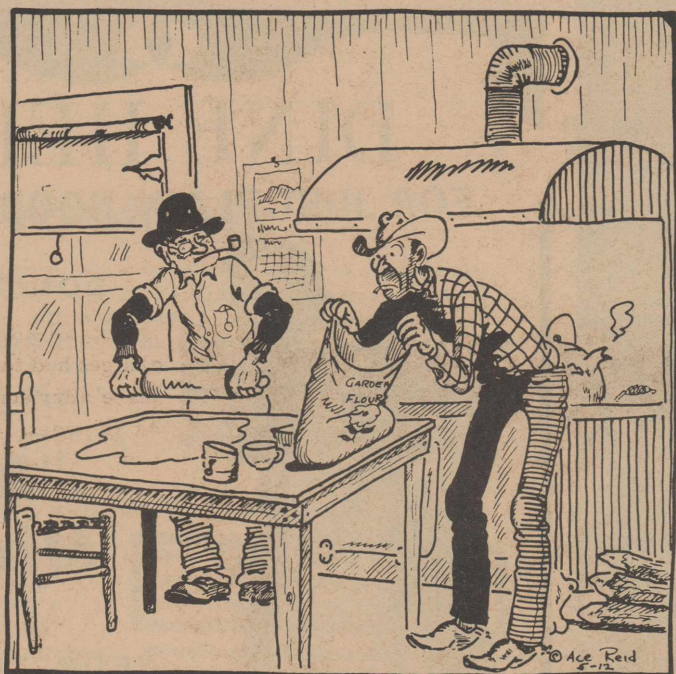

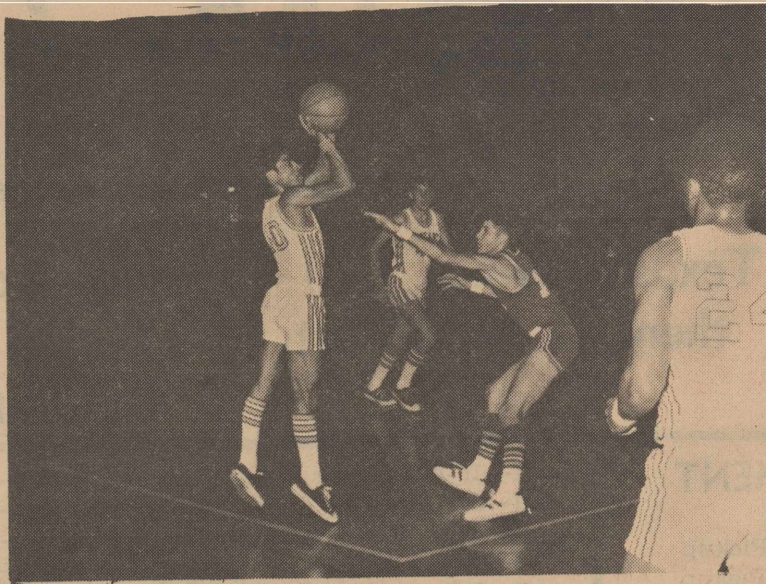

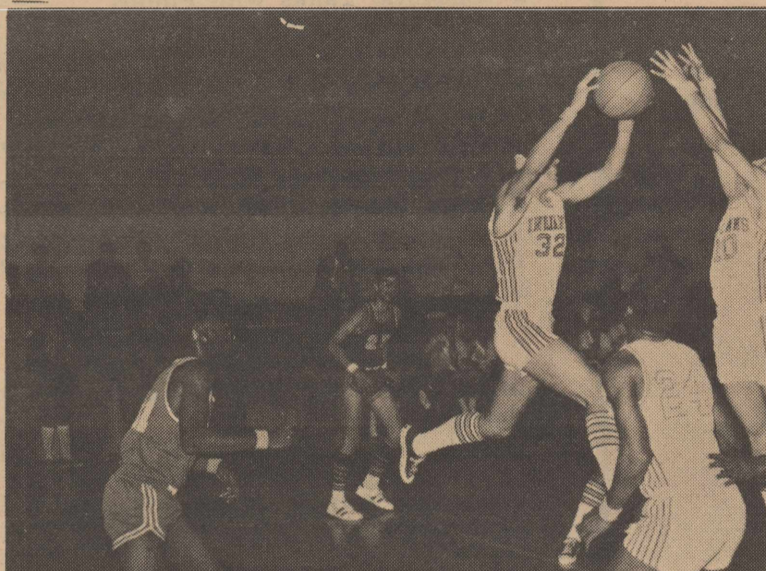

Number 24, Baker, looks on as Gonzales, #10, shoots away against Pecos. In the background is Roberts coming in to rebound. Seminole won their first district outing.



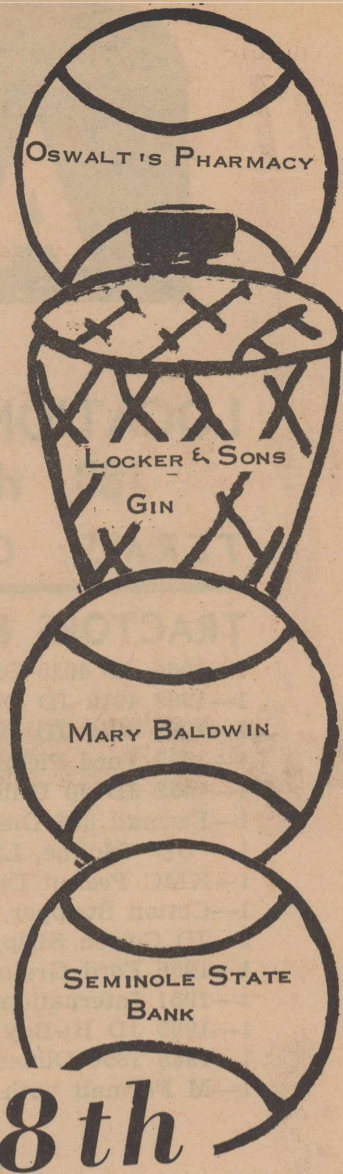
First down and 10 to go as Livingston rebounds against Pecos last Friday night. Number 24 is Baker and #10 Gonzales.

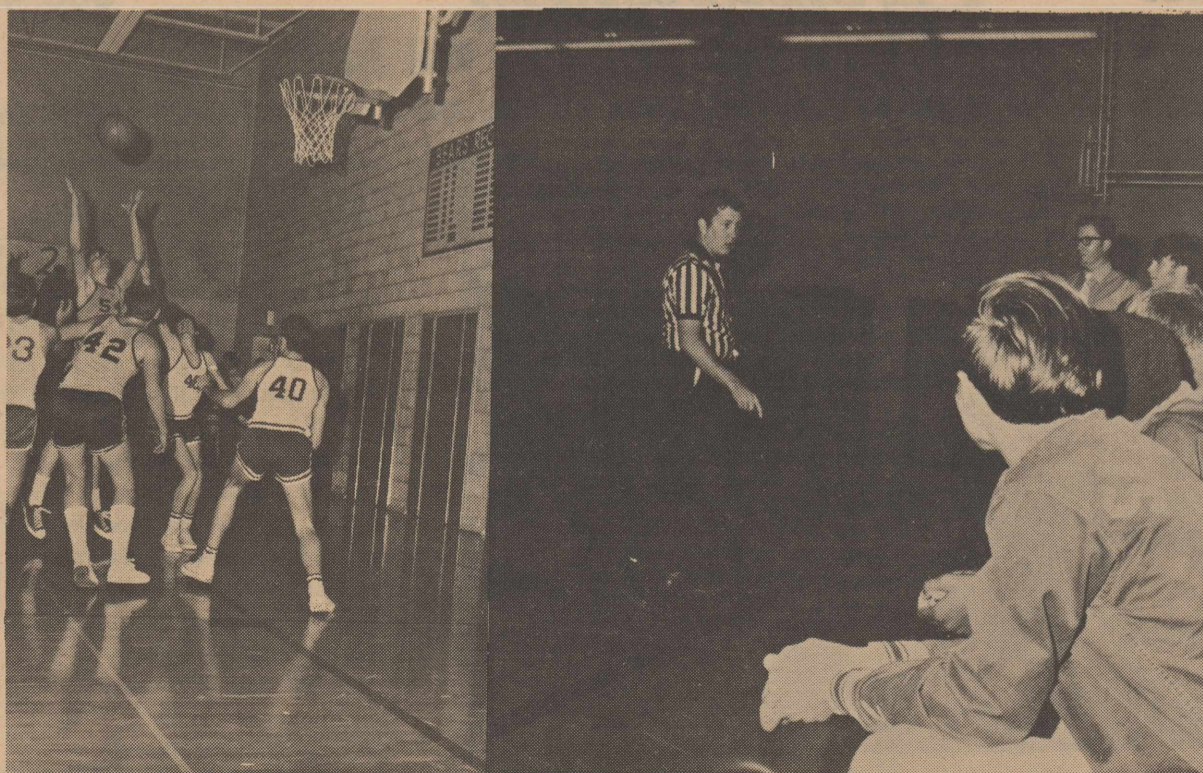
FRESH MEN

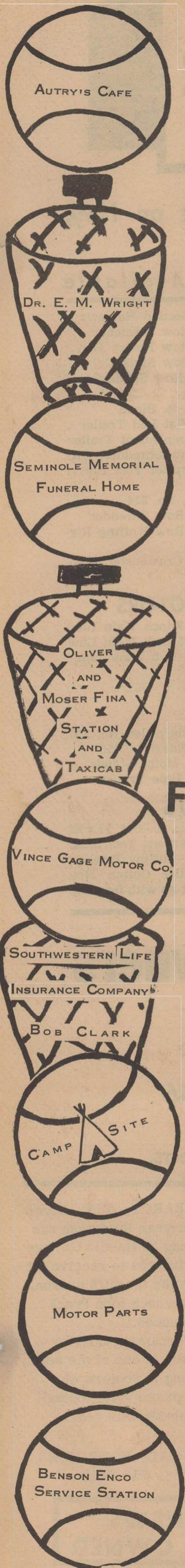


Ralph Sandoval, #31, goes up for a shot and 2 points against Hobbs Highland last Thursday.

VISIT YOUR LIBRARY

From time to time the past several weeks the News has run stories on the libraries throughout the school and this week the county library located in the courthouse basement in Seminole and in Seagraves. The Seminole library has 15,548 volumes, Seagraves 8,275, for a total of 23,823 in both libraries. In 1970 the Seminole library added 375 new books and Seagraves 250, for a total of 625 new books.

Besides serving adult residents of Seminole and school children, the library service includes college students attending Hobbs, Odessa and Levelland and students taking correspondence courses. The library has 4,539 subscribers in Seminole with the summertime being their busy time with over 200 books per day and a daily average of 98. The library subscribes to 44 periodicals plus seven newspapers. If you try the local library and the book is unavailable you may borrow through the Inter-library loan.

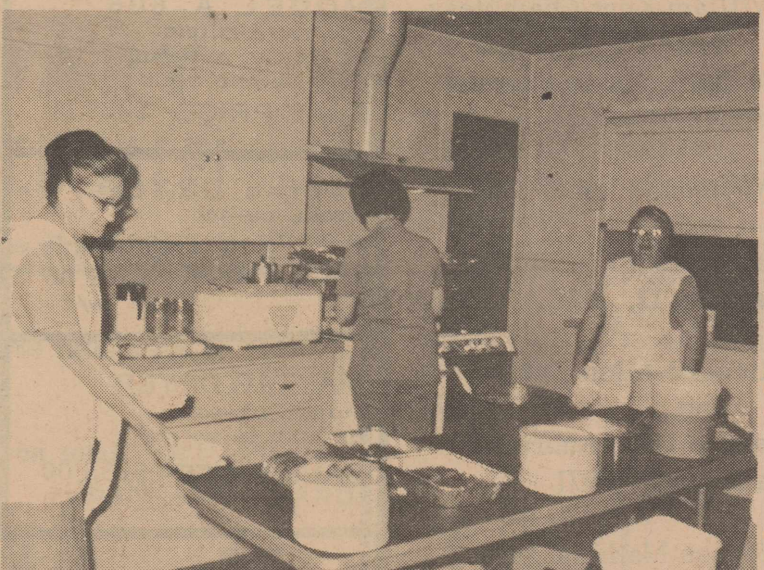

Letter to the Editor

Concerning letters to the editor written by Ita Fae Smith, 402 S. W. 11th St., Seminole, Texas, in which she said, "... Hospital rooms in Seminole are up to \$32 January 1, 1971. A hospital room 28 miles south was \$24 a day....." several readers asked that evidence be furnished from Memorial Hospital, Andrews, concerning room cost, as she promised.

The bills furnished the News show the following figures. Memorial Hospital - October 26, 1969 through November 9, 1969 - daily service charge (room) - \$21.00 per day. Permian General Hospital - December 3, 1970 through December 12, 1970 - Daily Patient Service (room) - \$24.00 per day.

Questions were asked, if the bills were paid. Memorial Hospital shows \$200.00 paid October 28, 1969, with \$408.05 balance. Permian General Hospital shows \$412.30 balance, with no payment shown. This does mean that payment on either one has not been made. It is not shown on the bills received by the editor.

Evidently Permian General Hospital does not charge as much today for rooms as Memorial Hospital. Hospitals with more rooms can service those rooms cheaper under present wage standards and HEW requirements than can smaller hospitals.

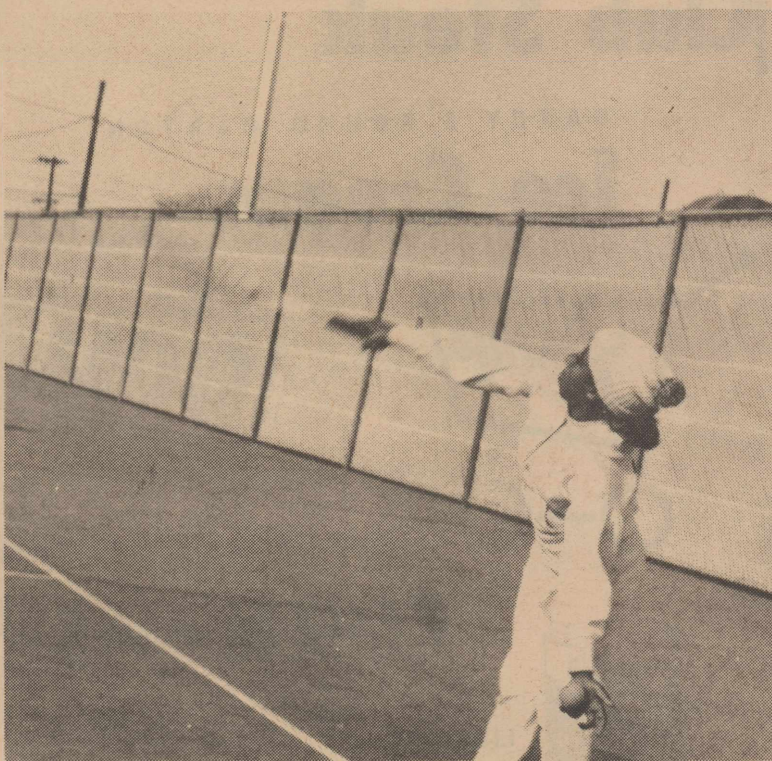

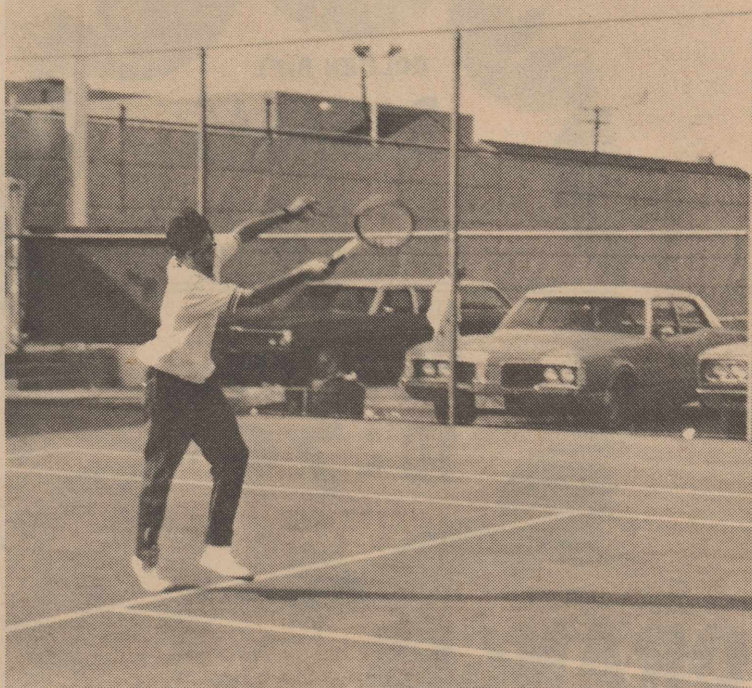

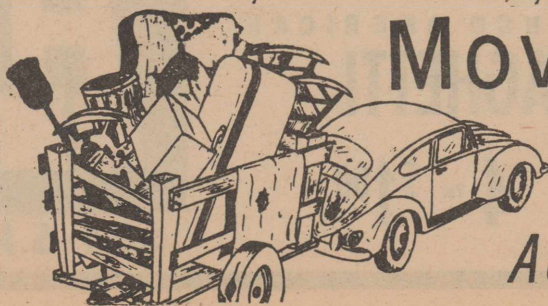
