of Floyd County met at the Floyd County Courthouse, May 14, 2018. Commissioners present were Tanner Smith, Lindan Morris, Nathan Johnson, and Amado Morales. Judge Marty Lucke presided over the meeting.

Commissioners reviewed and approved claims and accounts, as well as the items of consent on the agenda.

Cristen Brooks gave a detailed report of Extension activities that have taken place as well as those upcoming events.

Matthew Rainwater addressed the commission regarding unsafe conditions of county roads in his district. Commissioner Morales discussed difficulties of road maintenance, claiming to answer every call made for his district. Rainwater gave additional information concerning road maintenance lacking around his farm that has created unsafe conditions

for the required large equipment traffic. No action was taken at this time.

Judge Lucke reported that the wind companies were all up-to-date on their payments.

The Warranty Deed for Fred Thayer's property on East California had been submitted. The commission accepted that deed on behalf of the county. The Texas AgriLife Extension Service will be moving to the property later this year.

The Office of Attorney General-Child Support Court requested permission to install a designated T-2 line. They have instilled a new digital case-management system that requires uninterrupted internet service. The commission approved the installation.

Judge Lucke reported that Adult Probations is losing a \$50K grant. He said that one probation officer covers 4 counties at this time. Scurry County performs the drug and alcohol counseling for Floyd County. Judge Lucke stated that the Juvenile Pro-

bation Costs will increase a bit, but Domingo has been pushing PAC around the area, so the numbers are up. There is only one individual from the 110th Division. All others are brought in from other districts which equals outside money coming in to Floyd County.

Discussion has started with the City of Lockney for Floyd County to provide a turn-key contract for Law Enforcement for that community. Additional details will be forthcoming.

Judge Lucke reported that the lighting in the courthouse is being changed to LED products which should result in a savings for electricity utilities. There are some major electrical repairs/upgrades within the Courthouse. The County has an electrician that is willing to work on the aged







#### Ryan Chavarria Corporal Ryan Chavarria-US Marine

Ryan Chavarria needs little introduction. A graduate of Floydada's High School Class of 2012, he was a leader in church, sports, and various extracurricular activities. Currently, he is serving a tour, soon to extend again, in Japan where he is known as Corporal Ryan Chavarria.

I visited with Ryan's mom and dad, wanting to get a very personal view of Ryan; of how he came to the decision to enlist into the military; of how it affects his family; of how Ryan has changed. It's that portrait that I share today.

"I remember that day well," stated his dad, Ruben Chavarria when I asked him about the day Ryan come home with the news that he would enlist. "He was actually home for the summer. A couple of his friends had decided to enlist, and there was one that was already in the system. That day, he just finally came around to telling me." The response to his son, "If you are going to do it, do it for you!" Dad didn't want pressure from friends or life, itself, to be the cause of Ryan's decision. "It's not a lighthearted subject. Immediately, I thought the worst." But, Ryan convinced his dad that enlisting was what he wanted to do.

Mom, Alma Ascenciio, said the news caught her by surprise. "I tried to change his mind--He is my only son! But, that didn't work." When Ryan headed off to Basic Training in San Diego, he left behind his four sisters: Aimee, Ashton, Addison and Averii...and a whole host of Chavarrias.

And...he had to leave his mom. "I always say, 'My Ryan' or 'My Scottie' when I speak of him to his sisters," commented Alma. "It's hard on his sisters, having him so



far away--especially during their events like graduation, birthdays and holidays. We always make sure to send My Ryan pictures and videos," so he can feel a part of the celebrations. Of the few times he has gotten to come home, his mom adds, "we all make sure to hug and kiss him as much as we could. He would reply with a smile on his face, 'My sisters are too much for me mom!"

I asked his dad to describe Ryan to me. "He is a protector. I've seen him angry, but it takes a lot, and that anger usually has to do with family stuff. He lives up to being a big brother." Thinking a bit, he added, "He is wellrounded. He's caring. He puts a lot of thought into what he does. He's awesome!"

In truth, the military was Ryan's first job. From Basic Training in San Diego, Ryan went to North Carolina where he began his official duties. "His time in Carolina didn't meet his expectations, and he's got some high ones," stated his dad. "He expects to be doing something--that's what he is all about. He's not content sitting idle. If it means doing something for somebody, man! He's on it! But, Carolina was a lot of downtime. He got really disengaged and had talked about getting out. That was before he got this chance to go to Japan." Ryan has been stationed in Japan for just about a year now, and he has extended for another year. He told his dad recently, "It's good. I'll stay here."

I asked, from a dad's perspective, how has Ryan changed since enlisting? "It's not so much a change. It just seeing him at work; seeing him doing the things that you already knew he could do. He realizes that now and puts it into action." Servicemen's lives are run by the clock, and Ruben sees some of that in Ryan, more so, now. "He wants to know that it's at least, on the schedule. Not so much an itinerary, but he does seem to need to make that plan more now."

"It's unbelievable to see these kids grown up." Dad smiles, "I still look at him as a kid. We were talking this morning. He said he was thinking about Special Forces. As a dad I said, 'Can you stop thinking?!' But, that's right up his alley. He's really into 'doing things with a purpose."

"He said he wanted to do that so that I could have a conversation with my friends and they can have an 'Awe moment.' I keep telling him, 'Man, Ryan! You've already done that. Just doing what you are doing takes a lot of guts.'I tell him all the time, but I don't think it registers in his mind."

What is in Ryan's future?

"He has a passion for coaching and teaching-getting to work with youth," states dad. "I believe he will attend college and get his teaching degree." That is what he has voiced to Ruben. "I think he'd be perfect for it. He's something...that kid's something else!" It just seems natural that Ryan will end up doing something that is meaningful to others, that helps them in some way.

Ruben stated that Ryan was thrilled about this interview. "It's something that is needed. It puts a face on things, and on the families that live with sons and daughters that are serving."

Speaking for the entire population of Floyd County, Ryan, we wish you the best in your future. Corporal Ryan Chavarria. we salute you!





## Texas Drilling Permits and Completions Statistics for April 2018

Special to The Hesperian-Beacon

AUSTIN — The Railroad Commission of Texas (Commission) issued a total of 1,221 original drilling permits in April 2018 compared to 909 in April 2017. The April total included 1,101 permits to drill new oil or gas wells, seven to re-enter plugged well bores and 113 for re-completions of existing well bores. The breakdown of well types for

2018 included 331 oil, 60 gas, 731 oil or gas, 87 injection, one service and 11 other permits.

In April 2018, Commission staff processed 616 United States. oil, 134 gas, 48 injection and four other completions compared to 439 oil, 44 gas, 45 injection and two other completions in April 2017. Total well completions processed for 2018 year to date are 3,514; up

## Pet Talk Chagas Disease in Dogs

COLLEGE STATION, April 9, 2018 - Whether your dog stays outside for hours at a time or is primarily an inside dog, all dogs are at risk for Chagas disease, a potentially fatal disease that affects the heart and other organ systems.

Chagas disease is caused by the protozoan parasite Trypanosoma cruzi, which is spread to dogs through insects in the Reduviidae family, also commonly known as cone-nose or kissing bugs.

"Kissing bugs are blood-sucking insects that often hang out in or around places where sources of blood are readily avail-

and, unfortunately, sometimes in human dwellings," said Dr. Sarah Hamer, an associate professor at the Texas A&M College of Veterinary Medicine & Biomedical Sciences. "The parasite is transmitted to dogs when they are exposed to the feces of the bug or when they eat the bugs. About 60 percent of kissing bugs across Texas are infected with the parasite.

"Many dogs can be infected with the Chagas parasite and show no signs of disease, while others may develop life-threatening heart complications," Hamer added.

Chagas symptoms can appear within weeks of infection (acute) or months to years later (chronic). Typically, dogs that are younger than 2 years old are more likely to develop acute disease, with possible symp-

By the Texas A&M Univer- able, such as dog kennels, woodrat nests, toms of diarrhea, lethargy, seizures, swollen lymph nodes, fluid retention, and heart failure. Symptoms that occur during chronic disease are those of congestive heart failure, including lethargy, fainting, increased heart rate or abnormal heart rhythm, and fluid buildup in the abdomen or lungs.

Although there is no vaccine or veterinary treatment for Chagas disease, pets can be protected through insect control.

By reducing the amount of outdoor lighting at night, kissing bugs may be less attracted to an area. If you keep your dog in a kennel outside at night, consider installing a protective screen on the kennel. In addition, try to keep your backyard free of woodpiles and other brushy areas, because these areas can serve as a breeding ground for infected insects. Hamer added that licensed pest control operators can help recommend a pest control plan to combat the bugs.

To better protect humans and animals from Chagas, Hamer and a team of researchers have been coordinating a special project since 2013.

"We run a 'Kissing Bug Citizen Science' program to engage the public in Chagas research and provide resources for people to better protect themselves and their pets," Hamer said. "Our program accepts kissing bugs encountered by the public across the southern United States. Submitters provide important data, including the location, time, and behavior of the bug when it was encountered. Each bug provides a wealth of information for our research—we've received over 4,000 kissing bugs since the start of our program."

Hamer added that her research helps to characterize the natural cycle of Chagas transmission and determine risk factors for human and animal exposure.

A kissing bug app is also available on iTunes and Google Play. Through the website and apps, Hamer said the public can submit photos of bugs if they are unsure if they are kissing bugs.

With no vaccine or treatment available, prevention is key in protecting your pet from Chagas. Fortunately, Hamer and her team are working to learn more about Chagas and how to better protect you and






