## Rains continue to fall on saturated County

Floyd County and the High Plains has continued to receive rainfall just about every weekend and this past weekend was no exception.

Cotton producers in Floyd County are waiting for some dry weather to get into their fields, some to finish planting, while others may have to replant due to recent hail damage.

Floyd County Extension Agent J.D. Ragland told the Hesperian-Beacon, "It is 'wait and see' right now whether some producers will lose their cotton, or not. I don't know what the planting deadline will be now (on late planting). The original deadline was June 5."

According to Ragland, the wheat in the fields ready to be cut can now be damaged by high winds. "It will cause the wheat to lay over," he said.

This week's West Texas

Mesonet rainfall chart dated 6/10/07 shows Floydada receiving more rainfall so far this year than any other town on the High Plains.

The chart shows Floydada's total so far this year at 18.25 inches and it shows Lubbock receiving 16.61 inches to date. Anton shows receiving 16.56 inches, while Ralls shows 16.18 inches of rainfall so far this year.

## FLDS fleeing UEP changes

Wisam making few friends as trust overseer

They have a litany of nicknames for him: Bruce Almighty, Uncle Bruce, Wisepants and the State Ordained Bishop, among them.

Yes, that makes Bruce R. Wisan an S.O.B., which he finds hilarious. At least they're talking about him, if not to him.

For the past two years, at a judge's request, Wisan has overseen a property trust once run by polygamist Warren S. Jeffs and other leaders of the Fundamental Church of Jesus Christ of Latter Day Saints.

Some beneficiaries of the trust love what he is doing, some despise it - and some hold both feelings at once.

Wisan just keeps plowing ahead. "You can't please everybody," he says.

The certified public account-

ant, who has a distinctive Daddy Warbucks look, describes himself as "tenacious, a little combative and a little aggressive."

That is, perfectly suited for the role of a receiver or fiduciary.

Wisan is an old hand at running other people's businesses. He has overseen a motel in Provo, a wedding reception center in Layton, and a bowling alley/cafe/bar in Orem - where the bartender threw down his apron in disgust and walked out when Wisan arrived.

So Wisan asked a handful of regulars if any of them knew how to tend bar. One said yes and minutes later Wisan had put him to work.

None of these "second" jobs, however, involved the challenges Wisan faces in his current capacity as caretaker of the United Effort Plan Trust, the \$114 million trust created about 70 years ago in southern Utah by polygamists.

"A black hole." Wisan was

drawn into the post by Tim Bodily of the Utah Attorney General's Office. In a case years earlier, Bodily enlisted Wisan to sell off inventory at a used appliance business to pay back taxes. Then, when it didn't make money operating legally, Wisan simply shut it.

In 2005, Bodily called Wisan as the state alleged the trust's assets were being pilfered by its FLDS trustees and left undefended against lawsuits. The trust holds virtually all land and buildings in Hildale, Utah; Colorado City, Ariz.; and Bountiful, British Columbia.

"He said [the job] could last a year to five years and it was pretty complicated," Wisan recalls. "The whole thing was total unknowns, a black hole. There were a lot of risks."

Among them: Getting paid. Wisan quickly reclaimed a 400-acre property that FLDS leaders

## Trial set for FLDS Prophet, Warren Jeffs

A trial date for September 10-21 has been set for FLDS polygamist sect leader Warren Jeffs.

According to a May 31, Salt Lake Tribune story, Fifth District Judge James Shumate said the trial will be held in Washington County, Utah unless he can't find enough fair minded jurors.

Jury selection will begin September 7.

The trial date was set after court ordered psychological evaluations stated Jeffs was com-

petent to proceed with the trial.

Jeffs is charged with two felony counts of being an accomplice to rape for performing a 2001 marriage of a 14 year old bride to her 19 year old cousin. The underage bride objected to the marriage.

Members of FLDS believe their spiritual salvation depends on allegiance to Jeffs. Because of this, complaints against Jeffs by any girl forced into marriage is rare to nonexistent.

## Workshop set for Playa management

Did you know Floyd County ranks second in the number of playa lakes on a per county basis with a total of 1,763 to be exact?

To address how to better manage these in Floyd County the Texas Cooperative Extension Service will be conducting a Playa Lake Workshop on June 27 at the Floyd County Friends Unity Center. Registration will start at 8:30 a.m. with the workshop concluding at 3:00 p.m.

Ken Cearly, Extension Wildlife specialist will be the program presenter.

The meetings will include sessions on the value of the plants, historical use of playas, managing playas for pheasants and wa-

terfowl, and assistance programs available, Cearly said.

Special programs will be presented on the Mossy Oak / Ducks Unlimited Ochiltree playa restoration project and the Ogallala Commons, he said, as well as hunting/leisure/recreation opportunities.

A field tour at each site will be taken to show nearby contrasting playa management scenarios, ie heavily grazed vs lightly grazed or ungrazed, cropland playa with buffer vs without, fenced vs unfenced, Cearly said.

Though the cumulative footprint is relatively small, playas still make up 400,000 acres in the

## The Lamplighter

The immigration bill is dead, for the moment. In our opinion, it will stay dead. And that's the best news we have had out of Congress in recent weeks.

Any time Teddy Kennedy and George W. Bush get together on anything, we all have reason to worry. In this case, due to an outpouring of public sentiment in opposition to the bill, the lead Democrat in the matter, Senator Harry Reid of Nevada, pulled the measure down from consideration. Unless he and Teddy, and the President, can come up with the votes, the measure will stay dead. The President says he still has hopes of reviving the bill. Many of us have hopes too...that the bill won't be brought back until it has been improved.

The immigration thing has been building for years, if not decades. It has been building ever since Lyndon Johnson forced through a bill that made possible the "reunification" of families, or anybody that resembled a family

member. From there it was a small step, or a series of small steps, until anyone from Mexico or Latin America could send their kids to school alongside everyone else. Or until they could flood our emergency rooms with cases needing treatment.

The President, and Senator John McCain of Arizona, along with a host of other people, throw out the comment that "well, if you don't like the bill, tell us what you would do to make the situation better." So we'll tell them, and anyone else who will listen. For starters we would simply enforce the laws already on the books. That would effectively close the border to illegal aliens. Then, once the borders were effectively closed, they could start rounding up those here illegally and sending them back to "the country of origin."

That business of "enforcing the laws already on the books," worked just fine when George W.

Bush was running for the Presidency and the issue was gun control. Then, the argument made good sense. In this case it still does. The borders should be closed to all but legal entrants, now and in the future. We remember well, as if it were yesterday, when we were visiting our mother-in-law then living in Knippa, Texas when we were awakened by bright lights and whirling helicopters at about three in the morning as a freight train came through the small nearby town just west of Uvalde, Texas, on its way to San Antonio. The undermanned Border Patrol had decided to stage a raid at that time. To make what turned out to be a long story a little shorter, the Border Patrol got 145 illegal "wetbacks" off that train or in the fields nearby, in less than one hour. That was in one small town, at one stop, at three o'clock in the morning. And yet innumerable politicians

act as if it were a new situation.

We doubt seriously that our courts ever made disposition of those cases. About all anyone ever got out of a deal like that was a free trip back to their homeland, courtesy the U.S. taxpayer. Federal law, don't you know. And who, pray tell, was in charge of the immigration laws at that moment? It wasn't George W. Bush, or a Republican Congress. But Bush's later claim to fame certainly was not a concern for border security, until, that is, airplanes flew into the Twin Towers in New York City.

We will admit that the entire issue would now be a tough nut to crack. Only a relatively few in Congress feel any sense of urgency about this issue. Most take the position that they should be concerned only about issues that affect their own political future, or their retirement income. They are now finding out that this issue certainly does.

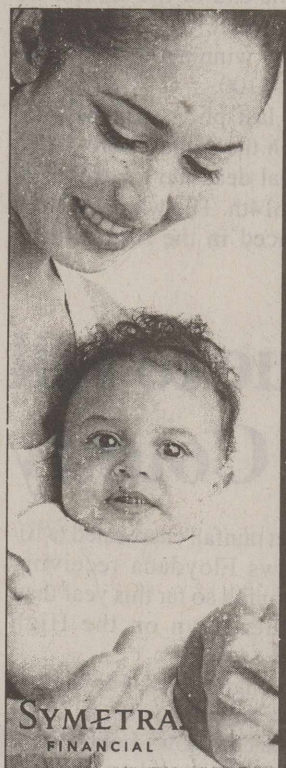

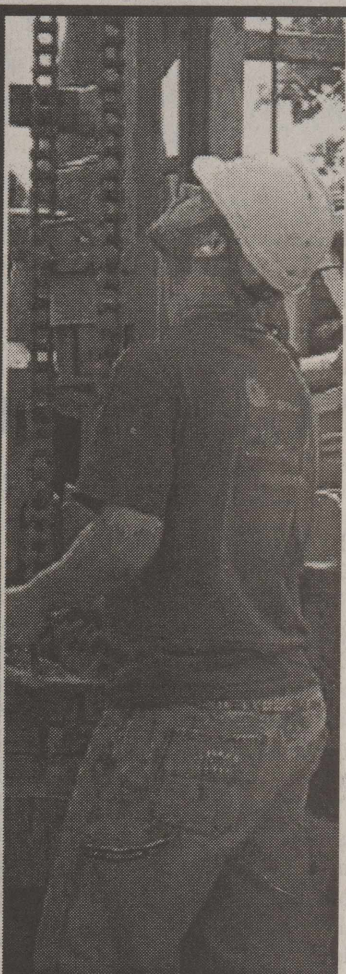

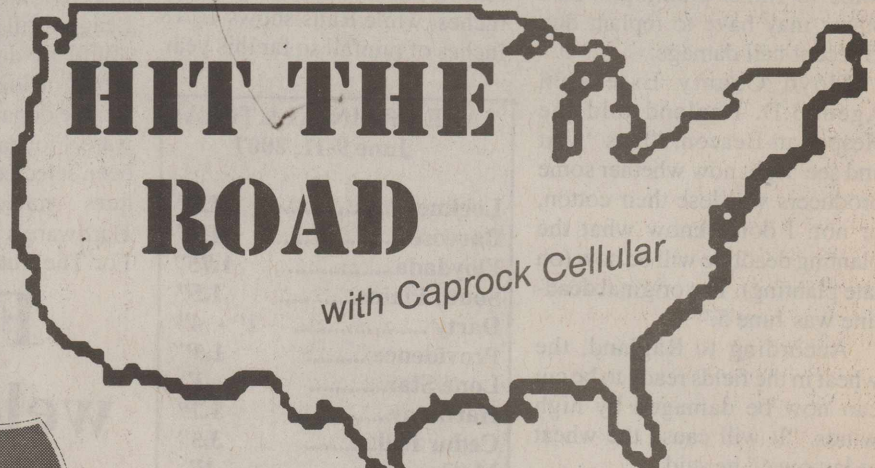

# Trust changes may be reason for FLDS movement

 attempted to transfer out of the trust. He sold it for \$1.5 million and socked it away to cover his fees and those of his attorneys.

Then he went to work. Wisan has been unrelenting in hunting down missing property and battling over ownership of businesses, buildings, a farm and documents when Jeffs was arrested nearly nine months ago. In February, he auctioned off a state-of-the-art building that once housed a high-tech machine shop for \$1.65 million.

This month, he seized an alfalfa farm in Beryl to satisfy an \$8.8 million default judgment against Jeffs and other former FLDS trustees for mismanaging the trust.

Wisan played hardball when FLDS members refused to send him property tax payments, posting notices on nearly every home in the twin towns advising residents to pay up or face eviction. In a concession, Wisan allowed payments to be made directly to the counties so FLDS didn't have to deal with him.

Other items on Wisan's "done" list: The FLDS trustees were suspended and replaced with a new advisory board; the trust has been rewritten; and two of three lawsuits that targeted trust assets have been settled. Wisan also in-

stigated ongoing investigations of the Colorado City Town Marshal's Office, whose deputies he accused of obstructing his work.

Today, he says he would "like to privatize the trust as much as possible. If I could, I would like to dissolve the trust."

Wisan has had unexpected success, Bodily says, given the "hostile environment, lack of records and circumstances he faced."

But Wisan "is a risk-taker and he's thick-skinned and he's a mover," Bodily said. "Once he's done due diligence, he has the strength to pursue and take that big step."

"Say nothing." Meanwhile, the FLDS, who are the majority in the twin towns, have maintained a stoic silence. They have stayed away from Wisan's informational meetings in Hildale, considering him an interloper in cahoots with apostates in a state-orchestrated scheme to destroy their community, their church and their charitable trust.

The trust, set up in the 1940s, was intended to provide a safe haven for fundamentalist Mormons engaged in polygamy, a place that would provide homes and jobs far from government intrusion and public disdain.

Wisan has done "everything possible" to reach out to the

FLDS, said Robert C. Huddleston, former Dixie College president and an advisory board member. "Unfortunately, their leadership wants nothing to do with it," he said.

Wisan said Jeffs instructed his followers to avoid him, a "say nothing, do nothing" order that carried the threat of disfellowship and, worse, loss of their family.

"Certainly, I would like more cooperation but I wouldn't want to cause any more pain and agony for the people to whom I'm speaking," Wisan said.

Bodily called the lack of FLDS participation a "surprising turn."

"We were just wanting the fiduciary in there to protect the trust," Bodily said. "But since no one was willing to cooperate, I'm not sure [Wisan] had any other options other than to" liquidate the trust.

Privatization of the trust will, in fact, be the culmination of a battle begun 22 years ago by dissidents who resisted efforts of FLDS leaders to kick them out of their homes.

But it may be Wisan's biggest challenge. For the FLDS faithful, there is no taking back property consecrated to the trust and many are, instead, leaving the community.

Homeowners wanted. Wisan's push to privatize the trust - by turning residents into homeowners and broadening the towns' economic base - has moved slowly.

Wisan sees homeownership as a "watershed event."

The first step is a nearly completed, \$402,000 property survey that will allow residents, now in trust homes as tenants at-will, to seek deeds. The survey was delayed when Hildale and Colorado City officials refused to cooperate, but they reversed course this spring after Wisan sought county approval instead.

So far, Wisan has handed out just one deed: to Richard Holm, who reclaimed a Colorado City home he was kicked out of by

Jeffs in 2003.

But Wisan sees the "stretch run" ahead. He and his advisory board have identified 42 "clean" homes with uncontested ownership claims - all from ex-FLDS members - that are awaiting deeds once the survey is recorded.

"Everybody is disappointed with how slow it's been," said Carolyn Jessop, an ex-FLDS member who is on the trust's advisory board. But, "There were a lot of earth-moving things that had to happen to get it to this point. . . . Bruce has done an excellent job."

Holm would like to see Wisan move faster, using warranty or quit-claim deeds to turn over properties rather than wait for official approval of the survey.

Others are outraged by Wisan's stipulation that they pay \$5,000 plus recording fees for the deeds, given their years of labor, home construction and monetary donations. Wisan is nonplussed, saying residents should expect to bear the costs of privatizing the trust.

"A thing of the past." Also moving slowly: Wisan's push to broaden the towns' economic base.

Northwest Land Co., which bought the high-tech building Wisan auctioned earlier this year, has yet to land a tenant.

Wisan is exploring selling other property with development potential - fast-food franchises and an RV storage facility have been discussed - along much-traveled Highway 56, which skirts the towns' west edge.

Holm, once a leading businessman in the community, said development would be better spurred by installing new trustees who are residents. Only two of the six current advisers live in the community. He also said it is time for Wisan to act as an adviser to the board, rather than the other way around.

"What he's done has been okay, but really all the money that has come in has gone to pay his and the attorney's fees," Holm said.

Management and expense fees for the trust have topped \$1.6 million so far.

That's hard to justify, said Rod Parker, an attorney who formerly represented the trust and the FLDS church.

"Everything he's done [has] been at the instigation of dissidents and with the result of helping himself and them to the assets of the trust," Parker said. "It should have been obvious from the beginning that the beneficiaries wouldn't go along with it, and they've spent a lot of money proving that true."

In Parker's view, Wisan is "an instrument of a broader crusade" who is, without any restraint, moving far from his original mission of protecting beneficiaries' interests.

But Winston Blackmore, an ex-FLDS member in Canada and former UEP trustee, sees the costs as necessary. Blackmore is the only former trustee who has cooperated with Wisan, which led to him being dropped as a defendant in the mismanagement lawsuit.

Under FLDS trustees, "businesses were looted, retirement funds cashed in, insurance proceeds confiscated, holiday pay

taken and many businesses were contributing on behalf of their reluctant employees with money that really belonged to the employee," Blackmore said.

"The UEP as we knew and loved it is a thing of the past, and it requires the efforts of a crass, no-nonsense, unbiased but tough administrator to deal with the issues in the timely manner that [Wisan] has been doing," he said.

Service with a smile: Wisan believes he can accomplish remaining items on his "to-do" list within the year.

That is partly why he has told 3rd District Judge Denise Lindberg it is too soon for him to step aside. His advisory board agrees.

"There are a few major issues we want to tackle," Wisan said, "but I like where we're going and what we've done."

And he holds out hope the FLDS may take part, noting he is treated less rudely in the twin towns these days. During a visit in April, Wisan met with Colorado City Mayor Terrell Johnson, who had previously vowed never to speak to him.

"I can go to a restaurant in the community, get served and get served with a smile," Wisan said. *brooke@strib.com*

## Workshop focuses on area playa lakes

 High Plains, or about 2 percent of the land area, he said. Texas possesses the largest number of playas, an estimated 20,000, he said. Another 10,000 playas can be found in New Mexico, Colorado, Nebraska, Kansas and Oklahoma.

Playas are an important landscape feature, Cearley said.

"These small wetland areas hold enormous capability for ecosystem contribution, yet often fall short of their productive potential due to lack of management," he said. "In many cases, playas are ignored, unnoticed or over-utilized."

Varying in configuration and size, from less than an acre to several hundred acres, Cearley said playas serve as a source of Ogallala Aquifer replenishment and provide habitat for numerous wildlife species.

Several million migrating waterfowl and 400,000 sandhill cranes will utilize these wetlands each year, he said. In addition,

up to 250,000 ducks are reared on playas in Texas annually. Pheasants use them for year-round habitat, and are especially dependent on them for winter cover.

The primary uses for playa lakes are crop production, grazing, wildlife production and wintering habitat, urban stormwater and feedyard waste containment, Cearley said.

"Educational efforts such as these meetings are needed to raise awareness and to disseminate sound information relative to playa management," he said. "Such management will provide high quality wildlife habitat, a source of aquifer replenishment, and sustained rangeland production."

## Commissioners look at employee insurance

 The Floyd County Commissioners met Monday, June 11, and heard a county health care insurance presentation by Kyle Smith, and a 4-H report from Floyd County Extension Agent J.D. Ragland.

Ragland told the court the 2007 Floyd County Senior 4-H Livestock Judging Team had placed 2nd in State competition.

Concerning health care insurance for county employees, Smith of Goen and Goen Insurance said, "It will cost the county around \$170 to \$200 per year to join the Lubbock County Chamber Association, which will give you lower group insurance rates for your 42 full-time county employees."

Smith presented several different plans to the commissioners. The cost of the plans were from \$143 per month per employee up to \$236 per month per employee, depending on the deductible and co-pays.

According to Smith, Lockney Mangold Hospital and the Floyd County Appraisal District office are already on one of these plans and rate increases would be limited to 10 percent per year.

No action was taken on the matter by the court.

County Agent Ragland told the commissioners, "I'm here bragging on this year's Floyd County 4-H Livestock Judging Team. They won 2nd Place at the State 4-H Roundup at Texas A&M, June 5-8, in College Station."

The team is coached by Ragland and its members are: Sence' Foster, Brazos Williams, Segayle Foster and Brady Ragland.

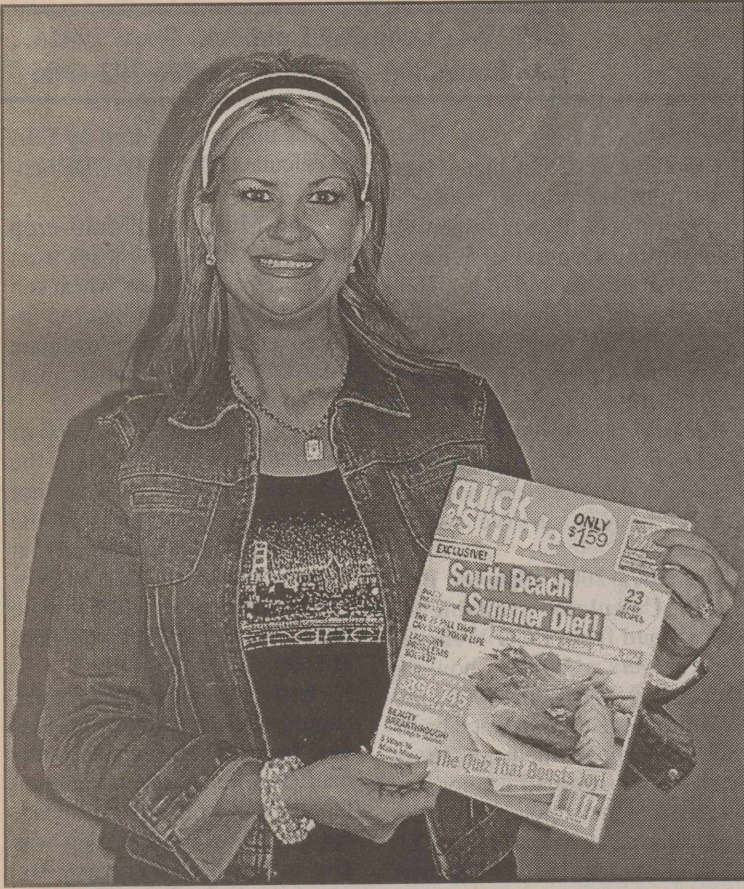

Brandon Rainwater #19 was the Place Kicker. He kicked 2

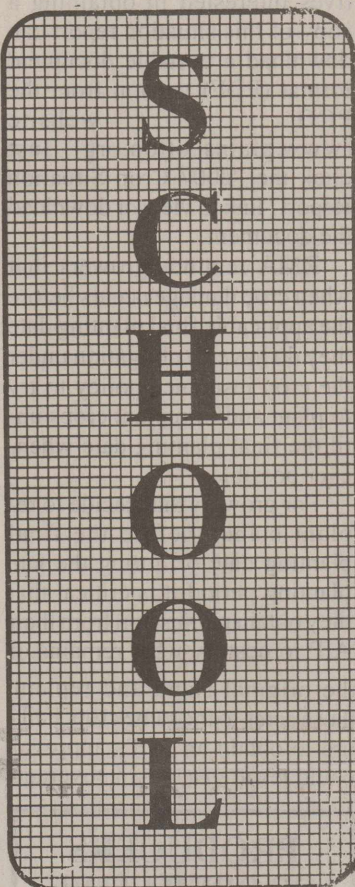
extra points and a 34 yard field goal.

Floyd County Judge Penny Golightly told the commissioners, "This full-time position is already in the county's budget."

A request by Sandra Stafford to install a monitor well on county property inside the city limits of Lockney was unanimously tabled by the commissioners. Quattlebaum made the motion and Commissioner Jon Jones seconded it.

According to Judge Golightly, this is a project by the TCEQ (Texas Commission of Environmental Quality).

The court approved a motion by Commissioner Jones, and seconded by Commissioner Quattlebaum, to accept the highest bids for the 70+ items that were advertised for sale by the county. The court received 21 bids for many of the items, which included a pickup, old benches, desks, chairs and many other miscellaneous surplus county items.

Floyd County Extension Agent Melissa Long reported to the court concerning 'Walk Across Texas' which is already into its fifth week. "We have 11 teams and 87 people involved in this fitness program," said Long.

Long reported to the commissioners also about the 4-H State Roundup, "There were 14 4-Her's involved and the Rifle Team made up of Dillon Chesshir, J.C. Chappell, Bailey Davenport and Jill Bramlet placed 16th. Katie Beth Crossland received a \$12,000 Houston Livestock Show and Rodeo Scholarship."

According to Long, Jill Bramlet received the Blue Award in Photography and two 3rd Places in Fashion Show. Brady Ragland was appointed to the National 4-H Congress. Mike and Ginger Mathis received Distinguished Leader Awards. Cheyann Powell placed 4th in Consumer Education.

Jordan Cornelius, Mason Lipham, Dillon Chesshir, J.C. Chappell, Laci Nixon, Jill Bramlet and Evan Johnson placed 5th in Share The Fun competition, according to Long.

Recent volatile weather has combined with the 2007 growing season's wet and cool start to complicate cropping decisions for cotton producers and crop insurance providers.

Recent thunderstorms which brought locally heavy rainfall, hail and high winds have damaged a significant number of cotton acres on the eve of their federal crop insurance final planting dates.

For many growers the impact of recent weather is very similar to the situation they found themselves in during the 2005 growing season and brings on a strong feeling of deja vu.

As happened in 2005, multiple storms have crisscrossed the area practically on top of the crop insurance final planting dates in the affected areas. Just like 2005, the current situation makes growers unsure of their options going forward and leaves crop insurance providers responsible for making decisions about how they will deal with damaged acres.

To help answer some of the questions involved, Lubbock based Plains Cotton Growers contacted the USDA Risk Management Agency to revisit the rules governing the decision making process an approved insurance provider (AIP) will go through to determine when it is practical to replant damaged stands and when acreage will be released to alternate uses.

As in 2005, RMA officials note the "practical to replant" determination is the responsibility of the approved insurance provider and that current insurance program rules do not specifically require, or create an expectation that, a producer replant damaged stands beyond the final planting date for their county.

This year AIP's seem similarly challenged to determine when it is not practical to replant a damaged stand, even though much of this year's uncertainty is being fueled by the same concerns that triggered consultations on the issue between RMA and AIP's in 2005. AIP's should be able to utilize the knowledge they gained in 2005 to move forward with the process of evaluating and releasing damaged stands this year since many of the same conditions exist.

Based on the feedback PCG has received from RMA, AIP's should be making replant determinations on a case-by-case basis and can take into account a variety of circumstances includ-

ing the amount of growing season remaining until average frost/freeze dates and field conditions to make these decisions just as they have in the past.

By and large the same rules and definitions that concerned AIP's in 2005 are still in force. One change that has come to light, however, is a requirement that documentation supporting the AIP's in 2005 are still in force. One change that has come to light, however, is a requirement that documentation supporting the AIP's determination that it is not practical for a producer to replant be included in the producer's file when acreage is released to other uses and a loss claim is processed.



In an attempt to provide Extension personnel, cotton producers and AIP's with information detailing the current crop situation and prospects for late planted cotton based on long-term average weather patterns, PCG consulted with Texas Cooperative Extension and Experiment Station personnel at the Lubbock Research and Extension Center and developed a situational overview of the 2007 growing season.

Cotton growers, Extension personnel and AIP representatives interested in obtaining a copy of this situation report can download a portable document format (PDF) version from the PCG website ([www.plainscotton.org](http://www.plainscotton.org)). Just click the "2007 Crop Situation Report" link to view or download the document.

RMA reminds growers that when crop damage occurs before the applicable final planting date they do have an obligation under the crop insurance policy to try to plant and/or replant crops until the final planting date whenever possible.

For growers that decide to replant stands before the final planting date or during the late planting period it is critical that they obtain permission from their AIP to destroy what remains of the original stand and replant those acres to the same crop. Failure to obtain an AIP's approval could result in a loss of coverage

For those acres.

For growers that incur damage from hail or other causes it is appropriate that they contact their insurance provider to notify them of the loss and to schedule an evaluation of the damage by a loss adjuster. Such appraisals, especially those triggered by a hail event, are typically delayed at least 7 days from the date of loss so that a more accurate evaluation of the crops potential to recover or survive can be made.

**New 2005-2006 Disaster Program Calculator available for download from PCG Website**

Growers wondering how the recently passed 2005-2006 agriculture disaster assistance package will impact their operations can now download an updated version of the popular Texas Cooperative Extension/Plains Cotton Growers, Inc. Multifarm/Multi-crop Disaster Calculator.

The updated Disaster Calculator is available for download from the PCG website ([www.plainscotton.org](http://www.plainscotton.org)) and from the Texas Cooperative Extension South Plains Farm Assist website ([tceblogs.tamu.edu/mt/spcu](http://tceblogs.tamu.edu/mt/spcu)).

Producers are advised to use the new calculator as an estimation tool only and to check the Farm Assist website or the PCG Home Page regularly for updated versions once a better knowledge of the rules is available.

The calculator can provide growers a clear picture of which farms or units will qualify for the CDP, estimate how much benefit they are likely to receive and help identify records needed to complete an application should the FSA database be incomplete.

Like past CDP programs, much of the information producers need should available to FSA personnel electronically, but it is always a good idea to have backup copies of insurance and production information just in case there is a hole in the data FSA received.

By taking the time to run through their information before getting to the FSA office, growers can quickly identify and fix incorrect information and verify that no eligible farms are being inadvertently left out due to incomplete information.

Texas Cooperative Extension Risk Management Specialist Jay Yates of Lubbock provided this year's update. Jay has updated the highly popular disaster program calculator originally developed in collaboration with Plains Cotton Growers, with statewide county average yields and the

prices that will be used by FSA to calculate 2005/2006 CDP benefits.

The Multi-farm/Multi-crop calculator will allow losses from cotton, corn, sorghum, wheat and peanuts to be put in by crop insurance unit and then estimate total CDP benefits across multiple units.

Due to the wide variety of business structures out there, the new calculator does not attempt to quantify the effects of the \$80,000 payment limitation that is part of the 2005/2006 CDP program, although it will estimate the effects of the 95 percent benefit cap.

To use the calculator a grower should first determine the loss year for which they want to estimate benefits. Growers can then input what crop was produced, the county where the crop was grown, whether the unit was irrigated or dryland, verify if the crop was insured or not and if it was carried to harvest.

In addition to the information outlined above, growers will also need to have the following information to estimate CDP benefits: Actual Production History (APH) yield used to determine the insurance guarantee for each qualifying unit; Harvested production or amount of cotton counted against the insurance guarantee in the year of loss; Planted acres for each qualifying unit; Share of production (percent); Gross insurance indemnity for each qualifying unit; and, the Crop Insurance premium paid on each qualifying unit.

**Upland Cotton Average Price received by growers through April 2007**

Cumulative Upland cotton marketings through April 2007 total 11,856 million bales according to information released May 31 by the USDA National Agricultural Statistics Service.

According to USDA estimates, April 2007 cotton marketings totaled 1.155 million bales with an average selling price of 47.3 cents per pound. So far the 2006 Upland Cotton Weighted Average Price calculated through April 2007 stands at 47.73 cents per pound, slightly below the 47.77 cent weighted average price calculated through the first eight months of the marketing year.

The following table shows the average price received each month by farmers and the associated weighted average price based on prices and cumulative marketings from August 1, 2006 through April 30, 2007.


