T is, perhaps, only natural to be proud of your heritage. There is a fine little lake up in north Texas named for our late uncle, our mother's youngest brother, JAKE J. LOY. The lake is situated in the center of a state park, LOY MEMORIAL. The people of Grayson County bestowed the name. Sherman is the county seat of Grayson and Denison is the other large city in the county. There is also Pottsboro, Whitewright, and other smaller towns in the county. For many years, my late uncle served Grayson County as Judge and the beautiful courthouse there in Sherman was built under his administration. He resigned from the county judge's job once just to run for the state senate and was elected. He made the race so he could go to Austin and introduce a free bridge bill. The people he served up on the Red River-bordering on the Oklahoma line, wanted nothing to do with toll bridges. UNCLE JAKE remained in the Texas Senate two terms-He died in office. The bridges up there across Red River, bear name plates which tell why toll bridges between Texas and Oklahoma were elminiated—by the free bridge bill introduced by SENATOR LOY. As a lad I used to go up in the beautiful section of north Texas and pass out candidate cards for UNCLE JAKE. But back to the lake, and the reason for this paragraph. The state game commission passed out a press release the other day stating that the commission had started a four-step project aimed at cleaning out the popular county lake at the southwest edge of Denison. They are going to fix it up real nice and restock it with fish. That sure would make the fellow who never lost a political race in his life happy and proud. And we are proud that some of his and my late mother's blood courses through our veins too. The Sherman-Denison area is heavily populated by fine men and women of the Catholic faith. My late uncle was a Methodist and a Shriner. But for the many years he remained in officehe really must have been what we like to think he was, a good man and friend to all. BY-THE-WAY, there is a lot of talk about redistricting the old fourth congressional district. That's my home-town district-that's the one represented so long by SAM RAYBURN, the late Speaker of the House of Representatives. MR. SAM and my dad were the best of friends. And when we were very small, CONG. RAY-BURN used to drop in for a meal at our house now and then. It was against the house rules to think ill of MR. RAYBURN. He was sort of a part of many households in his district. No voter in our family ever thought about casting a vote other than for RAYBURN. My dad would have disowned his own flesh and blood for the Bonham congressman. Years after my dad died and they were looking around in Washington for a federal judge in Texas, it was SAM RAYBURN who, for the first and only time in his life, joined the Dallas Bar Association, in endorsing his old friend's boy for the place. EISENHOWER was the president and appointed my brother, JOE. But he didn't do it without consulting SAM RAYBURN. Incidentally, EISENHOWER was born in Denison, SAM RAYBURN represented that city and many others in Congress. Despite political party differences, RAYBURN and EISENHOWER remained good friends through IKE'S administration. And IKE flew down to Perrin Air Force Base in Sherman and motored over to Bonham to attend the last funeral services for RAYBURN. A young fellow from Mc-Kinney is representing the fourth district now. We understand he is very capable. We don't know CON-GRESSMAN RAY ROBERTS, but we hear is doing a splendid job in Washington. For strictly sentimental reasons, I would hate to see the old fourth turned upside down for political concerns.




