BEIRUT, Lebanon (AP) Iran is believed to have pressured pro-Iranian militants to put off killing American hostage Joseph Cicippio, and the chance his life will be spared has increased, Shiite Moslem sources said today.

The group holding Cicippio, the **Revolutionary Justice Organiza**tion, had said it would kill him Tuesday at 11 a.m. EDT unless Israel freed Sheik Abdul Karim Obeid, a Shiite Moslem cleric kidnapped by Israeli commandos July 28. It then extended the

Hurricane warnings were posted for the islands of the Lesser Antilles from Guadeloupe to the U.S. Virgin Islands, said forecasters at the National Hurricane Center in suburban Coral Gables. A watch was in effect for Puerto Rico, Dominica and Martinique.

At 9 a.m. EDT, the center was located near 17.4 north, 58.5 west, or about 500 miles east of San Juan, Puerto Rico. The storm was rushing westward at 20 mph, and conditions were favorable for development, forecasters said.

"It's very warm water. There's not anything in the atmosphere to cause it to break up, so basically it looks good for further development," said hurricane center meteorologist Jesse Moore.

Israel's defense minister, Yitzhak Rabin, today defended the abduction and said the Cabinet considered the dangers to hostages in Lebanon before approving it. He repeated Israel's offer to swap Obeid and Lebanese Shiite Moslem prisoners held in Israel for Israeli soldiers and foreigners held in Lebanon.

The pro-Iranian Hezbollah, of which Obeid is reported to be a leader, has rejected a swap.

President Bush, faced with his most serious foreign policy challenge, consulted world leaders, including Pope John Paul II, and met with his Cabinet twice in 24 hours.

The pope agreed to intervene to seek the return to the United States of the body of Marine Lt. Col. William R. Higgins, reportedly hanged Monday by a Shiite Moslem group.

West Germany said today it had contacted Iran and Syria on the United States' behalf. France also asked countries that might have influence over groups holding hostages to try to ensure the captives' safety.

Bush — oilman, baseball team owner and president's eldest son - publicly declared Tuesday he would not run for governor of Texas next year.

"I have had time to think and sort things out, and at this time. I am not a candidate for governor in 1990," Bush said during a speech to lawyers.

Bush is managing partner of the Texas Rangers baseball team, which is battling for the AL West division title.

#### **Fares are cut**

HOUSTON (AP) - Continental Airlines is lowering fares on most of its nonstop, weekend flights to \$75 each way for the rest of the summer.

In addition, fares on Continental's transcontinental connecting and direct flights will be lowered to \$100 each way for the next five weekends, the carrier announced Tuesday

Tickets for both lowered fares must be purchased on a round-trip basis. About 125,000 seats will be available for the lowered fares on each of the five weekends, Continental spokesman Ned Walker said.

### **Snyder man drowns** at Lake J.B. Thomas

A 30-year-old Snyder man drowned in Lake J.B. Thomas Tuesday night, and scuba drivers found his body at 10:26 a.m. Wednesday in the Rocky Point area on the southeastern side of the lake.

He was identified as Rondly Blevins of 3107 39th St.

A spokesman for the Scurry County Sheriff's Office said Blevins was in a flat-bottomed aluminum fishing boat with his pre-school-age son 60 to 80 yards off shore when the boat capsized about 9 p.m. Tuesday.

The spokesman said the boy, whose name was not immediately available, had a life jacket on and Blevins "apparently didn't" because the father disappeared under the water.

A by-stander on the shore swam out and retrieved the boy, the sheriff's deputy said.

Lake Supt. Richard Halfmann, lake patrolman Doug Frey and Game Warden Mel Reed dragged the lake bottom with hooks up-H about 11:30 p.m. Tuesday and started work again at 7 a.m. Wednesday with the help of sheriff's deputies Charlie Reynolds and Delwin Davis.

Halfmann said using hooks proved difficult in that area, however, and scuba divers Bill and Sid Brooks of Snyder were summoned to assist, discovering the body about 40 feet away from a rock bluff at Rocky Point.

Justice of the Peace R.C. Nixon of Hermleigh was summoned to the scene as a Snyder EMS Ambulance Service ambulance stood by at the lake's south side boat dock.

EMS removed the body, and funeral arrangements were not immediately known.



DALLAS (AP) - In the plane wreck would one day exminutes before Delta Airlines pose their gleeful cockpit conver-

> The tape made by the cockpit voice recorder was released under a judge's order Tuesday. revealing crew member's views on news coverage of other crashes, Jesse Jackson's politics and Marilyn Quayle's looks. The conversation involved the cabin crew and a flight attendant who was forbidden by law to be in the cabin while the plane was in motion.

Fourteen people were killed in the crash at Dallas-Fort Worth **International Airport. More than** 90 passengers survived.

At a hearing in November, National Transportation Safety Board investigators rigorously questioned the crew about the apparent idle nature of the conversation when they should have been going over preflight checklists.

**District Judge Adolph Canales** released the tape over the objec-tions of a Delta lawyer who argued the recording should be made available only to parties in liability suits stemming from the crash of the Boeing 727.

The nearly 10 minutes of conversation, deemed "casual and for Salt Lake City after a stop at non-duty related" and kept Dallas-Fort Worth. secret by the NTSB, was released at the request of WFAA-TV.

The only female voice on the recording was identified by a special court master as that of flight attendant Mary O'Neill, who survived the crash.

Some of the talk apparently took place while the plane was taxiing.

Since 1981, the Federal Avia-tion Administration has had a "sterile cockpit" rule that prohibits any flight crew conversation not related to the operation of the aircraft when the plane is taxiing, and when it is flying below 10,000 feet in an approach or departure. Flight attendants also are prohibited from entering

the cockpit during those periods.

While they waited for takeoff, an unidentified crew member said, "We forgot to discuss about the dating habits of our flight attendants so we could get it on the recorder in case we crashed.'

"Then the media would have some kind of a juicy tidbit," the crew member said.

That was a reference to Continental crew members who were said to have discussed a flight attendant's dating habits before their jet crashed on takeoff in Denver in 1987, killing 28 people. Delta last week accepted

responsibility for the crash and said its own investigation revealed the crew failed to set the wing flaps for takeoff. Delta also announced it had fired the flight's pilot, co-pilot and flight engineer.

Delta spokesman Bill Berry said Tuesday in Atlanta that Ms. O'Neill, who is on medical leave due to crash injuries, has not been disciplined. He refused to say if she would be subject to penalties when she returns to a full schedule.

The flight originated in Jackson, Miss., and was bound





amazed with the quick recovery of a 73-year-old American nun who was seriously wounded by a gunshot in the head six weeks ago during an apparent robbery attempt in El Salvador.

Sister Mary Stanislaus Mackey, a member of the Sisters of Charity of the Incarnate Word, will be moved to a Houston convent this week to continue her recuperation, doctors at Houston's St. Joseph Hospital said Tuesday.

"I think the outcome approaches miracle stage when one considers she was shot in the head at close range with a large caliber handgun," Dr. Rob Parrish, the nun's neurosurgeon, said.

'Sister Stan,' as she is called, was working at an orphanage in El Salvador on June 21 when she was shot with a .38 caliber gun fired from a pickup truck as she rode in another vehicle with two other Roman Catholic nuns.

The bullet shattered her cheekbone. After initial treatment in San Salvador, she was flown to Houston, where her religious order is based.

Physicians in Houston performed a craniotomy June 26 to remove a bullet fragment that lodged in her brain and to relieve swelling in her brain.

A second operation was per-formed July 8 to reattach the retina in her left eye.

"There appears to have been some damage to her optic nerve and we're not sure how much sight she will recover in her left eye," Dr. James Baker said.

Sister Mackey, accompanied by a nurse and using a cane for support, read a brief prepared statement at a news conference Tuesday but declined to take questions.

Sister Ann Mary Brangan, who was in the truck during the June 21st shooting, said the nuns were about three blocks from their convent when the incident occurred.

She speculated robbery was a motive, since the nuns had been at a bank, although they had no money with them.

"We work in a tense type of political situation down there," Sister Brangan, a Bay City native, said. "We knew of the possibility."

She said five or six men accused of the shooting were taken into custody within the past week, but she has been unable to identify them.

Sister Mackey, a registered nurse, is a native of Ireland and a naturalized U.S. citizen. She had worked in Central America since 1963 and in El Salvador since 1983

Despite holding the ace of spades, East should double four diamonds as a lead-directing strategy. East does not expect the opponents to reach slam without some sort of spade control, and a spade lead from partner might just solve a crucial problem for declarer. But the diamond lead would give away nothing and so should be encouraged by East.







CINCINNATI (AP)-Pete Rose once again is proposing that "Jones is an amazing athlete commissioner A. Bartlett a move sure to be rejected.

Robert A. Pitcairn Jr., one of Rose's lawyers, said Tuesday that Rose would propose that an independant arbitrator hear the allegations. Giamatti rejected a similar proposal in June.

"All we have wanted all along is a procedure before a fair and impartial trier of fact," Pitcairn was quoted as saying in Wednesday's editions of the Cincinnati Enquirer.

**Deputy commissioner Francis** T. Vincent Jr. said baseball would not give serious consideration to the proposal.

"We have said to the world we cannot deal with the commissioner's position in this matter," Vincent was quoted as saying. "He is our only authority. We have no one else. ... This issue, in many ways, is about the commissioner's authority and power."

Vincent had said on Monday that baseball would seek to take separate action against Rose for his admission of football gambling that he made in an interview published in last Sunday's editions of The Washington post.

Roger J. Makley, another Rose lawyer, said the manager would oppose any attempt to modify the temporary restraining order issued in June by Judge Norbert A. Nadel of Hamilton County **Common Pleas Court.** 

"After all, the issue remains the same," Makley was quoted as saying. "Pete Rose is still entitled to a fair hearing ... before a person who is fair and impartial. Now, Vincent has joined the crowd in prejudging the issue."

U.S. District Judge John D. Holschuh on Monday turned back Rose's attempt to have the case returned to Ohio state court and scheduled an Aug. 14 hearing on Rose's request for a preliminary injunction. The July 5 stipulation between Rose and baseball that extended Nadel's restraining order was further extended to Aug. 14 by Holschuh.

Rose probably will appeal Holschuh's decision on federal jurisdiction to the 6th Circuit Court of Appeals in Cincinnati.





# **Upper Texas coast drenched** by Chantal-spawned rains

HOUSTON (AP) — Residents whose homes were flooded by torrential rains spawned by Hurricane Chantal began drying out their wet belongings as the storm today moved further into Texas, losing strengt

At least three deaths were blamed on the storm. A man died after falling from a Chevron oil platform in the Gulf of Mexico south of New Orleans and two Bryan teen-agers drowned when they were sucked into a floodswollen drainage ditch.

Chantal roared ashore early Tuesday morning at High Island, bringing with it driving rains and winds up to 80 mph. It lost strength within a few hours and was downgraded to a tropical storm, but it continued to be a heavy rainmaker for much of the upper Texas coast throughout the day.

On Tuesday night, the storm was further downgraded to a tropical depression as it continued to move northwest into Texas. Its winds had decreased to about 30 mph.

By early today, the storm's remnants were located between College Station and Waco, triggering rains and some tornadoes. No damage was immediately reported in central Texas from the storm.

Forecasters said the Dallas-Fort Worth area may get as much as five inches of rain in gusty thunderstorms today.

In sections of south Houston and its southern suburbs, hundreds of stalled cars and trucks lined flooded roads, and some stranded motorists sat atop their vehicles as they waited for the high water to recede.

There also was some residential flooding and scattered power outages, but the first hurricane of the 1989 Atlantic season apparently caused little serious damage.

In Bryan, officers said two youths drowned when they and two friends were riding rubber rafts on a stream swollen by heavy rainfall from Chantal. The



AUSTIN (AP) - The Texas Parks and Wildlife Department wants to balance competing interests in a proposed management plan for the \$186 million-ayear shrimp industry, a spokesman said.

The plan's primary goal is to increase the value of shrimp being landed, said Gary Matlock, director of fisheries for the department. For example, closing state waters at certain periods allow shrimp to grow larger before harvest.

However, he said Tuesday, the department also wants to achieve a balance between the interests of commercial shrimpers, sports fishermen who use shrimp for bait, consumers and wildlife.

"It is clear that the statute directs the department to recognize that shrimp are to be treated similarly to other natural resources managed by the state and country, like oil, gas, or timber," says the plan, which has been sent out for public comment.

The Parks and Wildlife Commission will consider adopting the plan after any changes are made.

Lawmakers ordered development of the plan in 1985, when they gave the commission authority to regulate shrimp fishing in Texas. The Legislature in the past has managed the industry.

The commission, which meets periodically through the year, can react more quickly to changes than the Legislature, which meets in regular session every two years, Matlock said.



# **Phoenix Health Care System** oks letter of intent with firm

PHOENIX (AP) - A 2-yearold Texas-based health corporation has signed a letter of intent to acquire Baptist Hospital and Health Systems, officials said.

The agreement is subject to approval of the physicians who practice at Baptist hospitals and who would be invited to invest in the venture, said Richard Scott, chairman and chief executive of Columbia Hospital Corp. of Fort Worth.

Scott said Tuesday that he would determine how much physician investment was needed to go ahead with the acquisition.

Columbia, started in October 1987 by Scott and other Texas investors, would assume \$230 million in debt owed by Phoenixbased Baptist Hospitals' five hospitals, two nursing homes and other health-related operations, Scott said.

"We are trying to buy larger hospitals in metropolitan areas and develop them into systems," Scott said. "If ... you can find hospitals that have good reputations and markets that are growing, I think you can do well in health care today."

Dwain Hoover, chairman of Baptist Hospitals' board, said the sale would allow the system to grow while still providing for some local management since each hospital would have a local board of directors.

Scott, 36, who was part of a 1987 attempt to take over Hospital Corporation of America, then the nation's largest for-profit hospital group, said he and part-ner Richard Rainwater, 45, would retain ultimate decisionmaking authority. Company of-ficials explained that Columbia operates under a philosophy of decentralized management and physician co-ownership.



### Treating shrinkage of the esophagus

DEAR DR. GOTT: What causes the esophagus to shrink in size, necessitating a person to eat soft foods and liquids? Can the condition be treated or alleviated?

DEAR READER: As we age, our tissues tend to shrink and become less elastic. This process can affect the intestinal tract, the esophagus in particular. Hence, older people may experi-ence difficulty swallowing dry or unchewed food. However, the situation seldom reaches the point where soft foods and liquids are necessary. In this instance, doctors usually look for other reasons to explain the difficulty in swallowing (dysphagia).

The most common causes of severe dysphagia are: tumors, scar tissue or er performs his act. During passage

loss of the normal muscular waves (peristalsis) that propel food from the mouth to the stomach. These conditions can be readily diagnosed.

A barium swallow is a test during which a person swallows a thick, chalky solution. As the barium traverses the esophagus, the person is Xrayed. When properly performed, a barium swallow is extremely useful, a radiologist can identify areas of obstruction or narrowing, as well as de-termine if esophageal peristalsis is normal.

Endoscopy, too, is often used to examine the esophagus. It is usually performed by a gastroenterologist, who passes a flexible, fiber-optic tube through the mouth and down the esophagus, much as a sword swallow-

of the tube, the specialist examines the lining and the motion of the esophageal wall. Tumors, scar tissue and other abnormalities can be observed. Obviously, treatment depends on

the condition causing the dysphagia. If simple shortening and shrinking are present, the patient may be helped by bougienage, a technique of stretching the esophagus using progressively larger devices designed for this purpose. Tumors may have to be removed or treated with radiation or chemotherapy. Scar tissue can be stretched or surgically manipulated. Unfortunately, disorders of esophageal motility, such as those seen in scleroderma, are hard to treat because they affect other body organs as well.

In any case, I believe that patients with persistent or severe dysphagia should be examined by (and under the care of) gastroenterologists, special-ists in disorders of the digestive tract.
