\$500,000 must be put up to continue objection to bond issue

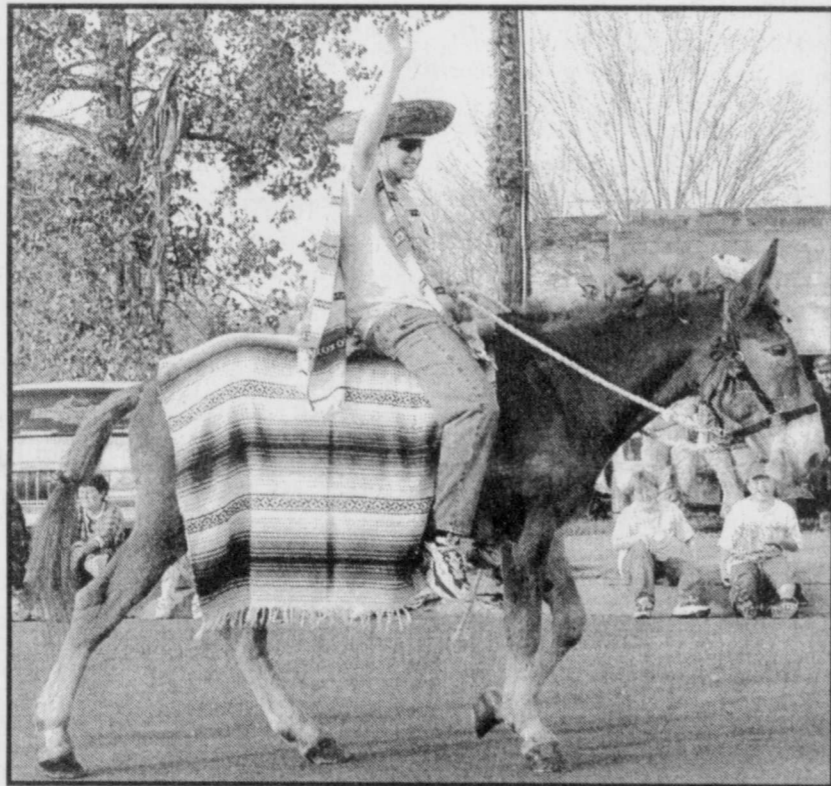
A visiting Judge has ruled that \$500,000 must be put up in order to continue the opposition to a \$9 million Talco-Bogata ISD Bond Election held recently.

Randy Carroll, Roy Marris and Darla Ottinger filed a petition to have the election set aside because of what they alleged were "Voting Irregularities".

The bond issue by only 10 votes in July after a lengthy campaign both for an against the proposal, which was a \$9 million bond issue to construct a centralized campus at Johntown, next to the current River-

crest High School. Visiting Judge H.G. Andrews of Rockwall, sitting in Red River County District Court at Clarksville, ordered the contestants to post the \$500,000

bond to "protect the school's interest against any loss it might incur because of the delay brought on by fighting the suit". The school district has not been able to continue with their consolidation project while the court issue remained unresolved.

Petition circulating to save Deport Clinic

A petition was begun last week to ask McCuiston Regional Medical Center to assume the Deport Medical Clinic after St. Joseph's Hospital and Health Center made the decision to close the clinic. St. Joseph's has generously agreed to relinquish the license belonging to the clinic to allow a citizen's committee to use this as an attraction to getting another hospital interested in operating the facility.

Ron Ragan Executive Director of Business Development at St. Joseph's said "We will assist the community in any way in helping to obtain medical care in Deport. The least we can do is release the license."

The original petition has requested McCuiston to take over the facility and, if possible, keep the current staff in place. However, this does not rule out the possibility of some other hos-

pital assuming the clinic, or a hospital putting in their own personnel.

A citizens committee of Deport people has been formed. Spokesperson Nanalee Nichols says "We feel that the current staff is a definite asset to this clinic, and would make a transition easier. Nurse Practitioner Susan Scholz has many loyal patients. We are aware that anyone looking at the clinic must take all factors into consideration. Our main concern is to keep easily accessible health care available in this town and the surrounding communities."

Anyone wishing to sign a petition will find them located at Deport Times, City Drug, Darden-Sparks Department Store, Guaranty Bank-Deport, Allen's Food Mart or Deport City Hall. Signing should be done quickly, as the petitions needs to be submitted within another week.

Cunningham Community Center houses many memories

There is a lot of history on the walls of the Cunningham Community Center. Photos of the school and military history of the residents of the Cunningham Community grace the center, thanks to Jean Williams and her daughter, Davy Jo Williams.

The military photos date back to the Civil War, featuring John C. Cunningham, father of Sam Cunningham who founded the community by giving any family who would settle there 2 acres of land. Other photos represent Veterans of World War I, World War II, Korea and Vietnam who came from Cunningham.

Photos of Senior Classes graduat-

ing from the Cunningham School date from 1936 through 1970.

Some of the old school photos were lost or destroyed, but the mother and daughter team have worked relentlessly to make copies of individual or created some of the lost and destroyed class photos at their own expense.

One large picture frame that stands out among the rest belongs to Melba Baker. The big red frame houses various photos of individuals and captures a part of the community's past. The frame is constructed from hardwood removed from the center of the Cunningham School's gymnasium. The school's mascot, the Cunningham Warrior, represented the school and

the community's pride for nearly thirty years. Now it is once again a symbol of that pride.

Cunningham is typical of many communities in this area. They no longer have a school, but they still take pride in their memories. They are fiercely loyal to their community, meeting to support the fire department, or to rally around anyone who suffers a loss or disaster. They hold well-attended homecomings, meet at the center for a variety of events, and have many active churches.

The Cunningham Community Center shines with that loyalty and feeling of community which hallmarks so many of the smaller towns in this area. It is a pleasure to behold.

Tis the season... and it is fast approaching... too fast in fact! But this week we are featuring some different candy recipes for everyone to try. I know that everyone is getting ready to hit the kitchen and start that baking and candy-making.

Also this week we have a recipe for a pie crust mix that was sent in from one of our readers. It makes enough for several crusts and can be stored unrefrigerated for up to four months.

We hope you enjoy these recipes and we will see you in the kitchen!

Date Krispie Balls—These will keep well covered and recipe can also be frozen. For a more festive air, add red or green food coloring to coconut!

Marshmallow Divinity—tired of your divinity being running... well this is a sure-fire recipe for everyone!

Peanut Butter Fudge—no one will be able to resist this favorite!

Old Fashioned Fudge—this recipe is an original and was made way before marshmallow creme came into style!

Cap'n Crunch Snacks—this is another one of those snacks that cannot be eaten a little bit at a time!

Crispy Pecans—store these in an airtight container... if they last that long!

Pie Crust Mixture—everyone needs a good pie crust recipe and this one make enough to keep a supply of crusts. This one was sent to us by Nanie Bell Hamm of Deport. She received it from her friend Pauline Gilliam of Malvern, Ohio. She tells that the crust can be stored unrefrigerated and when she wants a crust she just measures out a portion and mixes for the amount of crusts she needs. She has kept this up to as long as 4 months in an airtight container. A baked crust also can be kept for an indefinite time.

Internet service affects millions of men

Millions of young men were given an easier way to fulfill a civic and legal responsibility on December 2. As of that date, 18 through 25-year old male U.S. citizens everywhere were able to register with the Selective Service System using the Internet.

Federal law requires virtually all men to register with Selective Service within 30 days of turning 18. About 1.8 million men are required to register each year. Although late registrations are accepted, a man cannot register after reaching age 26. Failure to register is a felony. Registration is linked to many federal and state benefits. Male immigrants who fail to register as required cannot obtain citizenship. Half of the states have supporting legislation which precludes men who are required to register, but who have not done so, from receiving many state benefits, like state tuition assistance, eligibility for state jobs, and enrolling in state post-secondary institutions.

Although the U.S. relies on an all volunteer military today, the Selective Service System and the registration program help America remain prepared to reinstate a timely and fair draft in a future crisis, should a draft become necessary.

Christmas Candy Recipes

Date Krispie Balls
1 stick margarine
3/4 cup sugar
2 egg yolks-beaten
1 cup chopped dates
2 teaspoon vanilla
1/8 teaspoon salt
1 cup pecans-chopped
2 cups Rice Krispies cereal
1 package Angel Flake coconut
Over low heat, cook margarine, sugar and egg yolks; add dates. Cook and stir for 10 minutes. Remove from heat and add remaining ingredients except coconut. Cool slightly and roll into balls in coconut.

Marshmallow Divinity
1 pint marshmallow creme
1/2 cup water
2 cups sugar
pinch salt
1/2 cup chopped pecans
Place marshmallow creme in large bowl. Combine sugar, water and salt in saucepan. Bring to rolling boil and boil only two minutes or softball stage. Pour hot syrup over creme and stir until mixed. Stir until candy loses gloss. Add pecans and drop by spoonful on to waxed paper or pour into buttered dish and cut into pieces when cool.

Peanut Butter Fudge
2 cups sugar
1/2 can condensed milk
1/4 cup light corn syrup
1 cup peanut butter
1 teaspoon vanilla
Mix sugar, milk and syrup in pan. Cook on low heat until it reaches a soft-ball stage. Remove from heat and add peanut butter and vanilla. Mix well and pour into 8-inch buttered pan.

Old-Way Fudge
2 cups sugar
1/2 cup cocoa
1 cup sweet milk
1 teaspoon vanilla
2 tablespoons melted butter or margarine
Mix sugar and cocoa in saucepan. Pour in milk a little at a time until all ingredients are mixed. Add vanilla and melted butter. Cook until soft-ball stage or thick. Cool and stir until thick. Pour into buttered platter or pan.

Cap'n Crunch Snacks
1 cup Karo syrup
1 cup sugar
12 ounces peanut butter
2 cups Cap'n Crunch cereal
1 package dried apricots-chopped
1 jar dry-roasted or salted peanuts
Combine syrup and sugar together in a saucepan. Boil for 1 minute. Add peanut butter, cereal, apricots and peanuts. Mix well and drop by spoonful onto wax paper.

Special K Drops
1 cup sugar
1 cup white corn syrup
2 cups peanut butter
1/4 teaspoon salt
6 cups Special K cereal
Bring sugar and syrup to boil; take off heat. Add peanut butter and salt. Beat until smooth. Add cereal and drop by spoonful onto wax paper.

Crispy Pecans
2 pounds shelled pecan halves
1/4 teaspoon salt
3 cups sugar
1/2 cup honey
5 cups oil
Wash pecans thoroughly. Fill wok or heavy pot with water about halfway and put in pecans. Bring to boil and let boil for three minutes. Drain and wash them again. Pour 4 cups water into pot. Add salt, sugar and honey. Return pecans to pot and cook 20 minutes or until liquid begins to thicken. When thickened, pour contents into a large bowl and let them soak for 24 hours. Remove pecans and drain with strainer. Heat oil to 350 degrees and add pecans. Stir occasionally until pecans turn golden brown. Remove and let cool completely.

Pie Crust Mixture
6 cups flour
1 teaspoon salt
2-1/4 cup vegetable shortening
Mix together flour and salt using a pastry blender or your fingertips. Work shortening into flour mixture until resulting crumbs are about the size of dried split peas. Store tightly covered in container. To make crust measure out 3 cups of mixture and add 8 tablespoons of water. Mix and shape into dough. If necessary add more water.

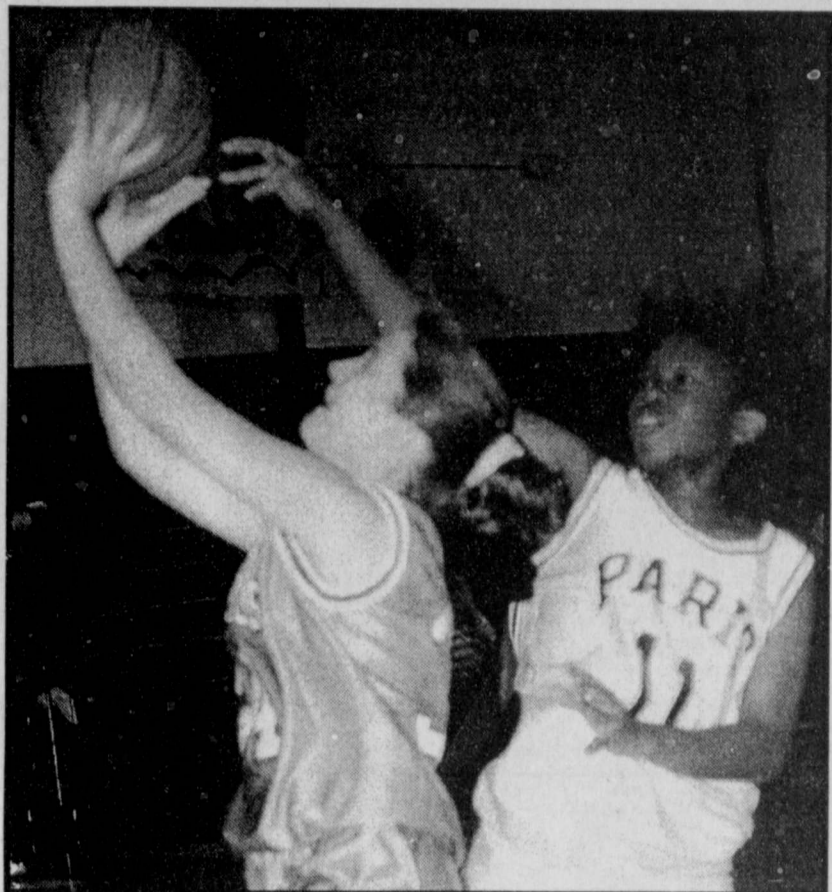

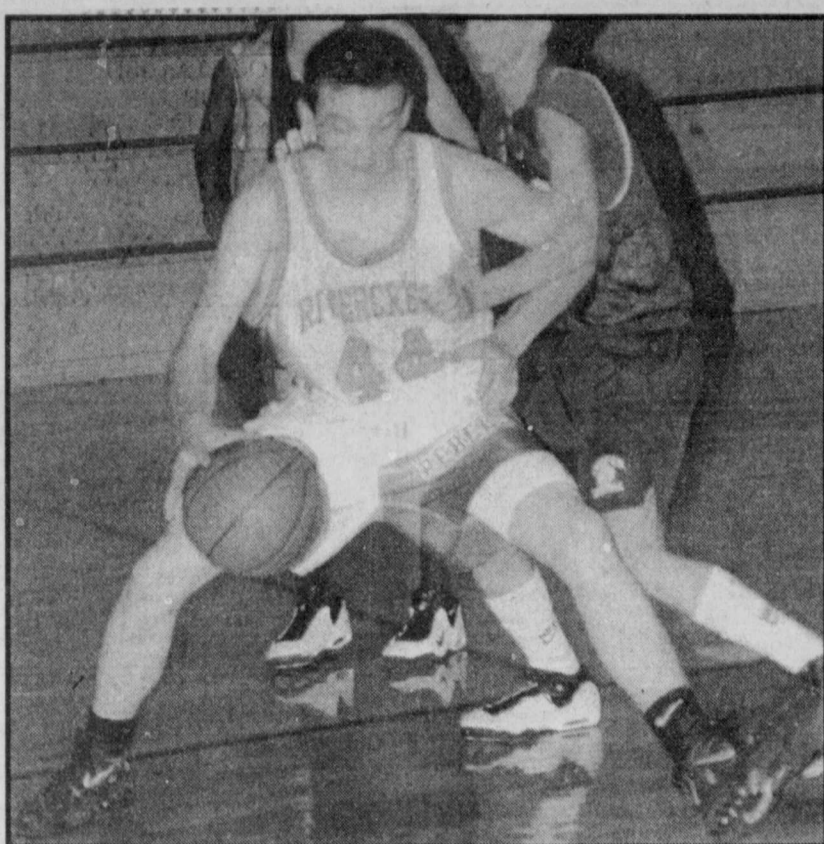

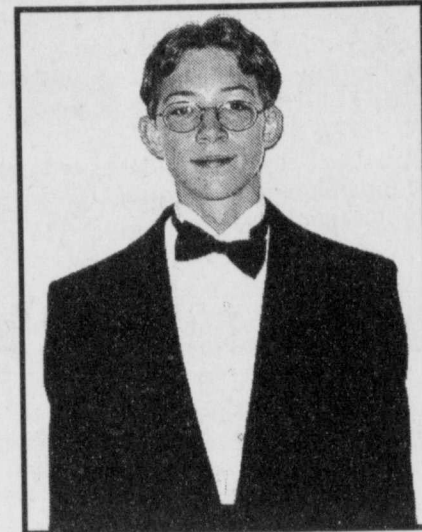

It's not taught in any driver's ed course, but it is a basic three-step lesson of *Driving 101*: drive up to the gas pump, select the grade of gasoline you want and fill 'er up.

Over the years, the Texas Department of Agriculture has worked to ensure that when you paid for a gallon of gasoline, the pump was accurately providing a gallon of gasoline. Now TDA inspectors are looking closely at the octane levels posted at the pump to verify what you're selecting is actually making it into your tank.

Under a comprehensive octane testing program now underway, TDA inspectors collect samples for both octane and alcohol analysis during routine gas pump inspections. Those service stations found selling gasoline that doesn't match up with the posted octane levels face a fine of up to \$500 per violation.

An octane rating in gasoline measures how the fuel performs in an engine. In many engines, the higher the grade the lower the probability of engine knock. For that reason, many consumers choose to spend a little more to pay for higher octane gasoline.

More than 40 states have an octane testing program. And if their experience is any gauge for Texas, then consumers here will discover that the vast majority of service stations are selling you exactly what they say.

It's a shame that TDA's strong commitment to consumer protection isn't taught in driver's ed either. But rest assured those efforts take place every day to help you steer clear of problems at the pump.

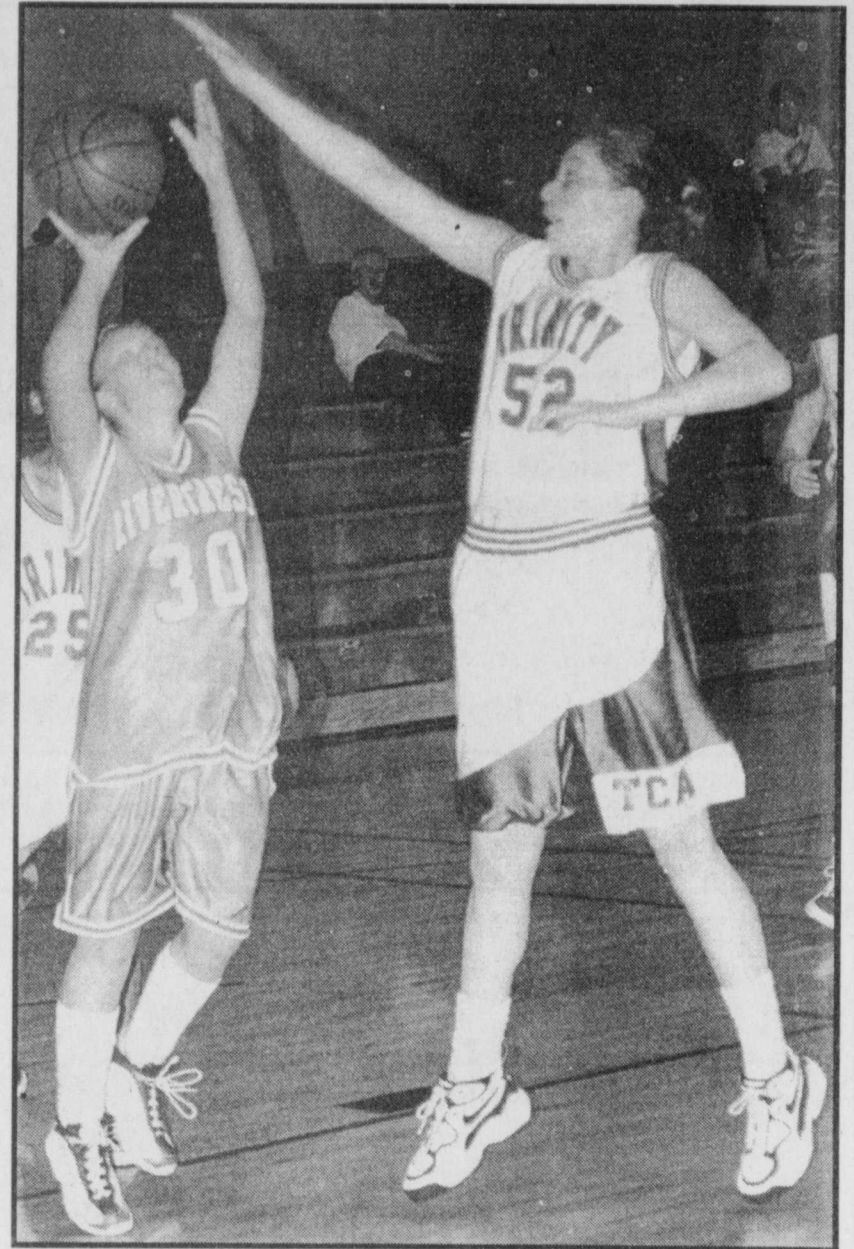

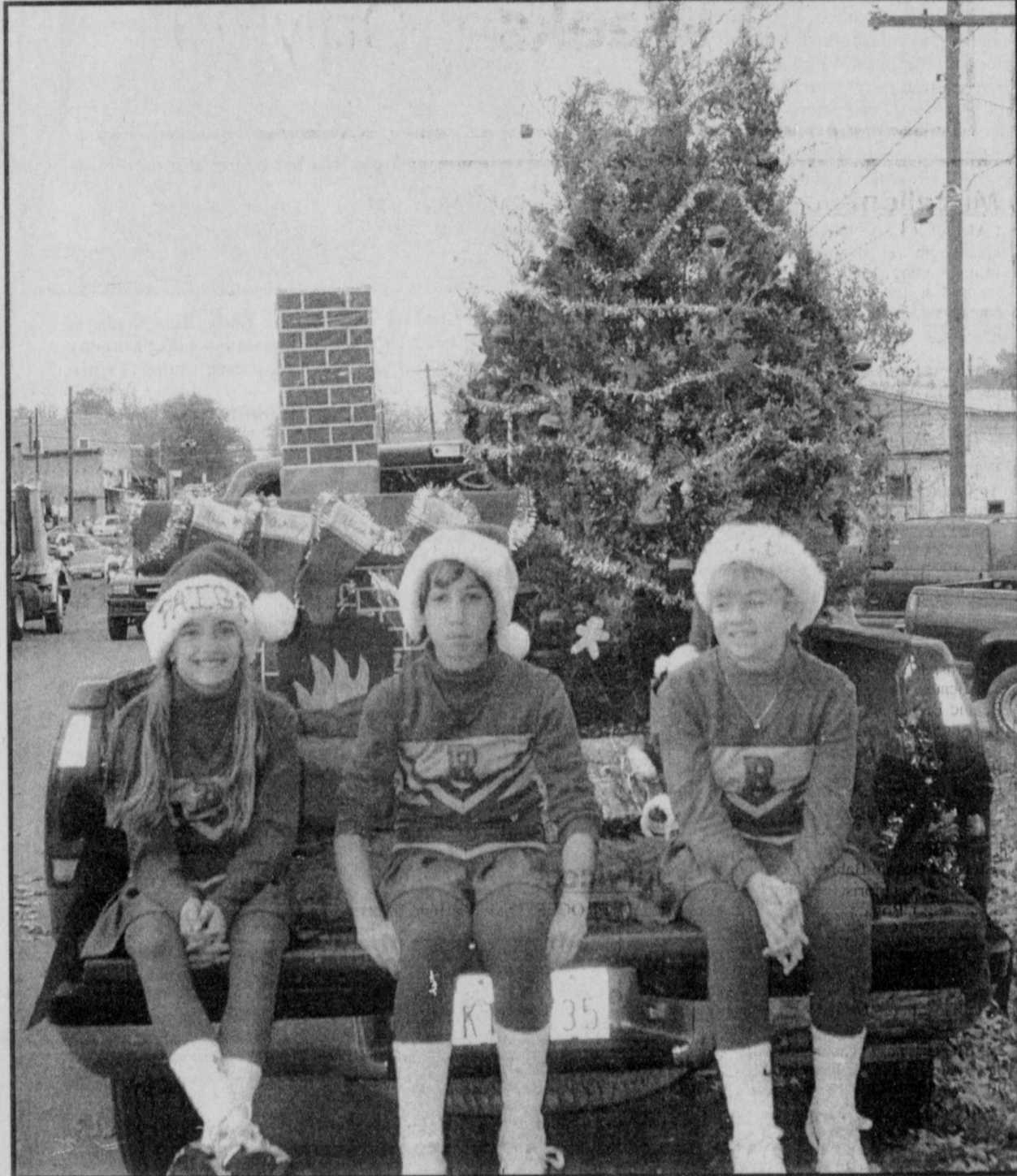

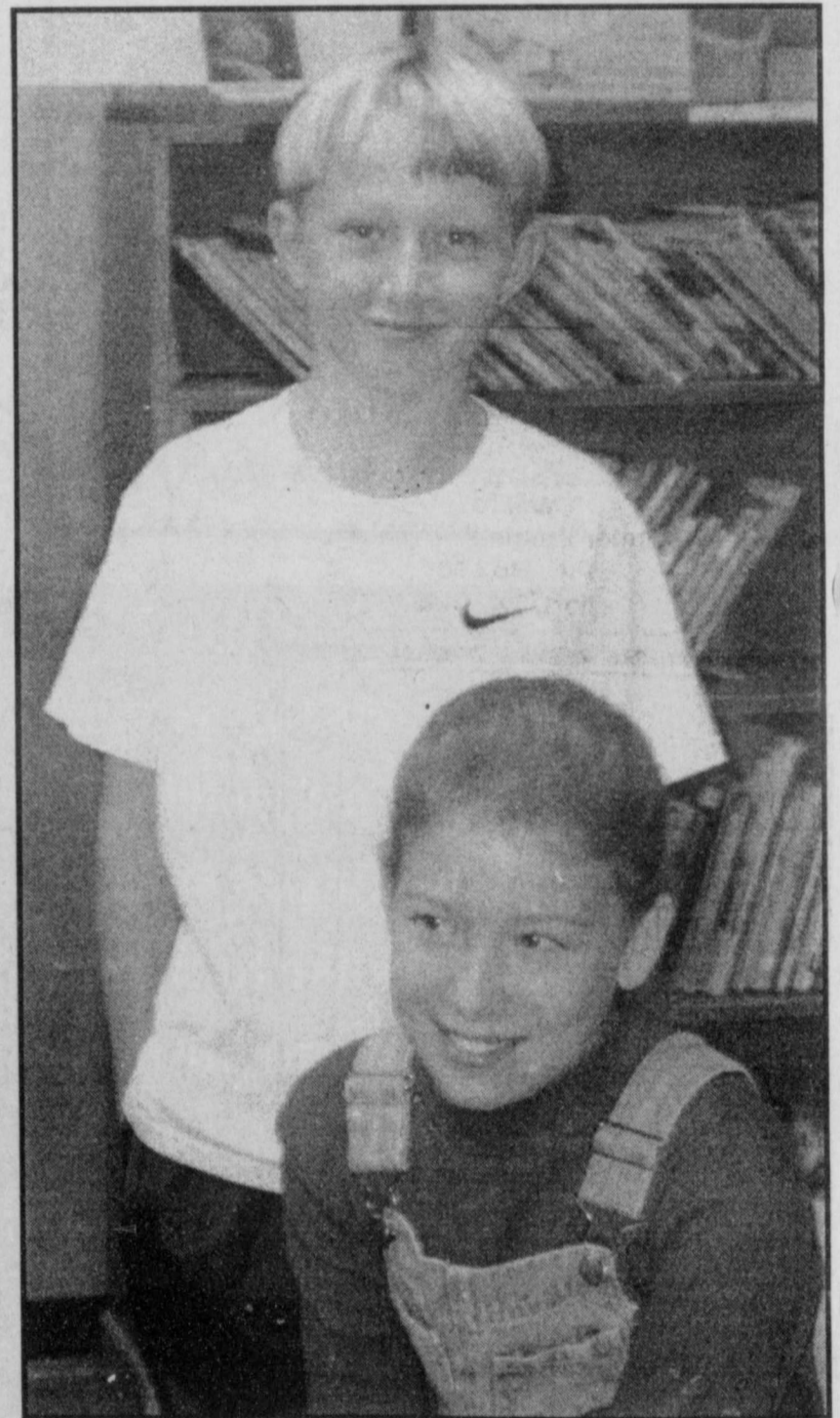
