Emergency Farm Loans Being Accepted

Applications for emergency farm loans for losses caused by severe storms, tornadoes and flooding that occurred from June 16, 2007 through August 3, 2007 are being accepted at the Farm Service Agency (FSA) office located in Vernon, Texas, FSA Farm Loan Manager Kelley R. Boone said today.

Wilbarger, Archer, Baylor, Knox and Wichita Counties in Texas were recently named by President Bush eligible for loans to cover part of actual production losses and physical losses resulting from the severe storms, tornadoes and flooding from June 16, 2007 through August 3, 2007.

Boone said farmers may be eligible for loans of up to 100% of their actual losses or the operating loan needed to continue the agriculture business, whichever is less. For farmers unable to obtain credit from private commercial lenders, the interest rate is 3.75 percent.

"As a general rule, a farmer must have suffered at least a 30 percent loss of production to be eligible for an FSA emergency loan," Boone said.

Farmers participating in the Federal Crop Insurance program and Crop Disaster Program or have property insurance will have to consider proceeds from those programs in determining their loss.

"Applications for loans under this emergency designation will be accepted until April 7, 2008 but farmers should apply as soon as possible. Delays in applying could create backlogs in processing, with possible delays into the new farming season," Boone said.

FSA is a credit agency of the U.S. Department of Agriculture. It is authorized to provide disaster emergency loans to recognized farmers who work at and rely on farming for a substantial part of their living.

Eligibility is extended to individual farmers who meet U.S. citizenship requirements and to farming partnerships, corporations or cooperatives in which U.S. citizenship requirements are met by individuals holding a majority interest.

The FSA office in Vernon, Texas is open from 8:00 a.m. to 4:30 p.m. Monday through Friday.

AUSTIN - Six hundred and fifty-four new state laws took effect on Sept. 1. The 80th Texas Legislature also passed 670 bills that became law immediately last spring. Another 22 bills will take effect on Jan.

The subject matter of the laws effective Sept. 1 is wideranging.

Major among them are money issues affecting nearly everyone: the state's 2008-2009 budget (House Bill 1) and

school property tax reduction (HB 2).

The Texas Department of Public Safety drew up its own list of safety-related new laws and on Aug. 20 posted the list online at www.txdps.state.

Here are a few traffic and criminal laws mentioned there: · HB 8, "Jessica's Law," imposes a 25-year minimum sentence for sexually violent offenses against children under 14; eliminates eligibility for parole for certain sex offenders; makes a second conviction of a sexually violent offense against a child under 14 a capital felony; mandates Global Positioning System monitoring for offenders committed under the sexually violent predator statutes; extends the statute of limitations for sexually violent offenses against children under 14 to 20 years past the victims'

18th birthday; and clarifies that

harboring a sex offender in violation of registration is an offense punishable by up to a third degree felony.

• SB 6 increases the penalty for sexually explicit online communication with a minor who is 14 to 16 years old from a state jail felony to a third degree felony and increases the penalty for online sexual solicitation of a minor who is 14 to 16 years old from a third degree felony to a second degree felony.

• SB 1315 requires the DPS to develop an alert system for missing senior citizens similar to the Amber Alert Program for abducted children.

• HB 323 requires all new buses purchased by a school district on or after Sept. 1, 2010, to be equipped with lap/shoulder seatbelts. All buses contracted for use by a school district on or after Sept. 1, 2011, must be equipped with lap/shoulder seatbelts. But, the

Legislature first must appropriate funds to school districts to cover the cost.

• SB 1287 requires certain establishments that sell alcohol to post specific notification regarding the offense of human trafficking in both English and Spanish along with the number to the national human trafficking hotline.

• SB 378, known as the "Castle Doctrine," removes the requirement that persons attempt to retreat before using deadly force to defend themselves.

• HB 1766 makes a state jail felony of the theft of wiring or cable that consists of at least 50 percent aluminum, bronze or copper and that has a value of less than \$20,000.

• HB 1355, "Lillian's Law," requires all dog owners to properly secure their dogs on their property. A dog owner now can be held criminally responsible if the dog causes serious bodily

injury or death at a location other than the owner's property in an unprovoked attack during which the owner, by criminal negligence, failed to secure the

The law exempts certain professionals, including peace officers, who deal with dogs on a regular basis.

Court rules in challenge to pledge

A Dallas federal district court on Aug. 28 denied a North Texas couple's attempt to prevent school children from reciting a revised Texas Pledge of Allegiance.

David Wallace Croft and his wife, Shannon, sought a preliminary injunction because the Texas Legislature, in the recently ended session, passed a law adding the words "one state under God" in the state pledge.

Texas Attorney General Greg Abbott commented on the

ruling. In regards to precedent, Abbott said the U.S. Supreme Court repeatedly has held "patriotic acknowledgments of the Almighty such as these" are consistent with the U.S. Constitution.

The voluntary, teacher-led recitation of the state pledge follows the U.S. Pledge of Allegiance.

Abbott's legal brief argues that instead of conflicting with the First Amendment, the state pledge reflects the protected freedom of religion.

On June 15, the wording of the pledge changed to this: "Honor the Texas flag; I pledge allegiance to thee, Texas, one state under God, one and indivisible."

Before the change, the pledge was worded, "Honor the Texas flag; I pledge allegiance to thee, Texas, one and indivisible."



But my personal best to date, I realized, settin' on that pretty piece of range land consecrated by cowboys, cows and Coronado, is to be the last man to punch a cow on its fertile, fragile skin. Back in the saddle I gave So, bring on the cement boys, paint her face, Botox her wrinkles and pave her veins till she pings like a floozy.

I knew her when...and ya can't take that away from me.

Spotty Hunting Not **Enough To Keep Hunters** Away



They did — but the caller, identified as 39-year-old Richard Harris, didn't need medical help. He needed a ride to his home in North Avondale, Ohio.


Harris was arrested and charged with making false alarms, a charge carrying a maximum sentence of 180 days in the county jail.


