






# Physician Assistant Chooses **Knox County To Complete Rural Clinical Training**

Katie Hare, a Physician Assisant student enrolled at the University of North Texas Health Science Center in Ft. Worth will be completing 160 hours of clinical training under the guidance of a preceptor, Dr. Kevin Finley at the Munday Clinic beginning February 25th, 2008.

In addition to the teaching support that Ms. Hare will be receiving from Dr. Finley, the Knox County Hospital, Administer Stephen Kuehler, will provide housing for Ms. Hare while she is completing her training in the community. Katie Hare is originally from Bogata, Texas. She completed her undergraduate degree (BS) at Texas A&M University in College Station,

majoring in Biology. Meeting the health needs of rural communities continues to be a focus of Area Health Education Center (AHEC) programs in Texas. Providing the opportunity for students in health professions programs to complete clinical training in rural areas not only gives the student a glimpse of what rural medicine entails but also allows the community the opportunity to recruit health professionals for the long-term future.

AUSTIN - Turnout for the March 4 primary elections likely will reach a record number.

Texas Secretary of State Phil Wilson, the state's chief elections officer, on Feb. 27 projected an overall turnout of 26 percent of the registered voters in Texas. That is 3.3 million voters.

The previous record came 20 years ago in the 1988 presidential primaries, with 2.7 million Texas voters casting ballots.

To predict turnout, the secretary of state's office factors

in early voting from Texas' 15 most populous counties: Harris, Dallas, Tarrant, Bexar, Travis, Collin, El Paso, Denton, Hidalgo, Fort Bend, Montgomery, Williamson, Nueces, Galveston and Cameron. About 60 percent of all voters in Texas are registered in those counties.

#### Candidates push hard for Texas

Texas continued to prove itself a battleground state for presidential candidates in the last few days leading up to the March 4 primaries.

Polls pointed toward a close finish in the race between U.S. Sens. Hillary Clinton and Barack Obama for the Democratic presidential nomination.

U.S. Sen. John McCain of Arizona and former Arkansas Gov. Mike Huckabee, vying for the Republican presidential nomination, spent time and energy in delegate-rich Texas.

Candidates seesawed back

and forth between Texas and Ohio, a state sharing the March 4 date for its primaries.

### Senate panel hears 'Gaps' update

The Senate Education Committee met Feb. 27 to hear from state education officials about the implementation of reforms passed by the Legislature last session.

Texas Commissioner of Higher Education Raymund Paredes reported on the "Closing the Gaps" initiative, a program to increase college enrollment and graduation rates for all Texas high school students.

Paredes said the state is on track to meet its enrollment goals by 2015, adding 235,000 more college enrollees as of 2007. Also, he said, minority enrollment is up since 2000, with an increase of 49 percent for Hispanics and 38 percent for African-Americans.

College completion rates

were also up, said Paredes, increasing by 152,000 degrees in the last seven years. Again, the largest percentages of growth were among minorities, with a 67 percent increase in college graduation for Hispanics, and 44 percent for African Ameri-

#### DPS gives details of cocaine bust

The Texas Department of Public Safety announced Feb. 27 it seized 360 pounds of cocaine after DPS Commercial Vehicle Enforcement troopers stopped a flatbed tractor trailer for a routine inspection.

The cocaine, with an estimated street value of \$3 million, was discovered in 142 individual packages in a secret compartment in a flatbed trailer.

The stop and seizure occurred Feb. 24 on U.S. 90 about 18 miles west of Brackettville at the Kinney County and Val Verde County line, a DPS

spokesperson said.

A Piedras Negras, Mexico, resident was arraigned Feb. 26 in Del Rio on federal drug charges in connection with the seizure.



#### **Disaster proclamation** renewed

Gov. Rick Perry on Feb. 29 renewed a disaster proclamation, originally issued Jan. 29, to address the threat of wildfires across the state. He identified 32 additional counties as threatened or impacted by wildfires, making a total of 216 counties at risk. To date, fires have destroyed homes and burned more than 500,000 acres.





A pastor doesn't have to be in ministry very long to hear more than enough excuses that people use to justify their absence in church. Yet, most people truly believe that he or she believes that there is one Supreme Being and His name is God. In fact, if you ask people, "Do you believe in God", you can't find hardly anyone who will say no! So, why don't you come to church? Typically people who don't come to church will have at least one of three reasons:

1. I'm not going to be a hypocrite like so many people that I know in that church! You might possibly be right. There may be some hypocrites in church. 
1. Attending church is like other places; you're sitting with people just like you.





Of course, we would like to have even more, and anticipate that we will next time, as word gets around that we really do have good jobs available in Knox County, as well as the assistance in finding and qualifying for these jobs." And according to Farrar, many of the visitors seemed surprised by the quality of information and opportunities available to them in Knox County and expressed interest more job fairs.

Over a dozen businesses and agencies present kept the large crowd moving from booth to booth with helpful information and ich opportunities

and job opportunities. Also available with job search services, career opportunity and training information and financial assistance for education and training were the Texas Workforce Commission, Workforce Solutions, Texas Department of Health Services and the Big Country Health Education Center, who, according to Farrar, were impressed with the participation by businesses and the turnout at the job fair. Each business and agency addressed those in attendance before those in attendance visited the booths.

Knox County Judge Travis

Floyd and Dr. Darryl Birkenfeld, Director of the Ogallala Commons program also spoke with the assembly about the Visioning Group and the Real Ranch Country Community Cluster.

### "Let Me Repay My Overdraft In Installments Or I'll Shoot You With My Water Pistol!"

Police in Viborg, Denmark, say that a man was placed in protective custody there on February 29 for robbing a bank with a water pistol after his bank refused to let him repay an account overdraft in installments.

The unidentified man, originally from Germany, had been living in Denmark for almost 50 years, walked into a Sydbank there on February 28 wearing dark glasses and carrying a cane.

Pointing a water gun, he politely asked her to give him a bit of

"Don't worry," he said, according to media reports. "I don't shoot people."

He left the bank with a plastic bag filled with about 30,000 kroner (about 4,025.13 euros, about US\$6,113.59), but only managed to walk some 985 feet before he was stopped by the cops.

By that time, his loot had become worthless after an exploding dye pack placed in the bag by the teller exploded spraying the money — and his clothing — with red ink.

The man planned the holdup after he overdrew his account when redecorating his new apartment in a retirement home and his bank refused to set up a repayment plan for him.

According to police, it remained unclear whether the man had robbed his own bank.

On February 29, the man happily accepted being sent to jail, telling the judge, "I don't want to return to my apartment. I'm too ashamed."

### Thief Gives Witnesses His Real Address

Police in Hurstpierpoint, England, have arrested a drunken burglar after he gave witnesses his real address.

The man, identified as 37-year-old Leon Gladding, tried to break into a house there on New Year's Eve.

He had been drinking all day.

Neighbors were alerted as he stumbled about, removing fence panels and glass from a window.

They found Gladding at the back of their neighbor's home on Western Road.

He told them that he had disturbed someone else breaking into the house and said that he was on his way home.

"The neighbors tried to detain him but let him go when he became

unruly," prosecutor Rhiannon Sadler said.

"He said he was going to 42 Kemps, Hurstpierpoint, because he

lived there."

The neighbors called the cops who went to the address and arrested Gladding when he answered the door.

He stuck to his story that he had disturbed a burglar at the house on Western Road.

Gladding maintained the pretense even when tiny pieces of glass from the smashed window were found on his jumper.

He told detectives that it got there after a window was smashed

when his own home was broken into on Christmas Eve.

However, he later admitted the attempted burglary on December

However, he later admitted the attempted burglary on December 31, 2007, and appeared at Hove Crown Court for sentencing February 25.

The court heard that Gladding has a string of previous convictions for theft, burglary and attempted burglary.

Andrew Selby, his defense attorney, said that Gladding had acted

Andrew Selby, his defense attorney, said that Gladding had acted stupidly and made an unsophisticated attempt to break into the house while drunk.

Judge Cedric Joseph sentenced Gladding to a year in jail.

"To suggest that you should receive anything other than an immediate prison sentence today is just ridiculous," Judge Cedric Joseph said.

"The fact that you were drunk and stupid enough to give your own address is not a mitigating factor at all.

"A stupid criminal is as much to blame as a clever criminal. As a result of your stupidity you got caught."

# Getaway Complicated Due To Car's Hood Being Up

A robbery suspect in Dallas, Texas, gave a whole new meaning to driving blind the evening of February 29.

According to police there, a woman had pulled over her overheating car around 6:20 p.m. at Elisha Pease Elementary School in the 2900 block of Cummings Street, near East Ledbetter Drive and Bonnie View Road.

The car's hood was up, and the woman was going into the school to ask for help when a man approached her. He threatened to harm her, then drove away in her car — with the hood still up.

A police officer who was in the area saw the car and gave chase. The unidentified man hit two vehicles before crashing into a tree. He fled on foot before he was caught. There wee no serious inju-

ries in the accident.

Police said that they expected to file a robbery charge against him.






