Knox County 4-Her's Place at Fort Worth Stock Show

The 2011 major stock show season kicked off at the legendary Fort Worth Stock Show & Rodeo where it celebrated it's 115th year of existence. Fort Worth is usually one of the coldest and wettest shows of the show trail, but it was especially cold and wet this year with a mix of snow, sleet, rain, and single digit temperatures. Although the temperatures were cold outside and inside of the barn, the show ring was burning up with Knox County participants competing in the goat, rabbit, and swine shows. 

People kill people

Those who advocate gun control take heed: Maksim Gelman, 23, is charged with killing his ex-girlfriend and her mother as well as his father and a pedestrian with a knife.

Gelman is alleged to have stabbed his father to death in in Brooklyn. Police say he had a fight with his mother when she refused to let him use her Lexus and his 54-year-old father intervened. Six hours later he arrived in his ex-girlfriend's house, where he murdered her 56-year-old mother, also with a knife.

Yelena Bulchenko, 20, the girlfriend, called the police when she found her mother's body. However, Gelman was still in the house and chased her outside before stabbing her 11 times.

While fleeing the scene in the Lexus, the suspect hit 62-year-old Stephen Tanenbaum, who later died of his injuries.

The bottom line is this: people have been killing each other forever. If it's not guns, it's knives. If there are no knives around, they'll use rocks.

Let's say the federal government decides to rewrite the constitution and take away firearms from citizens. That's a tall order. How many of you would surrender your guns without putting up a fight?

Wisconsin Takes on Big Labor

Wisconsin is yet again leading the way forward for the entire nation. Governor Scott Walker, in a bold and brave step, is making drastic and far reaching changes to the relationship between his state and the government employee unions that represent Wisconsin government employees.

The changes could not come soon enough, as Wisconsin is facing devastating budget shortfalls.

The plan proposed by Governor Walker effects most state and local employees, including teachers. Most local law enforcement and fire fighters will be exempt from his proposal.

- Eliminates the ability of state employees to bargain over anything except wages. This excludes benefits and work rules from the bargaining table;

- Prohibits state agencies from collecting union dues;
- Requires wage increases above and beyond inflation to be approved by a popular referendum;
- Requires state employees to contribute half of the cost of their pension payments, up from nothing now. This works out to 6 percent of their salaries;
- Requires state employees to cover 12 percent of their health-care premiums.

In effect, Walker's plan completely curbs the power of the union — a good first move to get Big Labor's money sucking tendencies under control.

Of course, Big Labor doesn't feel good about Walker's proposal. Reacting to the Governor's plan, Wisconsin State AFL-CIO President Phil Neuenfeldt said, "Instead of balancing the budget on the backs of hard-working Wisconsinites, we need to come up with a balanced approach that looks at shared sacrifice from everyone."

The statement from Neuenfeldt ignores the fact that the budget shortfall burden is indeed on the backs of hard-working Wisconsinites. After all, the taxpayers in Wisconsin are the ones who pay the bills that the government and the union, rack up.

And why shouldn't taxpayers have the right to decide if state employees should receive compensation raises that are absurd anywhere else in the marketplace. Governor Walker's proposal would drastically limit the ability of public sector unions to extort absurd levels of compensation from Wisconsin taxpayers.

If passed, the proposal would also severally limit the ability for the extremely partisan union in playing a major role inside of government.
