"We had an open house as part of the celebration honoring the Postal Service's 20th birthday," said Postmaster Larry Ward.

"An open house is an excellent way for people to get a behind-the-scenes view of how their mail gets processed and delivered," Ward continued.

The Silverton Post Office has five employees delivering 2300 pieces of mail to 510 addresses daily.

The Postal System has changed more in the last 20 years, since the creation of the Postal Service, than in any other time in history, and I enjoyed having the community share in the celebration," Ward concluded.

Silverton Student On **Dean's Honor Roll**


A student from Silverton has been named to the Dean's Honor Roll for the spring semester at Wayland Baptist University, it was announced today.



Pot Luck is Fun, But It's Not Good Business

Pot luck dinners are a favorite American pastime, and an excellent way to put a good meal together for a large gathering of people. Pot luck, however, is a poor way to do business. Most doctors, dentists and other professionals will allow unannounced visits only in an emergency. They work best from an appointment schedule.

For many years Social Security offices served the public primarily on an unscheduled walk-in basis. In the last few years Social Security has emphasized telephone and walk-in appointments as the standard way of conducting business. It has proven both more efficient and more economical.

In fact, we began appointment scheduling as an experiment. As late as two years ago, only 20-30 percent of our work was conducted this way. Many offices now process over 70 percent of their claims by appointment

their claims by appointment.

The public has responded very well.

They like not having to wait to talk to a representative, something that can happen in many offices. With an appointment, people know that on a certain day at a certain time, they will see or talk to a Social Security representative.

When we handle work by telephone, all the paperwork is sent through the mail. Claimants often don't have to visit the offices at all. In urban areas, this is a real help to the public.

Money Talk

Several people have written me recently seeking advice on how to obtain a credit card once their credit record has been damaged. This is a common problem and, unfortunately, often can be difficult and frustrating. If you can't qualify for a credit card yourself, you may want to consider

applying for a "secured" credit card.
Some banks offer this type of card for customers who have had credit problems or who have no credit at all. To receive a secured credit card requires a minimum savings account deposit to an issuing bank, generally a minimum of \$250 or more, which guarantees payment of your credit card purchases. I would recommend that you contact your bank or one that offers secured credit cards to investigate this possibility. It would be much better than calling a credit repair agency or service that charges you a fee to try to get a card for you.

Fireworks Present Fire, Injury Dangers

Independence Day 1991 will be a joyous celebration, marking the traditional holiday and the victory of the United States and its allies in the liberation of Kuwait; however, if Texans follow their traditional habits, July 4, 1991, also will be marked by tragic fires caused by the careless use of fireworks.

"Fireworks are a holiday tradition," said Claire Korioth, chair of the State Board of Insurance; "however, they traditionally are involved in needless fires, usually because someone chooses to use fireworks carelessly or thoughtlessly."

The State Fire Marshal's Office, which is a division of the State Board of Insurance, licenses companies and persons involved in manufacturing, storing and selling fireworks within the state. It also oversees fireworks technicians that design and operate large public displays of fireworks.

State Fire Marshal Ernest Emerson said that although most cities have banned the use of fireworks within city limits, fireworks still are easily available for sale to the public. He pointed out that fireworks require high temperatures to operate and that many discharged fireworks retain enough heat to start a fire or cause burns for hours after they are discharged. The result, he said, is that many fire departments will be called to battle fireworks-related fires this holiday.

"During 1989, fire departments in Texas reported that fireworks, including sparklers, caused more than 700 fires," Emerson said. "It is reported that these fires caused 13 injuries to firefighters, one injury to a civilian and approximately \$375,000 in property damage."

Emerson added that another nine fires were caused by smaller explosive paper caps and party poppers, available for sale at stores without restrictions year round. These nine fires caused seven civilian injuries and \$330,000 in property damage. The statistics are taken from the Texas Fire Incident Reporting System, which includes 300 fire departments representing about 74 percent of the state's population.

Nationwide, more than 44,000 fires, about 20 deaths and \$41 million in property damage were caused by fireworks-related fires during 1988, the latest year for which national statistics are available.

The statistics gathered by the State Fire Marshal's Office on fireworks-related fires do not include fireworks injuries not related to fires. Such injuries include eye injuries, cuts and burns from contact with fireworks materials. The U. S. Consumer Product Safety Commission (CPSC) estimates that 12,400 fireworks-related injuries were reported to hospital emergency rooms during 1990.

The CPSC also reports that:

*Sixty-six percent of fireworksrelated emergency-room injuries involved privately used devises that were legal under the federal law administered by the CPSC.

★Twenty-seven percent involved fireworks considered illegal under the

★Sparklers caused three-fourths of the injuries to children under five years old.

★Children under 19 years old suffered three of every five fire fireworks injuries. This means that children generally are more than four times as likely to be injured by fireworks as adults over 24 years old.

Using fireworks more safely can reduce the number of fires and injuries caused by fireworks. The State Fire Marshal's Office lists 10 recommendations for using fireworks

Money Talk

"A little bit goes a long way." Most of us have heard our parents or grandparents use that cliche to apply to just about anything. Be it aftershave, make-up or how much salt we put on our food. But when it comes to money matters "a little bit" sometimes can take you further into debt, especially when dealing with credit cards and minimum monthly payments.

My staff has checked with companies that issue credit cards and learned that they generally set minimum payments at between two and three percent of

as safely as possible:

1. Purchase fireworks only from a licensed vendor that displays a SFMO license certificate.

2. Remember that many cities and communities regulate the possession and use of fireworks. Contact the local fire department or law enforcement authorities for rules in your community.

3. Never let children use fireworks. Always designate a responsible, sober adult to ignite the fireworks.

4. Use fireworks outdoors only, in a clear area away from houses and flammable materials, such as grass, trees, gasoline cans or wooden decks. Be sure that the fireworks, especially aerial fireworks, will not contact or land on potentially dangerous objects, such as power lines or automobiles.

5. Keep a bucket of water nearby while setting off fireworks. Use the water to douse any malfunctioning fireworks or accidental fires and to immerse minor burns.

6. Keep everyone, especially children under 15 years old, a safe distance away from the area where the fireworks are ignited.

7. Read and follow the directions exactly. If you don't understand the instructions, don't take a chance by lighting the firework.

8. Never touch a firework after it has been lit. If the firework malfunctions, do not try to relight it or pick it up. Carefully douse all used fireworks with water.

9. Never experiment with fireworks. Don't take fireworks apart or mix anything with the contents. Never make fireworks at home. Don't set off fireworks in metal, glass or other types of containers.

10. After you have finished lighting fireworks, cool the remains with water. Then collect all used fireworks materials and put them in a metal container. Cover with water again to reduce the chance of an accidental fire.

Emerson made another suggestion for parents who allow children to use sparklers. "Keep a metal bucket nearby, and have the children put their used sparklers in the bucket," he said. "Be sure the children are wearing shoes to avoid burns from stepping on hot wires that are dropped accidentally."

The State Board of Insurance chair concluded that avoiding fireworks is the safest choice.

"Go to a public fireworks display," Korioth said. "Or choose another method of celebrating the Fouth of July, such as organizing a neighborhood parade or participating in one of the many Operation Desert Storm commemorations that will be held across the state."

your credit card balance. A finance charge is assessed on the remaining balance. The finance charge varies, depending on the credit card issuer with most companies charging a rate of between 15 and 20 percent.

For example, say the balance on your card is \$2,500, your interest rate is 17 percent and your minimum payment is set at two percent of your balance. In that case, your minimum monthly payment would be \$50 with \$37.50 going to pay finance charges and \$12.50 going to pay off the balance. As you can see, under that type of payment schedule, it could take you quite a while to pay off the balance.

Some credit card companies will lower the minimum payment once you've reduced your balance. For example, if you've reduced your balance to \$2,000 the company may drop the minimum balance by \$10. But this only increases the number of years it will take to pay off the debt. My advice is to try and pay more than the minimum even if it's only an additional \$5 or \$10 a month.

Each credit card company has its own rules and guidelines to determine minimum monthly payments, finance charges, etc. I suggest you call your credit card customer service agents as they can answer any questions that apply to their company's card.
