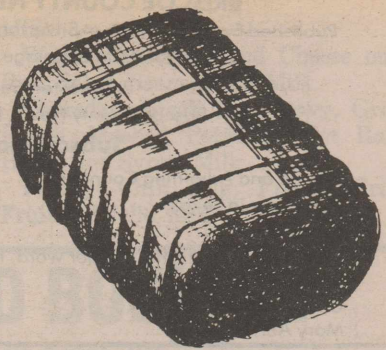

## Tax Rate Set By School Trustees

The Briscoe County Education District Board of Trustees met Thursday evening to set a tax rate for 1991. The rate will be .5580 per \$100 valuation and will allow the following discounts: 3% if paid in October, 2% if paid in November and 1% if paid in December.

The Silverton Independent School

District Board of Trustees met shortly after the CED meeting to set a 1991 tax rate for the ISD. A rate was established at .1703 per \$100 valuation with the following discounts: 3% if paid in October, 2% if paid in November and 1% if paid in December.

The total tax rate for the CED and ISD will be .7283 per \$100 valuation.

After conducting several items of business, the board discussed some of the innovations in technology which will be offered to Silverton students this year. The school will publish more details concerning this new technology in the near future. The board has dedicated a portion of the budget to technology for the '91-'92 school year.

Sometime during the school year, the Texas Education Agency will install telecommunications equipment in the school system to enhance communication capabilities and equity of access to various information services. The board approved the installation of this equipment including a satellite receiving antenna, satellite receiver-tuner, television monitor, video cassette recorder and audio return system with microphones and telephones. This equipment will be furnished to the school at no cost except for a phone line and a \$250 per year maintenance fee.

## Eighty-Three Banks Designated as Fortress Community Banks in 1990

In its June issue, *The Texas Independent Banker* printed an analysis of year-end 1990 data by Bank Source, W. C. Ferguson & Co., Irving. The date show that 83 community banks in Texas, including First State Bank in Silverton, met criteria for designation as a Fortress Community Bank.

The criteria are: (1) equity-to-assets in excess of 10 percent; (2) 90-day past due and nonaccrual loans on a cumulative basis below 2.50 percent of total loans; (3) the generation of a profit in 1990, and (4) total assets greater than \$15

million.

On a cumulative basis, total assets for the 83 Fortress Community Banks in Texas equaled \$5.3 billion. This translates to an average size of \$63.8 million in assets. On average, Texas Fortress Community Banks generated a return on average assets (ROA) of 1.19 percent in 1990 and reported equity-to-assets equaling 12.37 percent. Nonperforming loans (90-day past due plus nonaccrual) equaled 0.94 percent of total loans.

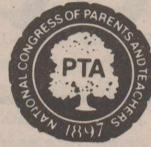

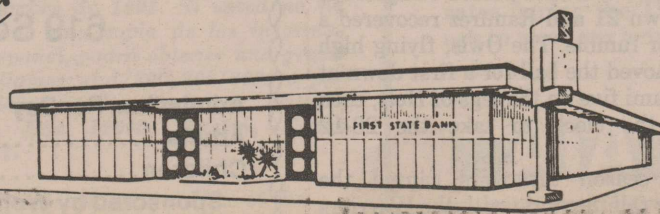

# Owls Add Miami to Their String of Victories 28-12

Silverton's Owls added the Miami Warriors to their string of victories this season last Friday night in a game that started late because one of the visitors' buses broke down enroute here. The Owls opened the game by kicking off, and Langdon Reagan held the return man at the Miami 18. The Warrior offense sputtered, and on third down Brian Martin intercepted a Miami pass and carried it to the 22. Brian West ran for eight yards on first down, but on third down the Owls fumbled and Miami recovered on their own 14.

After making a first down on the Silverton 26, the Warriors were stymied by the Owl defense and the Owls got the ball back on the 15. This time runs by Martin netted a first down on the Silverton 35, and a pass from Josh Brooks to Casey Frizzell was good for another first down. Next play, the Owls fumbled, Miami recovered and went back on offense again. Defense by Frizzell, Frank Ramirez, jr., Martin, Lyndell Ivory and others caused the Warriors to punt on fourth down. Taken by Martin, the ball was moved to the Silverton 18.

Runs by Lance Holt moved the ball for a first down on the Miami 26. As the scoreless first quarter came to a close, Brooks passed to Frizzell moving the ball to the Miami 13. West carried for a first down on the Miami seven, after which Martin moved the ball to the four, and West scored with 7:47 remaining to be played in the first half. West kicked the conversion, and the Owls moved out to an 8-0 lead.

The Owls kicked off, with Holt holding the return at the Miami eight. Unable to move the ball, the Warriors faked a punt and passed complete on fourth down, gaining a first down by penalty on their own 36. The Warriors passed complete for a first down on the Silverton 19, with defense by Martin, and on their next second-down play, Martin intercepted a Warrior pass on the Silverton two.

West ran for six yards on first down, and Martin moved it out to the 11 before the Owls punted away to the Miami 35 with 2:34 remaining in the quarter.

Miami gained a first down on a pass completion in spite of defense by Bryan Breedlove and Reagan stopped the ballcarrier for a four-yard gain on the next play. On third down, Frizzell intercepted a Miami pass on the Silverton 19. With 59 seconds remaining before halftime, Brooks completed a pass to Frizzell for a first down, and on the next play the Warriors intercepted a Silverton pass and carried it for a touchdown. There was no conversion, and with 12 seconds remaining in the first half, the Owls saw their lead cut to 8-6.

Miami kicked off to the Owls and Breedlove returned the ball to the Miami 23 with two seconds remaining on the clock. Brooks completed a pass to Martin which moved the ball to the Miami five as the first half came to a close.

Miami opened the second half of action by kicking off to the Owls, and Martin carried it out to the 39. Brooks completed a pass to Frizzell to move the ball to the Miami 30, but on fourth down the ball went over to the Warriors at their 31.

This time the Warriors gained a first down on the Silverton 29, then ran to the 22 before Frizzell recovered a Miami fumble on the 23. Back on offense again, Martin gained nine yards and West added a first down on the Miami 16. West and Ivory combined

talents to move the ball to the Miami one, where the ball went over on downs to the Warriors.

Miami gained a first down on their 21, but defense by Ramirez, Reagan, Breedlove and others tightened, and on fourth down they punted away. Martin brought it out to the Silverton 30, then ran for seven yards on the next play, but the Owls lost the ball via the fumble route on the Miami 36 on the next play. The Warriors passed for a first down, then carried a touchdown with 18 seconds remaining in the third quarter. The conversion kick was blocked, and Miami led the Owls 12-8.

As the fourth quarter began, the Owls moved downfield on the legs of Martin and West, gaining a first down on their own 35. The two backs combined for a first down on the Miami 28. Holt and West moved for another first down on the Miami 10 and Holt moved the ball nine yards closer to the goal. West carried the touchdown with 4:59 remaining to be played in the game, kicked the conversion, and gave Silverton a 16-12 lead.

The Owls kicked off to Miami, and Frizzell stopped the return player's progress at the Warrior 25. On second down, Martin intercepted a Miami pass at the Warrior 31. With 4:20 remaining to be played in the game, West carried another Silverton touchdown. The conversion kick failed, and the Owls extended their lead to 22-12.

Defense by Frizzell, Ivory and the other Owls held the Warriors to no gain, and on fourth down they punted short to their own 31. With 1:47 remaining in the game, Martin carried another touchdown for the Owls and the score became 28-12.

The Owls kicked off once again, this time stopping the return at the Miami 12, as the Owl momentum continued to build. The Warriors passed complete to their own 21 and Ramirez recovered a Warrior fumble. The Owls, flying high now, moved the ball for a first down at the Miami five on the legs of Holt, then killed the clock to take the 28-12 victory.

Last season turnovers caused the Owls to fall into a tie with the Warriors in a game played at Miami, but this

before game time Friday, and the wet field undoubtedly contributed to the fumbling.

The Owls made 15 first downs as compared with seven for Miami, passing for 89 yards and rushing for 337 to gain a total offense of 426 yards. The Warriors rushed for 126 yards and passed for 30 for a total offense of 156 yards.

Martin rushed the ball 23 times for 176 yards, West carried 15 times for 102 yards and Holt carried six times for a 48-yard gain. Frizzell caught four passes for a gain of 76 yards.

Martin intercepted three passes and Frizzell grabbed off one.

"I felt very good about the game and I think these young men know what it takes to win," said Coach Clyde Parham.

Silverton will host McLean on Friday, and Coach Parham says his team will be ready to play good hard-nosed football. The McLean team beat the Owls twice last season, 55-20 in a regular-season game and 58-26 in an area playoff game.

## Two Owls Receive Honorable Mention

Two Silverton Owls, Brian Martin and Brian West, received honorable mention in the selection of Player of the Week by the Amarillo Daily News.

Martin rushed for 172 yards and two touchdowns and grabbed three interceptions in the Owls' 28-12 victory over Miami.

West rushed for 102 yards and two touchdowns in the same game. He also kicked extra points for the Owls twice.

**PROPOSITION NO. 1  
ON THE BALLOT**

House Joint Resolution 114 proposes a constitutional amendment that would authorize home rule cities having a population of 5,000 or fewer inhabitants to amend their city charters by a majority vote of a city's qualified voters at an election held for that purpose. The amendment makes clear that home rule cities that have declined in population below the population required to initially adopt a charter may nevertheless continue to amend their charters.

The proposed amendment will be described on the ballot as follows: "The constitutional amendment allowing home-rule cities with a population of 5,000 or less to amend their charters by popular vote."

**PROPOSITION NO. 2  
ON THE BALLOT**

House Joint Resolution 10 proposes a constitutional amendment that would allow the legislature to authorize the Texas Department of Transportation to expend money, from any source available, for the costs of the turnpikes, toll roads, or toll bridges of the Texas Turnpike Authority, provided that any monies expended from the state highway fund shall be repaid to the fund from tolls or other turnpike revenue.

The proposed amendment will be described on the ballot as follows: "The constitutional amendment mandating the repayment to the Department of Transportation of monies expended to assist the Texas Turnpike Authority in the construction, maintenance, and operation of turnpikes, toll roads and toll bridges."

**PROPOSITION NO. 3  
ON THE BALLOT**

Senate Joint Resolution 26 proposes a constitutional amendment that would authorize the Veterans' Land Board to invest, as authorized by law, moneys of the Veterans' Land Fund which are not immediately committed to the payment of principal and interest on bonds issued by the Veterans' Land Board, the purchase of lands, or the payment of expenses. Investment of such moneys would no longer be restricted to investments in bonds or obligations of the United States. The proposed amendment would also authorize the Veterans' Land Board to invest, as authorized by law, moneys of the Veterans' Housing Assistance Fund which are not immediately committed to the payment of principal and interest on general obligation bonds issued by the Veterans' Land Board for the benefit of the Veterans' Housing Assistance Fund, the making of home mortgage loans, or the payment of expenses. Investment of such moneys would no longer be restricted to investments in bonds or obligations of the United States. The proposed amendment gives the legislature power to implement the amendment and to delegate such duties and authority to the Veterans' Land Board as it deems necessary.

The proposed amendment will be described on the ballot as follows: "The constitutional amendment to authorize the legislature to further implement and enhance the administration of the veterans' housing assistance and land pro-

grams and to expand the investment authority of the Veterans' Land Board."

**PROPOSITION NO. 4  
ON THE BALLOT**

Senate Joint Resolution 4 proposes a constitutional amendment that would allow the legislature to authorize the issuance of a maximum of \$1.1 billion in general obligation bonds. The proceeds of the bonds are to be used to acquire, construct, or equip new prisons and substance abuse felony punishment facilities, mental health and mental retardation institutions, and youth corrections institutions, to repair and renovate existing facilities of those institutions and to acquire, repair, or renovate other facilities for use as state prisons or substance abuse felony punishment facilities. The \$1.1 billion is in addition to the \$900 million currently authorized by the constitution to be expended on bond issues for facilities of correctional and mental health and mental retardation institutions. The bonds would constitute a general obligation of the state. The bonds and interest on the bonds would be paid from the first money coming into the state treasury that is not otherwise appropriated by the constitution, less any amount in a sinking fund at the end of the preceding fiscal year that is pledged to payment of the bonds or interest.

The proposed amendment will be described on the ballot as follows: "The constitutional amendment authorizing the issuance of up to \$1.1 billion in general obligation bonds for acquiring, constructing, or equipping new prisons or other punishment facilities to confine criminals, mental health and mental retardation institutions, and youth corrections institutions, for major repair or renovation of existing facilities of those institutions, and for the acquisition of, major repair to, or renovation of other facilities for use as state prisons or other punishment facilities."

**PROPOSITION NO. 5  
ON THE BALLOT**

Senate Joint Resolution 39 proposes a constitutional amendment that would allow a county, junior college district, or municipality to exempt tangible personal property from ad valorem taxation if: (1) the property is acquired or brought into the state in an enterprise zone to be forwarded outside the state, (2) the property is assembled, stored, repaired, maintained, manufactured, processed, or fabricated in the enterprise zone, (3) the property is transported outside the state not later than 175 days after being acquired or brought into an enterprise zone, and (4) the person who acquired or brought the property into an enterprise zone is a qualified business. A county, junior college district, or municipality may exempt such property by entering into a written agreement with a qualified business that states the duration of the exemption and the terms on which the exemption is granted. Any action to exempt property must be taken before April 1 of the first year in which the property would otherwise be taxed. The term "enterprise zone" means an area that (1) has been designated as such by a state agency responsible for economic development, and (2) has pervasive poverty, unemployment, and economic distress. The term "quali-

fied business" means a business that meets the qualification established by general law, and requires that the qualified business is actively engaged in a new business in the enterprise zone or is expanding a business that is already active in the enterprise zone. An enterprise zone is created to foster economic development in an area of pervasive poverty and unemployment.

The proposed amendment will be described on the ballot as follows: "The constitutional amendment authorizing the exemption for ad valorem taxes of certain property in an enterprise zone."

**PROPOSITION NO. 6  
ON THE BALLOT**

Senate Joint Resolution 8 proposes a constitutional amendment that would establish a Texas Ethics Commission with the powers and duties provided by law. The commission would consist of eight appointed members selected as follows: two members of different political parties appointed by the governor from a list of at least ten names submitted by the members of the house of representatives from each major political party; two

members of different political parties appointed by the governor from a list of at least ten names submitted by the members of the senate from each major political party; two members of different political parties appointed by the speaker of the house of representatives from a list of at least ten names submitted by the members of the house from each major political party; and two members of different political parties appointed by the lieutenant governor from a list of at least ten names submitted by the members of the senate from each major political party. A major political party is a political party required by law to hold a primary. With the exception of the initial appointees, commission members would serve for four-year terms. A member who has served for one term and any part of a second term would not be eligible for reappointment. The commission would be authorized to recommend the salary of the members of the legislature and may recommend that the salary of the speaker of the house of representatives and the lieutenant governor be set at an amount higher than that of other members. If the commission recommends a change in salary, the voters would be authorized to accept or reject the salary change at the next general election for state and county officers. If the voters approve the recommended salary, that salary would take effect January 1 of the next odd-numbered year; if the voters reject the recommended salary, no change in salary would occur. The commission would set the per diem of the members of the legislature and of the lieutenant governor. The per diem could be raised or lowered biennially as necessary to pay members' costs, but could not exceed the amount allowed as of January 1 that year as a federal income tax deduction for living expenses incurred in a legislative day in connection with a member's business as a legislator, disregarding any federal income tax exception for legislators residing near the Capitol. The commission would have other powers and duties provided by the commission's enabling act (Senate Bill 1, 72nd Legislature, Regular Session). The amendment would also provide that an increase in the emoluments of the office of Lieutenant Governor would not make a legislator ineligible to serve in the office of Lieutenant Governor.

The proposed amendment will be described on the ballot as follows:

"The constitutional amendment creating the Texas Ethics Commission and authorizing the commission to recommend the salary for members of the legislature and the lieutenant governor, subject to voter approval, and to set the per diem for those officials,

subject to a limit."

**PROPOSITION NO. 7  
ON THE BALLOT**

Senate Joint Resolution 6 proposes a constitutional amendment that would allow the board of trustees of each statewide public retirement system to invest the funds of the system in such manner as the board considers prudent. The board would no longer be limited to investing the funds of the system in securities.

The proposed amendment will be described on the ballot as follows:

"The constitutional amendment to allow the board of trustees of a statewide public retirement system to invest the funds of the system in a manner that the board considers prudent."

**PROPOSITION NO. 8  
ON THE BALLOT**

Senate Joint Resolution 21 proposes a constitutional amendment that would permit the legislature to create debt by or on behalf of the state if the legislature submitted the debt question to the voters of the state in the form of a proposition and a majority of those voting approved the proposition. The legislature may call the election, by joint resolution approved by at least two-thirds of the members of each house, during any regular session or during any special session if the subject of the proposition is included in the Governor's proclamation for that special session. A proposition must clearly describe the amount and purpose for which debt is to be created and must describe the source of payment for the debt. The amount of debt stated in the proposition may

not be exceeded and may not be renewed unless the right to exceed or renew is stated in the proposition. The legislature may enact laws necessary to implement the authority granted by a proposition. A law enacted in anticipation of the election on a proposition is valid if, by its terms, it is enacted subject to approval of the related proposition. State debt that is created following voter approval of a proposition and that is approved by the Attorney General is incontestable for any reason.

The proposed amendment will be described on the ballot as follows:

"The constitutional amendment authorizing the voters of this state to consider state debt questions in the form of ballot propositions that must clearly describe the amounts, purposes, and sources of payment of the debt only after approval of the propositions by a two-thirds vote of each house of the legislature."

**PROPOSITION NO. 9  
ON THE BALLOT**

Senate Joint Resolution 11 proposes a constitutional amendment that would authorize the commissioner of the General Land Office to issue patents for certain public free school fund land for which there is not a valid transfer of title from either the State or the Republic of Texas to a private party. A patent is a document of title issued by the state. On application to the School Land Board, a person is entitled to receive a patent if: (1) the land is surveyed public free school fund land, (2) the land was not patentable under the law before the adoption of this proposed amendment, (3) the person acquired the land without knowledge of the title defect out of the State of Texas or the Republic of Texas and held the land under color of title, the chain of which dates from at least January 1, 1941, (4) the person has a recorded deed on file in the county courthouse

and, in conjunction with his predecessor in interest, has claimed the land for at least fifty years as of January 1, 1991, and (5) the person, in conjunction with his predecessor in interest, for at least 50 years has paid taxes on the land together with all interest and penalties associated with any delinquency. If the applicant is denied a patent, the applicant may file suit against the School Land Board in a district court in the county where the land is located within 60 days from the date of denial. The proposed amendment does not apply to beach land, submerged land, or islands, and may not be used to resolve a boundary dispute. The proposed amendment also does not apply to land found by a court to be state-owned or to land on which the state has given a mineral lease that is in effect when a patent is sought. A patent under this proposed amendment for land within five miles of mineral production shall reserve minerals to the state in the manner provided by law for reservations of minerals in sales to claimants of unsurveyed school land within five miles of production. An application for a patent under this proposed amendment must be filed with the School Land Board before January 1, 1993.

This proposed constitutional amendment is similar to the version of article VII, section 4A, that was in effect between 1981 and 1990. The main difference is that under the earlier version the applicant for a patent to land had to have a chain of title that dated back to at least as early as January 1, 1932.

The proposed amendment will be described on the ballot as follows:

"The constitutional amendment authorizing the commissioner of the General Land Office to issue patents for certain public free school fund land held in good faith under color of title for at least 50 years."

**PROPOSITION NO. 10  
ON THE BALLOT**

Senate Joint Resolution 15 proposes a constitutional amendment that would allow the legislature to pass general laws to exempt property owned by a nonprofit corporation organized to supply water or provide wastewater service from ad valorem taxation. A nonprofit corporation would be eligible for the exemption if its bylaws provide that on dissolution, the assets remaining after the discharge of the corporation's indebtedness will be transferred to an entity providing water supply or wastewater service, or both, which is exempt from ad valorem taxation. The transferred assets must be property that is reasonably necessary for and used for water supply and wastewater services.

The proposed amendment will be described on the ballot as follows:

"The constitutional amendment authorizing the legislature to exempt from ad valorem taxes certain property of a nonprofit corporation that supplies water or provides wastewater service."

**PROPOSITION NO. 11  
ON THE BALLOT**

House Joint Resolution 8 proposes a constitutional amendment that would allow the legislature to pass laws to authorize the State of Texas

to operate lotteries and to enter into a contract with one or more legal entities that will operate lotteries on behalf of the State of Texas.

The proposed amendment will be described on the ballot as follows:

"The constitutional amendment authorizing a state lottery."

**PROPOSITION NO. 12  
ON THE BALLOT**

Senate Joint Resolution 34 proposes a constitutional amendment that would increase the total amount of bonds that may be issued by the Texas Water Development Board to provide wholesale and retail water and wastewater facilities to economically distressed areas of the state. The proposed amendment increases the maximum principal amount of the bonds from 20 percent to 50 percent of the \$500 million amount authorized by article III, section 49-d-7, of the Texas Constitution. The proposed amendment would increase the maximum aggregate dollar amount of bonds that the Texas Water Development Board could issue from \$100 million to \$250 million.

The proposed amendment will be described on the ballot as follows:

"The constitutional amendment to increase from 20 percent to 50 percent the percentage of Texas water development bonds previously authorized by Texas voters that may be issued for economically distressed areas."

**PROPOSITION NO. 13  
ON THE BALLOT**

Senate Joint Resolution 2 proposes a constitutional amendment that would allow the legislature to pass general laws authorizing Texas Higher Education Coordinating Board or its successor to issue and sell up to \$300 million of general obligation bonds to finance education loans to students. The maximum net effective interest rate to be borne by the bonds would be set by law. The amendment would also authorize the legislature to provide for the investment of bond proceeds and to establish an interest and sinking fund to pay the bonds and provide for the investment of such fund. Bonds authorized under this amendment would be paid from the first money coming into the treasury in each fiscal year that is not otherwise appropriated by the constitution, less any amount in an interest and sinking fund established at the end of the preceding year that is pledged to the payment of the bonds or interests.

The proposed amendment will be described on the ballot as follows:

"The constitutional amendment providing for the issuance of general obligation bonds not to exceed \$300,000,000 to continue existing programs to provide educational loans to students, with repayments of student loans applied toward retirement of the bonds."

Rue has served as a member of the Executive Board, Kentucky Baptist Convention; a member of the Board of Trustees, Quachita Baptist College, Arkadelphia, Arkansas; Associational Chairman of Evangelism in Arkansas, and trustee of High Plains Baptist Hospital, Amarillo. He also has served as member of the Executive Board, Christian Education Coordinating Board, Resolutions Committee and was chairman of the Committee on Nominations for Institutional Boards for the Baptist General Convention of Texas. He is presently serving as a trustee for Wayland Baptist University.

Rue is married to the former Bilye Franklin. They are the parents of three children and grandparents of three.

Gary Bledsoe, minister of music at

Paramount Baptist Church, Amarillo, since July 1988, was born September 28, 1954. He is married to the former Jayne Reed and has two daughters, ages six and three.

He received his bachelor of arts

degree in psychology from Angelo State University in San Angelo in 1976 and his M. C. M. degree from Southwestern Baptist Theological Seminary, Fort Worth, in 1983. Bledsoe has served as interim minister of music at Park

Heights Baptist Church in San Angelo; part-time minister of music at Southland Baptist Church in San Angelo, and minister of music at North Fort Worth Baptist Church.

## Public Notice

On June 28, 1991, Southwestern Bell Telephone Company (Southwestern Bell) filed an application with the Public Utility Commission of Texas (Commission) to add a new optional service offering for business Private Branch Exchange (PBX) Trunk customers called Digital Loop Service. The application has been assigned Docket No. 10461.

Digital Loop Service provides digital transmission of circuit switched voice and data communications between the customer's premises and the central office. This service allows the customer to use a 1.544 Mbps facility capable of delivering up to 24 line terminations. Southwestern Bell will provide Digital Loop Service within the customer's serving central office where facilities are available.

If approved by the Commission, the rates for the Digital Loop Service facilities will be \$445 per month for each digital transmission loop arrangement which provides a capacity of up to 24 line terminations, plus \$3 per month for each line termination and \$9 per month for each channel termination. The proposed rate for the unlimited use of the central office varies from \$12.25 up to \$18.90 per month for each line termination depending on the rate group classification, determined by the customer's location. Southwestern Bell estimates revenue of \$2.1 million from this offering during the first year.

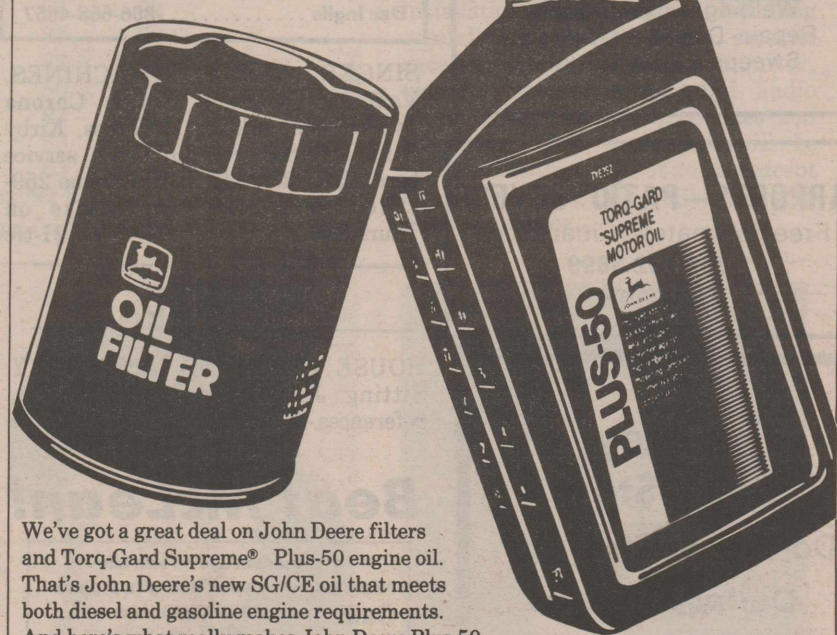
As proposed by Southwestern Bell, customers who currently receive digital loop compatibility through facilities installed under a special construction agreement will have the option to receive their current digital loop arrangements pursuant to the Digital Loop Service Tariff or continue to pay their current charges until they make a change of location or account. Any increase in the number of line terminations to a customer's current digital transmission loop arrangement will be provided pursuant to the proposed Digital Loop Service Tariff; however, the customer will continue to have the option of paying current charges for the existing digital transmission loop capacity. Southwestern Bell's proposal to "grandfather" existing digital loop facility arrangements is subject to review and approval by the Commission.

Persons who wish to intervene or otherwise participate in these proceedings should notify the Commission as soon as possible, but not later than October 15, 1991. A request to intervene, participate, or for further information should be mailed to the Public Utility Commission of Texas, 7800 Shoal Creek Blvd., Suite 400N, Austin, Texas 78757. 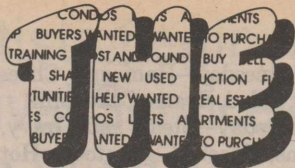

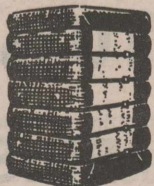
