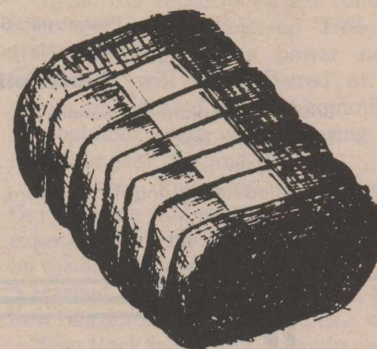
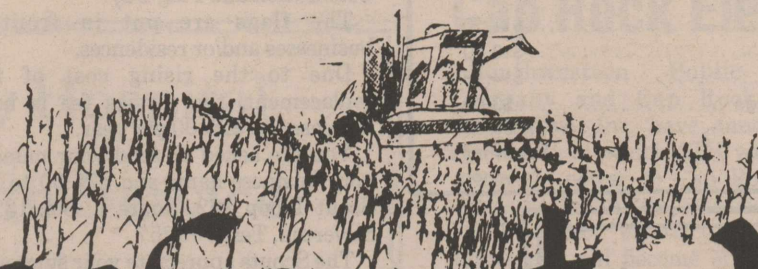

Owls Win The Championship!

Silverton's Owls defeated the Lazbuddie Longhorns 42-12 here Friday night to become the district champions for the first time since 1944. A wildly happy celebration broke out as soon as time expired on the game clock, and hardly quieted for the presentation of the trophy before resuming at a fever pitch.

The Owls had earned their moment of glory. They had known what they had to do to become the district champions, and they went out and did the job.

J. L. Self, grandfather of Casey Frizzell, was a member of the last Owl team to gain an outright district championship 47 years ago. It was fitting that Self saw the Owls usher in a new era at Payne Field Friday. "The '44 team and this one were very similar in that they were big, had one pretty fast guy, and they just played man-on-man," Self said.

Coach Clyde Parham also was impressed by his team's performance. "This was very much worth my while as a coach to see the joy on these kids' faces as they knew they were the champions!" he exclaimed. "I just can't say enough about the defense and the running in the offensive backfield. It was just tremendous," he added.

The Owls now move on to a bi-district game against District 4 runner-up New Home. Kickoff will be Friday at 7:30 p.m. in Silverton after Coach Parham won a coin toss Saturday morning in Abernathy (he won the toss last year, too).

"We can only take it one game at a time and go do what we know and that is winning," Coach Parham said of the upcoming test. "I'm gonna dance with the lady who brung me . . . just good, hard, straight-at-you football. I think the key to our victory was that we made it a regular game and I didn't blow it up like I did last year."

Of course, Lazbuddie Coach C. W. Williams was not pleased with his team's performance but did see some good coming out of the game. "I think this will help us down the road, maybe to humble us and show us that we better get prepared for every game and not listen to the newspapers so much. We decided to come out and play the second half and we shut them down and played like we were supposed to," said Williams, whose Longhorns face Meadow in bi-district. Their game will be played at Meadow at 7:30 p.m. Friday.

Brian Martin had a stellar performance for the Owls, running for 201 yards, including 168 in the first half. "I have to thank my line for my success tonight," he said following the game. "They had some tremendous blocking. This game should give us a lot of momentum going into the playoffs. We need to play in the playoffs like we

did tonight and we will be all right."

The Owls opened the game by kicking off to the Longhorns, and seeing the ball brought out for a touchback. The 'Horns completed a pass for a first down to the 39, and then moved for another at the Silverton 15. They scored with 8:00 remaining on the first-quarter clock, but this score was nullified by an illegal procedure penalty against the Longhorns. When Lazbuddie came passing back, their passes were batted down and fell incomplete, and on fourth down the ball went over to the Owls on their five.

Brian West picked up five yards on the first play, and Martin carried for a first down on the Lazbuddie 37. West carried for seven, and Lyndell Ivory ran for a first down on the 21. Martin carried the score with 5:20 remaining in the first quarter, the PAT kick was blocked, and the Owls held a 6-0 lead.

Once again the Owls kicked off, and held the runback deep in Longhorn territory. The 'Horns picked up a first down via the pass on the 37, before losing the ball on a fumble.

The Owls picked up a first down on

Younger was pronounced dead at Johnson's Gin at 11:05 a.m. Tuesday by Justice of the Peace Dale Ramsey of Quitaque. Even though it was believed that Younger was killed in an accident, an autopsy was ordered.

Sheriff Dick Roehr and City Marshal Bill Boling investigated the death, and have pieced together this information in regard to what might have happened. Younger began loading a truck with cottonseed at the gin at 7:30 a.m. Tuesday, and it is thought that about 8:00 a.m. he opened a hopper to dig cottonseed loose. Probably he was backed up against the truck's cab, and when the cottonseed came loose, it pulled him with it down into the truck, smothering him beneath its weight.

Roehr and Boling began looking for Younger about 10:00 a.m., and Boling located his body in the cottonseed about 10:30 a.m.

Younger was born December 17, 1952, in Dallas. He was graduated from Silverton High School with the Class of 1971.

He was employed as a truck driver and had worked for Mikel D. Griffin Trucking for the past five years. Before that he had been employed by Briscoe Implement for a year and Coca Cola Bottling Company for 12 years.

He married the former Cynthia Rackley in Lubbock on July 27, 1980.

He was a member of the First Baptist Church.

Survivors include his wife; a daughter, Tyra, of the home; two sons, Trenton of Amarillo and Martin of the home; his parents, Roy and Lou Younger of Silverton; two grandfathers, M. B. Self of Silverton and A. V. Younger of Diana; four sisters, Lexie McCutchen of Memphis, Lisa Gragson and Lydia Couch, both of Las Vegas, Nevada, and Jeanetta Bradford of Silverton.

PUBLIC NOTICE

On April 16, 1991, GTE Corporation ("GTE") and Contel Corporation ("Contel") filed a joint petition for declaratory relief with respect to the obligations or requirements of GTE or Contel and/or any of its subsidiaries relating to the merger of GTE and Contel. GTE and Contel have requested a ruling from the Public Utility Commission of Texas that neither GTE nor Contel is required to report the merger of GTE and Contel pursuant to Section 63 of the Public Utility Regulatory Act ("PURA"), TEX. REV. CIV. STAT. ANN. art. 1446c (Vernon Supp. 1991), that no investigation of the merger by the Commission is required. In the alternative, GTE and Contel seek a determination that the merger is consistent with the public interest.

The Commission is investigating the merger between GTE and Contel Corporations to determine whether the merger is consistent with the public interest. In reaching its determination, the Commission shall take into consideration the reasonable value of the property, facilities or securities to be acquired, disposed of, merged or consolidated. If the Commission finds that the merger is not in the public interest, the Commission shall take the effect of the transaction into consideration in GTE Southwest Incorporated's and Contel of Texas, Inc.'s next ratemaking proceeding and disallow the effect of such transaction if it will unreasonably affect rates or services.

This filing has been assigned Docket No. 10212. Persons who wish to intervene or otherwise participate in these proceedings should notify the Commission. A request to intervene, participate, or for further information, should be mailed by 3 p.m., December 31, 1991, to the Public Utility Commission of Texas, 7800 Shoal Creek Blvd., Suite 400N, Austin, TX, 78757. 

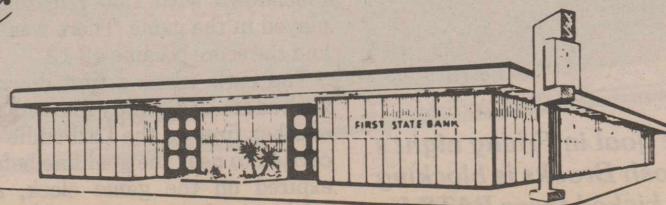

the 16, after which West carried a touchdown with 3:16 remaining in the quarter. West kicked the PAT, and the Owls moved ahead 14-0.

This time the Lazbuddie possession also was ended by a fumble recovery by the Owls, near the 'Horn 20. Martin picked up a first down, after which West carried the touchdown with 33 seconds still on the first-quarter clock. The PAT kick was blocked, and the Owls held a 20-0 lead.

The Owls allowed the 'Horns a good runback to near midfield on the next kickoff, and just after the second quarter began, the 'Horns punted to the Silverton 15.

This time the Owls marched downfield on runs by Martin and West, and Martin scored with 6:59 still remaining before halftime. There was

no PAT, and the Owls moved into a 26-0 lead.

There was a touchback on the kickoff, and the 'Horns picked up a first down on a penalty against the Owls before the ball went over on downs near the 36 yardline.

This time it took West and Martin only three plays to get the ball into the endzone, and West carried the touchdown with 3:59 still on the second-quarter clock. West kicked the PAT, and moved the Owls into a 34-0 lead.

The 'Horns started with another touchback, and ran only four plays before seeing the ball go back over to the Owls. Ivory carried to the 30, and Frizzell passed to Quarterback Josh Brooks for another touchdown with 1:48 remaining in the period. West kicked the PAT, and moved the Owls

ahead 42-0.

Lazbuddie took the ensuing kickoff all the way for a touchdown, there was no PAT, and with 1:35 still showing on the second-quarter clock, narrowed the score to 42-6.

Lazbuddie kicked off, and held the Owls to little gain, and the Owls were forced to punt. The 'Horns made a first down on the Silverton 26 before the first half ended.

The 'Horns kicked off to the Owls to open the second half, and Brooks ran for a first down before the 'Horns intercepted a Silverton pass on the Lazbuddie 15. The 'Horns made a first down at midfield, after which Frank Ramirez, jr. intercepted a Longhorn pass on the Silverton 33.

Martin completed a pass to Langdon Reagan, but the Owls were unable to move for a first down and Martin punted short. Lazbuddie wasn't able to move the ball, but had an injury to a player that resulted in a lengthy timeout as he was loaded into an ambulance for transport to a Lubbock hospital. This player was the district cross country champion, and had been scheduled to compete in the regional meet the following day, but was unable to do so; however, he was examined for a hip injury and released from the hospital that night.

Following the injury timeout, the ball went over to the Owls with two minutes remaining in the third quarter. Martin ran for a first down on the Lazbuddie 20, but the defense stiffened, and the ball went over to the 'Horns as the fourth quarter began.

The 'Horns made a first down before losing the ball via the fumble route, and the Owls took over again and were unable to move the ball. Lazbuddie's next possession resulted in a first down on the Silverton six followed by a touchdown with 1:50 remaining to be played in the game. There was no PAT, and the score became 42-12.

The Owls made a first down on the Lazbuddie 21, and Martin ran for another first on the Lazbuddie 8. Ivory carried to near the goal line before time expired on the game clock, and the celebration began.

The Owls made 15 first downs in the

JV Owls Take Big 52-7 Victory at Lazbuddie

Silverton's Junior Varsity Owls ended their game at Lazbuddie with 3:24 remaining to be played in the third quarter under the 45-point rule last Thursday.

Lazbuddie opened the game by kicking off, and Matt Francis took the short kick at the 37. The Owls went to work on runs by Michael Hill and Lance Bradford, and Bradford picked up a first down on the Lazbuddie 21. After an incomplete pass on fourth down, the ball went over on the 'Horn 11 with 5:24 remaining to be played in the first period.

The defense, with work provided by Lance Smith, Bradford, Hill and others held the 'Horns in check, and Hill took their short punt to the Lazbuddie 21. Hill scored on the next play, his kick was blocked, and with 4:06 still showing on the first-quarter clock, the Owls led 6-0.

The Owls allowed the 'Horns just three plays, and then Zane Henderson recovered a fumble on the Lazbuddie 32. From that point, Bradford picked up 13 yards and Hill ran for a first down on the five, before going over for a touchdown with 2:27 remaining in the first quarter. The PAT kick was blocked, and the Owls held a 12-0 lead.

When the Owls kicked off again, they held the 'Horns at the Lazbuddie 15, with the tackle made by Braden Towe, who is usually out front blocking for the runners on offense. Hill and Towe combined to stop the next play, before the 'Horns completed a pass for a first down on the Silverton 27. The 'Horns ran four more plays, ending on the Silverton 18, where the ball went back over to the Owls with 25 seconds remaining in the first period.

Bradford and Hill combined for a first down on the Lazbuddie 31, after which Hill got a first down on the 15, Bradford carried the touchdown. There was no PAT, and the Owls extended their lead to 18-0 with 7:34 remaining in the second quarter.

Lazbuddie started with a touchback, and on their first play the ball was snapped over the quarterback's head and he went down on it in the endzone, giving the Owls a safety and a 20-0 lead. Lazbuddie free-kicked to the Owls, taken by Henderson to the Lazbuddie 34. Carries by Hill, Bradford and Smith picked up a first down on the 'Horn five, and Bradford carried another touchdown with 4:53 remaining to be played before halftime. There was no PAT, and the score stood at 26-0.

The Owls kicked off once again, and Towe and Francis held the return at the Lazbuddie 23. The 'Horns picked up a first down on their 37 before the Owl defense closed off all avenues of approach, and the ball went over on downs on the Silverton 35.

Hill and Bradford set up the Owls in

scoring position, and Hill carried the touchdown with 2:17 remaining before halftime. There was no PAT, and the Owls had moved into a 32-0 lead.

When the Owls kicked off again, Lazbuddie fumbled, and the Owls recovered on the Longhorn 30. Francis ran for 14 yards and Hill gained a first down on the eight. Bradford and Hill moved the ball to the one, and Bradford scored with 18 seconds still showing on the first half clock. There was no PAT for the Owls, but the Longhorns grabbed the live ball and ran it all the way to the endzone for a point of their own, and the score became 38-1.

The Owls kicked off to open the second half, and Towe held the runback at the 18. After two incomplete passes, Smith sacked the quarterback for a five-yard loss, forcing the 'Horns to punt. Hill returned the punt to the Lazbuddie 13, and Bradford scored on the next play. Hill passed to Towe for the PAT, and the Owls moved into a 45-1 lead.

One of those approved was the state lottery question, which passed statewide. Briscoe County gave this question a 285 to 215 nod.

Another approved locally, which also passed statewide, was number thirteen,

concerning the issuance of bonds for student loan programs. This passed here 311 to 164.

Briscoe also approved, 152-9, the charter amending for cities smaller than 5,000; prison bonds, 273 to 197; description of state debt propositions,

287 to 163; nonprofit water corporations' tax exemption, 224 to 218; and water development bonds for colonias, 239 to 218.

Briscoe voters disapproved propositions concerning repayment for toll roads, 164 to 289; Veterans Land

Board investment authority, 72 to 136; tax exemptions in enterprise zones, 157 to 285; creation of Texas Ethics Commission, 177 to 281; public retirement system funds investment, 119 to 343; and land patents, 213 to 239.

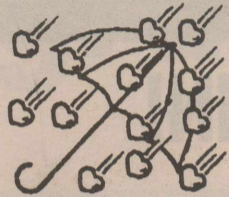

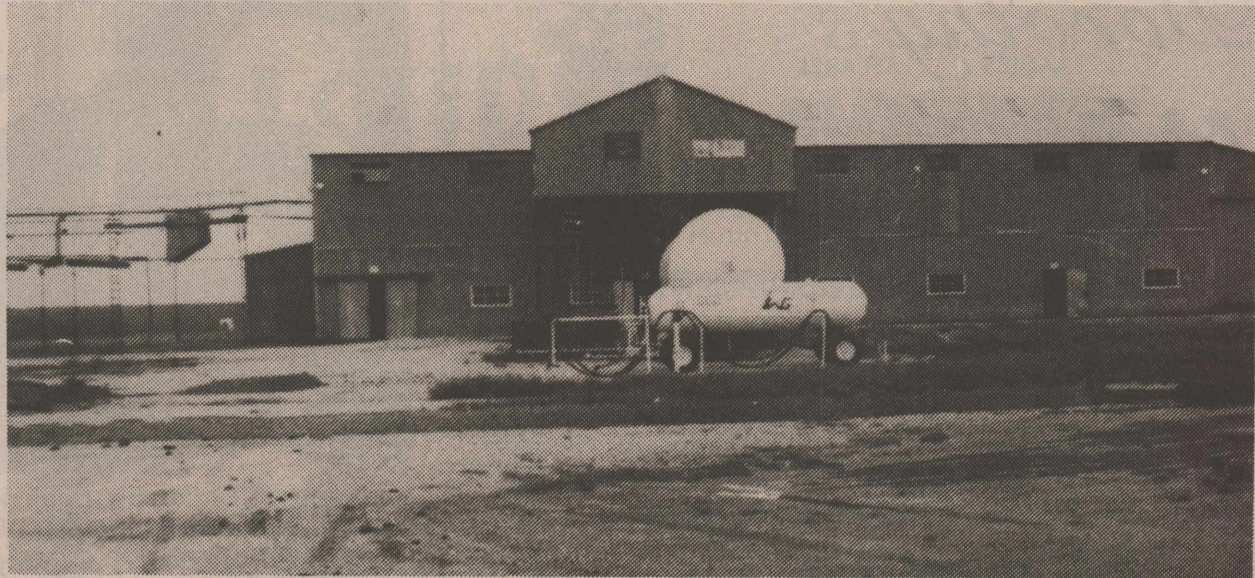

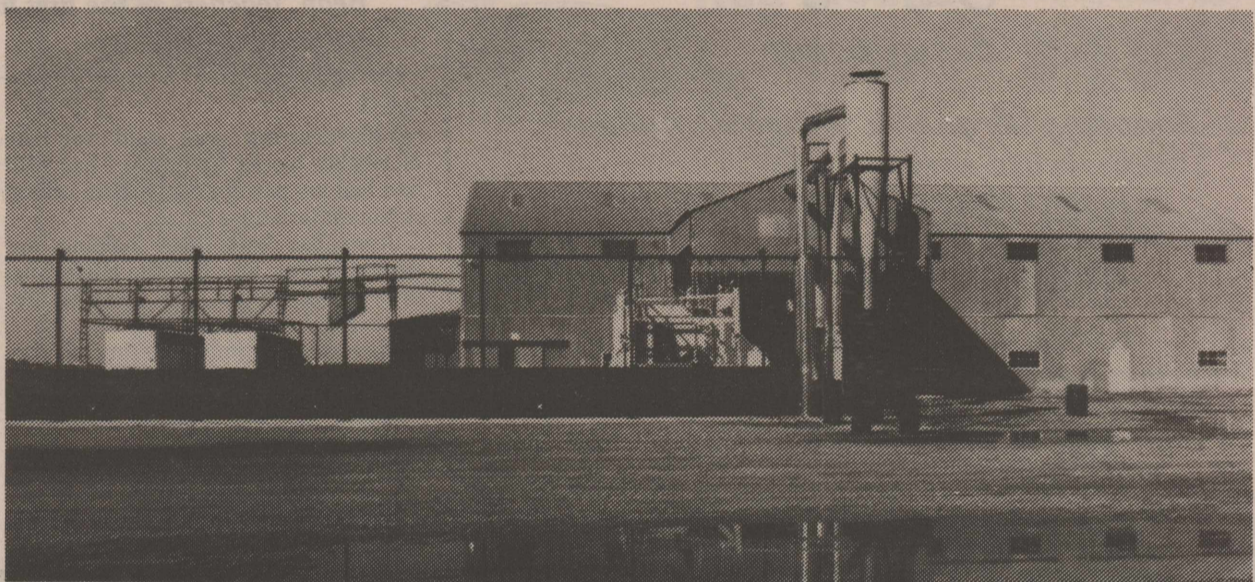

SPS To Provide Electricity for Cap Rock Electric

Southwestern Public Service Company and Cap Rock Electric Cooperative, Inc. have announced an agreement in which SPS will provide wholesale power to Cap Rock, which serves 17 West Texas counties.

Delivery of electricity under the agreement will become effective upon completion of transmission lines between the two companies, expected in mid-1993.

Cap Rock is headquartered in Stanton, 18 miles northeast of Midland, and serves more than 20,000 customers. SPS is a regional, investor-owned utility serving about 350,000 customers in the South Plains and Panhandle of Texas, eastern New Mexico, the Oklahoma Panhandle and southwestern Kansas.

Cap Rock will become the 17th rural electrical cooperative to which SPS provides wholesale power.

Cap Rock Director of Power Supply and Regulatory Affairs Steven E. Collier said the agreement with SPS is good news to co-op members.

"We constantly seek wholesale power from many sources, searching for the best deal for our customers," Collier said. "Our contract with SPS will result in lower power supply costs and more flexibility."

He said the agreement with SPS will result in lower rates for Cap Rock Electric's consumer-members than would have resulted otherwise.

Cap Rock Chief Executive Officer David W. Pruitt said savings and reliability will extend far into the future. "This assures our members the benefits of a long-term stable,

competitively priced supply of power into the next century," Pruitt said.

Under the recently signed contract, SPS will supply between 70% and 100% of Cap Rock's power needs. Electricity will be delivered at two points, one located near the community of Vealmoor north of Big Spring, and the other near Midland, Texas.

SPS Vice President of Marketing Gary Gibson said sales to Cap Rock are expected to reach 70 to 100 megawatts by the end of the decade.

He said SPS is looking forward to its new relationship with Cap Rock.

"Cap Rock is already a strong co-op," Gibson said. "We're pleased we can help keep it strong by providing its members with the low-cost electricity and dependable service we give all our customers."

Cap Rock Electric Cooperative, Inc. was formed in 1939, and serves Andrews, Borden, Dawson, Ector, Fisher, Glasscock, Howard, Irion, Martin, Midland, Mitchell, Nolan, Reagan, Scurry, Upton, Sterling and Tom Green counties.

The wholesale power arrangement must be approved by the Federal Energy Regulatory Agency, the Public Utility Commission of Texas and the New Mexico Public Service Commission prior to delivery of power.

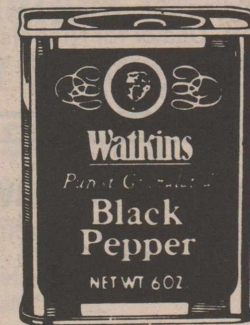
