EDC's Duckwall project update...


Warm weather has been a boost in recent weeks to the work going on at the old Perry Brothers building in preparation for a new Duckwall's Hometown Variety Store opening in Knox City.

While the cement slab for the expansion of the building, and the rough-in plumbing have been completed, the work pace really picked up this week as crews began construction of the new building in the rear that will tie directly into the existing building. Opening into one big showroom, the new and old buildings will allow a combined showroom space of 5100 square feet. The new building will also contain an office, employee break room, an ADA certified restroom for customers, and a storeroom.


In the photos shown at right, workers from Snyder Construction Company of Seymour (top photo) are shown constructing the framework for the new building expansion. Work is underway to remove and replace (middle photo) the sidewalk in front of the store in preparation for a totally new store front. Going from the old recessed double sets of doors, Duckwall's will have all new plate glass windows with one set of double doors on the north side of the front. The new glass and doors will be flush with the front of the building, and the glass will be the latest in approved safety glass.

Project Contractor Sid Richardson and Monty Stevens (bottom photo) are shown installing the new sub-flooring throughout the building. The last stage of the project will be to cover the sub-flooring with new linoleum tile.

County Judges provide information on next Tuesday's critical vote on local water regulation

Haskell County Judge David Davis and Knox County Judge David N. Perdue have received many requests for information from local citizens concerning the Haskell-Knox Underground Water District election that is to be held in both Haskell and Knox Counties on January 26, 1999.

Judge Perdue of Knox County, having been involved with the original legislation, working with State Representative David Counts and former State Representative,: now Texas Lt. Governor Rick Perry, offers the following observations. Judge Perdue also was appointed and serves on the Brazos G water planning group. Little did I realize back in 1991 when Judge B.O. Roberson of Haskell

and myself were asked to inquire about drafting legislation to help protect our under-

ground water how important

it would be to our future use of water. Their concern was to protect our water from being used and/or regulated by others than ourself. Their concern back then proved to be true because the Legislature passed Senate Bill 1 in 1997. Anytime our State Legislature gives either a Senate or House Bill number one, you can be assured that bill will be a priority on the legislative agenda.

Senate Bill 1 is now law. It contains many, many pages, mostly of hard to read, much less understand, words that creates 16 regional water planning areas across our state. The law says these regions will create a water plan by September 1, 2000 and report back to the Texas Legislature, who then will create a plan for the citizens of Texas to take us into the next century. A very large

and difficult task. Haskell and Knox County are in the Brazos G water plan. We are in the far north end of that region that extends to Taylor County and takes a southwest route all the way to Washington County back to the north to Brazos County to just south of Ft. Worth back to Knox County. This district includes 37 counties that include cities such as Brenham, Bryan-College Station, Georgetown, Temple, Belton, Killeen, Waco and Abilene to name just a few of the larger cities. Of those counties within this district, Knox County and Haskell County are the ninth and eleventh largest user of water. I point this out just to give you a picture of how important our water supply is to the

I see fit or at least I can right now I regulate my own water and protect it dearly and want to continue to do so. BUT, if Senate Bill 1 affects my

water usage would I prefer to have someone from my county monitor my use of water, to help me conserve my wells, support and help me in tough times such as this past year, and protect our water resources. Am I willing to pay .01¢ or .02¢ per \$100 to invest not only in my future but my kids and grandchildren's future; OR, should a state agency do that job from far away and charge me more money (with no control) than our own Haskell/Knox Underground Water District.

A vote yes is to form the district with local control.

A vote no is to not have any control, or say so, to our future use of our water.
