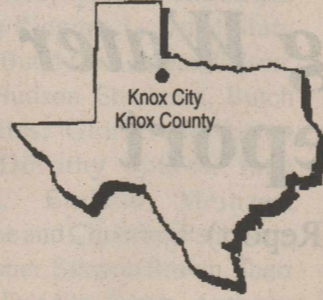

## 70th annual Texas Cowboy Reunion to unfold in Stamford beginning July 1 through July 4

Dedication at 4:00, Parade at 6:00 p.m. on June 30

STAMFORD - Hailed as the World's Largest Amateur Rodeo, the 70th Annual Texas Cowboy Reunion will get underway for fun, rodeo and reunion, Saturday, July 1; and continue through Sunday, July 2; Monday, July 3; and Tuesday, July 4.

The excitement will kick off Friday, June 30, at 6:00 p.m. when the children of famed western photographer and one of the originators of the Texas Cowboy Reunion, Ray Rector, will lead the Grand Parade through the historic streets of downtown Stamford.

The event will follow a dedication of Stamford's Centennial Monument of a 15 foot tall metal cowboy on a bucking horse by Throckmorton sculptor Joe Barrington. The dedication will be at 4:00 p.m. Congressmen Charles Stenholm, Representative David Counts, Senator Tom Haywood and other diplomats are scheduled to be present at the unveiling.

Following the parade at 7:30 p.m. will be a dinner at the Chuckwagon Grounds followed by a dance. Then on July 1, 2, 3 and 4, cowboys and cowgirls of the past, present and future will fill the authentic rodeo arena for

the grand entry introduction to the rodeo performances each night at 8:00 p.m.

Classic events of the rodeo plus a few that are unique to the TCR include double mugging, oldtimers events, wild cow milking and the infamous wild mare race.

The setting for the rodeo is picturesque as the grounds are located on the beautiful SMS Ranch with the West Texas sunset playing backdrop to the rustic arena which has been coined by many throughout the years as "Little Cheyenne".

Couples can dance the night

away beginning at 9:30 p.m. on Saturday night to the music of Red Steagall and the Boys in the Bunkhouse on Saturday night and to Jody Nix and the Texas Cowboys on Sunday through Tuesday.

Held in the TCR's open air covered pavilion, the dance is a fun and relaxing way to end a day full of TCR excitement.

Various other events are planned throughout the four days, including the Western Art Show in the air conditioned John Selmon Gallery and the TCR Trade Show featuring wall-to-wall booths of western attire, jewelry and TCR

souvenirs in the upstairs portion of the gallery.

The art Preview Party will be June 29 at 6:30 p.m. This evening of dancing, a Joe Allen's steak dinner, cocktails and a quick-draw auction benefits the West Texas Rehabilitation Center.

On Tuesday afternoon at 1:30 p.m., old Matador ranch cowboy Dennis Gaines will headline this year's Cowboy Poetry Gathering. Many of today's top cowboys and cowgirls of verse and song will be on hand for this extraordinary event.

## Memorial fundraising sailing 'full speed ahead'

Fundraising for the Knox County Memorial project is sailing 'full speed ahead' with \$38,000 of the \$50,000 so far. Sailing much as the Higgins boats of World War II. Even Hitler is reported to have said he could have won the war had it not been for these versatile Allied amphibious craft that landed the Allied Forces successfully on both fronts of WWII.

As Louisiana, the source of the

manufacturing plants producing these craft, opens a national museum making exploits of the Higgins landing craft and amphibious boats, Knox County residents remember one of their own, Bruce Campbell, who commanded a number of these craft in the Pacific in WWII. Excerpts from an article written by 1995 student of Darlene Bellinghausen, Aaron Earles, confirms the roles

the Higgins boats and gallant combat troops played in winning WWII.

In 1944, Campbell's platoon was selected to make the original landing on Leyte Island in the Philippines. One of Mr. Campbell's ships put General MacArthur ashore. One recalls this event from the famous photograph of the general wading knee-deep in the surf.

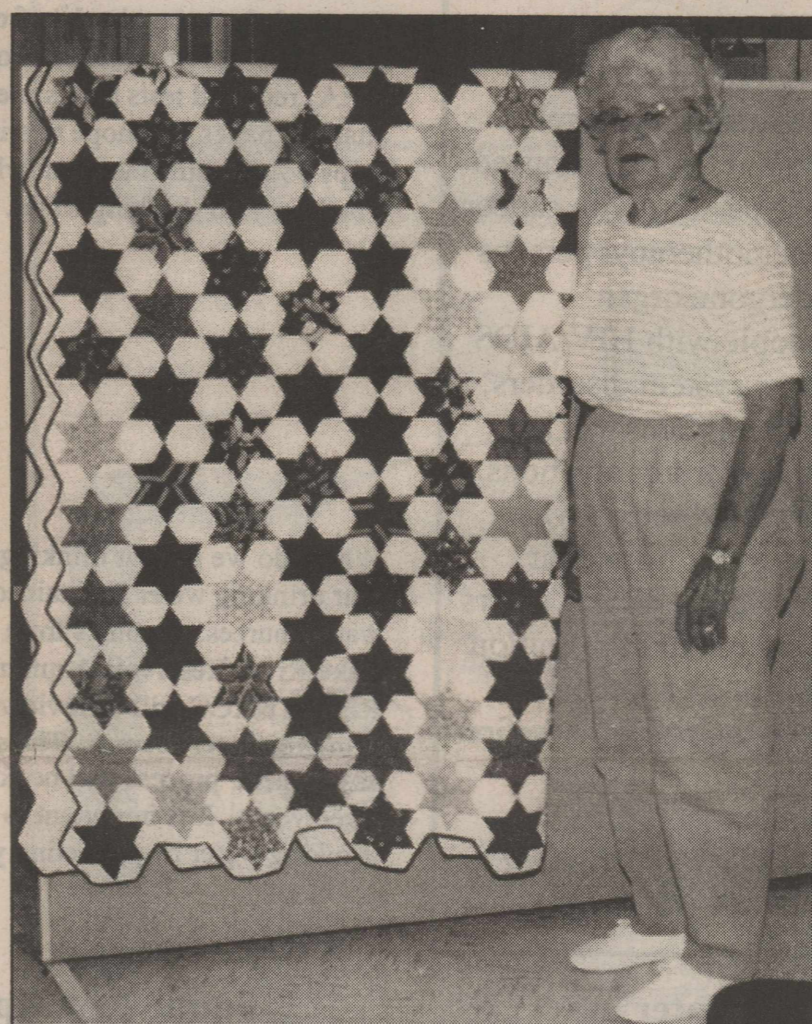
Philippine duty led to Lieutenant Campbell, along with 79 other men, being separated from the 2nd Engineer Special Brigade without food and supplies. The men had attacked a Japanese submarine when it had come to pick up high ranking Japanese generals by running the Higgins amphibious craft along wide it.

Campbell's ships relayed information about the attack ahead and

were given orders to hold one side of an inlet in order to prevent the submarine from completing its mission

Taking one side of the inlet meant staying on a peninsula and separation from the 2nd Engineer Special Brigade. For 1-weeks (the first week in October to Christmas Eve 1944) the men stayed on

### Secondary Constituents

#### Maximum Contaminant Level (MCL)

#### Maximum Contaminant Level Goal (MCLG)

The level of a contaminant in drinking water below which there is no known or expected health risk. MCLGs allow for a margin of safety

#### Treatment Technique (TT) -

A required process intended to reduce the level of a contaminant in drinking water.

#### Action Level (AL)-

The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

the peninsula. Eating the protein rich coconuts made the men sick, so they relied on bananas, starchy pastes derived from native plants and fresh water from holozone treated canteens to survive. Such treated water consumed during sterilization period, filled with still living microorganisms made the men very sick.

While in the jungle, the men slept on the ground on in "jungle hammocks". Malaria was rampant in the jungle and by the time they were relieved by another group, only 5 of the original 80 men survived. Lieutenant Campbell was 6'7" and weighed 195 pounds when he entered. He weighed only 145 pounds when he and his men were reattached to the 2nd Engineer Special Brigade. Even with the 2ESB, the men ate only five times a week.

After the Leyte campaign, the platoon left for Mindora Island. On December 23, 1944, Campbell's landing craft took a direct hit. Five of the crew escaped, two of them unconscious. The able men strapped double life-jackets on their sleeping buddies and floated in a huddle until picked

up by a Navy ship. Later then men thought unconscious were found to be dead. Campbell received a wound to the chest from a quarter sized piece of shrapnel.

Wounded, he was sent back to Leyte where he boarded a hospital ship, finally arriving at Kennedy General Hospital in Memphis, Tennessee. Due to a partially healed wound and the dangers in open chest surgery, he decided to keep the shrapnel with him always.

Campbell retired from the service in April 1945. An extensive traveler, he returned to New Guinea in 1988. Recalling his entering the service on a reserved commission at age 21, a mechanical engineer graduate of A&M in 1939 and the next five years that followed in all those Higgins amphibious craft, he would do it all over again. Strange that Hitler's statement was prophetic. The Higgins craft and the gallant youths who manned the controls, did their work to win the war.

Such men will be honored with one's contribution to the Knox County War Memorial.
