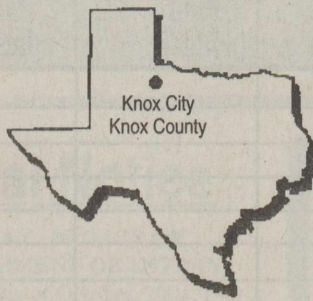

## Munday Moguls dominate Greyhounds, 27-0

With hundreds of fans cheering them on, the Knox City Greyhounds showed up in Munday last Friday night expecting a fight, but never anticipated the final 27-0 outcome of the game.

Prior to last week, the Greyhound defense had just allowed 42.2 yards rushing per game. The highly charged Munday Moguls spoiled that record though, rushing for 301 yards. The Mogul

offense seemed to have a free reign on the field while the Greyhound offense sputtered at best.

Things went from bad to worse early in the game for Knox City as the Moguls scored three touchdowns in the first half. A 75 yard drive with 10 running plays and a 29 yard touchdown run put the first points on the board for Munday, they were followed shortly by another Myers touch-

down after Knox City fumbled the ball and turned it over to the Moguls.

With 10 seconds left on the clock in the first half, the Greyhounds fumbled again and turned the ball over to Munday on the 42 yard line. With just 2 seconds left on the clock, Munday scored again with a double pass play from Myers to Jeffery Toliver, then from Toliver to Jeffery Urbanczyk

for a 38 yard touchdown play.

With Knox City down three touchdowns at the half, things did not get much better when the second half began. On the very first play of the second half, Munday scored again when Jeffery Urbanczyk ran the kickoff back for 83 yards and six more points.

Knox City was held to a total of 84 yards in the game by a Mogul defense that had the Greyhound

offensive game plan figured out.

Greyhounds making yards during the game were Riley Spells with 43 yards on 7 carries, Scooter Thompson with 32 yards on 5 carries, Sederick Roberson with 16 carries on 7 carries, Gemile Roberson with 4 yards on 3 carries, and Dominique Collier with 2 yards on 2 carries. Passing the ball, quarterback Sederick Roberson completed 2 of 8 passes

for 11 yards with 1 interception. Ryne Burkham received 1 pass for a 5 yard gain and Gemile Roberson received 1 pass for a 6 yard gain. Other stats were:

### Early voting to continue through Friday on 19 proposed amendments, voters may cast personal ballots on Tuesday, November 6, election day

Early voting on 19 proposed amendments will continue through Friday, November 2.

Voters may go to the polls to cast their ballots on Tuesday, November 6, at the Knox County Aging Services.

Proposition 19, the state constitution amendment authored by

State Representative David Counts, D-Knox City, would allow the water development board to issue \$2 billion in addition to the \$2.68 billion that the Texas Constitution allows. The Water Development Board lends bond money for water projects. Because the loans are backed by the state's

higher credit rating, cities can borrow the money and save millions on interest payments. Of the \$2 billion, \$50 million would be earmarked for the state's Water Infrastructure Fund. The Legislature created the fund to pay for projects - through loans and grants - in "Water for Texas - 2002."

Immunization clinic to visit in Knox City November 1

The Texas Department of Health will conduct an Immunization Clinic at the Community Center, Housing Authority in Knox City, Thursday, November 1, from 10:00 to 11:30 a.m. and 1:30 to 3:00 p.m.

Immunizations offered include DTaP, Hib, Polio, Measles, Mumps and Rubella and Hepatitis B for infants as well as all school immunizations.

The Hepatitis B series was re-

quired for Kindergarten entry this year and was required for 12 years old on August 1, 2000. Parents are asked to check their child's immunization record for this series.

The varicella (chickenpox) vaccine is available to anyone age 1 thru adulthood that has not had the chickenpox. For those children in need of this immunization, parents are asked to call to reserve a dose as only the proper amount will be reserved.

Participants are asked to bring immunization records and social security numbers. A parent, adult family member or legal guardian must accompany a minor.

All services provided by the Texas Department of Health are provided on a sliding fee scale but no one is denied services due to an ability to pay.

Funeral services for William E. (Bill) Ryder of Benjamin were held Tuesday, October 30, 2001, at 10:30 a.m. at the Benjamin Ex-Students Memorial Building. Fred Lewis Crenshaw and Rev. John Gillespie officiating. Burial was in the Benjamin Cemetery.

Mr. Ryder, 84, died Saturday, October 27, in a Munday nursing home following a lengthy illness.

Hayes and I.

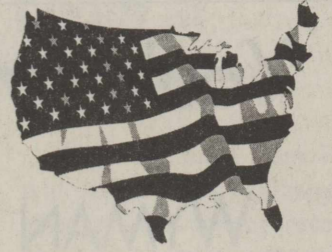
Janoma Stephens was in Dumas over the weekend to attend a Study Club meeting.

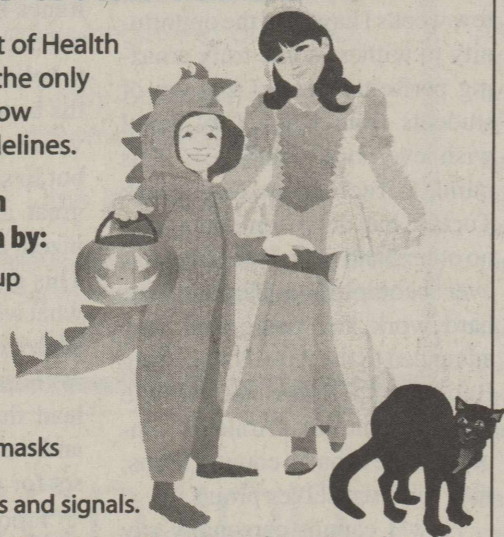

Researchers at Harvard have known for some time that Down Syndrome patients who survive past 30 tend to develop brain lesions & dementia like Alzheimer's Disease suffers. Class will meet from 7 to 9 p.m. on Tuesdays, beginning November 6 and ending December 11 for 12 hours of instruction.

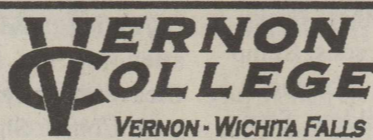

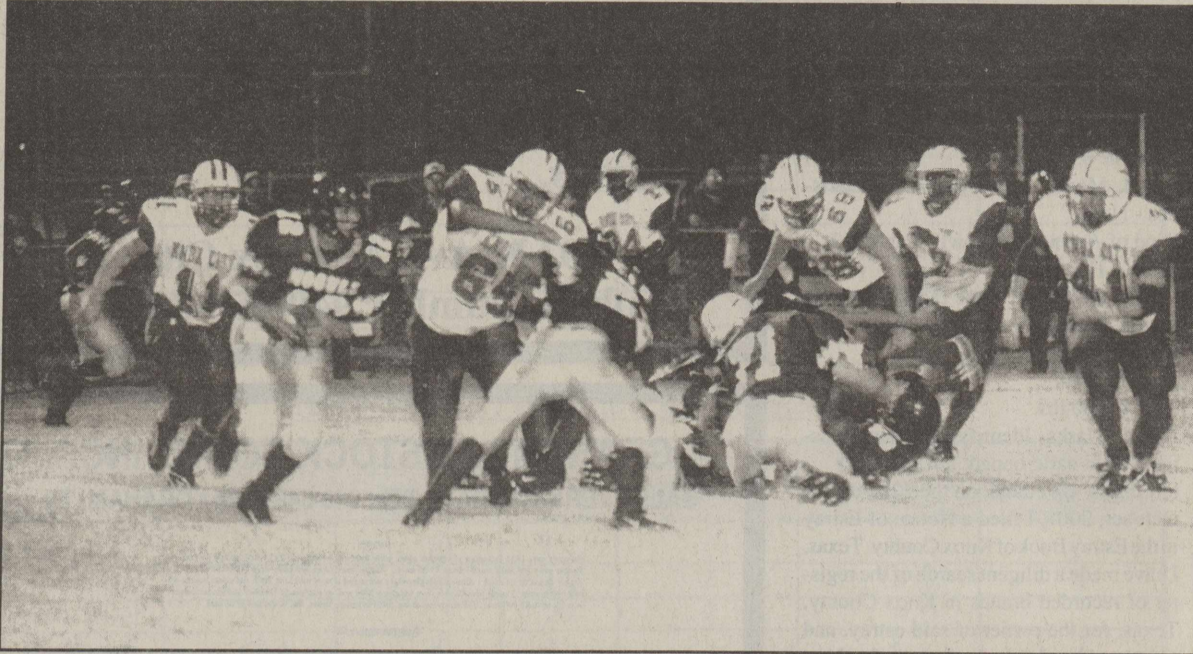

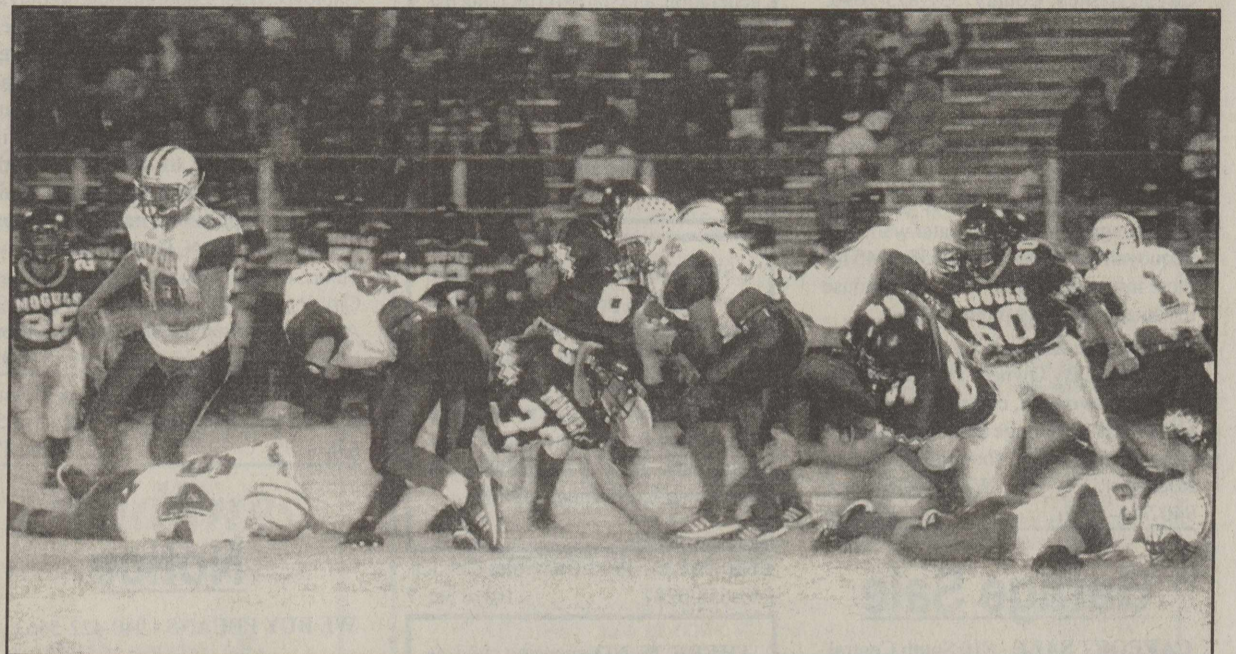

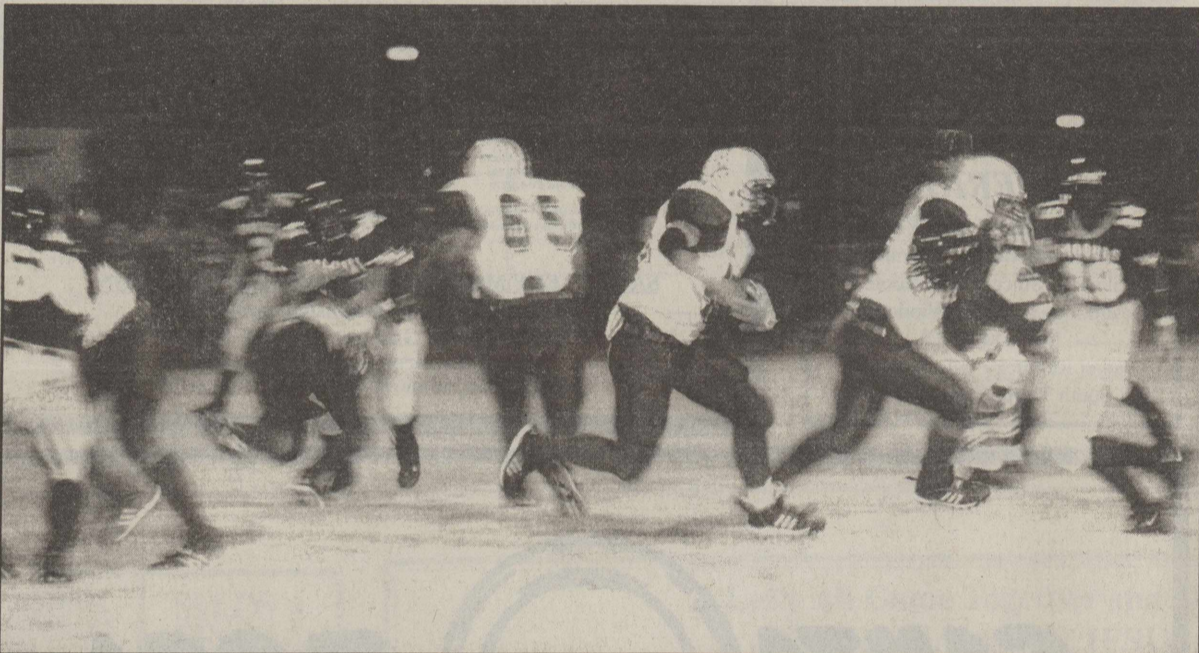
