Class of 1968 Planning 20 Year Reunion

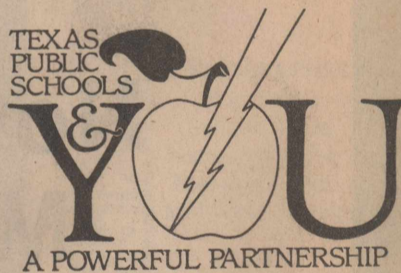

Drug Arrests Made In County

In a release of information from Knox County Sheriff Gene Nix, *The Knox County News* has learned that a series of drug arrests were conducted in Knox County last Tuesday night by Knox County Sheriff's Officers, Department of Public Safety Troopers, and Knox City Police Officers.

Arresting five persons in Knox County after an undercover police officer obtained enough evidence and information for warrants to be issued, Sheriff Nix advised that the undercover operation was in complete cooperation with the Sheriff's Department of Baylor County, District Attorney Tom Schrandt, and DA investigator Gerald Saffel.

The undercover officer used is a professionally certified police officer and was commissioned as a Baylor County Deputy Sheriff during his employment in the investigation. His work in both Baylor and Knox counties resulted in five Knox County warrants for seven Knox County offenses and five Baylor County warrants. As of the interview with Sheriff Nix on Monday morning, all the Knox County subjects arrested were in the Knox County or Baylor County Jails and Baylor County had arrested three of the five subjects for whom they were looking.

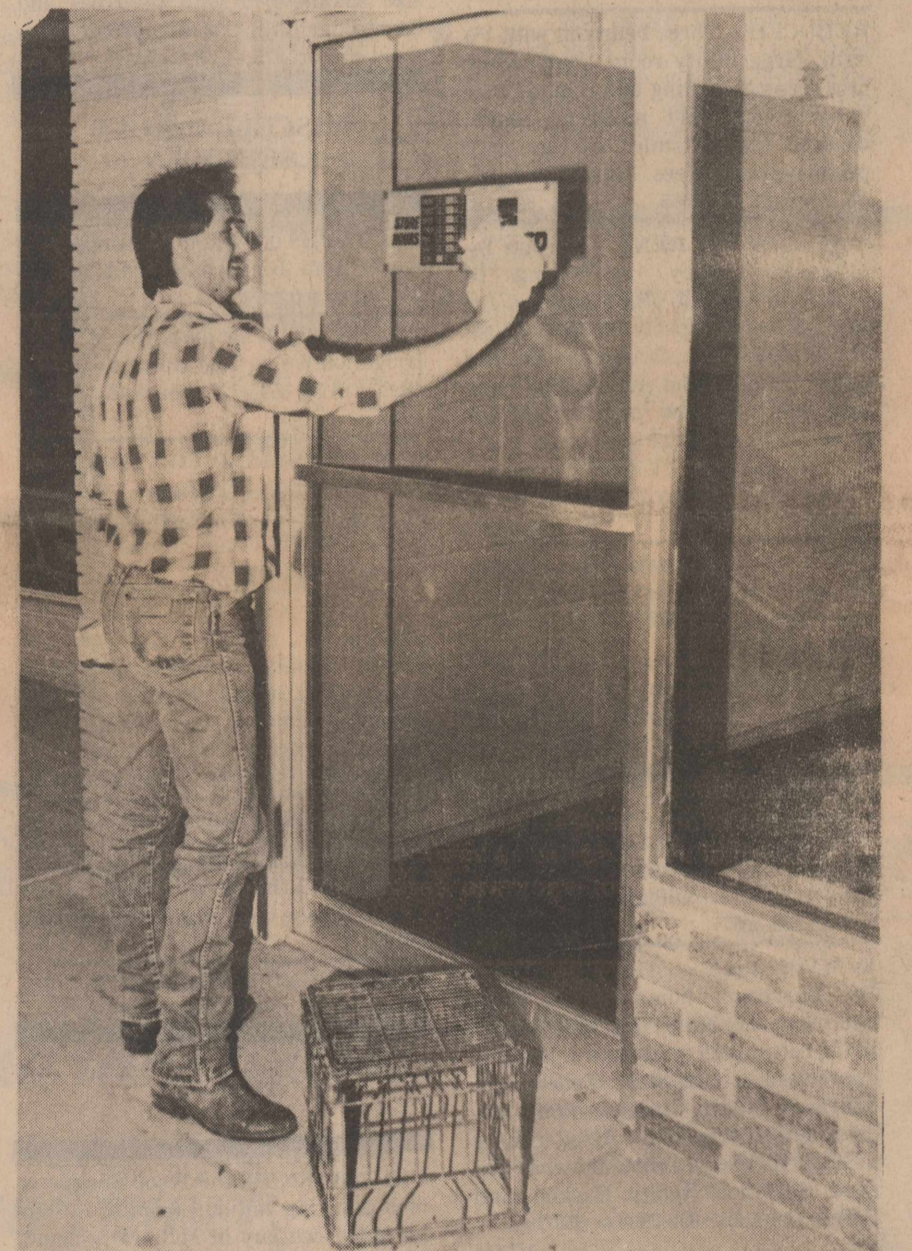
Acting on warrants from the JP court of Imogene Young of Benjamin, officers arrested the following Knox County residents on the following charges: L.C. Collier for three counts of Delivery of Controlled Substance, to wit: Marijuana, Anita Collier on one count of Delivery of Controlled Substance, to wit: Marijuana, Henry Lerma on one count of Delivery of Controlled Substance, to wit: Marijuana,

Roy Lerma on one count of Delivery of Controlled Substance, to wit: Marijuana and Rudy Jacques on one count of Delivery of Controlled Substance, to wit: Cocaine. The four male subjects were taken to the Knox County Jail in Benjamin while the female subject was taken to the Baylor County Jail in Seymour as the Knox County Jail is not equipped to house female prisoners.

Following appearances in court, bonds for the five were set as follows: L.C. Collier: \$10,000.00 each on two separate counts and \$25,000.00 on the third count, Anita Collier, Roy Lerma and Henry Lerma: \$10,000.00 each on

one count while Rudy Jacques had a bond of \$25,000.00 set on one count.

Officers participating in the arrest under the guidance of Sheriff Gene Nix were Knox County Sheriff's Deputies Ricky Russell and Leon Leonard, Reserve Deputies Mark Reed and Larry Tomlinson, Department of Public Safety Troopers Brian Williams and Danny Wainscott, and Knox City officers Gil Gillilan and Dean Homstad. Gerald Saffel, DA Investigator for the 50th Judicial District, assisted in the cases and served as evidence officer, transporting the drug evidence to and from the DPS narcotics lab in Abilene for testing and positive identification.

Cast Your Vote Super Tuesday March 8

"Super Tuesday" Primary, March 8, will be here shortly, and a good turnout of voters is expected by officials as several races are contested.

On the local county level, the sheriff's race, and on the district level, the district attorney's race, should prove to be responsible for many voters turning out to cast their ballots.

For Democrats, the Knox County Aging Center will be the site for both 7N and 7S boxes with polls open from 7 a.m. to 7 p.m. Tommie (Bud) Reynolds and Clyde Voss are election judges, respectively. David Counts is County Chairman.

Republican Primary locations are listed in a separate story in this week's News.

Voters who need a ride to the polls may obtain one by calling 658-3868.

Absentee voting continues this week and those appearing in person at the Knox County Courthouse, may vote without restriction, until Friday at 5:00 p.m. Unlike years in the past, one needs no specific reason to vote absentee. Now it can be strictly a matter of convenience, according to Gloria West, county and district clerk.

Republican Voting Places Are Listed

Three Republican voting places will be open in Knox County for the Super Tuesday primary, March 8, according to Bill Baker, chairman of the Knox County Republican Party.

Each of the three boxes will consolidate more than one voting precinct. Precincts 7S and 7N will vote at the Knox City Community Center; precincts 6N, 6S, 6W, 5 and 8 will vote at the Munday Elementary Library; and precincts 1-Benjamin, 2-Truscott, 3-Gilliland, and 4-Vera will vote at Truscott Community Center in the

COMMODITY FOOD FACT SHEETS
Ever wonder what to do with the free commodity foods of cornmeal, rice, flour, cheese, dry milk, and honey? I have received some fact sheets from the Texas A&M Nutrition Specialists that contain information on nutritional value, storage, use, and recipes. I would be glad to send them to you, just let me know by calling 454-2651 and leaving your name and address.

Pasteurized Processed American Cheese is high in protein, riboflavin, and calcium. It is convenient to use in cooked foods because it melts easily and blends well with other foods. Commodity cheese can be served "as is", with fruit, in sandwiches, in salads and grated over soup.

CHEESE-MEAT LOAF

2 slices bread
1/2 cup milk
1/2 onion
2 eggs
3/4 pound ground beef
1/2 cup cut-up cheese
1 teaspoon salt
Soak bread in milk. Chop onion. Beat eggs. Mix all ingredients well. Shape into a loaf in a baking pan. Bake at 375° F. (moderate oven) for 1 hour.

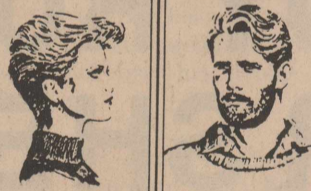
Streams In Desert Places

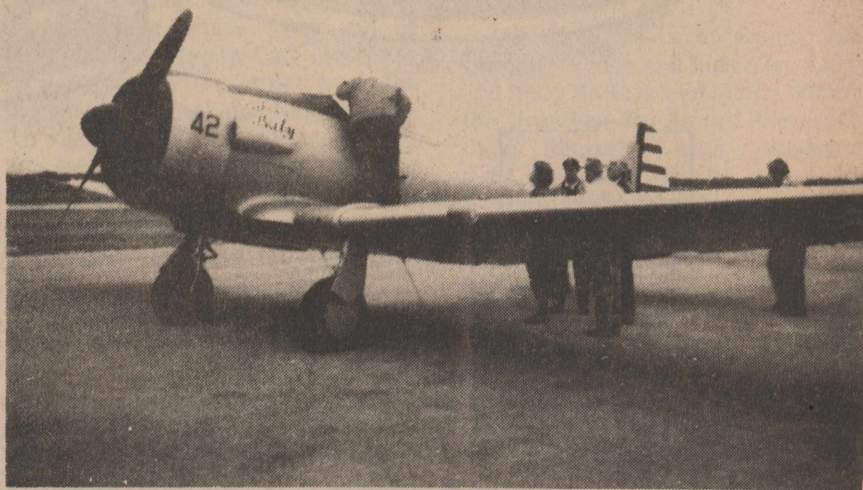

Judge Bud Arnot Greeted At Airport

Judge Bud Arnot, associate justice of the 11th Court of Appeals in Eastland, flew into Knox City last Friday to meet voters and discuss campaign issues.

Arnot "flew" into town, literally.

To help with his ambitious goal of visiting in all of the county seats in the sprawling, 23-county judicial district, Arnot is relying on his hobby—flying a vintage World War II trainer.

He usually keeps his AT-6 "Texan" in a Confederate Air Force hangar at Abilene, and commutes to Eastland by car, but he said he decided to use the plane during the campaign to try to reach as many voters as possible.

The 37-year old Breckenridge native jokingly blames his receding hairline on law school and his hobby of acrobatic flying.

Arnot has just completed his first year on the appellate court bench, having been appointed in December, 1986, to succeed the retiring Associate Justice Raleigh Brown. He is running in the Democratic primary, seeking to serve the two years remaining on Brown's unexpired term. His present appointment is through Dec. 31, 1988.

Arnot said he has enjoyed his service on the appellate court and definitely plans to run for a full, six-year term in 1990. "I didn't go into it looking at the Court as a place to retire, but rather as a place to work and get the job done," he said. "It has taken a lot of hard work to prove I could do the job, but hard work is not something I've ever shied away from."

For the year 1987, Judge Arnot participated in the disposition of 307

cases; 98 civil cases and 209 criminal cases. Arnot attended Washington and Lee University before receiving a business degree from the University of Texas in 1972. He graduated from Baylor University Law School in 1975.

While in law school he worked as a summer intern in the Taylor County district attorney's office, the largest prosecutor's office in the 11th Judicial District.

After graduation, he joined the Abilene law firm of Wagstaff, Harrell, Alvis, Stubbeman, Seamster & Longacre and later became a partner.

In 1982, he became one of the founding partners of a new firm, Glandon, Erwin, Scarborough, Baker, Choate & Arnot.

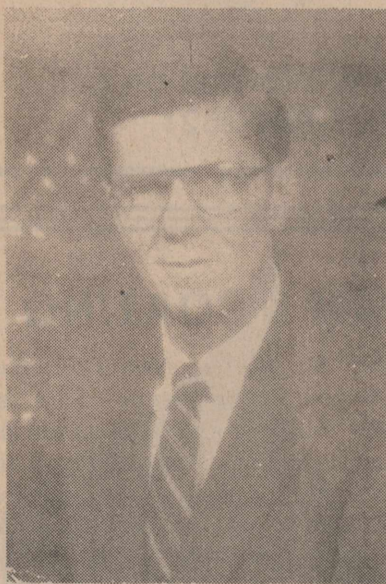

Sheriff Nix Asks Support In Re-Election

Knox County Sheriff Morris E. (Gene) Nix, in his bid for re-election, has issued the following statement to county voters.

The four years since I was re-elected sheriff in 1984 have been busy ones for me and for the department as a whole. We have made some improvements in our office, and I feel we have accomplished a great deal.

We're very proud of the TV monitor in our outer office which enables the dispatcher or officer on duty to keep a close watch on activities and inhabitants in the jail at all times. The jail itself, which has almost never been empty of prisoners during these four years, came in for some remodeling in order to remain in compliance with jail standards for the seventh consecutive year. We upgraded our patrol fleet from two cars to three, and we added a member to our crew of dispatchers.

Our main law enforcement thrust has been an all-out effort to stem drug use and sales in the county. It's an uphill battle, but we hope we've made some headway in this nationwide concern. We made numerous drug-related arrests last summer and several more just last week, and although these offenders are often not dealt with as severely as officers would like, not trying to get them off the streets would amount to a job neglect that I'm determined to avoid.

Our efforts to educate young people and their parents about the dangers of drugs have continued. I've presented drug programs in area schools and to adult organizations, and our office has distributed anti-drug literature throughout the county.

With our emphasis on fighting drugs, we haven't forgotten other crimes. I've spoken to citizen groups on how to protect homes and businesses from being burglarized, and I've urged the use of Crimestoppers and Neighborhood Watch programs. I've explained how to make it easier to locate stolen goods if a burglary does occur, and I've handed out more literature on this subject.

I feel I'm more qualified than ever before to serve as your sheriff. I've continued my law enforcement education whenever it was possible, and I now hold the basic and intermediate certifications and am only eight training hours short of receiving my advanced certificate. I have also completed the necessary training to receive my law enforcement instructor's certificate. Advanced experience and training are becoming more and more important to rural peace officers.

As a third-generation resident and property-owner in Knox County, I'm concerned about the same issues which affect most of you. As a father, I worry about the problems that the youths of today and of the future must face. And as a peace officer, I feel I am in a unique position to help resolve some of these issues, to find solutions to the problems that matter to our young people, to help make Knox County an even better place to live and raise our families.

I am asking for your votes and support on March 8 to keep me in office. In return I pledge a dedicated, professional and responsive sheriff's office. I want to continue the work that we've begun, and I'd appreciate the opportunity to serve as your sheriff for another four years.

Parents are urged to read them and become aware. Anyone wishing more information may call the extension office at (817) 454-2651.

Social Security News

It is important that the people in the Vernon area know when they should get in touch with Social Security, Frances Braden, Social Security representative in Vernon said recently.

Not knowing when to contact Social Security could mean lost benefits which could never be recovered, Braden said.

A person should contact Social Security:

Before getting their first job to get a Social Security number, which is required to get proper Social Security credit for earnings. People who change their names should also contact Social Security to get a new card. A person should allow at least 2 weeks.

After a death in the family to see if survivor benefits can be paid.

When someone in the family is disabled to find out if disability benefits can be paid.

At retirement-at 65 for full-rate benefits, or as early as 62 for reduced benefits. A person should sign up for Medicare 2 or 3 months before 65, even if there are no retirement plans.

Any time there is a question about Social Security.

When a person calls Social Security, the people there can tell:

How much work credit is needed to be insured for benefits.

Who can receive benefits.
How to replace a lost Social Security or Medicare card.

How to get a free statement of the earnings reported to the person's Social Security record.

What documents a person needs when applying for benefits.

Most all Social Security business can be conducted by telephone. The number for the Vernon Social Security office is 817-552-9346. The office is located at 1701 Cumberland.

Judge Hajek Issues Statement

Her favorite colors are Red and Blue. Her hobbies are listening to music (any kind), partying, being with friends and her boyfriend, basketball, and just having fun.

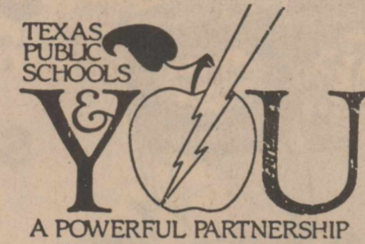

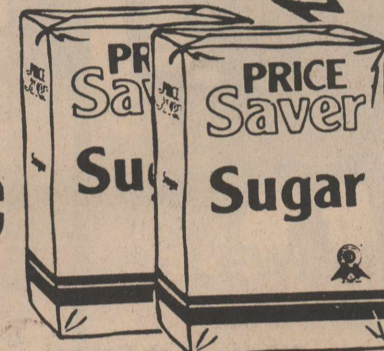
