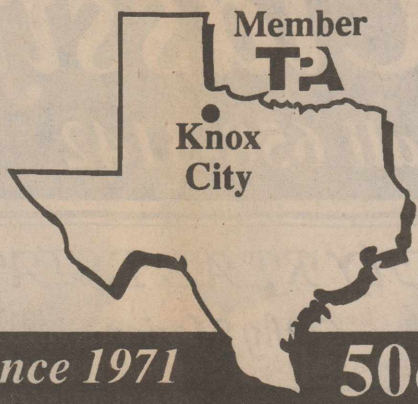

All Emergencies Are Now 9-1-1

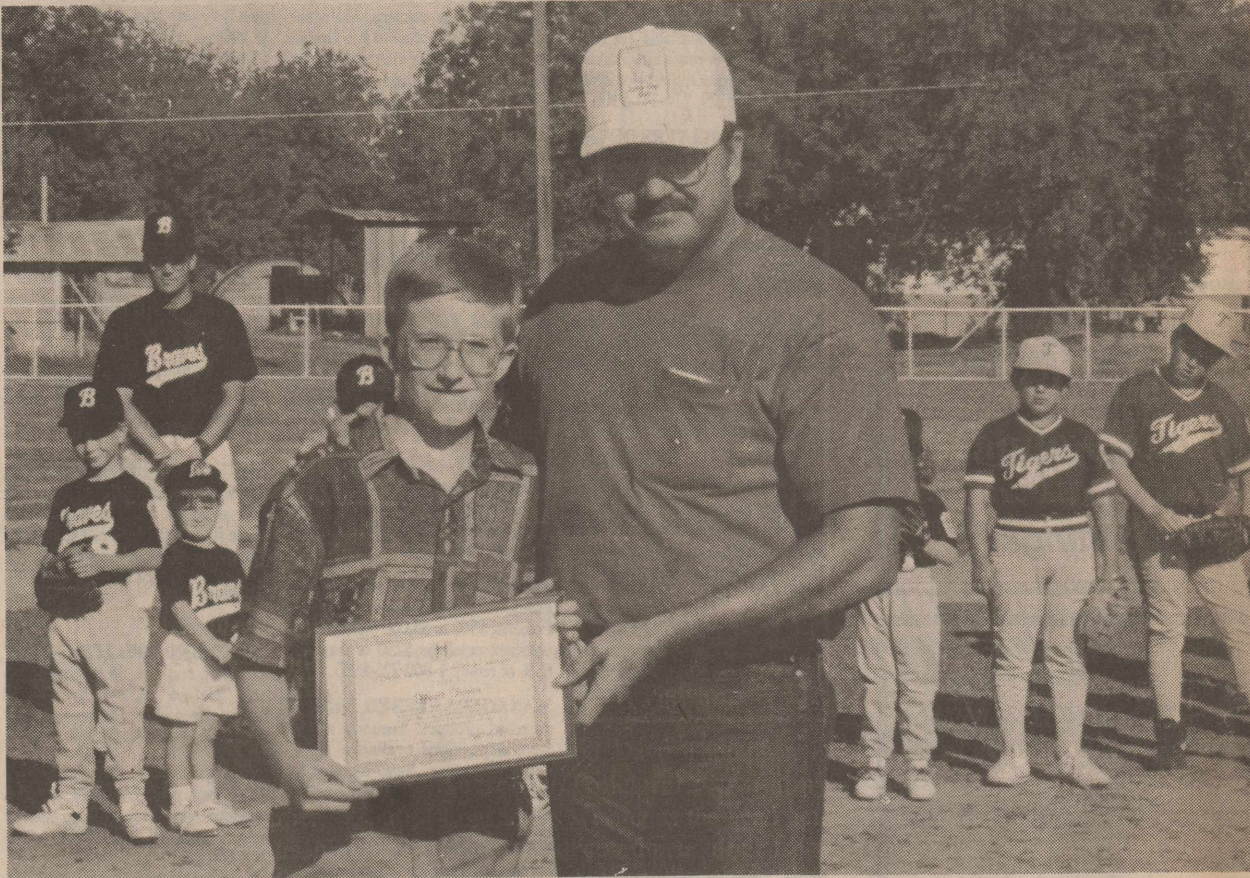

1993 Little League Season Kicks Off With Ceremonies, Lopsided Games

The 1993 Knox City-O'Brien Little League season officially opened Monday night with pre-game ceremonies and two games that ran up a total of 41 points for the two winning teams.

Prior to the start of baseball action, Pastor Bobby King of the First Baptist Church in Knox City gave the invocation that officially opened the pre-game ceremonies. While the pre-game ceremonies featured all the T-Ball and Little League players and coaches out on the diamond, second grader and T-Ball player Kimberly Hawkins stole the show with her solo rendition of the Star Spangled Banner as the Knox City Boy Scouts raised the American flag out in center field.

Following the flag raising, the teams were introduced and awards were presented. The Little League Dodgers were recognized as the top team in candy sales, and will receive a free pizza party for the entire team. The top individual player for candy sales was Aaron Large, who also plays on the Little League Dodgers. As a reward for his efforts, Aaron received a brand new bat and glove courtesy of Kamco Candy Company. The top T-Ball team in candy sales were the Braves, and the top T-Ball individual seller was Scooter Thompson, also a member of the Braves.

The presentation of a 1992 season Little League Good Sport Award was made next to Heath Turner. The award was made after a unanimous vote of the coaches, officers, and Little League Board.

Officers for the 1993 season were introduced, Kevin Stone is serving as President, Danny Parker is Vice-

President, and Dave Thompson is Secretary/Treasurer. Anthony Logsdon is serving as the head umpire and will coordinate officials for the games.

Two distinguished gentlemen who have served the Little League organization for many years were introduced, Dwight Gothard of O'Brien

threw out the first ball of the season, while Hershell Tankersley came back to umpire first base for the season opener.

With the first games of the season featuring four Little League teams, action was fast paced for at least two of the games. In what appeared to be lopsided scores, the Dodgers beat the Tigers 17 to 0, while the Cardinals were defeated by the Royals 21 to 5. The next Little League games will be on Thursday evening.

T-Ball action got off to a start Tuesday evening, but scores were not available as of our press deadline.

The concession stand, under the direction of Sammie Offield and worked by volunteer Mothers, reported a record night for the season opener on Monday, and many fans remarked that they enjoyed the food.

Good Turnout Noted In Saturday Election

Voters turned out in good numbers at the polls Saturday.

In the city election, Oscar Mangis was re-elected mayor with 196 votes, and Stan Wojcik received 113. In the race for councilmembers, Cathye Williams and Jerry Curd were elected. Mrs. Williams received 219, Curd 218, incumbent Barbara Barnard 99, and Danny Parker 67.

In the race for Knox City-O'Brien Independent Consolidated School District, three trustees were elected. Incumbent David Albus was re-elected with 280 votes in Knox City and 27 in O'Brien; Steve Pepper received 265 in Knox City and 24 in O'Brien; and Ray Penman received 208 in Knox City and 26 in O'Brien. Leona Burkham received 201 in

Knox City and 20 in O'Brien, while James Manning received 139 in Knox City and 26 in O'Brien.

Greg Clonts was unopposed in his bid for re-election to the Knox County Hospital District board with a total of 699 votes, including 275 votes in Knox City.

In the race for State Senator in Knox County, Krueger received 335, Hutchison 212, Fields 99, Barton 22, Fisher 74, and Gutierrez 3.

In the county vote on the three constitutional amendments, proposition one received 321 for, 487 against; proposition two had 387 for, 384 against; and proposition three received 275 for, with a total of 487 against.

The Rev. Farrell Lemings and his wife Sharlot have located to Knox City where he has assumed the pastorate of the Foursquare Church.

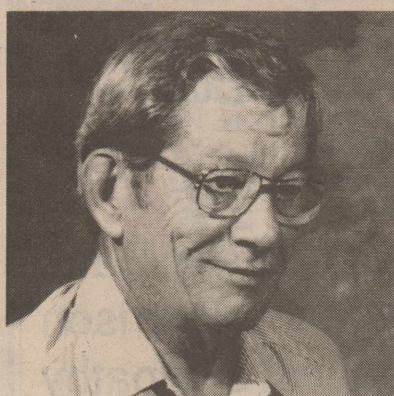
Originally from Arkansas, the couple says that they "already feel at home in Knox City" as the people are very friendly and have a special way of making them feel a part of the community.

Graveside services for Robert L. (Bob) Harrison, Knox City businessman, were held Friday afternoon, April 30, at two o'clock in the Knox City Cemetery. Officiating were the Rev. Bill Trice, Rev. Bobby King and the Rev. Leon Ward. Masonic rites were conducted with arrangements by Smith Funeral Home.

Mr. Harrison, 64, died Wednesday, April 28, in an Abilene hospital following a brief illness.

Born December 26, 1928, in Jayton, he married Bobbie D. Morrow on April 25, 1952, in Spur. The

couple moved to Knox City in 1962 from Rochester when they purchased Bradbury Grocery. The firm was renamed Bob's Super Save and closed in 1986. Mr. Harrison owned and operated Wes-Tex Coupon Clearing House and was stockholder and officer of Rolling Plains Well Service Inc., both of Knox City. He was Past Master of the Orient Masonic Lodge in Knox City where he was a member and also was a member of the Chamber of Commerce, serving as a past director. He served in the United States Army. 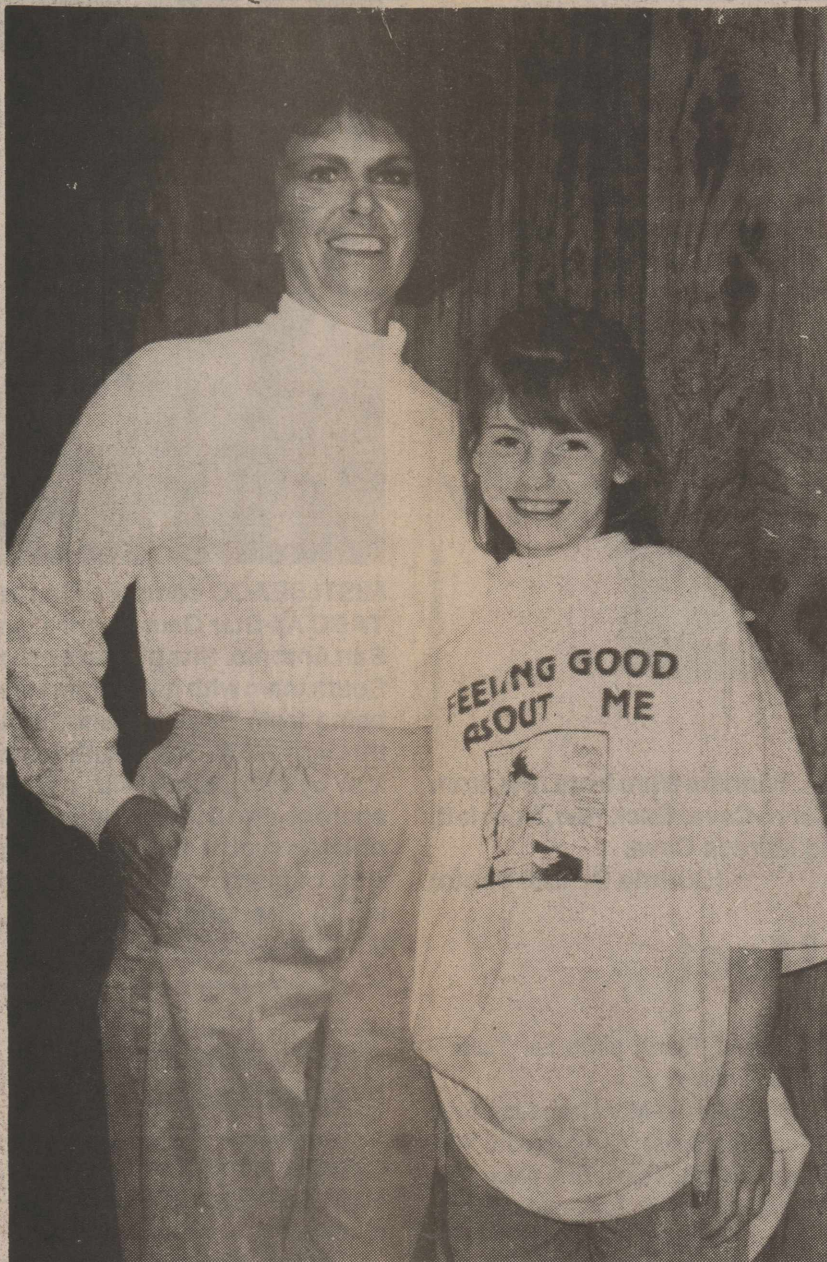

Nurses Are Honored During Special Week

Knox County Hospital is proud to acknowledge their staff of professional nurses during National Nurses Week, according to Mable Chaney, RN, director of nursing. "Our nurses not only give hands-on care to our patients, they also serve as patient advocates, assure the quality of the care process, and work closely with patient's families," she said. "Without them, we wouldn't have a hospital."

Mable explained that there are three levels of nursing: the registered nurse (RN), the licensed vocational nurse (LVN), and the nurse aide. Both the RN and LVN must pass state examinations to be licensed. An RN may have completed an ADN (associate degree of nursing) program, which takes two years, or may have completed a BSN (bachelor of science in nursing) degree. "Regardless of which level of training the nurse chooses, all RNs take the same test

and must possess the same skills to be licensed," Mable said.

The LVN training usually takes about 18 months, and consists of both classroom work and clinical training in a hospital. After completion of training, the student must pass a state licensing examination. The nurse aide usually receives on the job training or takes a special training class.

"Several years ago, most people thought of nurses as women who work in hospitals. That is changing rapidly with more men entering the field, and with the career opportunities for nurses expanding rapidly," she said.

In a rural hospital a nurse has the advantage of being cross-trained. The nurse may be assigned to any area of the hospital. "This naturally enhances the quality of care available," Stephen Kuehler, hospital administrator said.

Knox County Hospital has six RNs, six LVNs and six nurse aides.

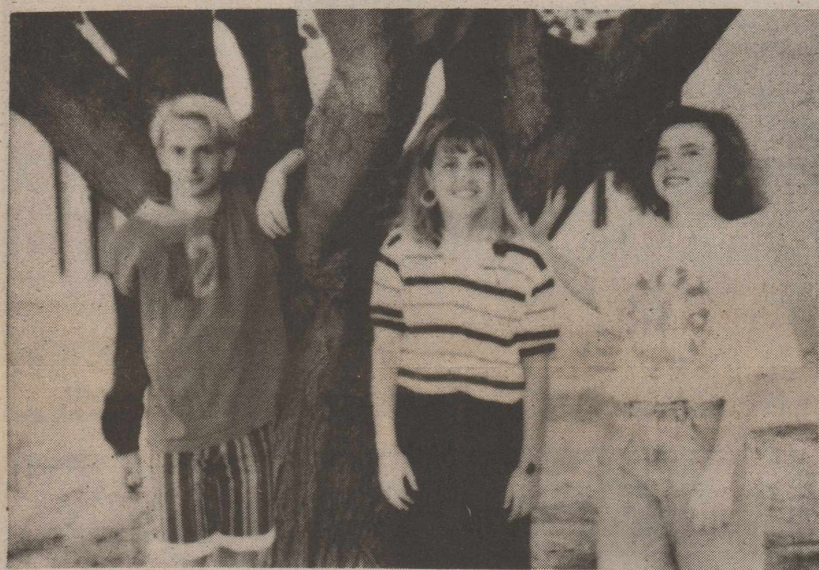

Spike Box Ranch Sets Lost Time Mark

Completes 1000 Days Without Lost Time Accident

The employee owners of Cactus Feeders' Spike Box Ranch in Benjamin recently celebrated a landmark event in the ranching industry; completing 1000 consecutive days without a lost time accident. This represents almost two and three-quarters years without an employee seriously injuring him or herself.

The ranch is located five miles west of Benjamin on Highway 82 and encompasses 90,000 acres of grass and wheat pasture. The ranch is part of Cactus Feeders, Inc., one of the world's largest feeding and ranching operations with six feed yards and five farms and ranches through Texas, New Mexico, and Nebraska.

According to Eddy Smith, Cactus Feeders Safety Director, this is a first in the ranching industry, explaining "Going 1000 days without a lost time accident is simply unheard of. The ranches around the county will sit up and take notice of this accomplishment." Mr. Smith went on to compliment the employees at the Benjamin ranch, "A fabulous job is being done by all our employee owners at the ranch. There are daily activities from working cattle to operating the farm equipment that expose our employees to many potential hazards. It takes a real effort and dedication to create a work place that values working safely."

Paul Engler, President of Cactus Feeders, Inc., celebrated the historic event with a steak dinner for the Spike Box employees, their spouses and children on April 4. Additionally, each employee was presented

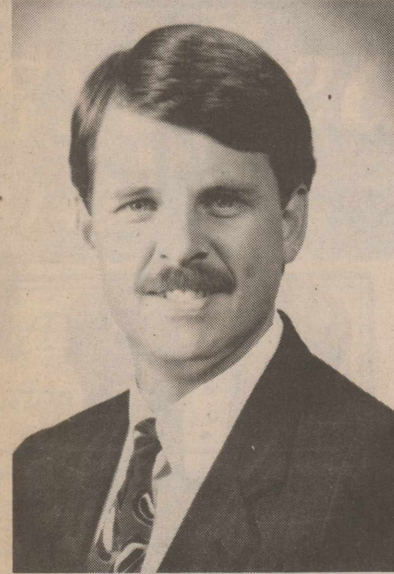
with a handmade belt buckle commemorating their achievement. Mr. Engler personally congratulated each employee and presented Charles Durham, Spike Box General Manager, with a plaque naming each employee and recognizing the 1000 day mark.

While 1000 days without a lost time accident is a record setting event, several Cactus Feeders and ranches have achieved marks of 400, 600 and 800 days. Currently Wrangler Feedyard in Tulia has worked 900 days without a lost time accident. Mr. Engler noted that this pays real dividends to all the employees of Cactus Feeders because each employee is now an owner of the company. Through the Cactus Feeders Employee Stock Ownership Plan, another first in the feeding and ranching industry, each eligible employee owns stock in the company. Reducing lost time accidents in turn reduces the company's workers compensation rates and translates to greater profitability and a higher stock value for the employees.

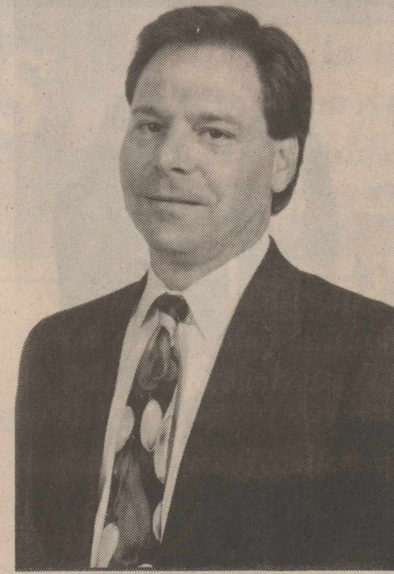

A Congressional report is urging the FDA to crack down on claims that Retin A can be used as an anti-aging wrinkle cream. The report says the cream swells the skin and only gives the impression of reducing wrinkles.

A survey by a Chicago group found that 34% of nursing homes offer respiratory therapy, 32% provide post-operative care, 18% have acute care services, 8% provide dialysis, and 7% offer hyperalimentation.

METER TAMPERING NOW A FELONY

The State of Texas has recently adopted an amendment to the State Penal Code making meter tampering a third degree felony. A third degree felony comes with a punishment of confinement in the Texas Department of Corrections for a term of not more than 10 or less than 2 years. In addition to imprisonment, an individual adjudged guilty of a third degree felony may be punished by a fine not to exceed \$5,000.

Before the amendment of the new law, it was a class A misdemeanor for meter tampering unless the loss of service was more than \$200. Under the new law, any meter tampering regardless of the amount of loss is now a felony of the third degree.

Meter tampering consists of, but is not limited to:

- (1) Diverting electricity from passing through a meter device.
- (2) Preventing electric service from being correctly registered by a meter device.
- (3) Unauthorized activation of electric service.

As a special note to our members, it will also be considered meter tampering if a meter is reset and electrical service is restored by anyone other than a Cooperative employee.

All Cooperative meters are sealed. This seal should not be cut or broken without special authorization. In cases where the seal must be cut for emergencies the Cooperative should be notified as soon as possible so that the meter can be resealed.
