Knox County Declared As Disaster Area

Knox County Judge David N. Perdue has received notification that Knox County has been designated eligible to apply for emergency disaster loans due to the fact that it is contiguous to a declared county.

Businesses in the following counties affected by drought and high winds which occurred March 1, 1995 through February 8, 1996 and continuing also have until January 8, 1997 to apply: Baylor, Haskell, Jones, King, Knox, Shackelford, Stonewall, Throckmorton.

Also effective May 8, 1996, Haskell County, was designated as a natural disaster area where eligible family farmers may qualify for Farm Service Agency (FSA) emergency loans due to damages and losses caused by

Ms. Verhalen, Students Do 'Good Deeds' For Rain Forest

Former Knox City resident Kathy Verhalen, daughter of Lillian Rae and Mat Verhalen, has been featured along with her Shackelford Junior High students in the Arlington Citizen-Journal the week of May 26.

Kathy and her students have raised enough money to buy and preserve 520 acres of rain forest.

The Arlington school was recently named the nation's No. 1 school for preserving tropical rain forests by the Rain Forest Preservation Foundation, an international nonprofit organization based in Fort Worth.

According to Baptist missionary and founder Don Davis, he was quoted as saying, "They raised more than \$13,000, and I think the closest other school was \$3,000," he said. "They really put on a program and did a tremendous job. I am astounded at the school and Kathy."

Kathy has nurtured the school's program since she launched it three years ago. This year, students earned the bulk of the \$25 an acre needed to buy the land through door-to-door sales of rain forest deeds for \$1, \$5, \$10 or \$20, she said. The students also helped raise money through a recycling program and T-shirt sales.

The T-shirt design was picked during a schoolwide art contest, she said. The winning design, a hand-drawn globe with pictures of the school's mascot and rain forest filling two of four continents, went up against a plethora of designs with animals, Earth Day or environmental themes.

The school's two-week campaign also included speakers and presentations geared toward educating the students on environmental issues.

The year's campaign included students from all curriculum and raised more than \$6,000, enough to buy an additional 240 acres. "This year 83 percent of the staff and faculty and about two-thirds of the students were involved in the project," she said. "I have had so many students who have said they are going to continue to work toward preservation."

Kathy said she decided to start the program after Davis made a presentation at Shackelford five years ago.

"She called me and wanted to go to Brazil for a trip," said Davis, who was a missionary in Brazil from 1965 to 1978. "We go there about four times a year to negotiate for land."

Davis said Kathy's commitment came from personal experience. She joined him on a 24-hour trek across the rain forest in 1991 that left her exhausted and excited about the tropical rain forest.

"She's great. If she falls in the water and gets soaked and is be-

ing bitten by a half-dozen insects she can't identify, she's still game to go," he said. "Kathy made it her

Kathy said her visit to the pristine rain forest made her trip more than an exotic adventure.

"This is what literally changed my life," she said. "One day I was standing in the middle of an island rain forest and everything was literally packed with life.

"The next day I had to travel through 10 hours of barren land, which had been stripped for farms, ranches and lumber. It was the longest 10 hours of my life.

"When I came back I knew it was time to pay the rent."

When Kathy came back in 1993, she arranged the first campaign at school. The two weekend projects, which included students from science and speech classes, was centered around Earth Day and earned about \$4,000, enough

to save 160 acres, she said. Shackelford students bumped up the total acres saved to about 279 the next year, she said.

This year Shackelford students raised enough money to boost the total number of acres saved to 520, at a total cost just over \$13,000.

Judy Duke, Shackelford principal, såid everyone at the school shares in the accomplishment.

"I think it is something they can be real proud of and they can feel a sense of community and pride about," she said. "I think the kids of this particular generation are much more in tune with the environment."

Kathy said next year she hopes to create a packet that shows teachers at other schools how to start environmental projects.

"Our ultimate goal is to challenge other schools to adopt an environmental issue yearly as well," she said. "Before I retire, I want the whole rain forest to be preserved."

School Board Orientates Newly Elected Trustees

Trustees of the Knox City-O'Brien CISD met in two sessions on Tuesday, June 18, 1996 at the administrative office, 606 East Main St.

At 6:30 p.m. Superintendent Louis Baty led a New Board Member Orientation for newly elected trustees Kim Clonts, Scott Lynn, and Bill Stewart. Mr. Baty discussed the Texas Open Meetings Act, budget and tax issues, and personnel policy including contracts.

At 7:30 the school board met in its regular monthly meeting. The extension of Supt. Baty's contract for the 1997/98 year was approved unanimously. Local board policies covering vacation and leave time were approved. Mr. Baty was appointed as the district's representative to the Region IX Education Service Center Advisory Board. The Education Service Center is in Wichita Falls and serves the North Texas area by helping local schools develop curriculum and by conducting training for educational programs both in Wichita Falls and in the local districts. School board members also receive continuing education hours at the Service Center, as well.

The board also approved the implementation of a reading lab at O'Brien midschool, beginning with the 1996/97 school year. The lab is produced by the Creative Education Institute and is a computer learning system for reading. The lab is commonly called "CEI Lab."

In other routine matters the board approved renewal of Unemployed Insurance Coverage and of Workers Comp. Insurance Coverage for the next school year.

Mr. Baty then reported on the 1995-96 TAAS Scores and advised the board that the test scores for our district would appear in the Knox County News at the earliest opportunity.

The next meeting of the board is set for Tuesday night, June 25. This meting will be a special session to consider personnel for the 1996/97 school year.

David Boren Begins Duties As KC Church of Christ Minister


David Boren, his wife Heather and two children, Calina and Jacob, have moved to Knox City where he has begun serving as minister of the Church of Christ.

Excerpt from the By-Laws of B-K Electric Cooperative, Inc.

ARTICLE IV DIRECTORS

SECTION 4.01. NUMBER AND GENERAL POWERS. The business and affairs of the Cooperative shall be managed by a Board of seven (7) directors. The Board shall exercise all of the powers of the Cooperative except such as are by law or by the Cooperative's Articles of Incorporation or Bylaws conferred upon or reserved to the members.

SECTION 4.02. QUALIFICATIONS. No member shall be eligible to become a director or to hold any position of trust in the Cooperative who is not a member receiving service from the Cooperative at his primary residential abode in the area served by the Cooperative, or is in any way employed by or financially interested in a competing enterprise or a business selling electric energy or supplies to the Cooperative, or a business primarily engaged in selling electrical or plumbing appliances, fixtures or supplies to the members of the Cooperative, and no person shall take or hold office as a director who is the incumbent of or candidate for an elective public office in connection with which a salary is paid. When a membership is held jointly by a husband and wife, either one, but not both may be elected as director, provided however, that neither one shall be eligible to become or remain a director or to hold a position of trust in the Cooperative unless both shall meet the qualifications herein above set forth. Any director who shall miss three (3) Board of Directors' meetings in a row, without an excuse duly accepted and noted by the Board, shall lack eligibility to further serve and it shall be the duty of the Board of Directors to remove him from the Board. No former employee whose employment has been terminated by the Cooperative may be eligible to serve as director. Any employee who resigns or retires from employment by the Cooperative shall not be eligible to serve as a director for a period of ten (10) years following such resignation or retirement. Nothing contained in this Section shall, or shall be construed to, affect in any manner whatsoever the validity of any action taken at any meeting of the Board of Directors, unless such action is taken with respect to a matter which is affected by the provisions of this Section and in which one or more of the directors have an interest adverse to that of the Cooperative.

In the event an incumbent director, having served on the Board of Directors a minimum of six years, ceases to meet the requirement of receiving service from the Cooperative at his primary residential abode, such incumbent director shall nevertheless be qualified to continue to serve as director so long as he remains a member of the Cooperative and his primary residential abode is located within the area served by the Cooperative, or in close proximity thereto.

SECTION 4.03. ELECTION. At each annual meeting of the members, directors shall be elected by secret written ballot by the members and from among those members who are natural persons; provided however, that when the number of nominees does not exceed the number of directors to be elected, and if there is no objection, secret written balloting may be dispensed with and voting may be conducted in any other proper manner. Directors shall be elected by a plurality of the votes cast unless the members in advance of any balloting resolve that a majority of the votes cast shall be required to elect, and this Bylaw provision shall be drawn to the attention of the members and explained to them prior to any balloting. Drawing by lot shall resolve, where necessary, any tie vote.

SECTION 4.04. TENURE. The business and affairs of the Cooperative shall be managed by a Board of seven (7) directors which shall exercise all of the powers of the Cooperative except such that are by law, or by the Articles of Incorporation of the Cooperative, or by these Bylaws conferred upon or reserved to the members. Beginning with the Annual Meeting of the members of the Cooperative held on August 21, 1954, two (2) members of the Board of Directors shall serve for a period of one year, two (2) members shall serve for two years, and three (3) members shall serve for three years, and that lots be cast as to the length of time each director shall serve; and beginning with the Annual Meeting of the members held in 1954, those directors whose terms expire, such vacancy shall be filled for a period of three years.

SECTION 4.05. NOMINATIONS. It shall be the duty of the Board of Directors to appoint, not less than sixty (60) nor more than ninety (90) days prior to the date of a meeting of the members at which directors are to be elected, a Committee on Nominations, consisting of not less than five (5) nor more than eleven (11) members of the Cooperative who are not existing Cooperative employees, agents, officers, directors or known candidates for director, who are not close relatives (as hereinafter defined) or members of the same household of such existing employees, agents, officers, directors or known candidates for director, and who are so selected so as to give equitable representation on the committee to the geographical areas served or to be served by the Cooperative. The Committee shall prepare and post at the principal office of the Cooperative at least thirty (30) days prior to the meeting a list of nominations for directors to be elected. Any fifteen (15) or more members of the Cooperative, acting together, may make additional nominations in writing over their signatures, listing their nominee(s) in like manner, not less than twenty (20) days prior to the meeting, and the Secretary shall post such nominations at the same place where the list of nominations made by the Committee is posted. The Secretary shall mail to the members with the notice of the meeting, or separately, but at least ten (10) days prior to the date of the meeting, a statement of the names and addresses of all nominee(s) showing clearly those nominated by the Committee and those nominated by petition, if any. The chairman at such meeting, after all nominations so made have been duly announced, shall call for additional nominations from the floor. Notwithstanding the provisions contained in this Section, failure to comply with any of such provisions shall not affect in any manner whatsoever the validity of any action taken by the Board of Directors after the election of directors.



METER TAMPERING NOW A FELON

The State of Texas has recently adopted an amendment to the State Penal Code making meter tampering a third degree felony. A third degree felony comes with a punishment of confinement in the Texas Department of Corrections for a term of not more than 10 or less than 2 years. In addition to imprisonment, an individual adjudged guilty of a third degree felony may be punished by a fine not to exceed \$5,000.

Before the amendment of the new law, it was a class A misdemeanor for meter tampering unless the loss of service was more than \$200. Under the new law, any meter tampering regardless of the amount of loss is now a felony of the third degree.

Meter tampering consists of, but is not limited to: (1) Diverting electricity from passing through a meter device.

(2) Preventing electric service from being correctly registered by a meter device.

(3) Unauthorized activation of service.

As a special note to our members, it will also be considered meter tampering if a meter is reset and electrical service is restored by anyone other than a Cooperative

All Cooperative meters are sealed. This seal should not be cut or broken without special authorization. In cases where the seal must be cut for emergencies, the Cooperative should be notified as soon as possible so that the meter can be resealed.


