Great Texas trash-off is set for Saturday

It's spring cleaning time in Texas ! On Saturday, April 5, more than 120,000 volunteers will take part in the 12th annual "Great Texas Trash-Off", one of the nation's largest single-day litter pickup events.

Part of the "Don't Mess with Texas" litter prevention campaign, the Trash-Off is organized by the Texas Department of Transportation (TxDOT) and Keep Texas Beautiful (KTB).

In Knox County two Adopt-a-Highway groups including Knox City Lions Club and Knox City Chamber of Commerce will rid state roads of litter.

Scheduled for the first weekend in April, the Trash-Off coincides with Texas' wildflower season. It also kicks off Keep Texas Beautiful Month and Keep America Beautiful Month.

"The Trash-Off has become one of the rites of spring that addresses one of the 'wrongs' of the roadway: littering. When motorists travel Texas roads to see the bluebonnets and wildflowers we're so proud of, their views should not be obscured by litter," Doris Howdeshell, TxDOT's travel and information division director, said.

"We never know when a crisis may strike in our community or our personal lives," Alex Maldonado of the American Red Cross said, "that's why it's very important to maintain a blood supply that is more than adequate to meet our needs. Patients and hospitals in Knox City are in need of blood everyday, so the supply needs are constantly replenishing, just to keep with the usual therapies, surgeries and emergencies."

The donation process is easy and takes less than an hour. Each donor is asked to fill our a health questionnaire and given aminihealth check. After a pint of blood they can donate every 56 days," Maldonado said. "If every donor in Knox City would follow this schedule, the problems of blood collection would be greatly eased and we would be prepared for those inevitable rainy days. Saving you blood for a rainy day or for when someone you know needs blood is not a good idea. We need blood before the rains fall."

Maldonado says one in three people will need blood in his or her lifetime and that there is a good chance one of those people will be someone you love. "When we think about it in these terms, it is easy to understand the urgency and immediate.

Someone somewhere is needing blood right now. And as long as there is a need, we need people to give. Prevention month.

Ladies return from tour

Phipps of Knox City, Margaret Hill of Munday and Oleta Cornelius of Rule have returned from a recent "South in the Spring" tour with Fun Line tours.

The ladies left Bowie on March 11 with the tour and other passengers were loaded in Saint Jo, Gainesville, Lenard and Greensville. They then began their journey with 34 passengers.

First stop of the tour was in Baton Rouge, Louisiana, where they toured Nottoway Plantation which was constructed in 1859 and overlooks the Mississippi River. Patrons may rent one of the 64 rooms there for overnight visits.

Tuesday, the group left for the John C. Stennis Space Center in Mississipi. This is a NASA test center where main engines used to boost the Space Shuttle into orbit are certified.

The tour then visited in Biloxi, Mississippi, and set sail on the "Sailfish". Upon leaving the harbor a shrimping net was set out after the captain made a brief explanation. Thirty minutes later he drew the nets in and identified the catch prior to returning to shore.

Another intersting visit was made to the Doll House, where over 500 dolls of every description, plus stuffed animals and two doll houses were on display.

"Beauvoir", the last home of Jefferson Davis, President of the Confederate States of America, was also on the tour list. There the group ventured throught he house, which was built in 1853 and furnished mostly with original David pieces and two museums.

Wednesday, they visited Bellingraph Gardens, the 900 acre estate of Walter Bellinggraph, a pioneer in the Coca Cola bottling industry. Here 65 acres are landscaped around the mansion. Camellias, daffodils, tulips, and many azaleas were in full bloom.

Next came a tour of the city of Mobile where they visited the Spanish Plaza and historic district, Admiral Sterrmes Monument, Church Street Cemetery and Alabama State Docks. The beautiful windows of the Cathedral of the Immaculate Conception were also viewed.

They also visited the battleship USS Alabama, the Submarine Drum, Aircraft Pavillion and also attended the Greyhound races.

In Montgomery, Alabama, the toured the state capitol and the Jefferson Davis home, called the White House of the Confederacy. They viewed the grave of Hank Williams and the Dexter Church where Martin Luther King preached and the Civil Rights Memorial

Friday, the traveled to Jackson, Mississippi, where they walked through the War Memorial Building, the Mississippi State Capitol City Hall, Governor's Mansion and downtown. They toured the Old Capitol Building and Museum., the Missisippi Agriculture and Forestry / National Agricultural Aviation Museum, which is a living museum with buildings, a school, gin, maple syrup mill, church, general store, blacksmith shop and is set up on location like a town of old times.

Then it was on to Port Gibson to tour the Energy Center, a nuclear plant where they viewed a 2,000 ton reactor vessel and 1300 megawatt boiling water reactor, the largest of its kind in the U.S. before journeying to Vicksburg. In Vicksburg, they saw the mighty Mississippi River rising.

They began their return Saturday morning.
