## Monday, September 1, brings changes to Texas motorcycle helmet law

It's official...and it's coming next Monday. The first day of September marks the first day that motorcycle riders in the State of Texas will be able to ride a motorcycle without wearing a protective motorcycle helmet.

While some have been waiting a long time for this new law, others dread it, and yet others are not covered by the law. To sort through the confusion, here is a brief explanation of how the new law operates:

- Yes, a new law was passed by the last session of the Texas Legislature.

- Yes, Gov. George Bush did sign the new bill into law.

- The new law takes effect on Monday, September 1, 1997.

- The new law only effects motorcycle riders who are at least 21 years of age and older. Those riders under the age of 21 still need to wear a helmet. There are NO exceptions to that part of the law!!

- Those riders who are 21 years of age and older do not have to wear a helmet - **IF** - they comply with one of the following two provisions:

1. Riders may ride without a helmet if they can show proof that they have attended a motorcycle safety course. The two acceptable course completion certificates that are acceptable are for either the Basic Motorcycle Training Course or the advanced Motorcycle Operators Training Course offered by the Motorcycle Safety Foundation. Here in Texas, those courses are offered through the Motorcycle Safety Bureau of the Texas Department of Public Safety in Austin.

2. If no safety course has been taken by an over 21 year old rider, they may still ride without a helmet - **IF** - they can show proof of

a medical insurance policy that covers them for at least \$10,000 of medical and surgical expenses in the event of an accident.

- There is a license plate sticker being offered by the DPS Motorcycle Safety Bureau that over 21 year old riders who meet either of the two requirements listed above can place on their motorcycle license plate to show proof that they have met the requirements to ride without a helmet. The sticker is available from the DPS Motorcycle Safety Bureau after the rider fills out an application form, then sends it in to Austin along with proof of either a safety course or adequate insurance and a \$5.00 application fee.

- **HOWEVER** - the sticker is **NOT REQUIRED** in order to ride without a helmet. The sticker only serves as a visible, advance notification to law enforcement officers that the rider has met the requirements to ride without a helmet.

- A rider (over age 21) may ride without a helmet and without displaying a license plate sticker, but he or she must be ready to show proof of either a safety course completion or medical insurance of at least \$10,000 any time a law enforcement officer stops them and requests the information.

- To avoid a hassle with law enforcement officers, it seems prudent to send off for the \$5.00 sticker. Forms are available at most motorcycle dealers, here at the NEWS office, or they can be downloaded off the internet by going to the DPS Motorcycle Safety Bureau's web page at: ([www.txdps.state.tx.us/msb](http://www.txdps.state.tx.us/msb)).

- Passengers over the age of 21 are considered under the state required liability insurance of the rider's motorcycle, so they can ride without a helmet without meeting either of the above re-

quirements.

- An out of state rider who is 21 years of age or older may ride without a helmet, but must be able to show proof of either a safety course completion or of the mandated \$10,000 worth of medical insurance.

After qualifying for and completing the above listed requirements, riders must then make up their own minds about the wisdom of riding without a helmet.

As a former Motorcycle Safety Instructor for the Motorcycle Safety Foundation and the Texas Department of Public Safety Motorcycle Safety Bureau, and as a former State Safety Coordinator for the Harley-Davidson® Motorcycle Company, I have heard all the arguments both for and against helmets. From freedom of choice to possibly restricting vision and hearing, the arguments are too long to list here. Then again, the arguments really don't matter too much any more since the new law allows adult riders to make up their own minds.

Hopefully, sensible judgments will be made by riders and the State of Texas will still be able to enjoy a low accident fatality rate for motorcycle riders.

The key to safe motorcycle riding does not rest solely on the helmet issue. Increased safety and low accident fatality rates are the end result of EDUCATION.

The DPS Motorcycle Safety Bureau is dedicated toward educating the public. Their small, underpaid and overworked staff in the DPS Austin headquarters accomplishes that task by both training motorcycle riders and teaching other drivers on the roadway to be more aware of motorcycles. A great group, my hat is off to them. The new helmet law will make their job much more difficult.

## Dr. Rao begins duties here as Knox County's newest physician


Knox County's newest physician, Dr. Imran Rao, arrived in Knox City late Sunday night and hit the ground running Monday morning at the Knox City Clinic.

Dr. Rao (rhymes with "how") was quite busy on his first day of duty with "First Flight" arriving twice at the hospital, once during the afternoon and again during the early evening.

The 30 year old physician was spending some of Tuesday morning with hospital administrator Kevin Ansley who brought him by the News and was assisting him with getting settled into Knox City life.

A native of Pakistan, Dr. Rao comes to Knox County by way of Rush-Westlake Hospital in Melrose Park, Illinois, just outside of Chicago. He completed his three year residency requirement in June 1997.

Dr. Rao took his board in Boston last week, August 19 and 20, traveled back to Chicago and then

on to Knox City.

The new physician said he was looking forward to the West Texas climate as it is very similar to that in Pakistan, leaving behind Chicago's cold weather and snow. He visited Knox City earlier in

March of this year.

Hospital administrator Ansley, who ran an advertisement in the *Journal of the American Medical Association* for a physician, said the local facility received 85 responses to the ad and that Dr. Rao was picked from this field.

Ansley plans to teach Dr. Rao the game of golf with tennis already being among his hobbies.

Dr. Rao's fiancée, who is also from Pakistan, has completed medical school and will do her three year residency in Texas, hopefully in Lubbock.

Being an internist, licensed physician and surgeon, combined with his personality, Dr. Rao should be well received by our communities.

The new physician will be rotating calls with Dr. Shirley Baretto, Ansley said. He will be in the Knox City Clinic on Wednesdays, Thursdays and Fridays and in the Munday Clinic on Mondays and Tuesdays.

## Time is running out to obtain crop insurance

Ron Berryhill, director of the Oklahoma City Regional Service Office, Risk Management Agency, announced today the sales closing date for crop insurance is September 30 for Wheat. Last year in Texas, \$171.5 million in protection (liability) was provided to producers through more than 20,000 policies.

"The freeze of last April is a vivid reminder that eventually everybody will have to cope with crop losses or low prices," Ron Berryhill said. "Appropriate crop or revenue insurance protection will help you survive these hardships."

Sales closing dates are significant because signing up for insurance, changing the crop insured or level of protection, and changing insurance providers, must be done prior to the announced date. Sales closing dates vary by crop and location.

Beginning with the 1998 crop year, crop insurance is available

exclusively through crop insurance agents. USDA will continue to subsidize all policies, establish policy terms and conditions, set rates and guarantee funds for the payment of approved claims. Although a producer's policy will be randomly transferred from USDA to an insurance company, producers have the right to choose their own agent prior to the sales closing date for the insured crop.

To ensure that all producers are served, insurance companies are required to insure all eligible crops, and provide all levels of coverage in the states in which they operate.

A waiver of administrative fees for producers who qualify as limited resource farmers is available from all crop insurance companies. Private agents are willing and prepared to assist those qualifying producers with determining eligibility. A listing of agents may be found in all local Farm Service Agency offices.

## Jessie Rios works toward Eagle badge

Jessie Rios, a Knox City High School student and son of Dora and Jessie Rios, has completed a project toward earning the prestigious Eagle Badge, the highest ranking for an Eagle Scout.

The Eagle Badge is earned through community service by completion of projects in a town or community. Jessie contacted City Administrator Robert Patrick for assistance in locating a town project. Through the efforts of the Economic Development Corporation, the City Laundry Mat was purchased and renovated for ap-







## METER TAMPERING NOW A FELONY

The State of Texas has recently adopted an amendment to the State Penal Code making meter tampering a third degree felony. A third degree felony comes with a punishment of confinement in the Texas Department of Corrections for a term of not more than 10 or less than 2 years. In addition to imprisonment, an individual adjudged guilty of a third degree felony may be punished by a fine not to exceed \$5,000.

Before the amendment of the new law, it was a class A misdemeanor for meter tampering unless the loss of service was more than \$200. Under the new law, any meter tampering regardless of the amount of loss is now a felony of the third degree.

Meter tampering consists of, but is not limited to:

- (1) Diverting electricity from passing through a meter device.
- (2) Preventing electric service from being correctly registered by a meter device.
- (3) Unauthorized activation of service.

As a special note to our members, it will also be considered meter tampering if a meter is reset and electrical service is restored by anyone other than a Cooperative employee.

All Cooperative meters are sealed. This seal should not be cut or broken without special authorization. In cases where the seal must be cut for emergencies, the Cooperative should be notified as soon as possible so that the meter can be resealed.





