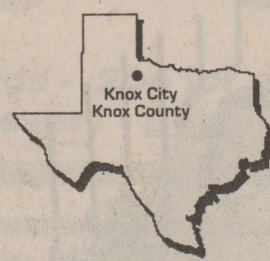

Greyhound Pride marching band to compete at Region II contest

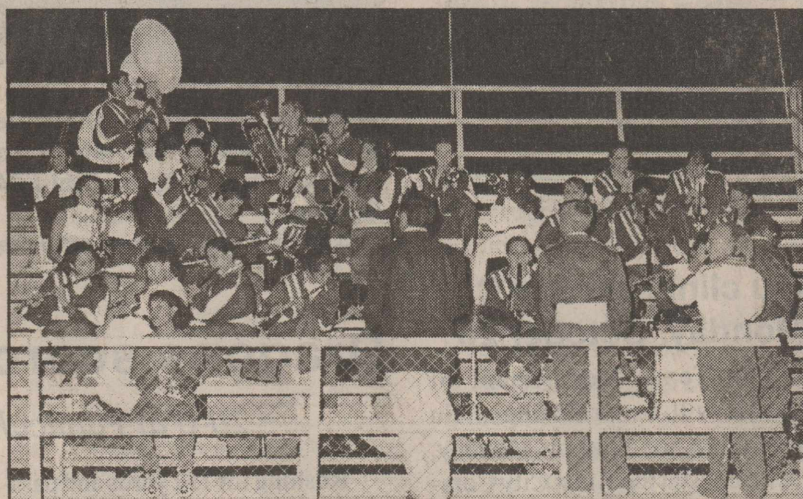
Saturday, 11:00 A.M., Memorial Stadium, Wichita Falls

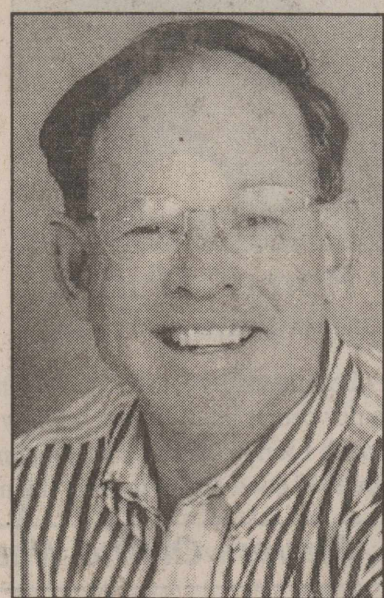

This was also the year he began showing horses. By the time he graduated from high school he had won several national championships with his horses. It was also during this period that alcohol began to destroy his life.

Joe Howard went to college at Sul Ross University for one semester and then transferred to Tarleton State University in Stephenville, TX. He became heavily involved in calf roping and steer wrestling while in college. He began rodeoing at the amateur level and went on the professional level. (P.R.C.A.)

After making a decision to re-

tire from rodeoing, Joe Howard returned to the horse show business as a professional trainer where he experienced wonderful success. He has also shown a good number of world and national champion halter and calf roping horses and presently shows cutting horses as a non-pro competitor in the National Cutting Horse Association.

Joe Howard's main interests are his Christian faith, family, ranching and talking to teenagers about the Laws of Diminishing Returns concerning drugs, alcohol abuse, sexual promiscuity and suicide.

Some of Joe Howard's heroes are Cody Custer, a world champion cowboy; Jim Harbaugh, NFL Quarterback for the Indianapolis Colts; Reggie White, NFL Defensive Tackle for the Green Bay Packers; A.C. Green of the Phoenix Suns, and last but not least his wife Tracy, along with his Mom and Dad, Jodie and Stanley Williamson of Iowa Park, TX.

Joe Howard, having the background that he has, is very well suited to speak to the rural teenagers of America. The negative things that have plagued Joe Howard's life are being used to bring changes to many hopeless teenagers. He has also spoken to many people in Japan and on the continent of Africa in the countries of Kenya and Uganda. Joe Howard's and Tracy's testimonies have brought hope to many who were hopeless.

Joe Howard looks forward to coming to Knox City to speak. As he says "I comes as a spokesman to the American teenager and also as a spokesman for the American teenager."

Play Ball !!

'Field Of Dreams' to become reality in Knox City

In a very hard decision made after much thought, study, conversation, and input from citizens, the Knox City-O'Brien CISD Board of Trustees voted a majority of yes votes on Monday night to allow boys baseball and girls softball to be included in the sports to be played by Knox City High School student athletes.

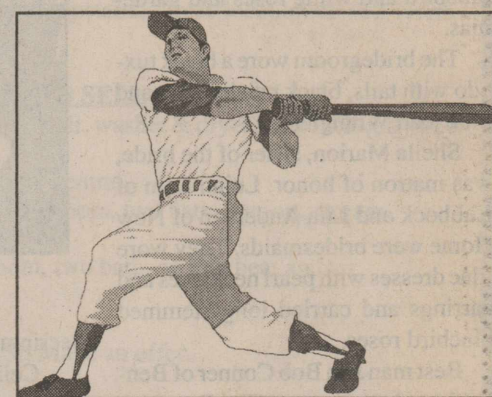
Beginning with the spring baseball season of 1999, Knox City will field a team in the high school level for both baseball and softball. A baseball field will be constructed just to the North and East of Greyhound Football Stadium on the East side of Knox City.

Allowing time for coaching selections, construction of a field, schedule planning and equipment ordering is the primary reason behind not starting baseball and softball until the 1999 season.

Casting their votes 5 for and 2 against, members of the school board did not have an easy time with their decision. While a lot of citizens voiced positive sentiments to individual board members, not all of the opinions expressed were in favor of the proposal. Some of the negative reasons expressed concerned the cost of such a program, the fear of taxes being raised in the future, and the impact baseball and football might have on the other sports already being played. At this point in time, individual board members have expressed no desire to raise taxes, and a lot of Monday night's talk was centered around both the cost factors and obtaining help from the community with start-up of the program. Board members Donnie Roberts, Dwayne Johnson, Tammy Gonzales, Bill Stewart and Kim Clonts voted in favor of the proposal, while board members Scott Lynn and Jerry Williams cast no votes.

With Knox City and O'Brien having such a strong Little League program, area youth begin playing baseball here at 5 years old. Going through Minor League, Little League, Little League Softball, Senior League, and Senior League Softball, the players can now move right into high school baseball and softball when they enter the 9th grade level and play right through their senior year. In years past, the Little League program here has produced some mighty fine baseball and softball players. With no previous school program, all that talent was wasted when the players became too old for Senior League, the last level of Little League ball. Now, with the implementation of High School baseball and softball, there might even be the possibility that baseball players from Knox City will advance later in life to the semipro and pro baseball levels. Unlike other major sports, baseball players right out of high school can go to training camp tryouts for all the major baseball teams.

With a strong baseball program here, our community has taken a giant step towards helping some of our youth prepare for the future. In my opinion, the school board should be commended for taking such positive action this past Monday night.



Sales tax rebate to Knox City for Sept. of 1997 is \$11,345.73

Monthly total down 26.32% from year ago

(Austin) State Comptroller John Sharp delivered \$172.7 million in monthly sales tax rebates to 1,085 Texas cities and 117 counties, including a check of \$11,345.73 to Knox City. The rebate to Knox City reflects an decrease of 26.32% from a rebate check of \$15,399.36 for the same period in 1996. Knox City collects a 2.000% rate of sales tax, with a full 1.000% of the tax directed towards EDC funding.

Texas cities received \$157.6 million, 4.5 percent higher than payments of \$150.8 million at this same time one year ago. Counties received a total of 15.1 million in rebates, 1.2 percent above the \$16.2 million in allocations for the same period in 1996.

September, 1997 payments include taxes collected by monthly filers on July, 1997 sales and reported to the Comptroller in August of 1997.

For other Knox County cities, Benjamin received \$33.64, a 82.63% decrease from \$193.73 for the same period a year ago. Gore received \$400.79, down 23.04% from a payment of \$520.82 last year at the same time. Munday received \$6,788.59, down 6.86% from a payment of \$7,288.59 in 1996 at the same time. Munday collects a 1.500% rate of sales tax, with Benjamin and Gore collecting a 1.000% sales tax.

In Haskell County, Haskell received \$23,648.19, down 29.61%

from a payment of \$33,598.75 in 1996. Haskell collects a 2.000% rate of sales tax. O'Brien received \$101.57 this period, down 54.945% from a payment of \$225.45 a year ago. Rochester received \$453.78, down 27.57% from a payment of \$626.59 during the same period last year.

In Jones County, Stamford received a payment of \$42,334.81, down 6.49% from a payment of \$45,277.36 in 1996. Anson received \$10,481.41, down 31.92% from a payment of \$15,396.94 last year. Hamlin received a check of \$14,936.38, down 5.80% from \$15,856.25 in 1996. Stamford, Anson and Hamlin all collect a 2% rate of sales tax.

In Baylor County, the city of Seymour received a payment of \$14,403.81, down 9.50% from a payment of \$15,916.54 in 1996. Seymour collects a 1.000 rate of sales tax.

In Foard County, Crowell received a payment of \$2,899.19, down 42.81% from a payment of \$5,069.87 in 1996. Crowell collects a 1.500% rate of sales tax.

In Dickens County, Dickens received \$2,528.83, up 0.30% from a payment of \$2,521.05 in 1996. Spur received a payment of \$3,435.65, down 7.38% from a 1996 payment of \$3,709.46. Dickens collects a 1.5% rate of sales tax, while Spur collects a 1% rate.

In Cottle County, Paducah received a payment of \$3,127.71,

down 1.97% from a payment of \$3,190.87 in 1996. Paducah collects a 1% rate of sales tax.

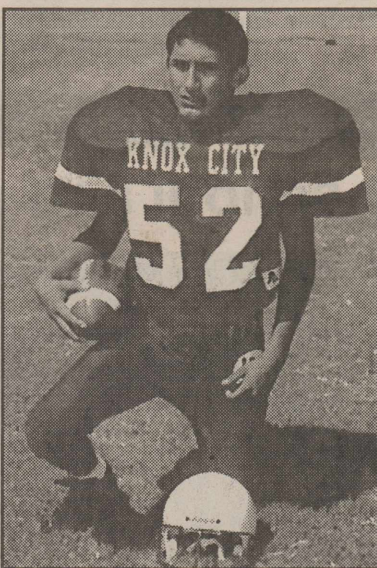

Knoxville City will host the Munday Moguls this Friday night here at Greyhound Stadium. Game time is 7:30 p.m. for this district matchup.

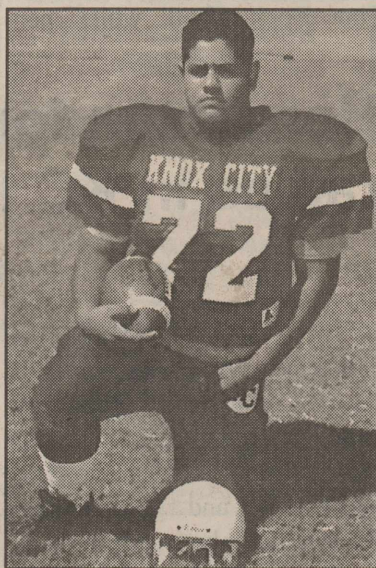
For those unable to attend the game, KVRP FM 95 will broadcast the game with live, play by play action.

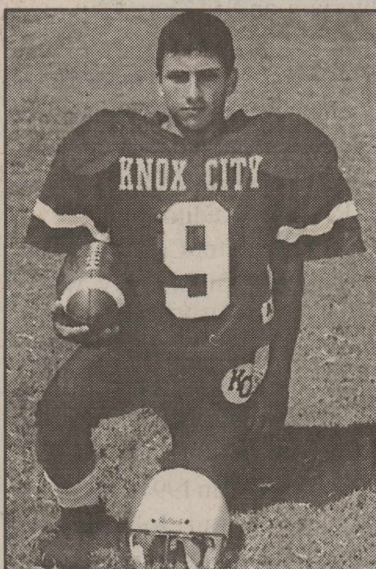

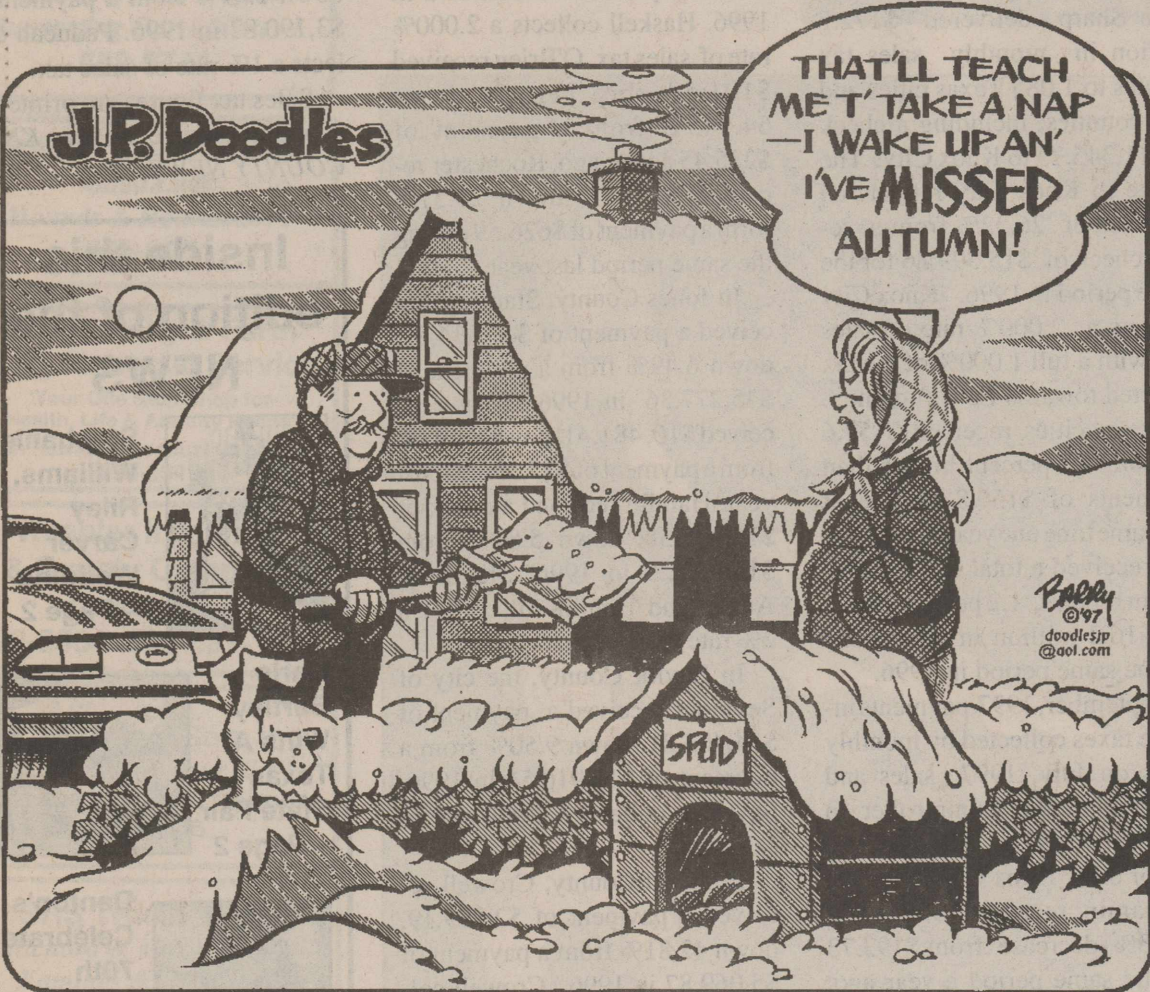

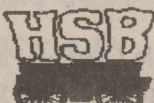

Sheep & goat validation set for October 22

The 1997-98 sheep and goat validation for the Knox County Junior Livestock Show and all major shows in Texas will be held on Wednesday, October 22, at the Brazos Valley Young Farmers Building in Munday beginning at 4:30 p.m. All market goats and market sheep must be brought to this validation.

The goats will be ear tagged and the tag number and exhibitor's name will be recorded. The market lambs will also be ear tagged. However, they will also have a tattoo placed in their ear and will have a nose print taken for the records.

Cost for validation will be three dollars for the sheep and the goats will not be charged a fee. The ear tags to be used on the goats have been donated. The ear tags to be used on the sheep were specifically designed for a state wide sheep validation. The cost of these tags, plus the cost of the tattoo ink and nose printing supplies were used to determine the three dollar charge.

Anyone who will have difficulty in getting their animals to this validation, or anyone with questions should contact Paul Weiser in the Knox County Extension office at 454-2651 or their local high school ag science instructor.

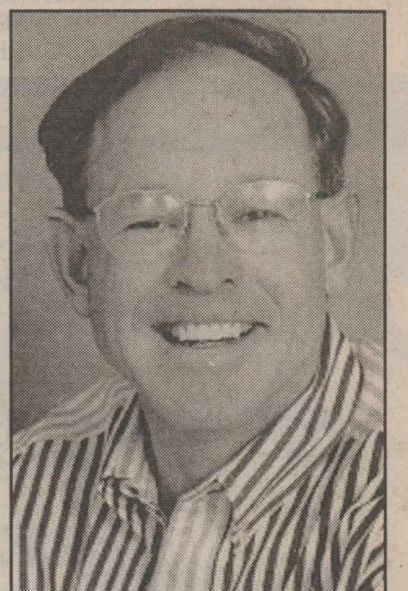

Homstad issues final police rept.

September 1997

The report for the month of September 1997 will be somewhat different than previously seen. Although there were numerous calls and tasks handled and completed during the month of September, they were not individually accounted for. The total number of actual offenses amounted to five, with one charge being filed. None of the offenses involved juveniles as offenders. All of the offenses listed were cleared to the satisfaction of this department. The offenses are as follows: Disorderly Conduct - 1, Hit and Run - 1, Child Abuse - 1, Keeping a Nuisance Dog - 1, Assault - 1, Traffic Charges Filed - 9, Warnings Issued - 11, Accidents - 3. Incidents reported during September are listed as follows: Missing Person - 1.

While working for the Knox City Police Department for the past 10 years, and having lived in Knox City for 23 years, I have become attached to the citizens of Knox City. I have been proud to work for the City of Knox City and to be able to develop a department that was dedicated to looking after the needs of the people. Some of these needs may range from entering a person's house to do a welfare check, to bringing a citizen's lost dog back home when the owner is out of town. It has been suggested that with today's economy, maybe Knox City cannot afford this kind of attention, and who am I to reject this suggestion. Many times, when a citizen does not know what else to do in a crisis situation, they will call the local Police Department, and many times call either myself or the other officer at home, which in a small locality is okay, and sometimes even suggested. October 14, 1997, will be my last day to work for the Knox City Police Department. I leave this position as Chief of Police wishing that I could have done more for the City of Knox City and wishing that the financial situation would have permitted this department to have continued. The boring task of documentation has been very important. That, along with investigation, may take a large portion of a day, which means that a person may have to spend a lot of time in the office. Documentation and investigation leads to cases being solved and assists greatly when a case goes to court several months or years later. Because an officer is not out "patrolling" does not necessarily mean that he is just wasting time at the office. As seen in my letter of resignation, I will be serving the entire county as Sheriff, and encourage all citizens to contact me with input or problems if the need be. I will continue to do my best to handle all problems presented to me.

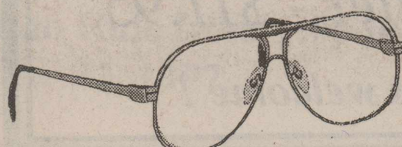

Judge Perdue proclaims breast cancer awareness

For month of October

In 1997, an estimated 11,500 Texas women will be diagnosed with breast cancer and about 2800 women will die of the disease. Nationally, breast cancer is the most common form of cancer in women. Research shows that breast cancer mortality could be reduced by at least 30 percent if women followed recommended breast cancer screening guidelines.

All women are at risk for developing breast cancer. However, more than 75 percent of all breast cancers are found in women 50 or older. Therefore, all women 50 or older are urged to get a mammogram and breast examination by a doctor or nurse every year. The American Cancer Society further recommends that women 40 or older get a yearly mammogram and breast exam. Getting a breast exam and mammogram only once is not enough.

In recognition of the important lifesaving early detection practices available for breast cancer, Judge David Perdue, County Judge of Knox County, has proclaimed October 1997 as Breast Cancer Awareness Month. All Knox County women are urged to become aware that they are at risk and to discuss a screening program with their health care providers. Other Knox County citizens should encourage a women they love to do so.

Seven criminal cases disposed of in 50th Judicial District Court

Seven criminal cases were disposed of in the 50th Judicial District Court last week with two men drawing sentences in the state penitentiary, according to District Attorney Bill Neal.

Kenneth Ray White, 45, of Lubbock was sentenced last Tuesday to seven years to do in the state pen after pleading guilty to a felony DWI indictment out of the Baylor County District Court. White had had numerous prior DWI convictions according to Neal. He was represented by Robert Huddleston, attorney of Lubbock.

Also, in the Baylor County District Court last Tuesday, District Judge David Hajek assessed a three-year prison sentence against Shedric Fulbright, 20, of Seymour after he pled guilty to violating his probation. Fulbright has previously been placed on a three-year probation after pleading guilty to burglary. He was brought back before the Court by the District Attorney who alleged that Fulbright had repeatedly violated his probation terms by failing to report to his probation officer as directed, failing drug screen tests and committing a misdemeanor theft.

Fulbright was represented by Vernon attorney Paul Scott.

Juan Zamarron, 46, of Seymour, represented by attorney Greg Merkle of Wichita Falls, also pled guilty last Tuesday in Baylor County District Court to an indictment charging him with felony DWI. Under a plea bargain agreement with the State, represented by District Attorney Neal, Zamarron was fined \$5,000.00 to be paid to Baylor County, plus court costs, and was sentenced to 10 days in jail and then placed on a five-year probated prison sentence during which time he was directed to perform 500 hours of community ser-

vice under the supervision of the adult probation department.

In addition, a weapons charge against Zamarron was dropped by the State when Zamarron agreed to forfeit, to the Baylor County Sheriff's Department, the 9mm automatic weapon found in his possession when he was arrested on the DWI charge.

Last Wednesday in the Knox County District Court, three individuals also pled guilty to felony charges according to District Attorney Neal.

Michelle Desiree Collier, 18, of Knox City, and Herbert Lee Roberts, 31, of Dallas, both pled guilty to Unauthorized Use of a Motor Vehicle in connection with running off with a pickup owned by Ray Morales.

Judge Hajek set punishment against Collier, who had cooperated with officers in locating the vehicle and Roberts, at a two-year state jail sentence probated for two years, but with the provision that she must pay a \$500.00 fine to Knox County and do 200 hours of community service over her probation time. Roberts was assessed a two-year state jail sentence, but probated for a term of five years. He was also ordered to pay \$1,947.44 in restitution to Ray Morales for damages he caused to the stolen pickup.

Pamela May Blalock, 30, of Munday pled guilty to Assault on a Peace Officer in connection with biting acting Sheriff Johnny Andrade while he was attempting to arrest her on another charge. Judge Hajek gave her a two-year deferred adjudication probation, but ordered her to pay a \$500.00 fine to Knox County.

Last Thursday in the King County District Court in Guthrie, Joshua Griffin Brown, 19, of Paducah, pled guilty to Burglary of a Habitation pursuant

to a plea bargain agreement with the State represented by District Attorney Neal. Brown was represented by Vernon attorney Gene Heatly.

Brown pled guilty to burglarizing a home in Paducah owned by Pete McWilliams on November 7, 1996. He and another defendant, Henry Fabian Martinez Jr., and three juveniles had been charged with the burglary.

Judge Hajek accepted the plea and assessed a five-year deferred adjudication probation against Brown, but with the provision that Brown pay \$5,338.19 in restitution to McWilliams for the damage and theft loss caused in the burglary of the McWilliams home. He was also ordered to perform 500 hours of community service under the direction of the Cottle County Probation Department and pay all court costs.

In a previous proceeding in the Cottle County District Court, Henry Fabian Martinez Jr. received an identical sentence.

Brown's guilty plea to the Paducah (Cottle County) burglary was heard in King County last Thursday on a change of venue order agreed to by all parties for the convenience of the Court.

Last Tuesday in the Baylor County District Court, pre-trial hearings and arraignments were held in the following cases: John Anthony Thomas, 22, of Dumas, and Terri Lynn Jones, 22, of Dalhart, accused of conspiracy to commit burglary of a habitation; Ruben Hernandez, 41, of Seymour, accused of felony DWI, and Debbie Walker, 38, of Seymour, charged with second offense DWI.

John Anthony Thomas, Terri Lynn Jones and Eric Albright, 23, of Seymour, who is indicted for Unauthorized Use of a Motor Vehicle, were all set down for jury trial by Judge Hajek for the week of October 27, 1997 in the Baylor County District Court.

In Knox County, a pre-trial hearing for Jonathon Granville Rizan, 18, of Knox City, indicted for burglary of a building, was waived by his attorney, Bob Estrada, of Wichita Falls. Judge Hajek set his case number one on the jury trial docket in the Knox County District Court for November 18, 1997.

**Voters to decide future
of Texas water supplies**

by Lt. Governor Bob Bullock
Texans soon will have a chance to vote on our state's future. Two amendments on the Nov. 4 ballot will change the state's constitution and play a critical role in making sure Texas has enough water for the next century. One amendment will allow

property tax relief on land using water conservation measures. The other will give the Texas Water Development Board greater flexibility in financing a wide variety of critically-needed water projects without increasing the state's bond debt limit. The two votes cap a 40 year span of false starts in developing a long range, comprehensive state water plan. Lawmakers last spring approved a master plan to conserve, develop and manage the state's valuable water resources.

New Wichita Falls weather tower, web site now available

River Bend Nature Works begins a new chapter in community and regional services with the launch of an internet web site for weather information.

A ten meter, solar-powered weather tower located at River Bend (near Lucy Park) generates more than thirty types of weather information and updates the data hourly. Web site visitors find an hour by hour report of the day's weather, a summary of current conditions and a summary of information from the preceding day.

From a very practical standpoint, city officials hope the tower's soil moisture measurements can be used to trigger the city of Wichita Falls sprinkler systems electronically and automatically so no more nor less water is used than necessary.
