Sharp Warns Against Paying To Receive Any Property Exemptions

"Texas taxpayers should always take advantage of all the exemptions afforded them to reduce their local residential property tax bills," State Comptroller John Sharp says, "But they don't need to pay someone to file for those exemptions, especially when they're so easy to obtain free of charge-either in person or by mail.'

Sharp cautioned Texas homeowners about companies that have advertised that they will obtain a person's property tax exemption from the appropriate local authorities, but for fees that sometimes total as much as 50 percent of the tax savings.

The most common exemption in Texas is \$5,000 of the assessed value of residential property for school taxes. There are also exemptions for persons age 65 and older, military veterans, and the disabled.

"At the time of the year when most Texas homeowners are paying their local property taxes, some have been solicited by companies informing the property owners that they are eligible for certain exemptions. The companies then promise to obtain an exemption for the homeowner, but only for a fee of \$25 or more," Sharp said. "Using such a service is both costly

and unnecessary. County appraisal offices have an easy-to-complete form that homeowners can file-at no charge—to receive the appropriate property tax exemptions," Sharp said.

"After filing an application for exemptions, homeowners need not file again, unless they qualify for new exemptions. For example, homeowners who became 65 or disabled during 1993 will qualify for additional exemptions for tax year 1994," Sharp said.

Holiday Closings Are Being Announced Here

Offices in the Briscoe County Courthouse will .close at noon on Friday, and will reopen on Monday, January 3.

Sharp said the county appraisal office can help an individual obtain property tax exemptions on a specific property, at no charge. For general questions

January SSI Checks Being Delivered Early

"Supplemental Security Income (SSI) checks are being delivered today (Thursday, December 30)',, said Terry Richardson, Social Security office manager in Plainview. The checks usually arrive on the first of each month. But in January, the first falls on a Saturday, and Friday is a federal holiday, so the checks will arrive on Thursday.

"Whether you receive your benefits by mail, or you have them deposited directly in your bank account," Richardson said, your SSI payment should be available two days early." As usual, Social Security payments will arrive on the third day of the month.


The Briscoe County Tax Appraisal District office will remain open for your convenience Friday and will be closed on Monday, January 3. Briscoe County News will be closed

The home of Calvin and Carolyn Shelton was chosen to receive first place in the Christmas decoration contest sponsored by Briscoe County Activities Association.


The home of Wayne and Tina Nance received second place, and the home of David and Reba Tipton was chosen for third place.

Hints for Business Owners Filing For Their Social Security

If you own a business and you're getting ready to retire, Social Security has some hints to help you prepare to file your claim for benefits.

In taking your claim for benefits, we will need to know whether you'll be completely retired or whether you plan to continue some involvement in the business. To get all of your Social Security retirement benefits, you must retire, or at least reduce your earnings below certain limits. Otherwise, some-or all-of your benefits will be withheld. Here's how it goes: in 1994, if you are under age 65, you can earn up to \$8,040. For every \$2 you earn over this limit, \$1 is withheld from your benefits. For people age 65 through 69, the 1994 limit is \$11,160. For every \$3 you earn over this limit, \$1 is withheld from your benefits. These limits apply to everyone: people who work for wages and those who are self-employed. If you are age 70 or over, there are no earnings limits.

When you work for wages, it's easy for us to determine whether you're "retired." Your earnings record tells the whole story. But when you are selfemployed, it's not as simple. For example, if you decide to file for benefits but continue to work part-time in the business, you could be in a position to control your earnings. In that case, we probably will ask you for additional information-such as tax returns or corporate records. This will help us to decide whether you have reduced your services in the business to match the reduction in your income. In other words, the income you receive from the business must match the work you do. You cannot simply pay yourself a small salary to stay under Social Security's earnings limits.

When you file for Social Security benefits, several situations require

additional information and evidence to help us decide your level of retirement. Additional evidence would be necessary if you are:

*Involved in a family business or another family member is assuming some, or all, of your dutues.

 \star Continuing to render services for the business at a reduced rate of compensation.

★ Still the owner, or part-owner of a business and own stock in the business.

*Splitting wages with others (dividing former salary between you and your spouse or children, for example).

Here's an example of a situation that would require an extensive interview and documentation because the person is retiring from his or her own business. Let's say Mr. Davenport owns and manages a furniture store. His net profit was \$65,000 last year. He turns 62 in 1994 and plans to file for Social Security retirement benefits. He decides to incorporate the business, naming his wife as president, his oldest son as vice-president, and declares himself treasurer-paying himself \$8,000 so he will be under Social Security's earnings limit. But he intends to continue to control and manage the business just as he did before he incorporated.

While Mr. Davenport makes the arrangements with the best of intentions, only when when he talks with a Social Security representative does he learn that his arrangements may be improper. The representative explains that Mr. Davenport cannot simply reduce his income in order to receive Social Security without also reducing the services he provides to the business. Fortunately, Mr. Davenport talked to Social Security before he had to file amended tax reports and before we would have had to make adjustments to his Social Security record. All of these actions could have delayed the processing of his retirement claim.

We encourage you to check with us well before filing for benefits to make sure you are aware of the documentation you will need for the interview. Remember-you have to to collect "retirement" "retire"

benefits-or at least significantly reduce your involvement in your business and keep your earnings under the limits

Operation Lifesaver Urges Motorists to be More Train Cautious

Winter brings expectations of "blue northers," festivals and gatherings of holiday celebration. Winter, however, also is the season when vehicle-train crashes significantly increase in Texas and the nation.

In each of the past ten years, December and January have been the months with the highest number of highway-rail grade crossing crashes, according to the Federal Railroad Administration (FRA). This sharp increase deviates from other types of highway collisions which most frequently occur during the summer, according to the National Highway Traffic Safety Administration.

'The increase in vehicle-train crash frequency during these months may be attributed to more severe weather conditions, decreased daylight hours, holiday traffic, increased drunk driving, but it's hard to attribute to one factor," said Thomas D. Simpson, president of Operation Lifesaver, Inc., a national non-profit, public education program dedicated to reducing crashes, injuries and fatalities at highway-rail grade crossings.

"Vehicle-train crashes are notably different than other accidents involving motor vehicles in that they are eleven times more likely to result in a fatality. Vehicle-train crashes are almost always preventable," said Simpson.

Every 90 minutes, on the average, a vehicle and train collide somewhere in the U.S. Last year there were 579 people killed and 1,975 injured in 4,910 grade crossing crashes, according to the FRA.

Texas ranks number one in the nation for vehicle-train crashes. Last year there were 486 crashes which resulted in 59 fatalities and 196 injuries. This year doesn't promise to be any better

for Texas. FRA's preliminary statistics for the first six months of 1993 indicate a five percent increase in vehicle-train crashes and a 60 percent increase in fatalities in Texas compared to the same period in 1992

Texas Operation Lifesaver urges all motorists to follow these safety tips to prevent highway-rail grade crossing crashes:

*Never attempt to beat a train through the crossing. If it's a tie, YOU LOSE!

 \star Do not get trapped on a crossing. Proceed through a crossing ONLY if you are sure you can clear the ENTIRE track.

* Expect a train on any track at any time

*Look for a second train when crossing multiple tracks.

* Get out of your vehicle if it stalls on a crossing and call 911. Only attempt to restart your vehicle if you can post a lookout to watch for approaching trains.

★ Never drive around crossing gates when they are down. To violate activated crossing gates is both illegal and deadly!

★Be aware trains cannot stop quickly. Even though the locomotive engineer may see you in a crossing, it can take up to one and a half miles to stop once the emergency brakes are applied.

"This winter-and always-remember four simple words approaching grade when crossings-Look, Listen and Live," urged Simpson.






