

Continue your prayers for Ed and Ann Norris and family. Though details are sketchy as to the conditions of each individual. it is thought that Ann's brotherin-law continues to be in critical condition, and Ann continues to receive treatment at the hospital. Funeral services were conducted last week for Ann's sister, and Charlie Parker and Dwain Henderson went up for the ser-vices and brought Ed and Ann's car back. (They had left it there when they continued on their trip in her sister and brother-in-law's new van.)

More about the Ozark Trail: In the later years of the Ozark Trail Association there are indications of conflict. Nothing is clearly stated in newspaper reports of conventions or other OTA activities, but one sees hints of trouble in some of Coin Harvey's speecnes and in reactions to his decisions. Harvey's opening address to the 1918 convention concerning the selfish motives of "those who are unappreciative of their duties and obligations to our Association" indicates that he was displeased with some of the OTA's officers. In 1921, several delegations walked out of the convention and left the OTA, the only reason published in any newspaper being "we have had all the experience with Mr. Harvey we care to have.'

Because of the widespread powers of the president, the ac-tual organization of the OTA is not as clear as one might expect. At some point, a vice-president at large (in addition to the vicepresidents for the states) was appointed or elected. M. D. Lightfoot, the vice-president for Missouri, was appointed the "per-manent chairman" of the OTA conventions in 1916, although his duties are unclear, as organizations in the convention city took care of the local arrangements and Harvey opened and closed the sessions. At the 1919 convention--although not provided for in the constitution--two vice-presidents were elected for New Mexico, one for the southern part of the state, one for the north. Presumably this was to honor Roswell for a good convention while not detracting from the importance of the northern part of the state on the main OTA route.

Although the constitution made no provision for them, Harvey himself encouraged the organization of local clubs among Ozark Trail communities to "look after road matters, and . . . make frequent sociability runs to promote friendly rivalry in road work." Local OTA boards appointed managers for certain sections of their routes and "Mile Captains," who were responsible for making sure a particular mile of road remained in good condi- tion of good roads.

The top ten contestants from each event will qualify for the regional finals, to be held on November 7th, in Floydada.





## **Owls Roll To 69-47 Victory Over Undefeated Three Way Eagles**

The Owls rolled to a 69-47 victory over the previously undefeated Three Way Eagles in the first district game of the season.

It was a big night for passing quarterback Nathan Francis, who completed 10 of 13 aerials with no interceptions. His main targets were Jeremy Holt, who caught five for a gain of 122 yards, and Jay Arnold, who also caught five for a gain of 60 yards.

Jeremy Holt also rushed the ball 25 times for a gain of 279 yards. Jared Holt carried 10 times for a gain of 68 yards. Others carrying the ball for the Owls were Issac Garcia, Jimmy Castillo and Andrew Francis.

It was another really big night for Jared Holt, who kicked off to open the game. The Owl defense held the Eagles to three and out, thanks to Jay Hicks, Clint Ivory and others who forced a fourthdown punt.

It was a very successful first offensive effort of the game for the Owls. Nathan Francis handed off to Jeremy Holt, who scampered five or six yards before Jared Holt picked up a first down on the Three Way 32. Jared picked up 12 yards before the Owls lost four yards. A fourth down pass from Nathan Francis to Jeremy Holt moved the ball for a first down on the Three Way 10. Jared Holt scored with 4:38 still to be played in the first quarter. Andrew Francis held the ball and Jeremy Holt kicked the PAT through the uprights, to give the Owls an 8-0 lead.







### **Funding Approved** For Nine Contracts

Nine producers in Briscoe County have been approved for the new Environmental Quality Incentives Program (EQIP). These nine producers will receive

a total of over \$76,000 to install USDA, Washington, D. C. 20250, tices including irrigation pipelines, terraces, fences, brush con- nity employer. trol, and livestock watering facilities

Alton Riddell, chairman of the local Soil and Water Conservation Board, says, "Briscoe County did extremely well considering we are not located within a priority area."

The EQIP program is a new conservation program designed to replace the Great Plains Conservation Program and the ACP Program. Producers are eligible for up to 75% cost share to install conservation practices. Producers must sign a five- to ten-year contract which will include management items. Total cost share is limited to \$50,000 per contract. Matthew Kast, District Conservationist with the NRCS, says that "EQIP is an excellent program that farmers and ranchers can use to improve their property. Producers should realize however, that EQIP is a long-term contract that requires management."

Producers interested should contact the local USDA Service Center. Producers may sign up for the program at any time at the NRCS office in Silverton. Offers will be ranked and funded during certain time periods. The next funding period is expected to be sometime after the first of the year.

The board voted to move the High Plains position held by Schumacher to the Rio Grande Valley in order to represent all soybean production areas in Texas.

The Texas Soybean Board is responsible for the disbursement of the national soybean checkoff. Half of all funds collected remain in Texas and are used to fund research and promotion to the benefit of Texas soybean producers. The remainder of the funds are send to the United Soybean Board and pooled with collections from across the country.
