New Information Confirms Corruption and Cover Up in Case Where White Pastor Killed His **Black Son In-Law**

Angier, NC — On October 12, 2013, white local Pastor Pat Chisenhall brutally killed his black son-in law 23-year-old Christian Griggs, fatally shooting Christian 6 times, 4 in the back as he lay wounded. The

state medical examiner ruled Christian's death a homicide.

Since Christian's tragic killing, District Attorney Vernon Stewart and Harnett law enforcement have done everything in their power to avoid holding



Pat Chisenhall accountable, including tampering with evidence, withholding key information and maintaining deep-seated conflicts of interests. Most recently, the family discovered that DA Stewart has withheld additional forensic data critical to the case. Dolly and Tony Griggs, Christian's parents, issued the following statement:

"The problems with DA Vernon and Harnett County law enforcement's investigation into our son's killing, or the lack there of, are almost too many to count. Months ago we were told by officials that no gunshot

residue tests were performed, but when picking up Christian's personal belongings this week we were presented with documentation revealing gunshot residue tests (GSR) performed on both Katie and Pat Chisenhall. GSR would determine who discharged the firearm and confirm or contradict their narrative of the shooting. What is the outcome of the test? What other information is DA Stewart hiding? This latest revelation only further deepens our grave mistrust of DA Stewart and local police.



In Cinque


I was saddened to learn that a man from the town in which I spent my early childhood days, had been found hanging and badly decomposed, from a tree fairly near his home. I was also saddened to learn that Rev. Al Sharpton had made a visit there to be informed and or inform the world about the tragic incident. In view of the past history of Claiborne County and Port Gibson, Mississippi and the recent protest regarding the deaths of Black males in America, this is truly a situation which calls for complete professional investigation before the renegades and vigilantes become active.

Many young people today are not aware that the N.A.AC.P. has a long standing history in Claiborne County which has historically attempted to settle racial disputes through the local, state and federal courts. The local residents also have a history of protest through rallies and boycotts. The county is predominantly Black and though there was racial segregation or "Jim Crow," friction was not one of its characteristics. One reason being that there was some identical blood running through the veins of some families of both races. Another being that in the olden days, house help was loved and admired as family. There were two communities within the greater community which existed peacefully together with mutual respect, as Black business flourished in this county until after the Korean Conflict. Black people did not fear white people and following the Korean Conflict, they began to demand equality on every level through protests and boycotts. Because this community was fearless, when a unique death did occur, it was thoroughly investigated and the culprit was usually brought to justice whether it was a Black or

White victim. But with the pressure of equality in all things, many Black businesses failed to thrive and government and business took a spiral downward. Much of this action has been a direct result of the famous case: NAACP v. Claiborne Hardware Co. in 1982.

In 1966, the Black citizens of Port Gibson, Mississippi and Claiborne County demanded equal rights and they were not granted. This resulted in a boycott of white merchants in the area. When a Black policeman was employed in 1867, the boycott was lifted. When a Black man was killed around the same time as Martin Luther King in 1968 by policemen and a demand was made to discharge the force and the demand was not met, the boycott was reimposed. The merchants sued 146 individuals, NAACP and the Mississippi Action for Progress to recover losses and stop the boycotts in 1969.

The lower courts upheld the Merchants wishes and the Supreme Court of Mississippi upheld the lower courts' rulings in 1980. From 1969 until the United Supreme Court ruled on appeal in favor of the NAACP in 1982, the 146 individuals named in the merchants' suit in essence had their civil rights frozen. By the time they were released from judgement, many had lost property, jobs and were in debt. Equality in the daily lives of many Claiborne County residents improved tremendously, but those in the forefront for freedom lost quite a bit. The county is trying to recoup its former status and a nationwide protest at this time is not in the best interest of the residents. We need to get 'in cinque' and weigh the consequences before jumping into protest mode as Ameri-

shown to our legal counsel and it's clear the crime scene had been doctored. The police report also indicates that the case was closed the day of the shooting with no investigation and prior to the autopsy release. We believe the crime scene was changed after the autopsy revealed Christian had been fatally shot in the back while he lay wounded. And the conflicts of interest run deep. Pat Chisenhall's attorney is DA Stewart's former partner, who is also a financial contributor to Stewart's election committee. Another officer close to the investigation was a neighbor of Pat Chisenhall and a friend who fraternized with Katie Chisenhall. If we hadn't raised our voices, DA Stewart would have succeeded in sweeping Christian's death under the rug.

It has been widely assumed, as it should be, that Michael Sam was not the only gay player in the NFL when he was with the St. Louis Rams and the Dallas Cowboys last year.

Sam confirmed that, saying several NFL players contacted claims not to remember the him after he was drafted and told him they were gay. The difference, of course, is that Sam was the only one who was openly

"I am not the only gay person in the NFL," Sam said, according to the Fort Worth Star-Telegram. "I'm just saying there is a lot of us. I respect the players that did reach out to me and had the courage to tell me that they were also gay, but they do not have the same courage as I do to come out before I even played a down in the NFL."

Sam, who was speaking at the 2015 Dallas Holocaust Museum Upstander Speaker series, said he didn't think it would be a big deal to come out, mostly because there are "gay athletes everywhere." But as he knows now, it was a big deal. On one hand there seem to be positives to it - Sam got the type of exposure almost no seventh-round

pick will ever get - but the negative is he'll always wonder if coming out hurt his professional career. He was cut by the Rams despite a solid preseason with 11 tackles and three sacks. Brutal and Bloody Arrest of African American Honors Student in Virginia **Leads To Investigation**

Charlottesville, VA — More than 1,000 students recently gathered at the University of Virginia (U.Va.) to protest and demand justice for 20-year old Martese Johnson, a Black student who was injured during a recent arrest by police officers. In pictures and videos circulating on Facebook, Johnson is seen being arrested with a very bloody face and shirt.

Johnson, a member of the Honor Committee at the university, was arrested and charged with public intoxication and obstruction of justice. But he was "brutalized" so bad that he reportedly needed 10 stitches. In the video, he can can be heard screaming: "I'm a UVA student. How did this happen you (bleeping) racists!"

The very next night after the arrest, a rally in support of Johnson drew hundreds of students including Johnson himself. Johnson told the crowd, "We are one community. We deserve to respect each other, especially in times like this."

Virginia Governor Terry McAuliffe issued a statement saying: "Governor McAuliffe is concerned by the reports of this incident and has asked the Secretary of Public Safety to initiate an independent Virginia State Police investigation into the use of force in this matter. The governor's office has been in contact with University of Virginia President Teresa Sullivan and local law enforcement and will continue to monitor this situation closely as the investigation proceeds."

University of Virginia President Teresa Sullivan also released a statement saying: "The safety and security of our students will always be my primary concern, and every member of our community should feel safe from the threat of bodily harm





Black Man Found Hanging From A Tree In Mississipi

FBI Special Agent in Charge Donald Alway confirmed in a press conference on Friday, March 20, 2015, the body found hanging in the woods in Claiborne County, Miss. has been identified by authorities as Otis Byrd.

Authorities are investigating the death of a Black man found hanging from a tree in Claiborne County, Miss.

The FBI, Mississippi Bureau of Investigation (MBI), local law enforcement, the Justice Department's Civil Rights Division and the U.S. Attorney's office are investigating the death. It has yet to be determined whether it was a homicide or suicide.

Claiborne County Sheriff Marvin Lucas and his officers discovered a decomposing body, believed to be Otis Byrd, with a bed sheet tied around his neck, hanging from a tree at approximately 10:21 a.m. on Thursday. His hands weren't tied. The area of the hanging is approximately 500 yards southwest of a house belonging to Byrd's family.

An official release from the FBI and the MBI on Thursday

Earlier in the day, the Claiborne County Sheriff's Department and the Mississippi Wildlife Fisheries and Parks conducted a ground search for a man who had been missing since early March. Officers located a man hanging in the woods near Old Rodney Road a half-mile from his last known residence.

Byrd, 54, was last seen March 2 when a friend dropped him off at the Riverwalk Casino in Vicksburg. He was reported missing by his family the same day, a missing person's report was formally filed on March 8, and on March 13 the MBI received a missing person's report from the Claiborne County Sheriff's Department.

Authorities have not positively identified the body as Byrd's. The body has been sent to the state Crime Lab in Jack-



son, and an autopsy will be completed to determine whether the death was a suicide or homicide. But the Claiborne County chapter of the NAACP says the deceased is Byrd.

In an official statement, Derrick Johnson, the President of the NAACP Mississippi State Conference, said:

The Mississippi NAACP calls for an investigation regarding the death of Mr. Otis Byrd of Claiborne County, MS. Mr. Byrd, who has been missing for over a week, was found hanging from a tree in a wooded area approximately 4 or 5 miles from his home. We are calling on federal authorities to immediately investigate the hanging death of Mr. Otis Byrd to determine

whether or not his death is the result of a hate crime."

The NAACP emailed the U.S. Department of Justice to ask for assistance in the investigation.

Released on parole in November 2006, Byrd was convicted of capital murder for killing Lucille Trim in Claiborne County in February 1980 during a robbery.

One of Byrd's family members, who did not want to be identified, told CNN that he was



Is The STEM Pipeline Really The Problem? Continued from Page 6

Nielsen, companies on the 2014 DiversityInc Top 50 and members of Change the Equation, the non-profit group set up to mobilize the business community in order to tackle the issue of STEM education, have made big strides by recognizing that there are already diverse, qualified workers already in existence for these tech jobs.

Still, while initiatives like Educate to Innovate and Change the Equation are important, for the underrepresentation of women in tech, the issue is further complicated by systemic bias in science and technology fields. Whether it's Microsoft's CEO saying women should rely on karma for raises or women seeing bias in training and sponsorship at tech firms, the issue of systemic attitudes towards gender persists.

Psychologist Joan C. Williams doesn't buy the pipeline as the main culprit behind the absence of women and, particularly, women of color. Based on her research with co-authors Katherine W. Phillips and Erika V. Hall, she writes in Harvard Business Review, "bias, not pipeline issues or personal choices, pushes women out of science – and that bias plays out differently depending on a woman's race or ethnicity."

The five specific biases she found that women in the sciences reported:

• Having to prove themselves repeatedly with "their successes discounted, their expertise questioned."

• Being required to walk the "tightrope" between acting masculine to prove competency but maintaining expected femininity

• Having "their commitment and competence" questioned after having children

• Struggling with conflict between differing generations of women

• Being isolated because they "feel that socially engaging" with colleagues might damage perceptions of their competence (particularly an issue among Black and Latina respondents)

These implicit biases find support in studies that shows both men and women on science faculties favor a fictional application's male name over a female one with identical credentials in terms of hiring for positions, or that when employers were only given physical characteristics, women were "half as likely to be hired as men, because they were (erroneously) perceived as less talented for the arithmetic task: Both men and women expected women to perform worse."

"It's so tempting the attribute the paucity of women in STEM to pipeline problems or personal choices," concludes Williams. "But it's time to listen to women scientists: they think the issue's gender bias, and an increasing amount of research supports that view."

White Parents Demand Apology For DC Area School's Black History Month Event

Washington, DÇ — Charles and Rebecca, two white parents from the Washington DC area, are outraged that their 8-year-old daughter's school district held a Black History Month event that turned into what they say was a civil rights rally. They were recently interviewed on Fox News' morning show "Fox & Friends"

During the interview, Rebecca comments, "Everywhere that we looked were students, high school students, wearing shirts that said 'Black Lives Matter, I Can't Breathe. As I was flipping through my program, it had 'Hands Up, Don't Shoot."

Charles, who is a local police deputy, says he felt the event was very anti-police. He says that he wanted to yank his daughter from the auditorium immediately, but his wife thought it best to at least let her stay long enough to sing with her school's choir.

Rebecca continues, "Students started coming out on stage saying things like, 'I'm from Ferguson, Missouri. I was

After the event, the two say that their daughter was asking them questions like: "Why do cops shoot black people? Why do cops shoot good people? If they do that, does that make them a bad cop? Daddy, you're a cop, does that make you a bad cop?""

They both say they are completely outraged that they were put into a position to speak to their child about racism and are now seeking an apology.

Meanwhile, Brenda Tanner, the school superintendent (who



Hundreds of Student Volunteers Travel to Ferguson For Spring Break to Help Rebuild the Community

Ferguson, MO — College students from all over the country are using their Spring Breaks to help rebuild the community and promote civic engagement in Ferguson. Students are coming from cities as far away as New York, Atlanta, and Los Angeles.

Most of them are a part of an organized initiative called Ferguson Alternative Spring Break (FASB), which is a five-week program that invites students from across the nation to help rebuild the city by addressing unmet social needs. The program, created by civic leaders and activists from Ferguson, started on March 7th and will end on April 11th.

According to USA Today, the program requires the student volunteers to spend at least 33 hours each week helping out with various community service projects. Such projects include: voter education and registration, community beautification projects, food collection/distribution, and homework help and tutoring with local schools. They are also assisting local businesses whose storefronts were damaged in the riots.

The founders of the program say the support has been overwhelming, and that as soon as their web site went live, they immediately received nearly 800

inquiries from interested volunteers.

Patricia Byrnes, co-founder of the project, says that the goal of the program was not to recruit protesters, but rather to get community volunteers to actually help rebuild the community.

She comments, "I thought the program would be a great way to show the community that there are people, especially students, from all over the country who

want to help empower them because the people in Ferguson do matter."

The city of Ferguson, although just a small town in Missouri, has been making national headlines for the past few months because of a highly publicized incident whereas a white police officer killed an unarmed Black teenager (Michael Brown).
