

NAACP Statement on Supreme Court Decision in King v. Burwell

Washington, DC -- Thursday, June 25, 2015, the U.S. Supreme Court upheld the Affordable Care Act, which represents our most significant achievement in health reform in nearly 50 years. The Affordable Care Act is a critical step toward redressing disparities in health that persist along racial/ethnic, geographic and other lines. Since 2013, the uninsured rate has declined 9.2 percentage points for African Americans, resulting in 2.3 million adults gaining coverage and 12.3 percentage points for Latinos, resulting in 4.2 million adults gaining coverage. Since 2013, the uninsured rate among women declined 7.7 percentage points, resulting in 7.7 million women gaining coverage. An estimated 55 million women are also benefiting from preventive

services coverage with no outof-pocket costs. And health insurers can no longer discriminate based on gender, so being a woman is no longer a preexisting condition.

From Roslyn M. Brock, Chairman of the NAACP Board

"The NAACP applauds the nation's highest court in recognizing the intent of the law: That all persons who obtain coverage through state- or federally-run health insurance exchanges and qualify for tax-credit subsidies to defray the cost of premiums can receive the subsidies. Especially with the ongoing economic challenges facing low and middle-income Americans, subsidies are often needed to open the door to health care and mitigate the high cost of not having health insurance. The NAACP will continue to educate Americans about the Affordable Care Act and encourage them to get covered and get healthy. We will also ask them to push locally for greater access to comprehensive health care coverage and quality, timely health care services. And certainly, we will continue to partner with organizations throughout our country toward the common goal of bringing about health equity for all."

My late mother's favorite hymn was "Amazing Grace" Her most favorite version was that of the great Mahalia Jackson. Oh, how I remember listening to her work around the house and kitchen saying those sweet words. I wonder if she knew the roots of this great song. The author John Newton was a minister during the 1700's from England. According to Wikipedia, "Amazing Grace is one of the most recognizable songs in the English-speaking world. Author Gilbert Chase writes that it is "without a doubt the most famous of all the folk hymns," and Jonathan Aitken, a Newton biographer, estimates that it is performed about 10 million times annually. It has had particular influence in folk music, and has become an emblematic African American spiritual. Its universal message has been a significant factor in its crossover into secular music. "Amazing Grace" saw a resurgence in popularity in the U.S. during the 1960s and has been recorded thousands of times during and since the 20th century, occasionally appearing on popular music charts."

Who was this John Nelson? In the song he writes "Amazing Grace! (How sweet the sound); that saved a wretch like me! I once was lost, but now am found; was blind, but now I see." Please take this literally. John Nelson was indeed a vile wretch. He started out as a British naval officer but then turned his sea talents to the evil slave trade from Africa to England and North America. He became a slave trader extraordinaire.





my thoughts wander back to my father. He has been gone quite a spell but his memory lingers. I often wonder what he would think of what is happening in our

world today if he were to come

confess he was not always right all the time, but what he said was law in our house. That is, of course, unless his wife contradicted him. Then it was time for us kids to seek sanctuary outside where we could not hear what

was going on. I cannot help but believe that some of the problems we are having in our society today would not be such a problem if we had fathers. How many families are there where children grow up not knowing their father? No wonder they have no respect for authority.

Although my father was not

Around this time of the year, a very well educated person, he knew how to use the Board of Education on the Seat of Learning for all of us children. Some of the stuff he did back in "the day," would bring him some real legal problems today.

For example. My father be-I grew up with a father who lieved he had the right to be believed in being the father. I judge, jury and executioner concerning the things in his children's life, with no appeal to a higher authority.

> In the kitchen hanging next to the door to go outside was a very interesting parenting tool, at least in my father's eyes. It was a paddle with a religious inscription, "I Need Thee Every Hour." The inscription was quite true to the reality of life in our

Spanking was a routine exercise in our home. My father had the idea that if you were in trouble in school you were also in trouble at home. He had this fantastic idea that the teacher

was right and I was wrong. I guess he knew me and that I could take a little bit of truth and spin it into a lie. I wonder who I learned that from?

Ruminating over these things, I tried to figure out how many spankings I actually got during my lifetime. Let me just say, it was significant. More than that. It taught me respect for author-

I wonder if some of these young people getting into trouble today ever had a spanking? pletely against PC. My father did not believe in PC, but he did believe emphatically in BS (Back Side). I think if parents today would focus more on BS than PC, things might be a lot

different. Today, people think those oldcruel and unusual punishment. However, if you look at this generation that has not had an oldfashioned spanking, I think the evidence speaks for itself.

To spank or not to spank, that is the dilemma today. Most gravitate towards the "not to spank" aspect unaware that they are creating a lot of damage for the next generation.

I must say that my father was not too much interested in what we call "love" today. He was more interested in respecting authority. All I can do is to quote a famous psychologist, "How's that working?"



Gunman Who Killed 9 People at Historic Black Church in SC Shouted Racial Epithets, "You Rape Our Women and You're Taking Over Our Country"



Charleston, SC — Police have captured and arrested Dylann Roof, a 21-year-old white male from Eastover, S.C. who reportedly went into Emanuel African Methodist Episcopal Church in Charleston, S.C. and opened fire and killing nine people during a prayer service. Six females and three males, including pastor, Clementa Pinckney, were killed in the attack.

Roof apparently walked into the church Wednesday evening, sat in attendance for about an hour, and then pulled out his weapon and started firing.

One survivor said...

According to one survivor, the shooter reloaded five different times and her son was trying to "talk him out of doing the act of killing people." But he wouldn't listen. While shooting, he kept saying, "You rape our women and you're taking over our country. And you have to go"

Charleston Police Chief Greg Mullen said the crime is being investigated as a hate crime. "No one in this community will forget this night," he said.

Attorney General Loretta Lynch vowed to bring the shooter to justice, and said, "Acts like this one have no place in our country and no place in a civil society."

"The only reason someone could walk into a church and shoot people praying is out of hate. The only reason. It is the most dastardly act that one could possibly imagine," said Charleston Mayor Joseph Riley.

Racially motivated?

Roof, who was arrested twice earlier this year, once on a drug charge and later for trespassing, has pictures his Facebook page of himself standing in in front of a swamp forest wearing a jacket with patches of the racist-era flags of South Africa and Rhodesia, the one white-ruled country now called Zimbabwe.

Where did the gun come from?

According to some media reports, the gun was a gift to him from his father on his 21st birthday.

Currently, Roof remains in custody with no bail awaiting charges. Prosecutors are expecting to ask for the death penalty.

Charleston, S.C.: A Millennial's Perspective on Racism in Her City

"Honestly, race relations in Charleston are hard to describe because in white circles, Black people honestly don't have a place," Allison* said. "The Black population of Charleston has halved in the last 30 years, gentrification is rampant."

Allison is a 21-year-old Black female student and a native of Charleston, S.C., who has just completed her third year at a university in New Jersey.

She had a candid conversation with DiversityInc about race relations in Charleston and discussed the mass murder of nine members of the historic Emanuel African Methodist Episcopal Church on June 17.

Allison is the youngest in a family of seven. She grew up in downtown Charleston, like her father, and her mother is from a different area of the South.

Her parents often shared with their children stories about life during times of segregation.

"Though [my parents] are fairly young and were born after Brown vs. Board of Education in 1954, the South took the sentence 'with all necessary haste'

to mean as slowly as possible," Allison said.

However, her parents did not think their children would experience the same kind of racism they did. They championed education in their household. Allison attended good private schools in Charleston. She now attends a prestigious college in the northeast.

She chose to attend a school far away from home because, as she said, "there wasn't real steps forward in my life I could take in a place that was so stilted, whose solution to the racial tension was to move people out so there wouldn't be racial tension at all."

But on the evening of June 17, the awful legacy of white supremacy in her home state, which her parents tried to shield her from, manifested itself yet again. Racist Dylann Roof, with the intentions of starting a race war, shot and killed nine members of the beloved and historic Black church Mother Emanuel.

Allison first learned about the

shooting via text message. sti "My white best friend from

home texted me at 11:45 p.m. at night," she said. "She was the first to let me know. My mother face-timed me, while my sisters sent me links to Twitter feeds and live news-streaming sites."

Allison said she and her family knew some of the victims.

"Mother Emanuel is nothing short of a beacon," she said. "Everyone sees it, knows it. The symbolism for the Black community of Charleston of marring this place of worship, is just, almost unparalleled."

Allison explained the history of the church, which is intertwined with her family and upbringing:

Denmark Vessy founded it. Coretta Scott King led a protest that ended there. It was a stop on the Underground Railroad. My father was baptized there. Countless people have been married and buried there. It has been burned and attacked and still it stands.

Top 15 Little-Known Scholarships For Women and Girls in 2015/2016



Nationwide — Every year, billions of dollars in scholar-ships are given away to students all over the world. These scholarships can be used to pay for college tuition, boarding, books, and more. Every scholarship has different criteria to be eligible, but all are not required to be repaid as long as the scholar continues to meet the guidelines.

Here are the top 15 scholarship programs for women and girls in the year 2015:

#1 – Executive Women International Scholarship Program: Offers scholarships to both male and female outstanding high school seniors who plan to pursue a four-year college degree program. Scholarships are based on academics, extracurricular activities, leadership and communication skills.

#2 – Linda Lael Miller Scholarships for Women: For women age 25 or older who want to complete their education. Candidates must complete a 500-word essay that explains the reasons for applying for the scholarship, how the funds will be used, and how the scholarship award will help them with their education and career goals.

#3 – Society of Women Engineers (SWE) Scholarships: For women pursuing undergraduate or graduate degrees in the areas of engineering, engineering technology and computer science. Female students must be attending accredited colleges or universities and preparing for careers in technical fields.

#4 – Joe Francis Haircare Scholarship: Named after Joe Francis (1933-1994), the founder of several hair care franchises, this scholarship is for women (and men) applying for entrance into Cosmetology/Barber School, OR actively enrolled in a Cosmetology/Barber program. An application must be submitted, as well as a one-page essay, and one or two letters or recommendation.

#5 – NFRW's Betty Rendel Scholarship: These awards go to three female undergraduates each year who are attending a four-year accredited college or university and majoring in political science, government or economics. It is open to women across the nation.

#6 – Women's Independence Scholarship Program: Helps women who have survived domestic violence to return to school and become self-sufficient. The primary candidates are single mothers with young children who lack the resources to attend college. It is based on financial need.

#7 – Young Women in Public Affairs Award: For young women age 16 to 19 with an interest in public affairs who plan to enroll in college. Interested

students must be knowledgeable about Zonta, have experience in local or student government, and generally be active in volunteer work.

#8 – At the Well Young Women's Leadership Academy Scholarship: These scholarships are available to help students attend a summer program at Princeton University, and is geared towards building leadership skills for minority girls entering the tenth, eleventh, or twelfth grades of high school.

#9 – Miss America Scholarship Fund: Offers scholarships to over 12,000 young women who compete in the state and local competitions as well as Miss America first place winner, four runners-up, semi-finalists and non-finalists.

#10 – Go Red Multicultural Scholarship Fund For Women: This program champions greater inclusion of multicultural women in the nursing and medical industries, address important gaps in treatment, and ensure that all Americans have an opprtunity to work with their

Retail Panel on Racial Profiling Convenes at John Jay College of Criminal Justice

Council of New York State joined forces with key retailers Thursday, June 25, 2015, to open a dialogue on race and retail. "The Retail Symposium on Shopping Equity" brought more than 100 retailers, community leaders, and law enforcement officials together at John Jay College of Criminal Justice for a full day of panels and a town hall meeting to address the complexities of racial profiling and strategize ways to create a shopping culture that is welcoming to all customers.

The symposium, co-sponsored by the Retail Council and Macy's, connected the wideranging groups to share their unique perspectives on racial profiling and develop a series of in-depth discussions about race, crime, and justice. Attendees examined the root causes of retail racial profiling — when certain consumers feel targeted and mistreated while shopping based on outward appearances, such as skin color, ethnicity, sexual orientation, or how they are dressed. In addition, they looked

New York, NY — The Retail at its impact at Black and Hispanic communities, ways to manage implicit biases, assessed data on prevalence, and reviewed best practices to create an anti-profiling gold-standard

> "This is not a box we would just like to check...and say we had that meeting and now let's move on," said Ted Potrikus, president of the Retail Council of New York State. According to Potrikus, the retail industry wants to definitely get the message out that they are paying attention to profiling. "It is a tough issue to talk about and it's one of those things where I think any retailer will say, 'This won't happen to us' - until it does happen...The issue is more than two brands, the issue is more than one borough. The issue can hit at any time. You just never know," Potrikus said.

> In addition to Macy's, associate relations, asset protections and human resources representatives from more than 15 leading retailers, including Barney's, Nordstrom, Walmart, Bloomingdale's and Home Depot were

present. Also in attendance were local and national Black and Hispanic community and civil rights leaders, including: Reverend Calvin O. Butts, of The Abyssinian Baptist Church; Michael Hardy, of the National Action Network; Michael Garner, of One Hundred Black Men, Inc. of New York; Gail Smith of Impacto Latin News; Rossana Rosado, former publisher of El Diario-La Prensa; and Marlene Cintron, of the Bronx Overall Economic Development Corporation. Broadcast journalist Soledad O'Brien hosted a town hall meeting and Professor Charles J. Ogletree ended the day with a talk on racial justice.

"Profiling is illegal, number one," said Hardy, who serves as the executive vice president and general counsel of the National Action Network and sat on the "Perspectives from Community Leaders When Profiling Allegations Arise" panel. "It's not good business and it's not good citizenship. No one wants to come to a place where they are not welcome and no one wants to spend money where they aren't

[either.]" Hardy added, retailers should take note that Blacks and Hispanics' buying power is \$1.3 and \$1.5 trillion respectively.

Butts, who was also on the community leaders panel, said that when it comes to spending their hard-earned money, Blacks and Hispanics need to redirect it to where they are respected.

"Racial profiling is directly connected to your influence in the marketplace," Butts said. "If you use your dollars wisely, you can influence a change. If you continue to spend your dollars where you are disrespected, then people are going to treat you the same way.'


Butts also encouraged minorities to speak with their wallets at retail outlets that respect diversity throughout its organization. "It's not only about shopping equity and how we spend our money," Butts said. "It's how [a company] spends its money. How [they] treat their employees and how [they] impact diversity in terms of their staff. Those messages of inclusion need to come from the top


Macy's CEO and Chairman Terry J. Lundgren addressed the audience, too. Macy's, he said, has a long history of incorporating diversity and inclusion into all facets of its business. However, he said, he is aware that a "trust gap" exists between the retail industry and many customers who are people of color.

If they feel like they have to look over their shoulder because of the way that they look or the color of their skin, or just the way they are acting inside of our store... If they feel there is mistrust on the part of the retailer. then we have to fix that," Lundgren said. We have to be responsive to that and decide what we have to do to adjust so the consumer doesn't have to adjust."

Lundgren said one way Macy's is addressing the racial profiling issue is by adopting and posting a Customer Bill of Rights - in both English and Spanish – that hangs promi-

Allison explained her sister and many others are complaining about the "audacity" of white South Carolinians to post pictures of rallies and prayer meetings "where white people and Black people hold hands and make statuses and updates to the effect of 'See Baltimore? See Ferguson? This is how you respond to racial violence!' As if to say, 'Look at how well behaved our Black people are!""

She is bothered by how some whites are grading the responses of Black people grieving. Allison also said there are rampant conversations about race culture in South Carolina that haven't happened until now.

"I think I'm feeling the sort of fatigue that comes from disgust and awe," she said. "But not necessarily the feeling that comes from surprise. Racial tension is everywhere and sometimes as a Black member of the Charleston community it weighs heavily on your thoughts."

Allison shared that while she #14 - Job's Daughters may get dirty looks from old racists warning her to stay away, it's the actions of young racists in her hometown that hurt the

> "Oftentimes they don't know they are racist and don't care to acknowledge their bias," she said. "They don't get why calling me 'exotic' or 'sassy' is uncomfortable or that inquiring whether or not my father is in the home is literally just insulting. And when you try to explain it the response is often, 'Whoa, there buddy! I'm not a racist!' When the ugly truth is that they

inspirational," Allison said. "His to remove the Confederate flag from South Carolina's Capitol grounds is now at the forefront. South Carolina Gov. Nikki Haley announced Monday that she will call on state lawmakers to move the Confederate flag from state grounds. Lawmakers are expected to debate the issue and vote in the coming weeks.

> "[South Carolina] makes it clear its interests as it flies the Confederate flag," Allison said. "I'll remind everyone that this is nothing new. This flag as been flying for hundreds of years. It's everywhere."

> "Sometimes you feel threatened by it," she went on. "Other times you forget it's there, it's so prominent. It doesn't always mean the person flying it is racist, but seeing it puts the thought in the back of your mind. Individuals fly the confederate flag all the time and sometimes you come to the shock that your white friends are racist."

However, Allison has no intention of letting racism impede

"Racism leaks over and clouds vision, but no it doesn't stop you from living your best life, from, as my mom would say, 'Dancing in the rain, even if it's lightning two miles away."



Travis said he was honored when the Retail Council and Macy's asked John Jay to host the event. "You've taken a moment in your history to say, 'Let's turn this around and figure out what to do differently' and you've shown a commitment to do things differently and I applaud you for it," Travis

NYPD Lieutenant, Tarik Sheppard, who was instrumental in creating the New York Metro Organized Crime Alliance (NY-MOCA), was also on hand. NY-MOCA is a private and public partnership that fights organized retail crime through sharing information with law enforcement and retailers. Sheppard encouraged improved cooperation, trust and information between retailers and police on a panel about the keys to successful partnerships between retailers and law enforcement.

Broadcast journalist Soledad O'Brien hosted a special town hall meeting entitled, "Where Do We Go from Here?" Panelist Kristen Clarke from the New York State Attorney General's Office shared several best practices that her office learned from working with retailers. They include: taking a data-driven approach to stops and detentions to see if any person, department, or store stands out; have chief executives make clear that profiling won't be tolerated; continuously train employees; take disciplinary action; put incentives in place; create and follow timelines for responding to customer complaints and adopt a consumer bill of rights.

Shortly after the symposium ended, Potrikus said the event was successful because it provided retailers with a clear cut way to deal with shopping equity concerns when they arise. Potrikus anticipates that industry groups like the Retail Industry Leaders Association and the National Retail Federation - both of whom attended - will keep the momentum going.

Potrikus said: "I think [the community] is seeing here that this is not just window dressing and that retailers aren't saying that if we do this, then we are off the hook."

Episcopal Church Elects Michael Curry, Its First Black Presiding Bishop



SALT LAKE CITY (AP) — The Episcopal Church elected its first African-American presiding bishop, choosing Bishop Michael Curry of North Carolina during the denomination's national assembly Saturday.

Curry was elected by a landslide in a vote at the Episcopal General Convention, the top legislative body of the church. Curry earned 121 of 174 votes from bishops on the first ballot. The other three candidates had 21 votes each or less. The decision was affirmed on an 800-12 vote by the House of Deputies,

the voting body of clergy and lay participants at the meeting.

Curry's election is the second consecutive historic choice for the New York-based church of nearly 1.9 million members. He will succeed Presiding Bishop Katharine Jefferts Schori, who was the first female presiding bishop and the first woman to lead an Anglican national church. The Episcopal Church is the U.S. body of the Anglican Communion, an 80-million member worldwide fellowship of churches with roots in the Church of England


