

Seymour and Brannon have been selected by the Silverton Chamber of Commerce as the Briscoe County Pioneer Couple of the Day, and will be honored during the County's 112th Birthday Celebration in Silverton Saturday, August 14. They will ride in a horse-drawn carriage in the parade, and will be presented a commemorative plaque following the parade.

Seymour Brannon and the former Miss Ruby Young were married at the parsonage of the Calvary Baptist Church in Silverton by the Rev. B. P. Harrison on September 24, 1938. They celebrated their golden wedding anniversary Saturday, September 24, 1988, and will have been married 66 years in September 2004.

Born in 1917, Seymour moved here with his family from Paris, Texas in 1925. He was one of five children and there are only two left, he and Opal McClure. A retired farmer and rancher, he was a carpenter until he began farming and ranching full time.
