Heard Bryan Williams is in a Lubbock Hospital, hope he is up and around again.

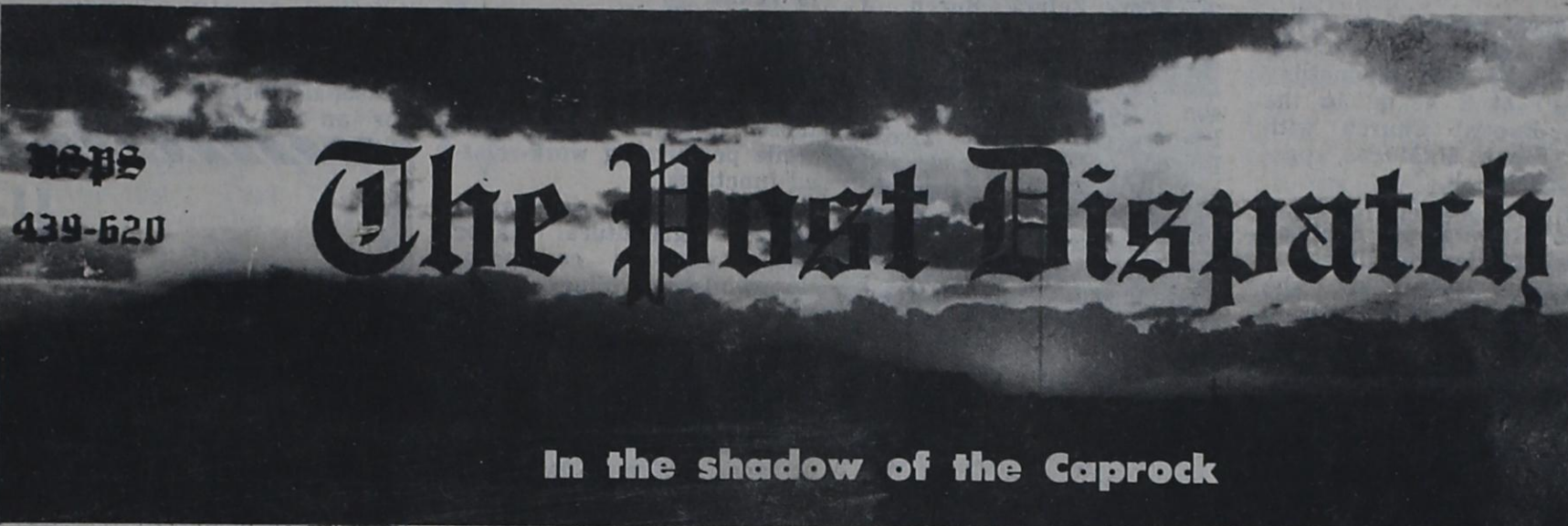
Also that Bill Shiver is recovering nicely from recent surgery and will be back at his desk again real soon.

# City Seeks Economic Planning Grant

The first of two public hearings on a state grant for economic planning in Post was held Monday night during the regular Post City Council meeting.

Post Chamber of Commerce manager Lewis Earl, who also serves on the board of directors of the Post Economic Development Corp., explained the grant application to the council.

The application goes to the Texas Department of Community Affairs, which administers federal grant funds for cities under 150,000 population.

If approved, the grant will fund the hiring of an economic planner to develop industry for Post in cooperation with the PEDC.

The \$25,000 grant is for a one-year period, and the person selected for the position would not be paid from city funds.

"We have a pressing need to have professional help in developing the best uses for the Postex Plant building

and all the other property," Earl commented.

Council members expressed their support and appreciation to Earl for his efforts in obtaining the grant and for the work on recruiting industry for Post.

A second public hearing has been set December 13 at 7 p. m. in the conference room at the Postex Plant building.

Earl also told the council that a recent questionnaire survey of former Burlington employees revealed 90 of 178 respondents being unemployed.

Of the 90 out of work, 73 live in the city limits and 17 live in rural addresses.

Earl said that of the 88 who are employed, 12 reported earning more and 73 earning less than when they were on the Burlington payroll.

More than 400 questionnaires were mailed to former Burlington employees and responses are still being solicited by the Chamber of Commerce.

In other action, the council approved adding the recently donated old theater buildings to the insurance coverage, heard the annual audit report and agreed to work with the new group "Post Cares" in forming a food bank.

No city funds were requested by the group representatives Earl Chapman and Steve Traw, but the council agreed to allow the use of part of a city building as a storage facility for the collected food.

Park board members David Newby and Jack Alexander reported on the progress of engineering planning for repairs and renovation at the swimming pool.

A special called meeting will be held to consider the final recommendations from the board before bids are let for the state, city and county jointly funded project.

The council approved the annual fire department bill,

renewed EMS insurance and authorized advertising for bids for a new pickup truck, which had been budgeted for the water department.

Attending the meeting were Mayor Giles McCrary,

Maxine Earl, Weaver McKemie, Jack Ault, Lewis Earl and Larry Mills.

Also at the meeting were city employees Wyvonne Kennedy and Mike Sanchez and city attorney Harvey Morton.

**Labor and Worker Compensation**

Effective January 1, certain agricultural labor will no longer be exempt from worker's compensation laws in Texas.

Worker's compensation addresses on-the-job injuries, and the corresponding insurance provides benefits to those injured or disabled while performing work-related functions.

Recent Texas legislation brings agricultural labor under worker's compensation while providing exemptions for some employers under specific circumstances.

Agricultural laborers are classified as either migrant workers, seasonal workers, or farm and ranch laborers.

Small farmers and ranchers qualify for some exemptions. For each of the calendar years 1985, 1986, or 1987, the employer is exempt from subscribing to the insurance if the preceding year's gross annual payroll is less than \$75,000.

The employer is exempt in 1988, 1989 or 1990 if the preceding year's gross annual payroll is less than \$50,000. For 1991 and thereafter, the payroll exemption threshold will be the same as for the seasonal worker provision although no exemption will be allowed if the farm or ranch employs three or more who are not migrant or seasonal workers.

A farm's gross annual payroll includes amounts paid directly to farm or ranch laborers, to seasonal and migrant workers, and to labor agents for their services. It does not include wages paid to the employer or his family a partner or partner's family, or a shareholder or member of his family.

Migrant workers are not exempt under the Texas law regardless of the number of workers employed or the gross annual payroll. Migrant workers are those persons employed in seasonal or temporary jobs who are required to be away from their permanent residence overnight. If migrant labor is provided by a labor agent, the agent is responsible for worker's comp insurance coverage for the employees. If the agent does not subscribe, however, the employer with whom contracted is responsible, along with the labor agent in any

action to recover damages for injury or disability.

Seasonal workers employed on a truck farm orchard or vineyard also are not exempt from worker's compensation. Seasonal workers are employees working in a seasonal or temporary position who are not required to be gone from their permanent residence overnight, says the economist. If a seasonal worker is working for an employer or labor

agent who also employs migrant workers and does the same work at the same time and place, the seasonal worker is then considered to be a migrant worker.

Employers of seasonal workers not on truck farms, orchards or vineyards are exempt in 1985 from subscribing for the insurance if their 1984 gross annual payroll is less than \$25,000.

The exhibit is being sponsored by the Post Art Guild and the bank.

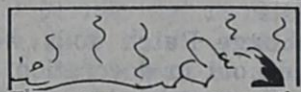
Glenda has been an active and inactive member of the Art Guild for the past 20 years, holding several offices over the years.
