### Post Notes

I had thought about publishing a U.S. flag in the upper right hand corner of this issue of The Post Dispatch, but after considering the uproar over the flag-burning incident, I decided that, since a lot of people still burn trash and frequently use the newspaper to get the fire started, that maybe I'd better not subject the Dispatch to criticism of being unpatriotic.

So, to all those people who are rushing around trying to enforce their ideas of symbolism at the expense of individual freedom, consider the consequences of a constitutional amendment forbidding desecration of the flag.

What happens to people in China who burn the flag? They are accused of fomenting insurrection and being traitors to the revolution...and then taken out and shot.

Is that the kind of freedom we want for America? Do we really want to stifle individual expression, just so that a piece of material, with three different colors arranged in a certain way, can be protected from a few would-be desecrators?

The flag is simply a symbol...and symbols have different meanings to different people...to some the flag might symbolize the enforced slavery that was considered legal for the first 90 years of this nation's history.

To others the flag is a symbol of liberty and freedom.

To many the flag has come to symbolize an oppressive federal government unwilling to hear the cries of agony and suffering by the massive poverty of its people.

To others the flag symbolizes the greed and fraud of its so-called leaders and elected officials. Many a politician has hidden his or her evil deeds behind the cloak of the flag.

To those who opposed the war in Vietnam the flag symbolized a government gone crazy, killing innocent people and ruining the lives of those young men and women we sent to Southeast Asia, trying to enforce our idea of government on a people unwilling to change.

And to many of those young women and men who suffered in that war, the flag symbolizes what they were fighting for.

To everyone it means a little something different.

Try as hard as they will, politicians will never be able to put in a simple statement the symbolism of the flag that will meet the ideas of all the citizens.

If we are to maintain the idealism of our founding mothers and fathers, who literally suffered and died to tear down the symbolism of oppression in their time, we must insist that individual freedom of expression be protected. Liberty, especially individual liberty, can be lost so easily, and once it is gone, it is extremely difficult to recover that precious idea to reality.

U.S. military veterans of all ages have put their lives on the line to ensure that our idea of individual freedom and liberty be maintained...from the battlefields in the 1780s through today's world-wide uncertainties. These men and women were not fighting for a flag...they were fighting for an idea, the idea was symbolized by a flag.

On this July 4th, as we celebrate the courageous act of our ancestors' declaration of independence from a tyrannical government, let us remember the sacrifices that it took to gain the freedom and liberty we enjoy today...and with continued diligence this same freedom may be enjoyed by our grandchildren and beyond.

Let's be careful about how we enforce our ideas on others, lest we ourselves become victims of oppression to another form of tyranny...the tyranny of conformity at the expense of individual freedom.

### Follow Some Major Rules for a Safer 4th of July

An average of 10,525 fireworks-related injuries per year were treated in hospital emergency rooms nationwide during the period 1985-1988, according to the United State Consumer Product Safety Commission (CPSC). The number of injuries reported in this manner has doubled since 1974, when 5,000 injuries occurred.

In 1988, almost 50 percent of the reported injuries happened to youngsters under 15 years of age. Half of the reported injuries consisted of burns, according to CPSC. These statistics do not include the number of injuries which were not treated or those which may have been treated in doctors' offices. The careless use of fireworks results in a significant amount of fire damage each year as well.

For instance, in 1987, fire departments in Texas reported 621 fireworks-related fires to the State Board of Insurance, State Fire Marshal's Office through the Texas Fire Incident Reporting System (TEXFIRS).

These fires resulted in about \$662,652 in property damage. Currently, about 321 fire departments protecting more than 70 percent of the state population submit data to the TEXFIRS.

The State Fire Marshal's Office, a division of the State Board of Insurance, is responsible for the licensing and regulation of the manufacturing, sale and storage of fireworks in Texas.

Paul T. Wrotenbery, Chairman of the State Board of Insurance, joins State Fire Marshal Ernest A. Emerson in offering the following major rules for a safer Fourth of July.

#### July 4, 1980

Approximately 1,000 persons were fed at the evening barbeque in the park following a day of games and sporting events which included the First National Bank Firecracker 500 bike race with three champions - Matt Pennell, John Wheatley and Steffaine Ford.

Don Pennell was the Frisbee Futurity winner in the adult division, followed by Carl Matsler, second; Charles Adams, third; Barbe Bevers, fourth; Albert Castro, fifth; and Debbie Redman, sixth.

In swim meets, Cindee Jackson was the biggest winner, with Bubba Wilson, Becky Shumard, Sarah Alexander, Clay Barnett, Sandra Barnett and David Love also champs in their divisions.

#### July 4, 1970

Post's second annual July 4th celebration Saturday beat the one held in 1969 by a country mile, with approximately 2,500 turning out for the activities in typical July 4th weather.

People began gathering at the park around noon, with stops by the swimming pool to watch the diving competition.

Kim Mitchell and Rodney King were awarded the trophies as the outstanding girl and boy competing in the swimming meet at the pool.

By 3 p.m. the Jaycees' dunking tank and concession booths were attracting the crowds.

About 4 p.m. long lines began forming to file past the serving tables for barbequed beef Rusty Dean and his helpers had started preparing Friday night. The beef was provided with money donated by ranchers, farmers and other individuals and businesses.

Entertainment began soon after 5 p.m. with Bill McBride as master of ceremonies and four local bands and two groups of gospel singers performing alternately from a stage formed by two flatbed trucks.

The two-hour fireworks display, directed by the Jaycees, began shortly before 10 p.m., after Rev. George L. Miller had led the crowd in singing patriotic songs, including "The Star Spangled Banner" as a finale.

\* Many towns and communities have ordinances that regulate the possession and use of fireworks. If you aren't certain about laws affecting fireworks in your area, contact your local fire protection or law enforcement authorities for information.

\* Use only fireworks which are legal for sale or use. Federal law bans fireworks that contain more than 50 milligrams of explosive charge.

\* Designate a responsible adult to ignite fireworks. Never give fireworks to children. Most fireworks injuries are caused by misuse, and mainly by children under 15.

\* Read the instructions. If you don't understand the instructions, don't take a chance by lighting the fireworks.

\* Never experiment with fireworks. Don't take fireworks apart or mix anything with the contents. Never make fireworks at home.

\* Ignite outdoors. Light fireworks only in a clear area away from houses and flammable materials (dry brush, gasoline cans, etc.).

\* Allow enough room for proper functioning. Never ignite fireworks in glass or other containers.

\* Keep a safe distance away from the fireworks ignition area and be sure that other potentially dangerous objects are out of range before lighting fireworks.

\* Never handle fireworks that have malfunctioned. Do not try to relight them or pick them up. Douse them with water instead.

It is vital that parents enforce these rules for the sake of the health and lives of youngsters, because it's the young people who are most often the victims of accidents involving fireworks.

The most common case of injury is due to unsupervised children playing with fireworks which can cause burns to the fingers and hands, ignite clothing and cause possible loss of fingertips. These cases usually occur because the handler has not released the firework before it exploded or the firework has misfired.

Children should not play with fireworks - they are not toys. Even children with sparklers should be supervised. Toddlers will grab at the lit sparkler, which is hot enough to burn someone.

Eye injury is another area of medical concern when it comes to firework safety. According to the American Academy of Ophthalmology, close to 4,000 people will suffer eye injuries, with 1,000 resulting in permanent vision loss, due to faulty firework handling.

Anyone who has been drinking alcoholic beverages should never be allowed to handle or ignite explosive fireworks. Alcohol has been proven to slow down response time.

As many experts recommend, "The best thing to do is watch a professional fireworks display from a distance."
