Council adopts budget including 10 capital improvement projects

Repairing curbs downtown on list

Following through on previously discussed city improvements, the Post City Council voted Monday night at a budget work session to include the 10 projects in the 1992-93 budget.

In approving the budget on its first reading, the council included the repair to downtown curbing, an item which has been discussed by council for the past several years.

Other capital improvements on the list include the purchase of a new vehicle for the sheriff's department, an addition to the fire station building, an office to be added at the cemetery, adding a concrete slab at the park and removal of the catails at the lake, constructing a new dog pound to meet state and federal regulations, sharing one third of the cost of the purchase of a new ambulance for the emergency medical services, water line replacement and repair to the community center.

The proposed budget also includes \$6,000 in merit salary increases approved earlier, a \$3,000 reserve for potential merit increases during the year and \$10,000 for the change to the Texas Municipal League's retirement plan.

"Even after all of these items have been completed," city manager Bob Turner explained, "we'll still have a reserve balance of \$645,239 at the end of

the 1993 budget year."

The city expects to begin this fiscal year with a reserve balance of \$723,777. The budget includes a three percent tax increase, raising the rate from this year's .3335 to .3433, or less than one cent.

Sanitation rates will be increased \$3, with revenues to be used to cover anticipated expenses related to future compliance with solid waste management regulations.

"We've survived the shut down at the mill and the oil price crash," Turner added, "and it appears we have leveled out and are in good financial shape."

City council members each took turns expressing support or disapproval for the proposed budgeted items.

The vote to split three to one, as Dan Lam, Jim Schooler and Maxine Conolly approved and Jimmy Holleman opposed the plan.

Mayor Jim Jackson reminded the council that the vote was the first reading and that changes could still be made, with a public hearing set for September 14.

Schooler complimented Turner for preparation of the budget, "it is clear and easy to follow and you keep us on top of things."

Jackson informed the council that he attended the Texas Department of Transportation public hearing in Crosbyton last week. "I spoke on behalf of the city and explained that we will continue our cooperation with the local engineer and the district." Jackson also said that district engineer Mel Pope expects the IH 27 extension study to take up to two years and that interested citizens could express their opinions by writing to the engineer's office.

"They are looking at IH 27 to connect to IH 20 by either Hwy 84, 87 or through Brownfield," Jackson reported.

Texas Department of Transportation outlines plans for Garza County highway projects

A Texas Department of Transportation public hearing last Thursday evening in Crosbyton outlined plans for highway projects in Garza County, including major reconstruction of portions of U.S. Highway 84.

District Engineer Mel Pope of Lubbock explained the projects in detail to the crowded room of interested citizens from area counties.

In September 1993 the proposal calls for an estimated \$4.1 million for reconstruction of the existing roadway from the Lynn County line to just west of the city limits of Post, approximately five miles.

Another \$4.5 million plus has been proposed for reconstruction of U.S. Highway 84 from Loop 46 (corner of Broadway and 15th Street) to 1.3 miles north of "Green Tanks" (near the Snyder Highway roadside park) for 6.57 miles, to begin in April 1995.

A repair and overlay on Loop 46 from U.S. Highway 380 to U.S. Highway 84 (intersection of East Main Street and Avenue F) is to also begin in April 1995 for an estimated cost of \$140,000 on the 1.215 miles of highway.

Post ISD site-based committee outlines ideas for education improvement

A committee appointed by the Post ISD board of trustees met Monday morning to outline ideas for the site-based decision making for the school district.

Serving on the committee are teachers, school staff members, a school board representative, business people, a senior at PHS and a recent PHS graduate now a college student.

Ideas for improving the educational climate came from all participants and will be consolidated into a statement which will be presented to the board of trustees.

Once the site-based decision making plan is approved, all school campuses will appoint individual site-based committees to develop individual plans to achieve the overall goals.

The broadest statement coming out of the Monday meeting emphasized the overall goal to serve every child from the youngest age to adulthood with the purpose of providing the best possible education so that the individual student may become a productive citizen.

Superintendent Bill Shiver guided the committee in its work, but emphasized that the "work must be done by the committee."

School board trustee Mark Kirkpatrick opened with a brief statement from the board of trustees, citing the goals set by the board.

Kirkpatrick explained that the board has set goals including stronger emphasis on language skills in the earlier year, achieving minimum of 50 percentile on achievement tests, emphasizing positive aspects and student self image and bringing more community and parental involvement into the schools.

This ANN That

With school starting today many of you may be packing lunch for your kids and/or yourself. If you regularly pack lunches, I hope you do so carefully following food safety rules.

It is highly likely that the stomach cramps, diarrhea or vomiting which are blamed on the flu bug going around is caused by "a food bug."

Packing a lunch that can be stored at room temperature and eaten hours later takes extra care. Bacteria that cause foodborne illness grow best at room temperature. In fact, between 40 and 140 degrees F, enough bacteria can grow in 2 hours to cause illness.

Some foods should be kept either cold (below 40 degrees F) or hot (above 140 degrees F). There are perishable foods like meats, poultry, seafood, eggs and milk products (including yogurt). The key to packing a safe lunch is to keep cold foods cold, hot foods hot and everything clean. Here's why and how.

To grow, the bacteria that cause food borne illness need the right temperature, moisture and a food source like protein. So any moist, protein-containing food is susceptible to bacterial growth. If the food is handled a lot during preparation, there's the extra risk of spreading germs from your hands to the food. That means there's more risk of contamination with meat

salads, like ham, chicken or egg salad.

If you choose cooked, ready-to-eat lunchmeats for a sandwich, pay attention to "use by" dates. These products may contain a type of bacteria that can grow slowly at refrigerator temperatures.

Ideally, you should store lunches in a refrigerator to keep them cold.

but this often is not possible. Lunch boxes, especially insulated ones, generally keep foods cold much better than paper bags. A commercial freezing gel, a container filled with ice or a frozen drink helps keep lunch contents chilled. Advise children to place their lunch in as cool a place as possible, never on a window ledge in the sun.

To keep foods hot for several hours, use a thermos designed for hot food. Bring the food to as high

a temperature as possible before pouring in the thermos. The food should still be hot to touch when eaten. Wash the thermos well after each use then rinse the inside with boiling water before using again.

While preparing lunches, keep everything clean to avoid spreading bacteria. Be sure utensils, hands and work areas are clean. Wash food containers, including the thermos and the lunch box itself, after each use. Wrap foods in clean wrap. If using brown paper bags, buy bags made for that purpose. Grocery bags may be contaminated from insects of food leakage.

Occasionally, foods that don't need to be kept hot or cold may be a desirable lunch choice. These foods include peanut butter, dry meats such as beef jerky, and some nonperishable cheeses and cheese spreads. Other options are meat, poultry and seafood canned products, opened and eaten immediately; fresh fruits and vegetables; and bread, cereals and nuts.

1992 Property Tax Rates in City of Post

This notice concerns 1992 property tax rates for City of Post. It presents information about three tax rates. Last year's tax rate is the actual rate the taxing unit used to determine property taxes last year. This year's effective tax rate would impose the same total taxes as last year if you compare properties taxed in both years. This year's rollback tax rate is the highest tax rate the taxing unit can set before taxpayers can start tax rollback procedures. In each case these rates are found by dividing the total amount of taxes by the tax base (the total value of taxable property) with adjustments as required by state law. 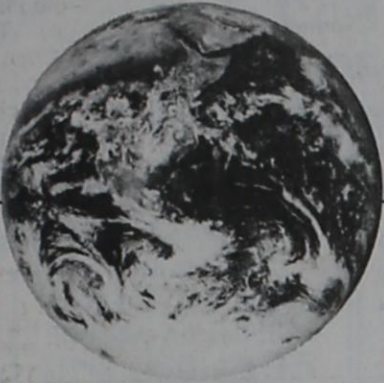

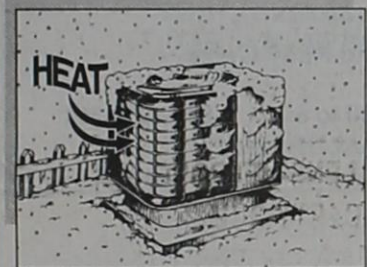

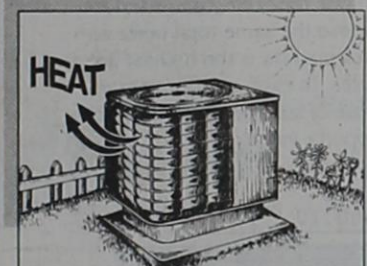

 The Post ISD serves meals each school day. Children grades PreK through 5 may buy lunch for \$1.15 and children in grades 6 through 12 may buy lunch for \$1.25. All children may buy breakfast for \$1.45. Children may also get meals free or at a reduced price.
 If you now get food stamps or AFDC for your children, your children can get free meals. If your total household income is the same or less than the amount on the Income Chart below, your children can get free meals or reduced price meals. A lower child may get free or reduced price meals regardless of your income. The reduced price is \$1.40 for lunch and \$.30 for breakfast.
TO GET FREE OR REDUCED PRICE MEALS FOR YOUR CHILDREN, YOU MUST COMPLETE AN APPLICATION AND RETURN IT TO THE SCHOOL. WE CANNOT APPROVE AN APPLICATION THAT IS NOT COMPLETE.

HOW TO APPLY

If you now get food stamps or AFDC for the child you are applying for, the application must have the child's name, a food stamp or AFDC case number for that child, and the signature of an adult household member. If you are applying for a foster child, the application must have the child's name, the child's "personal use" income, and an adult signature. If you do not get food stamps or AFDC for the child you are applying for, then the application must have the child's name, the names of all household members, the amount of income each person got last month and where it came from, the signature of an adult household member and that adult's social security number or the word "none" if the adult does not have a social security number.

CONFIDENTIALITY: School officials use the information on the application only to decide if your children should get free or reduced price meals.

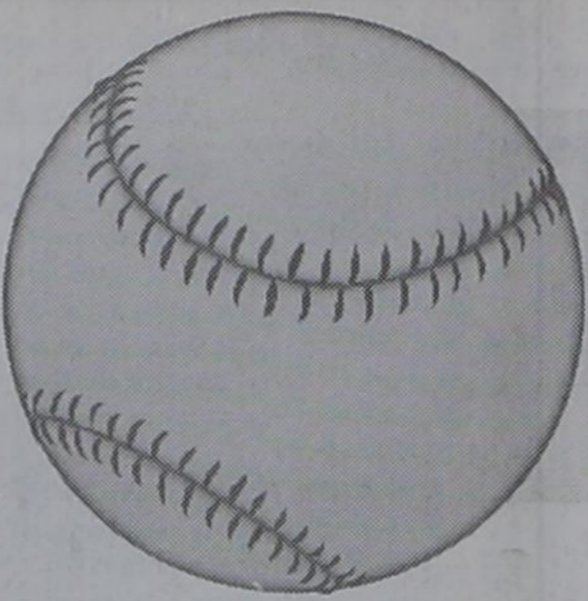

SAMPLE NOTIFICATION TOTAL COLIFORM VIOLATION

The CITY OF POST water system collected 2 water samples during the month of MAY, 1992 that contained Coliform bacteria. The CITY OF POST water system is required to submit a minimum of 4 water samples each month for bacteriological analysis.

The Texas Water Commission sets drinking water standards in Texas and has determined that the presence of total coliforms is a possible health concern. Total coliforms are common in the environment and are generally not harmful themselves. The presence of these bacteria in drinking water, however, generally is a result of a problem with water treatment or the pipes which distribute the water, and indicates that the water may be contaminated with organisms that can cause disease. Disease symptoms may include diarrhea, cramps, nausea, and possibly jaundice, and any associated headaches and fatigue. These symptoms, however, are not just associated with disease-causing organisms in drinking water. The Texas Water Commission has set an enforceable drinking water standard for total coliforms to reduce the risk of these adverse health effects. Under this standard, no more than 5.0 percent of the samples collected during a month can contain these bacteria, except that systems collecting fewer than 40 samples/month that have one total coliform-positive sample per month are not violating the standard. Drinking water which meets this standard is usually not associated with a health risk from disease-causing bacteria and should be considered safe.

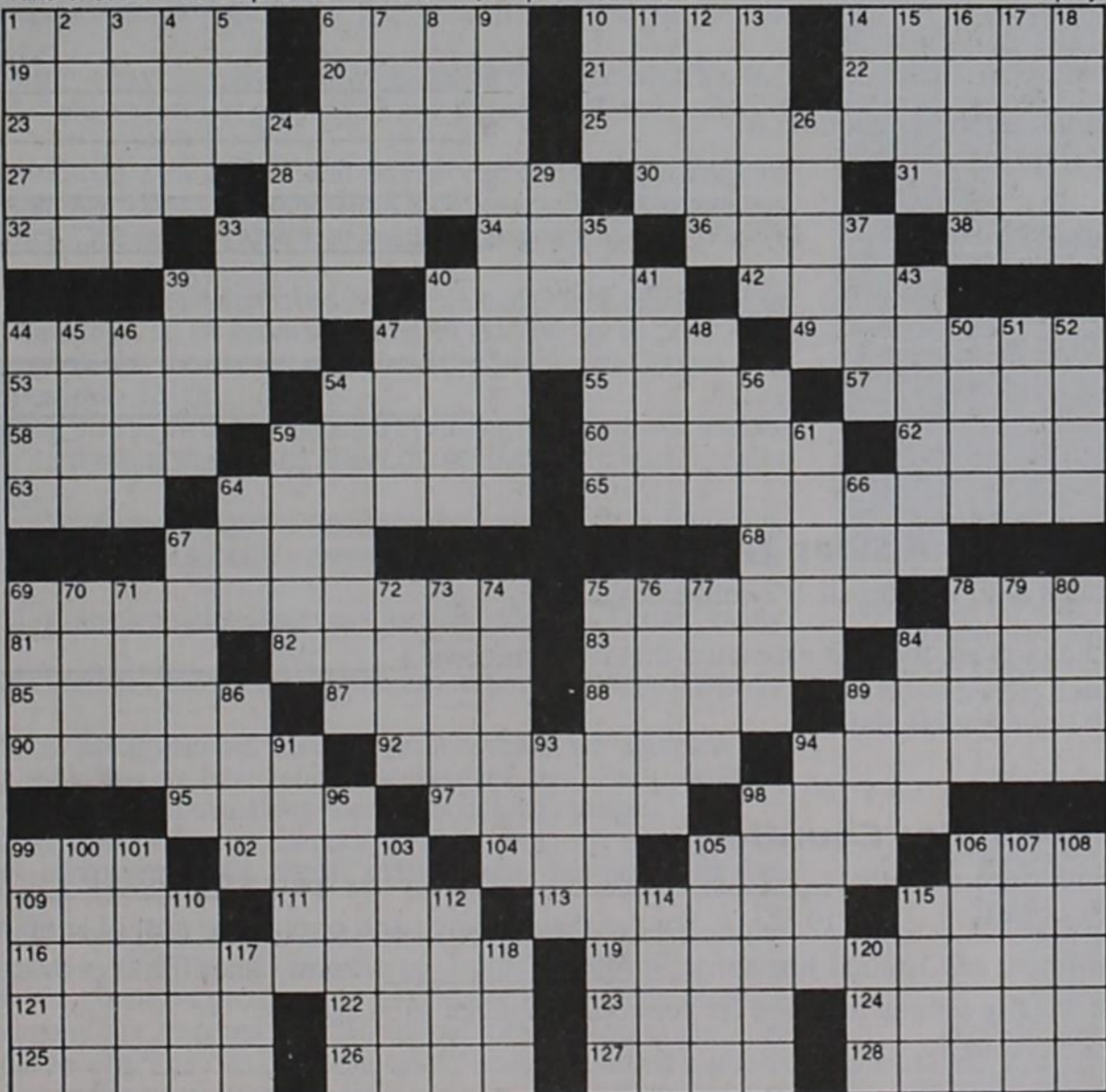

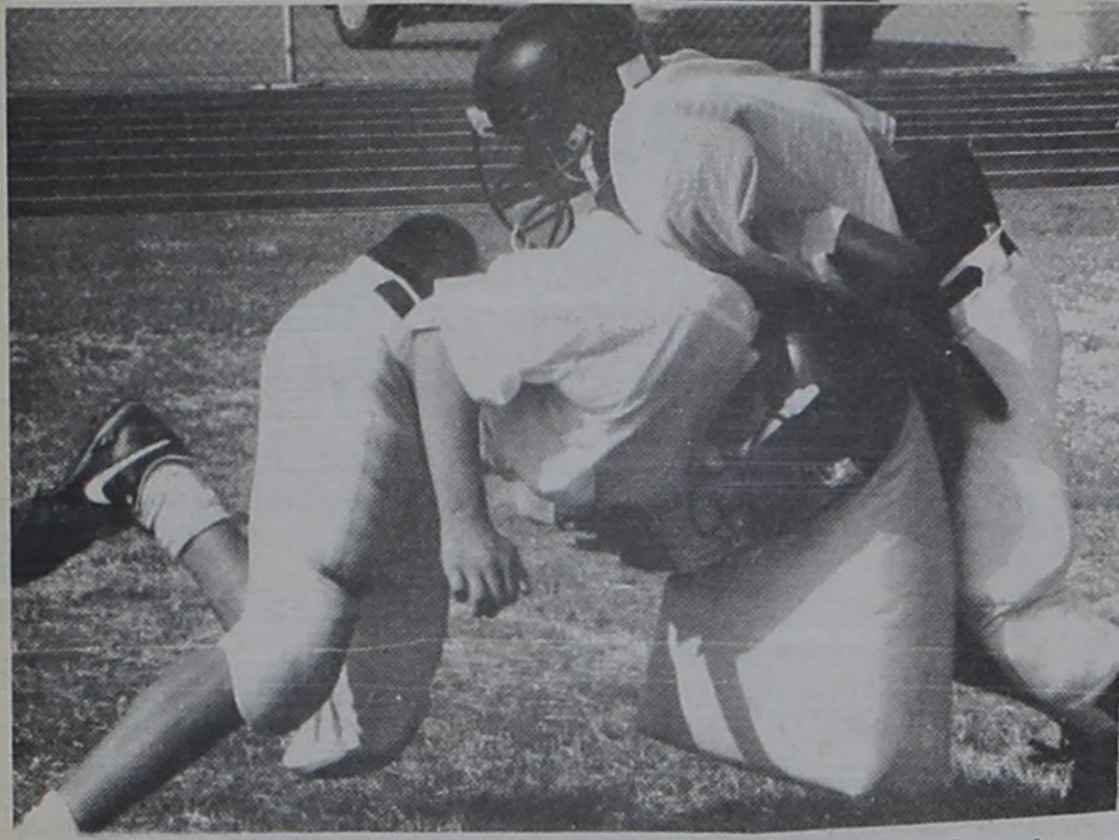
