

Early voting on bond issue said to be unusually heavy

Considerable interest is being shown locally in the \$9 million bond issue that was called by Wichita County commissioners court.

The money would be used to fund the county's portion of a \$25 million project to build a multi-purpose event center in Wichita Falls.

In only two and a half days of early voting, which began Monday, 59 votes had been cast locally.

Explaining the numbers, the early voting poll judge said that was more than are normally cast in any election, even the recent runoff for county commissioner.

Early voting will continue through July 21 for the July 25 election.

There were 12 votes cast Monday, 20 on Tuesday, and by 2 p.m. Wednesday, an additional 27 had been cast.

The election ballot reads, "The issuance of \$9,000,000 of certificates of obligation."

Early voting is being held at the Iowa Park Tax Sub Station, 220 West Park.

The office is open from 8 a.m. to 12-noon and 1-5 p.m. Monday through Friday.

Residents of Wichita Falls will vote twice on bond issues concerning the multi-purpose event center.

Those residents are eligible to vote in the county's \$9 million bond issue, as well as a \$4 million bond issue called by the City of Wichita Falls.

Supporters of the multi-purpose event center say both the county and city have pledged \$9 million to fund the project. An additional \$7 million is to be raised from "other sources within the community."

The complex would be built on both sides of the Wichita River, north of the downtown area in Wichita Falls.

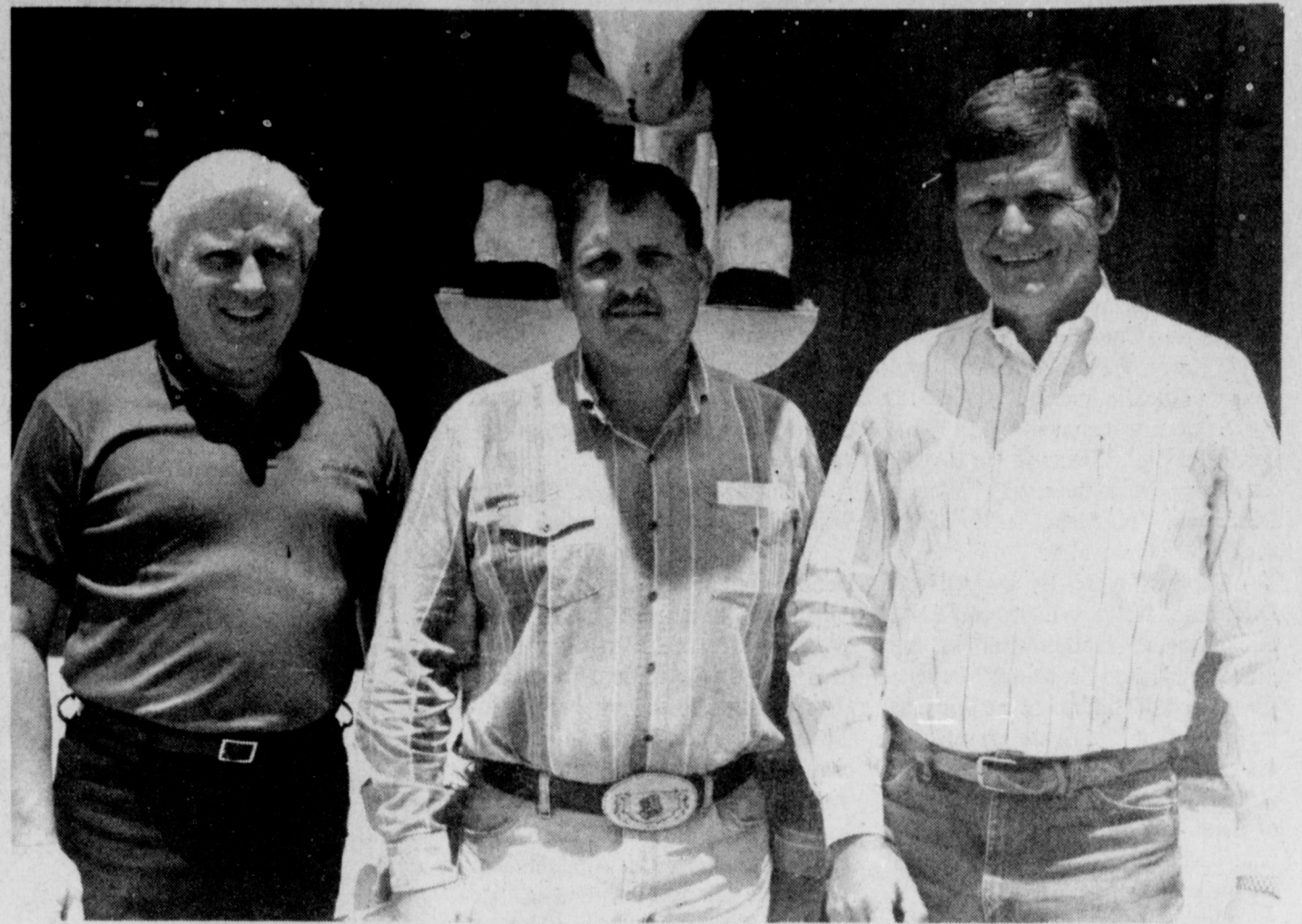
A 7,500-capacity coliseum, with the ability to provide an additional 2,500 seats, and exhibition hall with meeting rooms and banquet areas for 3,000 are planned to be built on the south side of the river.

On the north side of the river is planned an agriculture complex that is to provide four areas: livestock, show arena, practice arena and stalls.

Parking is planned on both side of the river.

The area is generally bounded by Fifth Street on the South, Wichita Street on the North, Scott Street on the East, and Burnett Street on the West. Three additional blocks of parking are planned west of Burnett.

Cripple Children's Auction next week

Members of the cattle auction committee in the 15-county area surrounding Wichita Falls have begun collecting livestock, merchandise and cash donations.

The committee issues an invitation to the public to participate, and there are numerous ways in which an individual or a group may support the event.

The two-day event is a tradition among area cattlemen, farmers, and merchants, who not only donate but attend the auction and buy.

Livestock will be sold beginning at 11 a.m. July 17, at Arrowhead Livestock Sales Barn, south of Wichita Falls on the Jacksboro Highway.

A new feature, the television auction, will be broadcast by TV-3 from the Rehab Center that evening, from 7 to 10. Call-in bidders will be invited to go to the Center to pick up their merchandise, offered a tour of the new facility, and served refreshments.

On the following day, the silent auction will be held from 10 a.m. until 4 p.m. at the Wichita Falls Activity Center. A barbecue will be served the public starting at 5 p.m.

Following the barbecue, the merchandise auction will begin at 7 p.m.

Byers rancher-banker Joe Parker will serve his 24th year as chairman of the event. Hollis Dickey of Waurika has been auctioneer almost since its 1968 beginning.

The "cattle auction" started with donations of livestock only, but through the years has increased to merchandise items of high quality.

FACULTY SELECTS

Teacher of the Year

"My greatest contribution to education is teaching first graders to read," said Dorothy Palmer, who has been first grade teacher at Kidwell Elementary eight years.

Mrs. Palmer recently was selected Teacher of the Year for the Iowa Park Independent School District. She was chosen for the honor from peer nominees representing grades K through 12. The program is designed to recognize outstanding classroom teachers.

She now is in competition for Regional Teacher of the Year to be selected in September. Regional winners will automatically become entrants in the State Teacher of the Year contest.

An elementary teacher 17 years, she began her teaching career in San Antonio, where her husband, Robert, (now Iowa Park High School assistant superintendent) was stationed in the service at Fort Sam Houston. When their son, Bruce was born she quit teaching six years, however, she substituted during those years.

When her husband was discharged from service, they returned to his home town of Electra where she taught second and third grades until moving to Iowa Park eight years ago.

"Fostering a desire and encouraging and supporting first graders to learn to read, helping them develop good self-esteem and set learning and work patterns for years to come, gives me a lot of pleasure. In fact, I consider that my greatest contribution in my teaching career," Mrs. Palmer commented.

Dorothy has always had a desire to help and teach children. She credits her mother, her teachers and the people in her community who touched her life with creating within her a desire to give something back by becoming a teacher.

Mrs. Palmer was reared in Burkburnett. Her father died when she and an older sister were in high school and her younger sisters were eight years old.

She said her mother, Verdine Reynolds, worked hard for low wages and really sacrificed so she and her sisters could receive college education.

"My mother always wanted us to learn and she gave us every learning experience and opportunity she could. My teachers instilled in me enthusiasm, interest and the love of learning, and the people helped me obtain a higher education by awarding me scholarships and by giving other help," Dorothy explained.

She added that she tries to share some of the difficult times with her students in an effort to help them understand that some things are worth hard work and sacrifice.

Mrs. Palmer earned the BSE degree at Midwestern State University, 18 graduate hours from MSU and Texas Women's University at Denton, and seven college computer hours from Vernon Regional Junior College at Vernon, in addition to numerous workshop hours.

She continuously seeks to improve her teaching through seminars and other training.

According to Ron Woods, Kidwell principal, Mrs. Palmer is on numerous committees and is always engaged in developing new ideas in improving curriculum. In this and effectiveness in teaching skills, she apparently does extremely well as she is on Level Three of the teachers' career ladder.

"I believe children must be treated with respect and consideration.

I try to create an atmosphere where every child feels that he belongs and that he is a capable, special and useful human being. I believe that is very important and contributes to each child achieving his fullest potential," Dorothy said.

Mrs. Palmer uses storytelling effectively in her classroom to develop listening skills, spark imagination, extend vocabulary, reinforce curriculum skills, and help children understand diverse cultures.

She said, "We listen to stories that originated in different areas of our country and in other countries. I use storytelling to reinforce sequencing skills."

"First graders are so excited about learning, and I encourage them to retell stories to improve their oral communication. Children can remember events in sequence much better through storytelling. I believe that it is a very useful teaching tool, as they use their different senses to experience what they are hearing, or telling.

"One little girl came to me after a story telling session about Hawaii, and excitedly said, 'I feel just like I've been to Hawaii.'"

Mrs. Palmer said she uses reader's theater to share newly gained reading skills with the kindergarten classes.

She makes poster board illustrations of several short stories. A child steps forward showing one poster page, and the next child reads it with expression. "I think it gives my students a desire to read well, and I believe we provide kindergarten students with good role models and something to look forward to in first grade," she remarked.

Mrs. Palmer is a member of Texas Federation of Women's Club, Immediate past president of GFWC Amity Study Club. She is active in PTA and the Association of Texas Professional Educators and is past president of the Iowa Park Chapter of ATPE. She also is active in First Baptist Church.

The Palmer family is active in recreational volleyball competition and support all school sports activities. They support the idea that a healthy-active body promotes a

Police arrest man for theft

An 18-year-old man was arrested Tuesday, clearing the theft of a motorcycle from the 200 block of West Smith on June 28.

Also reported Tuesday was a theft case and criminal mischief. A bicycle valued at \$150 was reportedly taken from the 400 block of West Texas. That complaint was filed at 10:55 a.m.

Tuesday afternoon, a resident in the 500 block of South Colorado told police a blue and white pickup had struck a fence in the yard. The pickup left without notifying the owner, and also left without a bumper, according to the blotter entry.

Council to consider tax change, purchase

The city council will consider changing its taxing method for the telephone company, and purchasing a street sweeper, during Monday night's meeting.

The meeting is to begin at 7 p.m. in council chambers.

A proposal to repeal an ordinance applied to taxing of Southwestern Bell Telephone, and adopt a new formula of taxing on gross receipts, according to the posted agenda.

Authorization will be considered to allow Administrator Gary Jones to take out a \$6,000 loan to purchase a used street sweeper from the highway department.

The loan would be for a six-month period, to be paid out of the 1992-93 budget.

A briefing on delinquent taxes by Allen Shewmake, local tax collector, is to be made, and the council is to consider approval of next year's budget for the Emergency 9-1-1 telephone system.

The city administrator's report to the council is to include the current year's budget situation, as well as a shortfall in revenue to the utility fund, caused by a lack of outside watering.

The year's persistent rainfall has thrown the city's projected sales of water for the year completely out of kilter.

During the second quarter of 1992, the city's sales of water is approximately eight million gallons lower than 1991.

Residents simply are not needing to water their yards and gardens this

year, because of persistent rains.

Last month, only 24,810,300 gallons of water were sold to city water customers, including local residents, the Wichita Valley Water Co-op, and two housing areas.

Street work schedule told

Weather permitting, street crews are planning to apply slurry coatings to five streets next week.

Public works director Mike Price said next week's schedule includes: Monday - all of Mary Drive; Tuesday - 1500 block of Douglas; Wednesday - 1000 and 1100 block of North Fourth; Thursday - 1200 and 1300 blocks of North Fourth; Friday - all of Sunset.

Price explained earlier that the original schedule that was published was thrown off because of heavy humidity which delayed the slurry applications' drying process.

Residents of the scheduled streets are asked to not attempt to drive on streets being treated until barriers are removed.

A new list of street schedules will be printed in the July 16 issue of the Leader.

As I See It. . .

By Bob Hamilton



A prudent economic fact is that one should not spend money he doesn't have. But that's just what our commissioners court promised to do when three of the five voted to commit \$9 million toward the construction of a \$25 million multi-purpose event center in Wichita Falls.

The county has overspent its budget by \$1.4 million last year and will be an additional \$1 million this year, all of which is coming out of its \$3.7 million carryover it had at the end of 1990.

Commissioners explained they would simply use the 2.5 cents on the current tax rate to pay for the \$9 million in bonds. That 2.5 cents has been collected over the past few years to pay for the jail renovation project.

As you will recall, the commissioners had just figured they would raise the \$9 million from certificate of obligation bonds. But petitions were circulated and signed by enough taxpayers in the county to shoot that idea down, and an election was called for July 25, seeking approval for the court to sell \$9

million in general obligation bonds. The county's ability to pay for that amount of bonds, spread out over a 20-year period, is in question. At least, without raising taxes.

First of all, that 2.5 cents on the current tax rate is to expire this fiscal year, as the jail bond money will be paid back.

If that 2.5 cents on the tax rate were to be continued, as the court intended, isn't that in fact a tax increase. Seems to me if it wasn't to be continued, then it is an increase.

Well, a promotion sheet explaining all there is anyone should want to know about the multi-purpose event center, prepared by "volunteers" of Wichita Falls, states in three different places that no tax increases, either in the county or in Wichita Falls, would be necessary to pay for the center.

"Both County and City Governments have gone on record pledging that there will be no tax increase to pay for the facility," the information sheet states.

Twice more, explanations end with the phrase "...without a tax increase."

Now, I can't comment on the financial status of Wichita Falls, but from a letter county judge Nick Gipson sent to all county department heads, dated April 1, there sure will be a tax increase. And that letter did not mention the multi-purpose event center funding.

"It will be my proposal for the 1993 budget to be presented to the Commissioners Court to offer a combination of expenditure cuts and revenue increases equalling 10% of our general fund or \$1 million," Gipson wrote.

"By the previous actions and their public statements over the months that have passed since the allocation of the 1992 budget, members of the Commissioners court have made it clear that they will not consider as a solution to the deficit budget the mere raising of taxes.

"Even if they did and we raised taxes to the rollback rate and froze expenditures at the 1992 level, our budget still would not be balanced. Therefore, my solution to the deficit budget will be one of combined expenditure cuts and increased revenues..."

You make up your own mind about the county's commitment of \$9 million to help pay for what I have called an urban renewal program for Wichita Falls.

I've made mine up. And I've already cast my early vote at the county tax office here.

The German student has had opportunity to visit Austin, San Antonio, Dallas, New Braunfels and other Texas cities and expects to visit Six Flags, Texas Stadium, the Astrodome and other Texas attractions before returning to her homeland.

Nicola's family will be the host family for Karlee during her stay in Germany. They've planned a tour of Hamburg and Berlin, as well as other

attractions in Germany.

Karlee and Nicola were guests at the the Iowa Park Rotary Club meeting Wednesday where they gave a brief presentation of the student exchange program and their experiences to date.

Karlee will share her travel experiences with members of the Iowa Park Rotary Club, which is sponsoring her, when she returns.

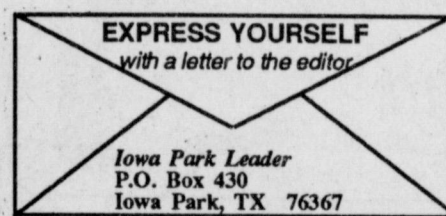

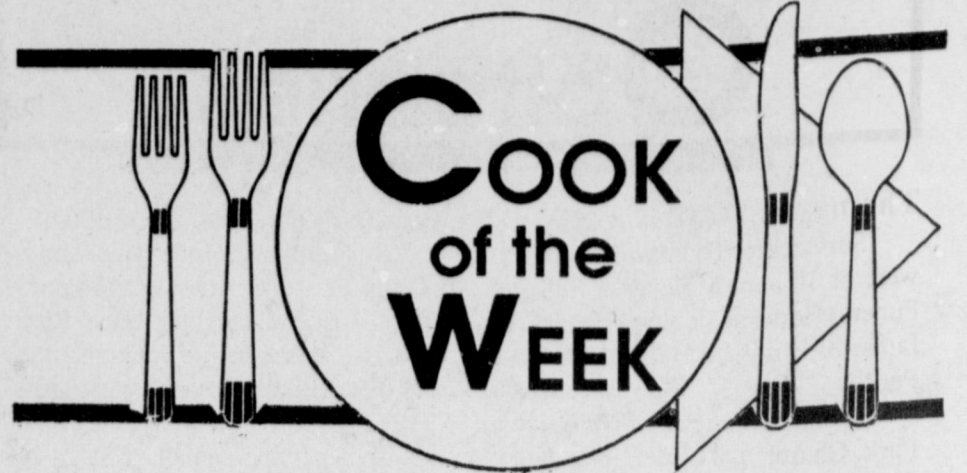
They are members of Faith Baptist Church.

Cheesecake

Preheat oven to 350 degrees.

- Crust:**
1 cup flour
2 Tbsp. sugar
1/2 tsp. baking powder
1/4 tsp. salt
1/3 cup butter
2-3 Tbsp. milk



In mixing bowl, combine dry ingredients with softened butter and mix well. Add milk and work into a ball of dough. Pat out crust along bottom and sides of an 8" springform pan. Place in refrigerator while making the filling.

Filling:

- 1 1/2 lbs. cream cheese, softened
1 1/4 cup sugar
5 eggs
1 1/2 tsp. vanilla
1 1/2 tsp. lemon juice

In large mixing bowl, combine cream cheese and sugar with electric mixer. Add eggs one at a time, mixing well after each egg.

When all eggs are blended thoroughly, add vanilla and lemon juice. Pour into prepared crust and bake one hour at 350 degrees until golden. Let cool. The middle will sink down, making a nice bowl in which to place desired fruit topping.

Chicken Parmigiana

- 1 pkg. boneless, skinless chicken breasts

Mix and set aside:

- 1 egg
1 Tbsp. milk
Combine:
Salt, pepper
1/2 cup grated Parmesan cheese
1/4 cup flour
1 Tbsp. paprika

Mix well.

Rinse and pat chicken. Dip in egg mixture and dredge in flour mixture. Put in baking dish. Pour 1/4 cup melted butter over chicken. Bake at 350 degrees one hour or until tender.

Sauce:

- 1 8 oz. can tomato sauce
Garlic, italian seasoning, salt and pepper to taste. Heat thoroughly.

Crab-Stuffed Chicken Breasts

- 4 whole med. chicken breasts
3 Tbsp. butter or margarine
1/4 cup flour
3/4 cup chicken broth
1/3 cup dry white wine
1/4 cup onion
1 Tbsp. butter
1 - 7 oz. can crab meat, drained, flaked, and cartilage removed
1/2 cup slightly crumbled crackers (10 crackers)
1 - 4 oz. can mushrooms, drained
2 Tbsp. snipped parsley

- 1/4 tsp. paprika
1 cup shredded Swiss cheese
Hot, cooked rice
1/4 tsp. salt, dash of pepper

Place chicken, boned side up, between 2 pieces clear plastic. Tenderize, forming a rectangle approximately 1/8" thick.

Wine Sauce:

Melt 3 Tbsp. butter in saucepan. Stir in flour. Add milk, chicken broth and wine. Cook and stir until thick and bubbly, then cook 1-2 minutes more. Set aside.

In skillet, cook onion with 1 Tbsp. butter until tender but not over-cooked. Stir in crab meat, crackers, mushrooms, parsley, salt and pepper. Stir in 2 Tbsp. wine sauce. Top each chicken piece with 1/4 cup crab mixture, fold sides in, and roll up.

Place seam side down in 12x7 baking dish. Pour wine sauce over all. Bake, covered for one hour or until chicken is tender. Sprinkle with cheese and paprika. Bake two minutes longer, or until cheese melts. Serve on platter with rice.

Potato Casserole

- 1/4 cup margarine melted in baking dish
2 lbs. frozen hash browns, slightly thawed

Mix together:

- 1 can cream of chicken soup
8 oz. Velveeta chunks
1 cup sour cream
1/2 cup chopped onion
Spread mixture on potatoes. Top with 2 cups crushed corn flakes mixed with 1/4 cup melted margarine. Bake one hour at 350 degrees.

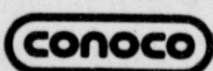

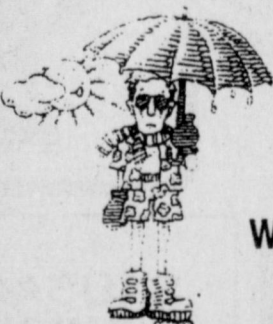


