TO FIGHT RURAL FIRES

Area mayors to appeal for more county funding

City aldermen Monday night indicated their support of an effort by three Wichita County mayors who plan to make a joint appeal to commissioners court for more equitable funding of their fire departments.

Mayor Wayne House told the council that he and the mayors of Electra and Burkburnett are unanimous in their desire to receive more adequate funding to offset all the fires their departments fight in the rural area.

In other business, the council voted to seek bids for street construction in a portion of the new Park Place Addition; authorized the city administrator to lease a brush chipper for a 30-day trial period; and held discussions on a proposed golf course, rate increase request for ambulance service, and an ordinance under consideration which would restrict the location of any sexually-oriented business that might locate in the city.

The mayor said he and the mayors of Electra and Burkburnett were all in agreement that the county's formula of funding each of the fire departments outside Wichita Falls equally, despite how many rural fires they respond to over a year's period, was in need of change.

The county funds \$14,400 to each of the departments.

But House said what is happening is, residents in those cities are supplementing the cost of rural firefighting with their tax dollars.

He gave the example that Iowa Park's budget for 1993-94 for its volunteer fire department is \$98,040, yet over the years, 75 to 85 percent of all fires responded to are outside the city limits.

And that does not include those calls for the department's emergency medical response team and vehicle.

House reported that during the first seven months of 1993, firemen responded to 82 fire calls, and 76 of those were outside the city limits.

Various proposals which might be submitted to the commissioners were discussed.

The proposals included a formula based on a five-year history of rural fires fought; a special tax on rural property specifically for fire fighting; and contracts between owners and cities that would reimburse the cities when departments were called out.

House did not say whether and the other mayors would meet with the commissioners, but it would be well before the county begins planning its next year's budget.

Aldermen delayed action on a new contract with Life Line EMS, Inc., to raise its fees. The county and cities of Iowa Park, Burkburnett and Wichita Falls are all involved in the contract and must approve any changes made.

Life Line is requesting to raise its "Advanced Life Support" rate from \$198 to \$218; "Routine" calls from \$144 to \$158, and "loaded mile" fee

from \$3.20 per mile to \$4.

Questions about definitions, as well as bills that were known to have been paid that were above those posted fees were the reason for the delay.

That will be one of the subjects on the agenda for a called meeting which will be held next Monday.

Following a lengthy discussion, aldermen voted to advertise for bids to pave the initial streets to be laid in Park Place Addition.

The council agreed to do the initial paving, as well as installing utilities in a portion of "Phase One" of the addition, and the developers will reimburse the city as each lot is sold. Total reimbursement is to be made within three years, whether all lots are sold or not.

An abandoned oil transmission line owned by Conoco was a sticking point, brought out during the discussion. The mayor wanted that issue to be finalized before the city took any action, but aldermen argued the line had nothing to do with the city's portion.

Arrests made in Graham of forgery ring suspects

An arrest Tuesday of last week in Graham could possibly lead to the breaking up of a gang that had been passing forged checks all over this part of the country.

Already one warrant issued here has been served on one of the suspects, for forgery, and others are expected to follow.

Iowa Park police became suspicious that a gang of some five men and women was operating out of Wichita

Falls. They believed the members were either stealing or passing forged checks at chain-owned stores over the area, and then exchanging the merchandise elsewhere for cash.

Iowa Park Detective Lynn Collins had been contacting representatives of area police departments, and their suspicions were correct.

Graham detective Charlie Parker was in his local Wal-Mart store Tuesday, and was alerted that one of the suspects was at the check-out counter.

Parker reportedly took off his badge and gun, and went to the counter area to report the situation. After he had visually identified the female suspect, he told her she was under arrest.

The suspect began running up and down aisles, trying to escape, according to a report, before she was taken into custody.

Arrested was Kristi Gregory, 28. Parker and other officers then located the suspect's husband, Randy, and another man, Michael Miller, in a vehicle in the parking lot, and took them into custody.

During a search of the vehicle and discovered an elaborate method the group used to alert others, in case a policeman or patrol vehicle were spotted in the area.

It was a device in the car that sounded a beeper the suspect in the store had. But it wasn't sounded in time to prevent the capture of the female.

Police also reportedly found less than two ounces of marijuana and drug paraphanelia in the Gregory vehicle, and he was charged with possession.

Collins, after learning Kristi Gregory was arrested, called her to the station. Continued on page 4

Domestic disturbance ends in three charges

Before police completed their handling of a man Thursday night who was allegedly involved in a domestic disturbance, the suspect had three different charges filed against him.

Police were called to a residence in the 800 block of North Wall at 10:24 p.m., where a man was reportedly engaged in a fight with his wife.

By the time they got Frank Kelnhofer, 40, to the police station, he was facing a Class B assault charge, criminal mischief over \$200, and resisting arrest.

Kelnhofer, who reportedly inflicted considerable damage to the interior of the police cruiser while en route to the station, was treated by emergency medical technicians, and then taken to the county jail.

Shortly after midnight Saturday, police arrested David Lynn Marsh, 23, in the 400 block of West Park, on a charge of public intoxication. He was released eight hours later, after paying a fine of \$280, according to the police blotter.

A charge of assault to prevent family violence was filed against Ronnie Teague, 23, when police responded to a domestic disturbance in the 300 block of East Garden at 2:08 a.m. Monday.

A resident of the 400 block of East Jefferson reported his pickup had been burglarized sometime between Friday night and Monday morning.

An inventory indicated that \$3,130 worth of tools were taken from a twin tool box on the vehicle.

SNB slates groundbreaking for branch in Wichita Falls

State National Bank will break ground for its first-ever branch office Tuesday, in Wichita Falls.

A ceremony is to begin at 1:30 p.m. at Thaten Shopping Center, on Old Iowa Park Road, according to Gene Jordan, SNB president.

The new institution, to be known as Wichita Falls Branch of State National Bank of Iowa Park, will initially have 3,000 square feet of space, and additional space for future expansion.

Hal Williams, of Electra Construction Co., is general contractor, and the building is expected to be open for business in June, weather permitting.

The branch will be located in the shopping center's large parking lot, nearest the old highway. Entrances off the four lanes of traffic to the area are

on either side of the acquired property.

For customer convenience, the branch will have three drive-in areas and an ATM lane. It will be FDIC insured and be a full-service facility.

Branch manager will be Bill Hoffman, veteran of 13 years banking in Wichita Falls. He is a native of Windthorst, and is also a Certified Public Accountant.

Hoffman is to complete his current obligations Feb. 16, Jordan said.

Assistant manager is Michelle Wells, who has worked in virtually every department of State National Bank. Three tellers will also be employed when the branch is ready to open.

State National Bank is a member of North Texas BankShares, which also owns four other banks and two other branches.

The meeting closed with the drawing of names for Secret Pals for 1994.

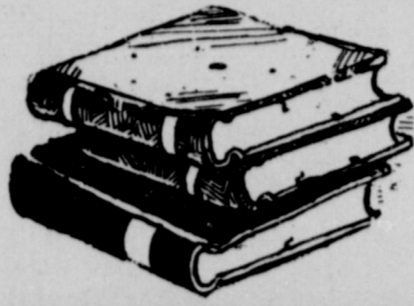

Beverly grew up in Wichita Falls and is a graduate of Wichita Falls High School. She has lived in Iowa Park since 1963.

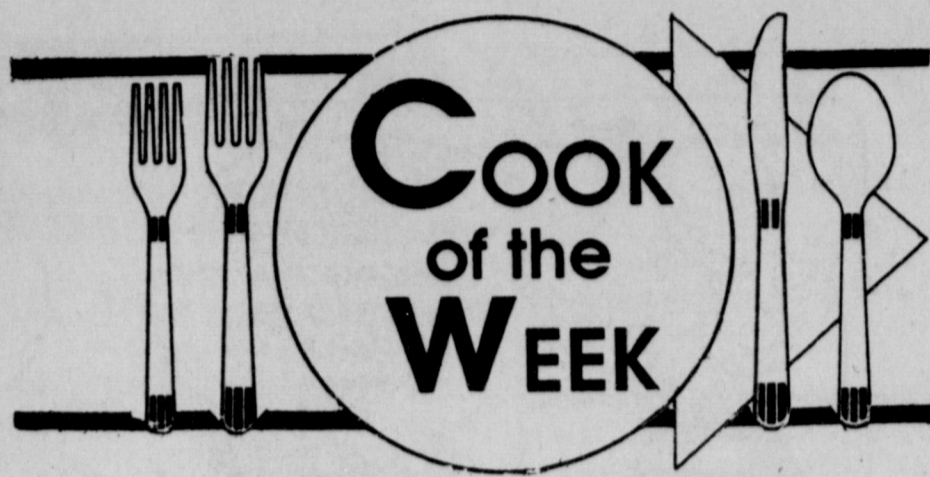

Round Steak Sauerbraten

- 1 1/2 lb. round steak
- 1 Tbsp. bacon drippings
- 1 envelope brown gravy mix
- 2 cups water
- 1 Tbsp. instant minced onion
- 2 Tbsp. white wine vinegar
- 2 Tbsp. brown sugar
- 1/2 tsp. salt
- 1 tsp. Worcestershire sauce
- 1 bay leaf
- Hot buttered noodles

Cut meat into 1-inch squares. In large skillet, brown meat on all sides in hot drippings. Remove meat from skillet; add gravy mix and water. Bring to a boil, stirring constantly. Stir in remaining ingredients except noodles. Return meat to skillet; cover and simmer 1 1/2 hours, stirring occasionally. Remove bay leaf. Serve meat over hot buttered noodles.

Easy Chicken Casserole

- 4-6 boneless, skinless chicken breasts
- Flour
- 1 egg
- Milk

Beat milk and egg together. Dip chicken breasts in flour, milk/egg mixture, and again in flour. Fry in skillet until golden brown, then place in casserole dish.

Combine:

- 1 can cream of celery soup
 - 1 can cream of chicken soup
 - 1/2 soup can water
- Pour over chicken and bake in 325 degree oven until done - about 1 hour.

Variation:

Peel and chunk up potatoes and place in casserole dish with chicken. Bake as directed.

German Chocolate Pie

- 1/3 cup sugar
- 3 Tbsp. cornstarch
- 1 1/2 cup milk
- 1 (4 oz.) bar sweet baking chocolate, broken into pieces
- 1 Tbsp. butter or margarine
- 2 egg yolks, beaten
- 1 tsp. vanilla extract
- 1 baked 9-inch pastry shell
- 1 egg, beaten
- 1/2 cup sugar
- 1/4 cup butter or margarine
- 1 (5.3 oz.) can evaporated milk
- 1 1/3 cup flaked coconut
- 2/3 cup chopped pecans

Combine 1/3 cup sugar and cornstarch in medium saucepan. Gradually add 1 1/2 cup milk, stirring well. Add chocolate and 1 tablespoon butter. Cook over medium heat, stirring constantly, until chocolate and butter melt and mixture thickens. Reduce heat and cook 2 minutes, stirring constantly. Gradually stir about 1/4 of hot mixture into 2 egg yolks. Add to remaining hot mixture, stirring constantly. Cook over medium heat until mixture thickens; cook an additional 2 minutes. Remove from heat and stir in vanilla. Pour chocolate mixture into pastry shell.

Combine egg, 1/2 cup sugar, 1/4 cup butter, and evaporated milk in saucepan. Cook over medium heat, stirring until mixture thickens. Remove from heat; add coconut and pecans, stirring well. Spread over chocolate filling. Let cool slightly. Cover and chill 4 hours.

Glazed Carrots

- 8 cooked carrots, sliced or cut in strips
 - 1/3 cup brown sugar
 - 2 Tbsp. butter
- Heat together brown sugar and butter until sugar dissolves. Add carrots and cook over medium heat, turning until well glazed, about 12 minutes.

Skillet Squash

- 2 Tbsp. olive oil
- 1 large zucchini
- 1 large yellow summer squash
- 1/3 cup red bell pepper, chopped
- 1/2 tsp. oregano
- 1/2 tsp. salt
- 1/4 tsp. black pepper
- 1/4 tsp. garlic powder

Slice squash into 1-inch chunks. Heat olive oil in medium skillet over medium heat. Add squash, pepper and spices and saute for 10 minutes. Don't allow squash to become mushy.

Fresh Vegetable Marinade

- 4 stalks broccoli (fresh)
- 8 large fresh mushrooms, sliced
- 1 medium-sized green pepper, chopped
- 3 stalks celery, chopped
- 1 small head cauliflower, broken into flowerets

Poppy Seed Dressing

- 1 cup sugar
- 2 tsp. dry mustard
- 1 tsp. salt
- 1/2 cup vinegar
- 1 1/2 cup vegetable oil
- 1 small onion, grated
- 2 Tbsp. poppy seed

Remove flowerets from broccoli; cut into bite-size pieces. Reserve stalks for other use. Combine flowerets, mushrooms, pepper, celery and cauliflower; toss lightly. Combine remaining ingredients; mix well and pour over vegetables. Chill at least 3 hours. Best served on the day made. Poppy seed dressing keeps great in refrigerator. Yield 10-12 servings.

The video will be placed in the library at Texas Garden Clubs, Inc., State Garden Club headquarters in the Botanic Gardens in Fort Worth.

All garden clubs in the state of Texas may check material out of the library.

Marie Wooten, horticulture chairman, gave each member an "Individual Horticulture Rating Sheet" to keep track of individual plantings throughout the year.

Denise Gilmore gave the conservation report on ECO-FOAM, an environmentally safe packaging material.

ECO-FOAM is composed of over 95 percent starch and a small amount of a water soluble organic polymer. It readily decomposes in water. It also can be reused as packing material, or can be disposed of by putting it in

a compost pile or watering it into the lawn.

Hostesses Gala Mikkelsen-Pinnix and Vickie Gilmore served sack lunches and soft drinks.

As members enjoyed the picnic, they viewed a video on the Butchart Gardens, presented by Bernice Williams.

The Butchart Gardens cover approximately 50 acres 10 miles north of Victoria, British Columbia. The 90-year-old gardens occupy an abandoned limestone quarry and attract many tourists to Vancouver Island.

The gardens include a sunken garden, an English rose garden, and Italian and Japanese gardens.

Symphony concerts and night illumination add to the beauty of the setting. More than 5,000 varieties of flowering plants, shrubs, and trees grow in the gardens.

Nineteen members of the club attended the meeting held at the RAC.

During a regular meeting of the Iowa Park Ministerial Alliance, members elected Glen Blackmon, minister of First United Methodist Church, as president.

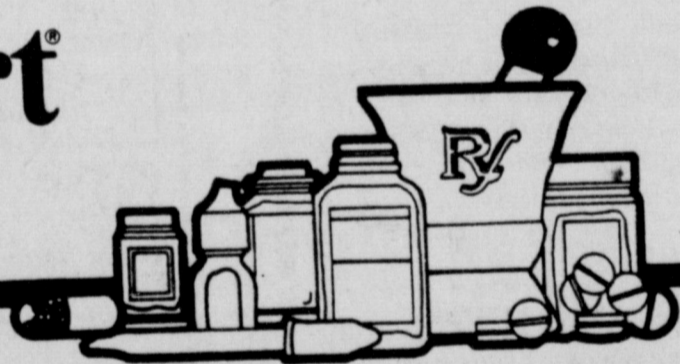
Blackmon fills the position vacated by Mike Grubbs, who took a chaplain position in Albuquerque, N.M.

But before the city makes any expenditures on its part, a finalized contract with the developers, Tommy Key and Tommy Hammonds, must be put in place.

In an update on plans for the proposed golf course to be built around Lake Iowa Park, House told the council the project is still very much alive.

He pointed out that some changes from the original plans were needed, because some erroneous water level figures had been used in original calculations, but should have no effect as far as those working on the project are concerned.

House said the financial backer was not asking for any investment from the city, other than a long-term lease on the land.

For the second time, the city has received bids for the purchase of a brush chipping machine. The original bids were all rejected, for various reasons.

At the suggestion of Administrator Mike Price, the council decided to accept a proposal by the supplier to lease a machine for 30 days, at a cost of \$2,100, to see if it is what the city wants and needs.

Price said there is already more than enough supply of trees and brush trimmings to use during the trial.

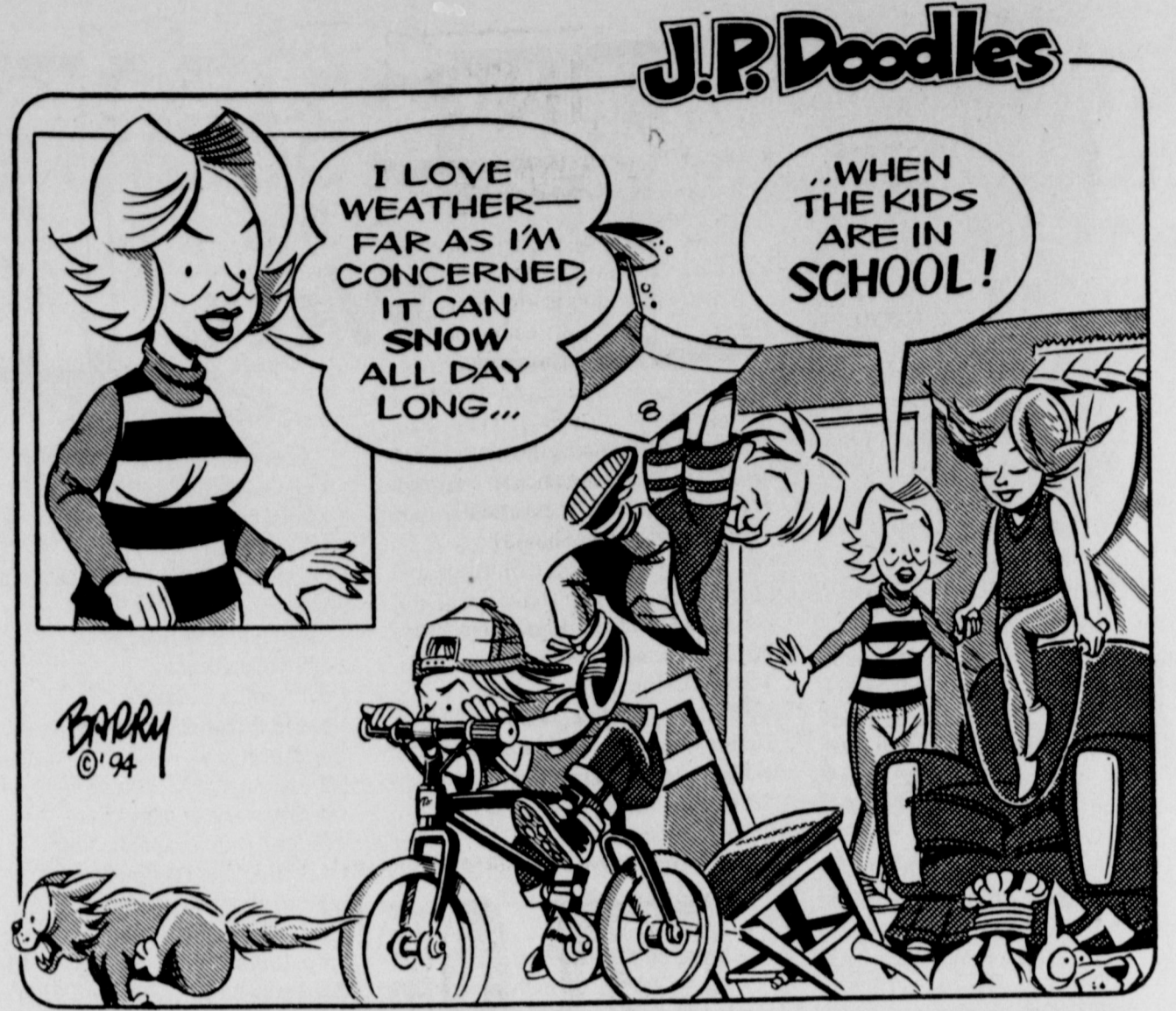
Changes were suggested to be made in a proposed ordinance that, if adopted, would restrict the location of any sexually-oriented business that might locate in the city.

Responding to a question from the audience, whether such a business is going to open here, Alderman Bob Hamilton said control was necessary before, rather than after, such a business does open.

If the ordinance were not already in place, the business would be "grandfathered" until it might move to a different location.

The city's ordinance would not affect any such business that might locate immediately outside the city's limits, however.

Because no such ordinance has ever been adopted by the commissioners court, Hamilton said it was possible for such a business to open its doors immediately next to Bradford Elementary, or in various tracts that are made virtual islands because they are surrounded by the city.

gory was in custody, served his warrant for her arrest Wednesday afternoon, while she was in the Graham jail.

That warrant stemmed from two forged checks that were passed Jan. 1 and 2 for purchases at the Iowa Park Wal-Mart store.

Those two purchases were made with forged checks on an account of "Joe or Elizabeth Whitaker" of Wichita Falls.

Collins said Wal-Mart loss-prevention personnel from Bowie, Eastland, Breckenridge, Gainesville, Burkburnett, Wichita Falls and Oklahoma cities of Lawton, Marlow and Duncan, also are interested in the suspects, and others who may be named in the near future.

The gang had interest in other chain stores besides Wal-Mart, and a map was discovered which had each of the cities mentioned highlighted for easy identification by the suspects.

Besides the map that was in Kristi Gregory's purse, there were some 30 Wal-Mart receipts for purchases apparently made by previous forgery purchases, including the two here earlier this month.

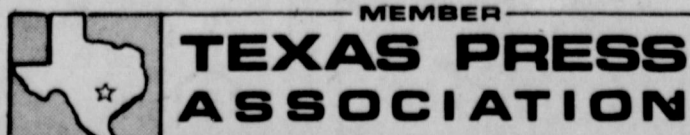
The suspects are believed to have used several different identifications and stolen personal checks during their spree.

Collins said Tuesday that Randy Gregory was free on bond, but Kristi Gregory remained in the Graham jail under a \$10,000 bond.

GARDENING HINTS

By MARK TERNING, COUNTY AGENT - HORTICULTURE

"As a twig is bent, so grows the tree."

This old saying about children could easily apply to pruning young shade trees. Proper pruning of young trees will affect the plant's shape, strength, and even its life span.

Years later, the benefits of proper tree pruning will be apparent and valuable.

The following story about a family who properly pruned their tree should help emphasize the importance of carefully planned pruning.

A family moved into their first home in a pleasant suburban location. This family had a love for trees and planted a shade tree in a special location in their front yard. Over the next 10 years the tree was carefully pruned to remove weak branches, diseased limbs, and unwanted sprouts.

The family was amazed to see their tree survive a major wind storm one spring day. Other trees in the area suffered split tops and broken limbs, while their tree stood strong.

Proper pruning gave strength to the branches and allowed wind to pass harmlessly through the thinned crown.

This family properly prunes their favorite tree on a regular basis, at the right time of year following proper pruning techniques. The family has been able to enjoy the shade and beauty of their tree with a basic understanding of proper pruning.

And what do you know? Just before they moved last summer, the real estate agent told them it was the tree in their yard that helped sell the property so quickly.

Follow these tips for proper pruning and you and your family will also benefit for many years to come.

* Deciduous shade trees should be pruned during the dormant season of winter to very early spring before trees leaf out.

* Prune with a purpose. Remove weak limbs, diseased branches, or damaged wood. Low limbs which have created excessive shade and thin lawn areas below can also be removed.

* Pruning cuts should be made to within one quarter inch of the main stem or trunk. Never leave large stubs that invite the entry of insects and disease.

* Never top or dehorn any shade tree under any circumstance. Topping a tree will result in stubs which cannot heal and become infected with disease, insect, and wood rot.

* Severe pruning should be avoided if possible. It is better to prune

lightly and regularly to help maintain a tree's natural form and beauty.

* Pruning paints or sealants are not always necessary for treating pruning cuts. Research has shown that these materials have no effect on the rate of wound closure or sealing. Their main function is cosmetic, however, they can retard insect entrance to a degree.

* Large trees or potentially hazardous pruning jobs should be referred to a professional tree care company. Professional arborists have the equipment and knowledge to safely prune large trees on commercial and residential sites.

* Complete tree pruning diagrams and University fact sheets are available through your local County Extension Service.

Some voters not registered

The office of voter registration in Wichita Falls mailed 3,333 inquiries to registered voters whose yellow and white voter certificates were returned to the office, according to Vernon Cannon, county clerk.

Out of 10,085 voter certificates that were returned, the 3,333 were the only ones with a postal address change.

A voter certificate cannot be forwarded, Cannon said.

To keep from spending more time at a voter's old precinct to vote because they must fill out additional paperwork, citizens need to get all residence address changes, mailing address changes, and name changes to the voter registrar by Friday, Feb. 4.

That can be accomplished by either going in person to Room 250 of the Wichita County courthouse, or by sending the changes by mail, as long as

the communication is postmarked by Monday, Feb. 7.

Only registered voters are permitted to cast ballots in election, and the next voting scheduled is the Democratic and Republican Party primary on Mar. 8.

Early voting in the primary is to

begin Feb. 16.

The latest approved redistricting changes that took effect Jan. 1 may

mean a voter is no longer in the old precinct in which his/her last election was held, according to Cannon.

AUSTIN — The Texas AFL-CIO has formally ceded its support to incumbent Gov. Ann Richards and former Texas Attorney General Jim Mattox, both candidates in the March 8 Democratic primary.

The 200,000-member labor group endorsed Richards, who is seeking re-election, even though she supported the North American Free Trade Agreement, which organized labor vehemently opposed.

Mattox, who is running for a U.S. Senate seat, said the AFL-CIO's endorsement is critical to win the primary over U.S. Rep. Mike Andrews of Houston and Dallas investor Richard Fisher.

In two previous bids for public office, Mattox failed to earn the endorsement: the first time in his 1990 gubernatorial race with Richards as his opponent; and the second time, in his aborted bid for the U.S. Senate seat before last year's special election.

Joe Gunn, president of the Texas AFL-CIO, said the labor union's support could help Mattox win the nomination without a runoff.

Other Democrats winning endorsement were Lt. Gov. Bob Bullock, Attorney General Dan Morales, Comptroller John Sharp, Treasurer Martha Whitehead, Land Commissioner Garry Mauro, and Railroad Commissioners Jim Nugent and Mary Scott Nabers.

Quake Won't Affect Rates

Insurance rates in Texas will not be affected by the earthquake which hit southern California, an insurance industry spokesman said.

"The price of insurance for consumers in Texas will not be influenced as a result of the disaster which struck those who live in areas hit by the earthquake," according to Jerry Johns, a spokesman for the Southwestern Insurance Information Service.

"The rates Texas residents pay for insurance are based on the losses experienced in the particular region of the state where people live," he said.

"Insurers throughout the country, including Texas, are sending thousands of claim specialists to southern California to help restore residents to a state of normalcy," Johns said.

Clinton Houston Visit Set

State Democratic Chairman Bob Slagle says President Clinton will visit Houston next month for a high-dollar political fund-raising event.

The event at the Wortham Center on Feb. 6 will cost \$1,000 per person and \$10,000 per table, he said.

Slagle said 15 percent of the funds will go toward the state Democratic Party and the remainder will be used by the Democratic National Committee.

He said he hoped to be able to arrange another fund-raising visit with Clinton this year for a less expensive affair.

Judicial Elections Intact

The U.S. Supreme Court last week refused to order Texas to abandon at-large elections of trial judges in its nine most populous counties.

The decision came in a six-year-old lawsuit in which minorities had challenged at-large elections in Dallas, Harris, Bexar, Tarrant, Travis, Lubbock, Midland, Ector and Jefferson counties.

Proponents of single-member districts say that electing judges on a countywide basis dilutes minority

voting strength and violates the U.S. Voting Rights Act.

Although the ruling was expected, one of the leaders of the battle for single-member districts said the decision "comes as a shock and disappointment."

"It is cruelly ironic that the Supreme Court, historically our country's greatest defender of civil rights, would reject consideration of this appeal," said state Sen. Rodney Ellis, D-Houston.

Medical School Hearings

Public hearings concerning the possible location of a medical school in South Texas will probably begin in March, a state legislator said last week.

State Rep. Todd Hunter, D-Corpus Christi, said no dates or locations for the hearings have been set.

Hunter, chairman of the House subcommittee looking into the issue, said the need and cost of another medical school must first be determined. Those issues will be examined through a series of public hearings in south Texas, he said.

Other Highlights

■ Lt. Gov. Bob Bullock has been endorsed by the Texas Civil Justice League for re-election to another four-year term. The group praised Bullock for spearheading legislation sought by business interests and for presiding over the Senate in a non-partisan way.

■ There's one less GOP candidate for governor. State Republican Party officials removed Sandra Lee Ritter's name from the March 8 primary ballot after her filing fee check was returned unpaid because of a closed checking account.

Surviving an alcoholic in the home

(This is the second in a series of articles on alcoholics in the home, by Diane Granbery, school counselor.)

The key to surviving an alcoholic home is adaptation.

One learns to adapt behavior in order to minimize the effect of alcoholism.

What is now known, however, is that though adaptation strategies (coping strategies) may serve the child while living with the alcoholic parent(s), the coping strategies often lead to problems later in the adult years. This is simply because the adaptation is dysfunctional in a "normal" setting and does not serve the person in building healthy relationships.

The following list of some of the more common coping strategies may also actually enable the problem drinking to continue:

1. Withdrawal from outside activities and friends.
2. Hiding the alcohol
3. Refusing to buy the alcohol
4. Staying away from home
5. Avoiding the alcoholic, not speaking when upset with the alcoholic as though this will send a message to the alcoholic that you disapprove of the drinking
6. Making threats or decisions and then not following through with them
7. Taking over chores and responsibilities that you would normally expect the alcoholic to do
8. Exerting tight control over the family finances with less and less success
9. Conceal problems, deny own personal needs and wants, and protect the problem drinker by making excuses and lying about absences from work and failed promises to children.

Emotional isolation within the home is a coping mechanism that has the greatest impact on problems later in life for the non-alcoholic family member.

Healthy relationships outside the home are often denied or postponed just to survive living in the unhealthy situation.

This may explain why a disproportionate number of children from alcoholic homes end up in juvenile courts, family courts, spouse and child abuse cases, divorce, and plagued with psychological and emotional problems as adults.

Teams win 3 of 4 games against Breckenridge

Iowa Park won three of its four basketball games Friday night against Breckenridge.

The Lady Hawks pulled off a 63-56 victory in overtime, and the host Buckaroos managed a three-point, 69-66, decision over the Hawks.

In Junior Varsity action, both Iowa Park teams won by a total of seven points: 60-57 by the boys and 51-47 by the girls.
