

STANGHAI, Tuesday, Feb. 23.-American and other warships in the Whangtoo river were in the line of fire early today as the Chinese opened a heavy artillery attack on he Japanese lines.

The cruiser Houston, Admiral Taylor's flagship, and several nearby American destroyers were within range, although so far the shells were falling short.

The Chinese were using an eightinch gun in an apparent effcrt to hit the Japanese consulate-general on the river front and the Japanese warships in the river. At 12:10 a. m Tuesday, two Chinese shells just missed Admiral Kichisaburo's flaghip, the Ibzuma. Others dropped alongside the Italian warship Livia In addition to the eight-inch gun the Chinese were using a battery near the north station to shell the river.

The Chinese shelling was part of an intense attack on the Japanese positions in Hongkew which began late Monday night.





Representative Sam Rayburn of Texas is chairman of the house interstate commerce commission. Chairman Rayburn let it be known that a bill embodying repeal of the law for recapture of excess profits of railroads and revamping the rate making provisions of the law will be the first of a threefold program to better railroad conditions that will reach the house this session.
