Mrs. Chatham Buried Wed.



Truck Driver Killed On IH 20 Tuesday



DEATH SCENE — A Wichita Falls truck driver was burned to death after his truck exploded 15 miles east of Baird Tuesday morning.

A Wichita Falls truck driver, Wyley Daniel Holmes, was burned to death about 7:50 a. m. Tuesday, August 16, when his truck crashed off a bridge and exploded, about 15 miles east of Baird on Interstate 20.

Funeral services for Holmes were held at 4:00 p. m. Thursday in Dumas Church of Christ. Burial was in Dumas Cemetery, directed by Boxwell Bros. Funeral Home. Local arrangements were handled by Godfrey Funeral Home.

Born March 30, 1940, in Eldorado, Okla., he was a member of the Church of Christ at Dumas.

Survivors include his wife, Bobbie of El Paso; a daughter, Lisa Loraine; his parents, Mr. and Mrs. A. Z. Holmes of Dumas; and two brothers, Jackie of El Paso and Alton, with the U. S. Army in El Paso.

Investigating officers, Highway Patrolmen Jerry Mathews and Bob Favor of Baird, and Kenneth Perry of Eastland, said Holmes' truck, loaded with 22 tons of molasses, careened off the side of a bridge and apparently exploded when it smashed into the concrete abutment on the other side of a small creek.

Members of Baird Volunteer Fire Dept. extinguished the blaze in about an hour, but workers were unable to remove the charred body until after 9 a. m. Justice of the Peace Garvin Jones of Baird pronounced the man dead at the scene.

Holmes had worked for the Robert Johnson Grain and Molasses Co. of Iowa Park for about 18 months. He was enroute to Sweetwater from Houston at the time the accident occurred, a company dispatcher said.

Backyard Visitor At Favor Home

Bob Favor, local Highway Patrolman, shot and killed a 4-foot, 9-inch rattler in his backyard at 741 E. 6th St. Monday morning, after the snake was discovered by his 11 year old daughter, Vanissa.

The snake, which had 14 rattlers and buttons, was crawling across the backyard in a half-coiled position and buzzing as he crawled, Favor said.

People in this area should consider this as a reminder to watch for rattlers in their own yards. With the weather cooling off slightly at night, the snakes are beginning to drift back to their dens, and are in a mean temper, striking at anything in their path.

1,000 Estimated At Pioneer Reunion

Judge Walter R. Ely, of Los Angeles, Calif., and formerly of Callahan County, who was a guest speaker at the 28th annual Callahan County Old Settlers Reunion, spoke mainly on the integrity and common sense of West Texas pioneer during his address at Treadway Park in Cross Plains.

The Baird native, son of W. R. Ely, Abilene attorney, spoke to an estimated 1,000 persons. He is the grandson of the late Mr. and Mrs. Jasper McCoy, who settled here before the county was organized.

During the course of his address, Judge Ely said "If everyone in the world came from Callahan County, it would be a better place in which to live." He then spoke of the parental devotion which early-day settlers gave to their young people.

Mrs. Dorothy Boydston Harper of Abilene led group sing-

ing, and Paul Shanks of Clyde, Old Settlers President and Mayor Doyle Birchfield of Cross Plains, also spoke. Masters of ceremonies were B. H. Freeland and James Paul Shanks, both of Baird, and Randall C. Jackson of Abilene.

Business conducted during Friday included the election of officers for next year's reunion. Elected were: Fred Stacy of Cross Plains, president; Homer (Blondy) McIntosh of Baird, vice-president; and Mrs. B. L. Boydston of Baird was re-elected secretary-treasurer.

Parade contestant winners were: Cisco Riding Club, 1st; Brownwood Riding Club, 2nd; and Callahan County Sheriff's Posse Riding Club, 3rd.

Joe Burd, 91, of Clyde, won first place in the old fiddlers contest, followed by Ford Smith, 77, of Merkel, 2nd; R. P. Luse, 77, Stephenville, 3rd; and Han-

cell Sanders, 60, Baird, 4th. L. A. Blakley, 85, of Baird, was recognized as earliest cowboy in the county. He was born August 19, 1880, in Belle Plain. He was also recognized as the earliest pioneer man with continuous residence in this county, and as the oldest native-born man with continuous residence in county.

Oldest man present was Tom D. Dawkins, 91, who settled at Admiral in 1876. Dawkins, a postal inspector for 40 years, now lives in San Antonio.

Recognized as the oldest woman present, Mrs. Al Young of Abilene, settled at Baird in 1887.

Earliest pioneer woman, Mrs. A. L. Young, 78, of Abilene, was born Dec. 30, 1887. She was also recognized as the oldest native-born woman.

Mrs. Charley Allen, 76, of Oplin, earliest pioneer woman with continuous residence in the county, was born Oct. 17, 1889

in Cottonwood and moved 12 miles south of Baird at the age of 3 months. She was married to Charley Allen at Clyde June 1, 1924 before moving to Oplin. Mrs. Allen was also recognized as the oldest native born woman with continuous residence in the county.

Barry Bell, 86, of Cross Plains, oldest native born man, was born Feb. 4, 1880.

Man coming greatest distance to attend the reunion was B. W. Fulton of Paradise, Calif. Mrs. E. B. Askley of Stayton, Ore., was the woman coming the greatest distance.

Couple married the longest and couple married the longest with continuous residence in the county were Mr. and Mrs. Steve Foster of Cross Plains. They were married at Atwell on Jan. 23, 1910, and lived at Atwell until 1939 when they moved to Cross Plains.

PUBLIC NOTICE

Proposed CONSTITUTIONAL AMENDMENT NUMBER FOUR ON THE BALLOT

PROPOSED CONSTITUTIONAL AMENDMENT TO BE VOTED ON AT AN ELECTION TO BE HELD ON NOVEMBER 8, 1966.

HOUSE JOINT RESOLUTION NO. 21 proposing an Amendment to Article XVI, Constitution of the State of Texas, relating to the terms of office of directors of conservation and reclamation districts.

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Article XVI, Constitution of the State of Texas, be amended by adding a new Section to read as follows:

"Section 30c. (a) The terms of office of persons serving on the governing body of a political subdivision of the State created to further the purposes of Section 52, Article III, or Section 59, Article XVI, of this Constitution, shall never exceed six years. (b) Statutory provisions enacted before the first Tuesday after the first Monday in November, 1966, relating to the terms of office of governing bodies of political subdivisions created to further the purposes of Section 52, Article III, or Section 59, Article XVI, are validated, so long as the provisions do not provide for a term of office which exceeds six years. Sec. 2. HOUSE JOINT RESOLUTION NO. 79 proposing an Amendment to Article VIII, Constitution of the State of Texas, by adding Section 1-d to provide that all land owned by natural persons designated for agricultural use shall be assessed for all tax purposes on the consideration of only those factors relative to such agricultural use.

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:


Section 1. That Article VIII, Constitution of the State of Texas, be amended by adding Section 1-d to read as follows:

"Section 1-d. (a) All land owned by natural persons which is designated for agricultural use in accordance with the provisions of this Section shall be assessed for all tax purposes on the consideration of only those factors relative to such agricultural use. 'Agricultural use' means the raising of livestock or growing of crops, fruit, flowers, and other products of the soil under natural conditions as a business venture for profit, which business is the primary occupation and source of income of the owner. (b) For each assessment year the owner wishes to qualify his land under provisions of this Section as designated for agricultural use he shall file with the local tax assessor a sworn statement in writing describing the use to which the land is devoted. (c) Upon receipt of the sworn statement in writing the local tax assessor shall determine whether or not such land qualifies for the designation as to agricultural use as defined herein and in the event it so qualifies he shall designate such land as being for agricultural use and assess the land accordingly. (d) Such local tax assessor may inspect the land and require such evidence of use and source of income as may be necessary or useful in determining whether or not the agricultural use provision of this article applies. (e) No land may qualify for the designation provided for in this Act unless for at least three (3) successive years immediately preceding the assessment date the land has been devoted exclusively for agricultural use, or unless the land has been continuously developed for agriculture during such time. (f) Each year during which the land is designated for agricultural use, the local tax assessor shall note on his records the valuation which would have been made had the land not qualified for such designation under this Section. If designated land is subsequently diverted to a purpose other than that of agricultural use, or is sold, the land shall be subject to an additional

tax. The additional tax shall equal the difference between taxes paid or payable, hereunder, and the amount of tax payable for the preceding three years had the land been otherwise assessed. Until paid, there shall be a lien for additional taxes and interest on land assessed under the provisions of this Section. (g) The valuation and assessment of any minerals or subsurface rights to minerals shall not come within the provisions of this Section. Sec. 2. The foregoing Constitutional Amendment shall be submitted to a vote of the qualified electors of this State at an election to be held on the first Tuesday after the first Monday in November, 1966, at which election all ballots shall have printed on them the following: "FOR the Constitutional Amendment to provide that all land owned by natural persons designated for agricultural use shall be assessed for all tax purposes on the consideration of only those factors relative to such agricultural use. "AGAINST the Constitutional Amendment to provide that all land owned by natural persons designated for agricultural use shall be assessed for all tax purposes on the consideration of only those factors relative to such agricultural use." Sec. 3. The Governor of the State of Texas shall issue the necessary proclamation for the election and this Amendment shall be published in the manner and for the length of time as required by the constitution and laws of this state.

"Wine Dulls The Senses"
 Bible Thought: "Woe unto them that rise early in the morning, that they may follow strong drink; that continue until night, till wine inflame them." (Isalah 5:11).
 It is obvious from this scripture that drunkenness is not a problem peculiar to our age. It caused shame and trouble even

in Noah's family.
 Why does an individual drink? Some may say they do it to feel well. The action of alcohol is particularly directed against the highest functioning of the brain and tends to reduce the importance of anxiety. Invariably, an individual who regularly consumes alcohol is trying to escape from problems. The amount of alcohol required to damage the body varies with each individual. It does do damage.

Someone has said that "alcohol will remove grass stains from summer clothes. It will also remove summer clothes, spring clothes and winter clothes, not only from the man who drinks it, but also from his wife and children. It will remove furniture from the house eatables from the pantry, smiles from the face of his wife, and happiness from the home. As a remover, alcohol has no equal!"

The cost of drinking to the home and to the government is alarmingly large. Even as early as 1961 the Co-ordinated Committee on Alcoholism estimated that alcoholism would for that year cost our nation \$1,400,000,000 in loss of wages, accidents and cost of institutional care and support of family groups. These figures did not come from some preacher or temperance crusader. They were compiled by a committee of 17 agencies, including lawyers, doctors and labor leaders. "The beer that made Milwaukee famous" is a slogan which has made many drinkers. What is Milwaukee famous for? Beer, of course! But here is something few people know: as far back as 1950, according to the Milwaukee Journal of January 6, 1950, alcoholism was costing Milwaukee County alone an estimated \$10,200,000 a year in lost wages and treatment and care of victims and support of their families to say nothing of the spiritual side of it. Of the 84,000 alcoholics in the state, Milwaukee county had 25,000 of them, with 5,500 of that number classified as chronic alcoholics. During World War II, millions of American soldiers learned to like beer because it was furnished to them by the government. As early as 1947, the VA Medical Director, Dr. Paul Hawley, was quoted as saying that the government hospitals were seriously burdened with alcoholics, and that the average cost of maintaining such a patient was \$8.70 per day. Certainly the picture is no better in 1966.

One does not need the deceptive powers of alcohol in order to meet life's frustrations. The wise Solomon said, "Happy is the man that findeth wisdom, and the man that getteth understanding. For the merchandise of it is better than

the merchandise of silver, and the gain thereof than fine gold. She is more precious than rubies: and all the things thou canst desire are not to be compared unto her. Length of days is in her right hand; and in her left hand riches and honour. Her ways are ways of pleasantness, and all her paths are peace. She is a tree of life to them that lay hold upon her; and happy is every one that retaineth her" (Proverbs 3:13-18). Again he said, "Wine is a mocker, strong drink is raging; and whosoever is deceived thereby is not wise." (Proverbs 20:1.)

PROPOSED CONSTITUTIONAL AMENDMENT TO BE VOTED ON AT AN ELECTION TO BE HELD ON NOVEMBER 8, 1966.
 HOUSE JOINT RESOLUTION NO. 65 proposing an Amendment to Section 3-b of Article VII of the Constitution of Texas providing that school taxes theretofore voted in any independent school district or in any junior college district shall not be abrogated, cancelled or invalidated by a change in boundaries nor shall bonds voted, but unissued, be invalidated by such change; authorizing the levy of taxes after such change without further election in the district as changed; providing an exception in the case of the annexation or consolidation of whole districts; providing for an election and the issuance of a proclamation therefor.
 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Section 3-b of Article VII of the Constitution of Texas be amended to be and read as follows:
 "Section 3-b. No tax for the maintenance of public free schools voted in any independent school district and no tax for the maintenance of a junior college voted by a junior college district, nor any bonds voted in any such district, but unissued, shall be abrogated, cancelled or invalidated by change of any kind in the boundaries thereof. After any change in boundaries, the governing body of any such district, without the necessity of an additional election, shall have the power to assess, levy and collect ad valorem taxes

on all taxable property within the boundaries of the district as changed, for the purposes of the maintenance of public free schools or the maintenance of a junior college, as the case may be, and the payment of principal of and interest on all bonded indebtedness outstanding against, or attributable, adjusted or allocated to, such district or any territory therein, in the amount, at the rate, or not to exceed the rate, and in the manner authorized in the district prior to the change in its boundaries, and further in accordance with the laws under which all such bonds, respectively, were voted; and such governing body also shall have the power, without the necessity of an additional election, to sell and deliver any unissued bonds voted in the district prior to any such change in boundaries, and to assess, levy and collect ad valorem taxes on all taxable property in the district as changed, for the payment of principal of and interest on such bonds in the manner permitted by the laws under which such bonds were voted. In those instances where the boundaries of any such independent school district are changed by the annexation of, or consolidation with, one or more whole school districts, the taxes to be levied for the purposes hereinabove authorized may be in the amount or at not to exceed the rate theretofore voted in the district having at the time of such change the greatest scholastic population according to the latest scholastic census and only the unissued bonds of such district voted prior to such change, may be

subsequently voted and delivered and any voted, but unissued, bonds of other school districts involved in such annexation or consolidation shall not thereafter be issued."

Sec. 2. The foregoing Constitutional Amendment shall be submitted to a vote of the qualified electors of this State at an election to be held throughout the State of Texas on the first Tuesday after the first Monday in November, 1966, at which election all ballots shall have printed thereon the following:

"FOR the Amendment to Section 3-b of Article VII of the Constitution of Texas providing that taxes or bonds previously voted in any independent school district or in any junior college district shall not be abrogated, cancelled or invalidated by any change in boundaries and authorizing the continuation of the levy of taxes after such change without further election."

"AGAINST the amendment to Section 3-b of Article VII of the Constitution of Texas providing that taxes or bonds previously voted in any independent school district or in any junior college district shall not be abrogated, cancelled or invalidated by any change in boundaries and authorizing the continuation of the levy of taxes after such change without further election."

If it appears from the returns of said election that a majority of the votes cast were in favor of said Amendment, the same shall become a part of the State Constitution and be effective on and after the date of its adoption.

Sec. 3. The Governor shall issue the necessary proclamation for said election and shall have the same published as required by the Constitution and Laws of this State.

PROPOSED CONSTITUTIONAL AMENDMENT TO BE VOTED ON AT AN ELECTION TO BE HELD ON NOVEMBER 8, 1966.
 SENATE JOINT RESOLUTION NO. 1 proposing an Amendment to Article IX of the Constitution of Texas by adding thereto a new Section to be known as Section 12; authorizing the Legislature to provide by law for the creation, establishment, maintenance and operation of Airport Authorities composed of one or more counties; authorizing the creation of a board of directors by appointment or election; providing that the membership of the board shall be based upon the proportionate part of the population of each county, with no county having less than one member; providing for the necessary election; authorizing the levy of an annual tax not to exceed Seventy-Five Cents (75c) per One Hundred Dollars (\$100) valuation; provided, however, that the property of state regulated common carriers required by law to pay a tax upon intangible assets shall not be subject to taxation by the Authority; authorizing the Authority to employ or appoint an assessor and collector of taxes whose duty it shall be to assess and collect the taxes on the tax rolls approved by the Board of Directors of said Authority, said taxes to be assessed equally and uniformly throughout the county or counties, comprising the Authority, as required by the Constitution; granting to such Authority the power to acquire by purchase, or through eminent domain proceedings existing publicly financed airport properties or other sites necessary to have and to improve the same, power to issue and sell general obligation bonds and revenue bonds, or either of them; authorizing the assumption of outstanding indebtedness secured by general obligation bonds and assuming the obligations of the city or cities under ordinances and bond indentures under which revenue bonds have been issued and sold; to enact zoning regulations and other measures to protect the airport facilities from hazards and obstructions; providing for the adding of an additional county or counties to the Authority.
 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Article IX of the Constitution of the State of Texas be amended by adding thereto a new Section to be known as Section 12, reading as follows:
 "Section 12. The Legislature may by law provide for the creation, establishment, maintenance and operation of

Airport Authorities composed of one or more counties, with power to issue general obligation bonds, revenue bonds, either or both of them, for the purchase, acquisition by the exercise of the power of eminent domain or otherwise, construction, reconstruction, repair or renovation of any airport or airports, landing fields and runways, airport buildings, hangars, facilities, equipment, fixtures, and any and all property, real or personal, necessary to operate, equip and maintain an airport; shall provide for the option by the governing body of the city or cities whose airport facilities are served by certificated airlines and whose facility or some interest therein, is proposed to be or has been acquired by the Authority, to either appoint or elect a Board of Directors of said Authority; if the Directors are appointed such appointment shall be made by the County Commissioners Court after consultation with and consent of the governing body or bodies of such city or cities, and if the Board of Directors is elected they shall be elected by the qualified taxpayer voters of the county which chooses to elect that county, such Directors shall serve without compensation for a term fixed by the Legislature not to exceed six (6) years, and shall be selected on the basis of the proportionate population of each county based upon the last preceding Federal Census, and shall be a resident or residents of such county; provide that no county shall have less than one (1) member on the Board of Directors; provide for the holding of an election in each county proposing the creation of an Authority to be called by the Commissioners Court or Commissioners Courts, as the case may be, upon petition of five per cent (5%) of the qualified taxpayer voters within the county or counties, said elections to be held on the same day if more than one county is included, provided that no more than one (1) such election may be called in a county until after the expiration of one (1) year; in the event such an election has failed, and thereafter only upon a petition of ten per cent (10%) of the qualified taxpayer voters being presented to the Commissioners Court or Commissioners Courts of the county or counties in which such an election has failed, and in the event that two or more counties vote on the proposition of the creation of an Authority therein, the proposition shall not be deemed to carry unless the majority of the qualified taxpayer voters in each county voting

thereon vote in favor thereof; provided, however, that an Airport Authority may be created and be composed of the county or counties that vote in favor of its creation if separate propositions are submitted to the voters of each county so that they may vote for a two or more county Authority or a single county Authority; provide for the appointment by the Board of Directors of an Assessor and Collector of Taxes in the Authority, whether constituted of one or more counties, whose duty it shall be to assess all taxable property, both real and personal, and collect the taxes thereon, based upon the tax rolls approved by the Board of Directors, the tax to be levied not to exceed Seventy-Five Cents (75c) per One Hundred Dollars (\$100) assessed valuation of the property, provided, however, that the property of state regulated common carriers required by law to pay a tax upon intangible assets shall not be subject to taxation by the Authority, said taxable property shall be assessed on a valuation not to exceed the market value and shall be equal and uniform throughout the Authority as is otherwise provided by the Constitution; the Legislature shall authorize the purchase or acquisition by the Authority of any existing airport facility publicly owned and financed and served by certificated airlines, in fee or in any interest therein, or to enter into any lease agreement; thereupon, upon such terms and conditions as may be mutually agreeable to the Authority and the owner of such facilities, or authorize the acquisition of same through the exercise of the power of eminent domain, and in the event of such acquisition, if there are any general obligation bonds that the owner of the publicly owned airport facility has outstanding, the same shall be fully assumed by the Authority and sufficient taxes levied by the Authority to discharge said outstanding indebtedness; and likewise any city or owner that has outstanding revenue bonds where the revenues of the airport have been pledged or said bonds constitute a lien against the airport facilities, the Authority shall assume and discharge all the obligations of the city under the ordinances and bond indentures under which said revenue bonds have been issued and sold. Any city which owns airport facilities not serving certificated airlines which are not purchased or acquired by the Authority as herein provided by such Authority, shall have the power to operate the same under the existing laws or as the same may hereafter be amended. Any such Authority when created may be granted the power and authority to promulgate, adopt and enforce appropriate zoning regulations to protect the airport from

hazards and obstructions which would interfere with the use of the airport and its facilities for landing and take-off; an additional county or counties may be added to an existing Authority if a petition of five per cent (5%) of the qualified taxpayer voters is filed with and an election is called by the Commissioners Court of the county or counties seeking admission to an Authority and the vote is favorable, then admission may be granted to such county or counties by the Board of Directors of the then existing Authority upon such terms and conditions as they may agree upon and evidenced by a resolution approved by two-thirds (2/3rds) of the then existing Board of Directors, provided, however, the county or counties that may be so added to the then existing Authority shall be given representation on the Board of Directors by adding additional directors in proportion to their population according to the last preceding Federal Census."

Sec. 2. The foregoing Constitutional Amendment shall be submitted to a vote of the qualified electors of this state at an election to be held on the first Tuesday after the first Monday in November, 1966, at which election all ballots shall have printed thereon the following:

"FOR the addition of Section 12 of Article IX of the Constitution, authorizing the Legislature to provide by law for the creation, establishment, maintenance and operation of Airport Authorities composed of one or more counties, and authorizing the levy of a tax not to exceed Seventy-Five Cents (75c) on the One Hundred Dollars (\$100) valuation of all taxable property within such Airport Authority except the property of state regulated common carriers required by law to pay a tax upon intangible assets, after approval of its voters."

PUBLIC NOTICE

Proposed CONSTITUTIONAL AMENDMENT NUMBER FIVE ON THE BALLOT

PROPOSED CONSTITUTIONAL AMENDMENT TO BE VOTED ON AT AN ELECTION TO BE HELD ON NOVEMBER 8, 1966. SENATE JOINT RESOLUTION NO. 4 proposing: an Amendment to the Constitution of Texas by adding to Section 62 of Article XVI a new subsection to be demarcated subsection (c), of said Section 62; authorizing the Legislature to enact laws establishing, subject to the limitations stated, a State-wide System of Retirement, Disability and Death Compensation benefits for the officers and employees of the counties and other political subdivisions of the state, and of the political subdivisions of any county.

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Section 62 of Article XVI of the Constitution of the State of Texas be amended by adding thereto a subsection (c) which shall read as follows: "(c) The Texas Legislature is authorized to enact appropriate laws to provide for a System of Retirement, Disability and Death Benefits for all the officers and employees of a county or other political subdivision of the state, or a political subdivision of a county; providing that when the Texas Legislature has passed the necessary enabling legislation pursuant to the Constitutional authorization, then the governing body of the county, or other political subdivision of the state, or political subdivision of the county shall make the determination as to whether a particular county or other political subdivision of the state, or subdivision of the county participates in this System; providing further that such System shall be operated at the expense of the county or other political subdivision of the state or political subdivision of the county electing to participate therein and the officers and employees covered by the System; and providing that the Legislature of the State of Texas shall never make an appropriation to pay the costs of this Retirement, Disability and Death Compensation System.

"The Legislature may provide for a voluntary merger into the System herein authorized by this Constitutional Amendment of any System of Retirement, Disability and Death Compensation Benefits which may now exist or that may hereafter be established under subsection (b) of Section 62 of Article XVI of the Texas Constitution; providing further that the Texas Legislature will make the determination as to the amount of money that will be contributed by the county or other political subdivision of the state or political subdivision of the county to the State-wide System of Retirement, Disability and Death Benefits, and the Legislature shall further provide that the amount of money contributed by the county or other political subdivision of the state or subdivision of the county shall equal the amount paid for the same purpose from the income of each officer and employee covered by this State-wide System.

"If it is the further intention of the Legislature, in submitting this Constitutional Amendment, that the officers and employees of the county or other political subdivision of the state or political subdivision of a county may be included in those systems regardless of whether the county or other political subdivision of the state or political subdivision of the county participates in the Retirement, Disability and Death Benefit System authorized by this Constitutional Amendment, or whether they participate in a System under the provisions of subsection (b) of Section 62 of Article XVI of the Texas Constitution as the same is herein amended."

Sec. 2. The foregoing Constitutional Amendment shall be submitted to a vote of the qualified electors of this state at the General Election in November, 1966, at which all ballots shall have printed thereon: "FOR the Constitutional Amendment authorizing the Texas Legislature to establish a State-wide Cooperative System of Retirement, Disability and Death Benefits for the officials and employees of the various counties or other political subdivisions of the state, or of this state."

Sec. 3. The Governor of the State of Texas shall issue the necessary proclamation for said election and have notice of said proposed Amendment and of said election published as required by the Constitution of Texas, and laws of this state.

political subdivisions of a county; authorizing the Legislature to provide for a voluntary merger into the system authorized by this Amendment by those officers and employees covered by the provisions of subsection (b) of Section 62 of the Texas Constitution as now existing or may hereafter be established; providing that costs of this System shall be borne by the counties and other political subdivisions of the state and political subdivisions of the county electing to participate therein and the officers and employees covered by the System; and forbidding the Legislature from making any appropriations for the operation of this System."

"AGAINST the Constitutional Amendment authorizing the Texas Legislature to establish a State-wide Cooperative System of Retirement, Disability and Death Benefits for the officials and employees of the various counties or other political subdivisions of the state, or political subdivisions of a county; authorizing the Legislature to provide for a voluntary merger into the system authorized by this Amendment by those officers and employees covered by the provisions of subsection (b) of Section 62 of Article XVI of the Texas Constitution as now existing or may hereafter be established; providing that costs of this System shall be borne by the counties and other political subdivisions of the state and political subdivisions of the county electing to participate therein and the officers and employees covered by the System; and forbidding the Legislature from making any appropriations for the operation of this System."

If it appears from the returns of said election that a majority of the votes have been cast in favor of such amendment, the same shall become a part of the Constitution of the State of Texas.

Sec. 3. The Governor of the State of Texas shall issue the necessary proclamation for said election and have notice of said proposed Amendment and of said election published as required by the Constitution of Texas, and laws of this state.


