No More Nice Guy On Checks

After the middle of June, it's no more Mr. Nice Guy.

In so many words, that's what Callahan County Attorney Bob McCool said this week concerning his efforts to prosecute those who write bad checks.

Ever since last Christmas, his office has been busier than a one-armed paper hanger trying to keep up with the increased flow of hot checks, and says, it's time to do something about it.

Right now, the office has about 170 pending bad-check cases. McCool said he is giving the hot-check writers 30 days to get their cases taken care of and then a deputy sheriff is going to be assigned full-time to tracking them down, arresting them and locking them up.

I'm going to fill the jail up, if I have to. They may have to build a new one," he said, only half kidding.

Also, he said that "no excuses" will be accepted for bad checking. After all, he said the person taking a bad check gives the writer 10 days written notice of intention to file charges and that his office does the same thing, so by the time a charge is filed, the hot checker has had ample

"If anybody thinks they've got a hot check (charge filed against them) they'd better trot over here," said Pat Holland, McCool's secretary said, referring to the 30-day warning period her boss has established.

McCool also had an important tip for anyone taking a check. Get the writer's driver's license number on the check.

He explained that if the check is bad and the suspect cannot be found, the sheriff's office will put the driver's license number in the DPS computer so that "any time they renew their driver's license or get a speeding ticket, we have a good chance of getting them."

McCool commented there is sometimes a strange mentality involved in bad-check writing. Often times, a person who wouldn't steal a dime otherwise will write a bad check after bad check. They apparently rationalize that it's not the same thing as stealing. "But it is, " McCool said.

So. East Peanut Crop in Doubt

Texas peanut growers should be aware that the drought in the Southeast has reached crisis proportions and is seriously affecting the peanut crop there. It has been reported to the Texas Peanut Producers Board that the crop to date is only 40 percent planted. If they do not get rain soon (and there is no appreciable rain in the immediate forecast) the crop could be seriously affected by as much as 40 percent.

The export prices have really strengthened the past week, increasing from .30 cents per pound to .50 cents per pound for jumbo runners.

65 percent of the U.S. peanut supply, such a shortage will put a big demand on peanuts from the Southwest.

The Texas Peanut Producers Board advises peanut growers in the Southwest to pay very close attention to the weather in the Southeast for the next 10 to 15 days. It could be profitable to plant the acres needed to fill the gap.

Postal regulations require that rual and contract route carriers must have access to mailboxes without having to leave their vehicles. Such boxes must be located on the right-hand side of the road in the carrier's direction of travel where traffic conditions would endanger a carrier driving to the left

to reach the boxes. The boxes also must be placed to conform with state laws and the highway regulations. Customers are requested to remove obstructions - including vehicles, trashcans and snow - that make

delivery difficult. For both suburban curbline and rural roadside boxes, the Postal Service requests a height of 31/2 to 4 feet from the bottom of the box to ground level. The address should be

assure more efficient delivery. There are approved traditional and contemporary mailbox designs. A customer-designed rural box needs the prior approval of the postmaster

before it can be installed.



One last safety caution from the Postal Service: Some mailbox supports are so massive (heavy metal posts, concrete, farm equipment filled with concrete), they are damaging vehicles and causing serious injuries to people who accidently strike them. The Federal Highway Administration has suggested mailbox mounting and support designs that post offices will share with their customers.
