## F-M 1864 Travelers To Get 'Direct Connection'

The farmers and ranchers, oil field workers and other Eastland County residents who use Farm-to-Market Road 1864 will soon have a direct connection with Texas 206, through a project of the State Department of Highways and Public Transportation. A caliche road east of Scanton, near the Callahan County line, will be upgraded as an extension of FM 1864, said Jean Sparks, public affairs officers for the highway department's Brownwood district. When the extension is finished, motorists will no longer have to take a winding, 6.2-mile ride on FM 569 to make the connection with Texas 206. Instead, FM 1864 will extend 1.6 miles from FM 569 directly to the state highway.

In addition, an extension of FM 8 will be built along the county road that was the old Texas 6, spanning 1.8 miles, from 3.2 miles west of Gorman southeastward to near the Comanche County line, Ms. Sparks said.

Construction of these roads will include widening, installing culverts, providing a flexible base and surfacing. A \$470,090.55 contract for the projects was awarded to T. M. Brown & Sons, Inc. of Abilene. R. P. Haun, Jr., of Eastland is the highway

department's resident engineer in charge of the project.

The work, expected to begin in May, will take 120 working days, or until about December, to complete. Traffic should not be disrupted during construction.

The projects are among 64 statewide, with a total price tag of \$141,839,172, awarded by the highway commission in March. Funds for this work are available from increased motor fuel taxes and vehicle registration fees, approved by a special session of the Legislature in 1984.

That inkling turned to cold fear, though, then I read the menu. The cheapest entree (main meal) on there was 20 bucks, I'm not lying, and that didn't include anything else, salad, soup, dessert, anything.

A plain old tossed salad was 5 bucks, a tiny bowl of soup was 4 bucks, appetizers (and I couldn't even find any onion rings listed) were all in the \$15 range, and the cheapest dessert was \$10.

I'm a survivalist, so my first thought was to escape, but the guy in the tux, the guy in the semi-tux and the waiter were all standing between us and the door. They had us out-numbered.

We surrendered and ordered the cheapest stuff we could find. (My wife's menu didn't even have prices on it so I had to read them off to her from mine which caused several nearby heads to turn.)

We were both hungry, and I figured at those prices, whatever we ordered, we'd get a big batch of it. It didn't work out that way. My \$20 lamb something-or-other turned out to be seven little slivers of mutton in some



#### Migration into Texas slows for first time in more than a decade

COLLEGE STATION - For the first time in more than 10 years the rate of in-migration into Texas from other states has declined, says a Texas A&M University demographer.

Dr. Steve Murdock, professor and

head of the Department of Rural Sociology in Texas A&M's College of Agriculture, points out that between 1982-84 net in-migration from other states into Texas was about 32,000 people.

"That's down considerably from the average annual in-migration to Texas of 300,000 people in the first part of this decade and the average annual inmigration of 170,000 people during the 1970s," Murdock said recently.

"The state's population is continuing to grow from births and in-migration, but the rate of growth in most places is substantially lower than before," he

said. "Counties such as Harris County and Montgomery County actually had a net out-migration in the past two years, a pattern which has not occurred for at least a decade and a half.

Murdock pointed out the change makes it difficult to predict future growth, noting that the Lone Star State's population in the year 2000 could be anywhere from 17 million to 23.9 million, depending on whether there's only natural growth without inmigration or the rate of in-migration is as rapid as the average 300,000 people experienced between 1980-82.

Social Security and withheld federal income taxes for the first quarter of 1986. If the quarterly tax due (less any deposit made during the quarter) is \$500 or more, the unpaid tax must be deposited by April 15, 1986.

### W-2 Form Information

Even if an employee is unable to get a W-2 before the tax filing deadline, the return must be filed by April 15.

Taxpayers must have a W-2 from every employer they worked for during the year. If it is impossible to obtain a W-2 from an employer, the employee should either obtain a Form 4852, Substitute Wage and Withholding Statement, from the IRS or attach a signed and dated statement showing the tax withholding information and attach it to the tax return, according to the IRS.





## Filing Deadline April 15

The Internal Revenue Service says you may receive an automatic 4-month extension of time to file your 1985 federal tax return. The application for the extension, Form 4868, must be filed by April 15.

The IRS stresses that this is an extension of time to file your return — not an extension of time for payment of taxes due.

When filing for the extension, the taxpayer must estimate their tax owed for 1985 and send that amount with the Form 4868 to avoid interest and late payment penalties.

The IRS notes that a deduction for an IRA contribution can be claimed on a 1985 tax return only if the contribution is made on or before April 15, even for those electing an extension to file.



#### TYPES OF POOLS

There are at least three different types of large pools. The oldest type is the *custom-built*, *concrete-poured pool*. This is generally the most expensive kind. *Fiberglass pools*, which are made of molded fiberglass and installed in much the same way as the concrete pools, have become popular recently.

Also requiring excavation is the *metal pool* with a vinyl liner inside steel or aluminum walls. And, of course, there are less expensive *above-ground pools*.

#### FLIM-FLAM SALES

According to a study by the Federal Trade Commission, the swimming pool business has had more than its share of bad operators, with many using the old "bait and switch" routine.

• The first rule to remember in choosing a swimming pool is to pick a reputable local business. Don't be taken in by a salesman who tries to talk you into purchasing a larger and more expensive model than you had originally wanted. My Consumer Protection Division recommends that you shop elsewhere if you suspect you are being lured into a more expensive purchase than you had planned.

• One inducement that the seller may offer you to switch to a more ex-

pensive model is a longer guarantee. Your best guarantee, however, is a business that will stay around long enough to answer your complaints if you have them. Too often, consumers find that their guarantees cover only specific (and unlikely) problems, such as a defective liner seam.

• Ask your swimming pool dealer for the names of some satisfied customers and talk to them. Try to find someone who bought the pool a year or more ago. That way, you can judge whether your pool will make you happy in the long run.

## Savings Bond Sales Up 40% In Texas

Sales of U. S. Savings Bonds during January, 1986 in Texas amounted to \$28,095,341, an increase of \$5,163,035 for 39.9% over the January a year ago, T. J. Morrow, District Director for U. S. Savings Bonds Division in Dallas, Texas, announced today. These sales represent 7.6% of the state's 1986 assigned dollar goal of \$370,000,000. Sales of Series EE Bonds amounted

## Senior Citizens to Elect Silver Haired Legislature

Paul S. Dulaney of Clyde has announced his candidacy for the first Texas Silver Haired Legislature, District 3, which covers 12 counties, including Callahan County.

Registered voters age 60 or over are eligible to vote. Balloting will be held in the local senior citizens center on May 30. Absentee ballots will also be made available, according to the West Central Texas Council of Governments, which is handling ballot details in 19 counties.

The Silver Haired Legislature was authorized by the 69th Texas Legislature last January. It is an elected, non-partisan body of seniors who will meet at the Texas Capitol in September to draft legislation of concern to the growing number of older Texans.

Their recommendations will then be presented to the 70th Texas Legislature for consideration when it convenes in January, 1987.





Sometime later they raked up all the leaves under their trees and spread them on their garden. Mr. Gary plowed, harrowed and raked the garden several times.


On March 31st, he was setting out their tomato plants, by hand. As he turned the soil for one plant, there was my watch!
