

1988 Earnings Base, **Tax Rate To Increase** The annual earnings base - the

maximum amount of earnings that counts for Social Security - will increase to \$45,000 for 1988, up from \$43,800 for 1987. In addition, the 1988 tax rate for employees and their employers will increase to 7.51 percent, up from the 1987 rate of 7.15 percent, Glyn Hammons, Social Security manager in Abilene, said recently.

The increase in the tax rate will amount to \$7.20 a month for a person earning \$2,000 a month.

Other Social Security figures are scheduled to increase in 1988 as well, Hammons said. The annual exempt amount used in the annual earnings test will increase. The annual earnings test is the measure used to determine whether a person who works will receive benefits during the year.

He has served on the adjunct faculty of McCormick Theological Seminary and has been a visiting professor of New Testament Greek and Literature at the Thailand Theological Seminary.



The 1988 annual exempt amount for people 65 through 69 will be \$8,400, up from the 1987 amount of \$8,160. The 1988 exempt amount for people under 65 all of 1988 will be \$6,120 up from the 1987 amount of \$6,000.

A person whose earnings do not exceed the annual exempt amount will receive all benefits for the year. A person's benefit is reduced by \$1 for each \$2 of earnings above the exempt amount. The annual earnings test does not apply once a person reaches 70.

The amount of earnings needed to earn a quarter of coverage - the measure of Social Security work credit - will be \$470 in 1988, up from \$460 for 1987. In 1988, a worker will earn four quarters of coverage if his or her annual earnings are \$1,880 or more. 1987 Sales Of Savings Bonds **Total \$367** Million

United States Savings Bonds sales in Texas during Fiscal Year 1987 amounted to \$366,982,471, T.J. Morrow, District Director for the U.S. Savings Bonds Division in Texas, announced today. These sales represent 94.6 percent of the state's 1987 assigned dollar goal of \$388 million.

Sales of Series EE Bonds amounted to \$2,925 during September 1987 in Callahan County, James Eubank, Volunteer County Chairman, said. The October 1986 through September 1987 total for the county was \$94,208, which represents 104.7 percent of the county's 1987 assigned dollar goal.

Nationally, September 1987 sales of Series EE Bonds totaled \$474 million and brought total sales of U.S. Savings Bonds to \$10.3 billion for Fiscal Year 1987, an increase of 24 percent over

The Democratic Primary will be held March 8 to determine the democratic nominee.





EXERCISE vs. DEPRESSION
