August 10 Election Site Change Announced

House Bill 2885, passed by the 72nd Legislature, was signed by the Governor on June 7, 1991. This bill had an immediate effect clause, and as a result, the bill became law on June 7, 1991. The bill requires each school district in the state to hold an August 10, 1991, election regarding tax exemptions for county education districts.

The legislature also passed two proposed constitutional amendments (S.J.R. 42 and S.J.R. 5) that will require each county in the state to hold a constitutional amendment election on the same day. The Secretary of State's Office has been in communication with the county clerks, and has recommended joint elections with the school districts in their counties.

The first proposal addresses the taxation of all personal property in particular cars, pickups, boats, etc. The second and third proposal addresses an increase in the residence homestead for both the regular and disabled individual

The Cross Plains ISD is advising all voters to vote AGAINST the first proposal and FOR the second and third proposals.

School district voters may vote absentee at the courthouse in Baird from July 22 through August 6, 1991 during regular office hours.

The August 10 election site has been changed from the Cross Plains Community Center as announced last week to the Cross Plains City Hall.



# Volunteer Firefighters Attend School

#### By RICKEY CAROUTH

Rickey Carouth and Bill Reed attended the 62nd Annual Texas A & M Firefighting School at College Station, Texas. The school is divided into four weeks of classes; 5,000 firefighters from as far away as Alaska and England participated at the 57 acre facility.

Carouth and Reed attended Firefighters 2 and 3 from July 22-27. The emphasis of this session was on oil field fires, industrial fires, multistory buildings, automobile fires, and learning new techniques to reduce water damage.

The instructors stressed the importance of protective clothing and air tanks to reduce the risk of smoke and chemical inhalation. They used equipment similar to what would be used in this area.

The firefighters put out actual fires. They walked into buildings that were between 1500 and 1700 degrees; they put out "oil field" fires that were up to 3500 degrees.

"I would like to see someone without training walk up to this fire and try to put it out," said Carouth, pointing to a picture of a blazing twostory oil field loading dock. "You couldn't make yourself walk into it."


Of the 2,900 people who attended the classes, 29 people were injured, although none seriously.

Firefighting is extremely dangerous work and periodic training is essential. Carouth and Reed would like to thank the Farm Bureau, the City of Cross Plains, and individual supporters for sending them to the training program.

# Need Help With Insect Plight?

Insects of all kinds have plagued homeowners, gardeners, and agricultural producers all year. Grasshoppers and webworms have dominated the area for the past few months and now another insect is being found in damaging numbers, the common bagworm. The common bagworm attacks a long list of trees and shrubs but its feeding is most destructive on arbor vitae and cedars. Many beautiful and ornamental plants around homes, public buildings, in parks and cemeteries are defoliated and killed each year by the feeding of these larvae. The young larvae construct small bags of silk in which are incorporated bits of leaves or twigs. As the larva grow, the size of the bag is increased correspondingly.

Chemical control or hand picking of the bagworm is usually effective. Dursban, malathion, or diazinon is recommended for control of this pest.

You can expect another generation (3rd or 4th) of webworms around the first week of August. This generation will probably be larger and more destructive than the last two previous infestation because of number buildup. Orthene seems to be the only chemical that is working with any regularity on the webworms.
