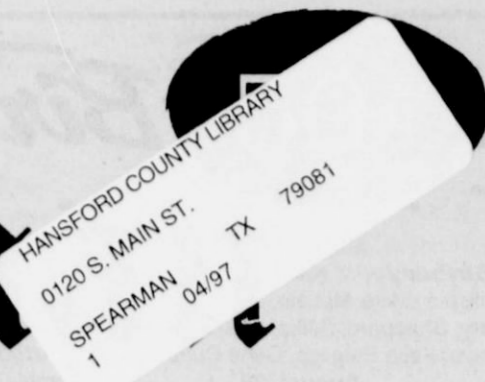

Focus On The Family

QUESTION: My husband and I are distressed because our teenager seems to be rejecting her religious beliefs. My inclination is to panic, but before I do, can you offer a word of encouragement?

DR. DOBSON: A small child is told what to think during his formative years. He is subjected to all the attitudes, biases and beliefs of his parents, which is right and proper. They are fulfilling their God-given responsibility to guide and train him.

However, there must come a moment when all of these concepts and ideas are examined by the individual and either adopted as true or rejected as false. If that personal evaluation never comes, then the adolescent fails to span the gap between "What I've been told" and "What I believe." This is one of the most important bridges leading from childhood to adulthood.

It is common, therefore, for teenagers to question the veracity of the religious instruction they have received. They may ask themselves, "Is there really a God? Does He know me? Do I believe in the values my parents have taught? Do I want what they want for my life? Have they misled me in any way? Does my experience contradict what I've been taught?"

For a period of years, beginning during adolescence and continuing into the 20s, this intensive self-examination is conducted. This process is especially distressing to parents who must sit on the sidelines and watch everything they have taught being scrutinized and questioned. It will be less painful, however, if both generations realize that the soul-searching is a normal, necessary part of growing up.

The mailman saw a horse without a bridle near his route, so he took the horse home on Saturday. So Mr. Blodgett and about 20 men went out on a search party for the missing man. He was found covered with dirt about five feet, in a slanting position in a wolf den. He had dug into the den for pups and managed to reach one and throw it out which scared the horse and he jumped the dirt above the den onto Mr. Lawson, and his body, head, and all was covered. Lawson had managed to move his arms enough to rake the dirt off his head so that he could breathe but he was unable to get loose so had lain there from Thursday until Sunday at 10 o'clock when he was found. He did get home and recovered from the shock."

Milo Blodgett, grandfather of Ralph, moved his family to Hansford County in 1907.

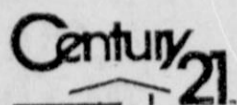

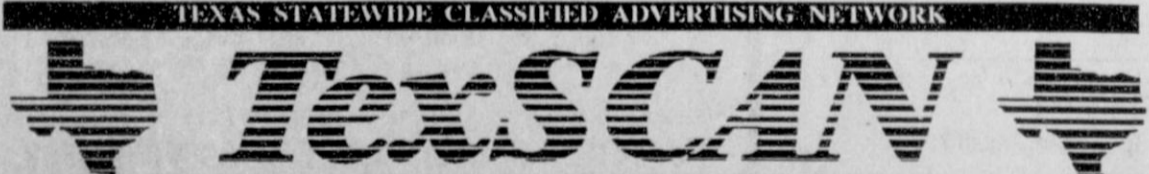

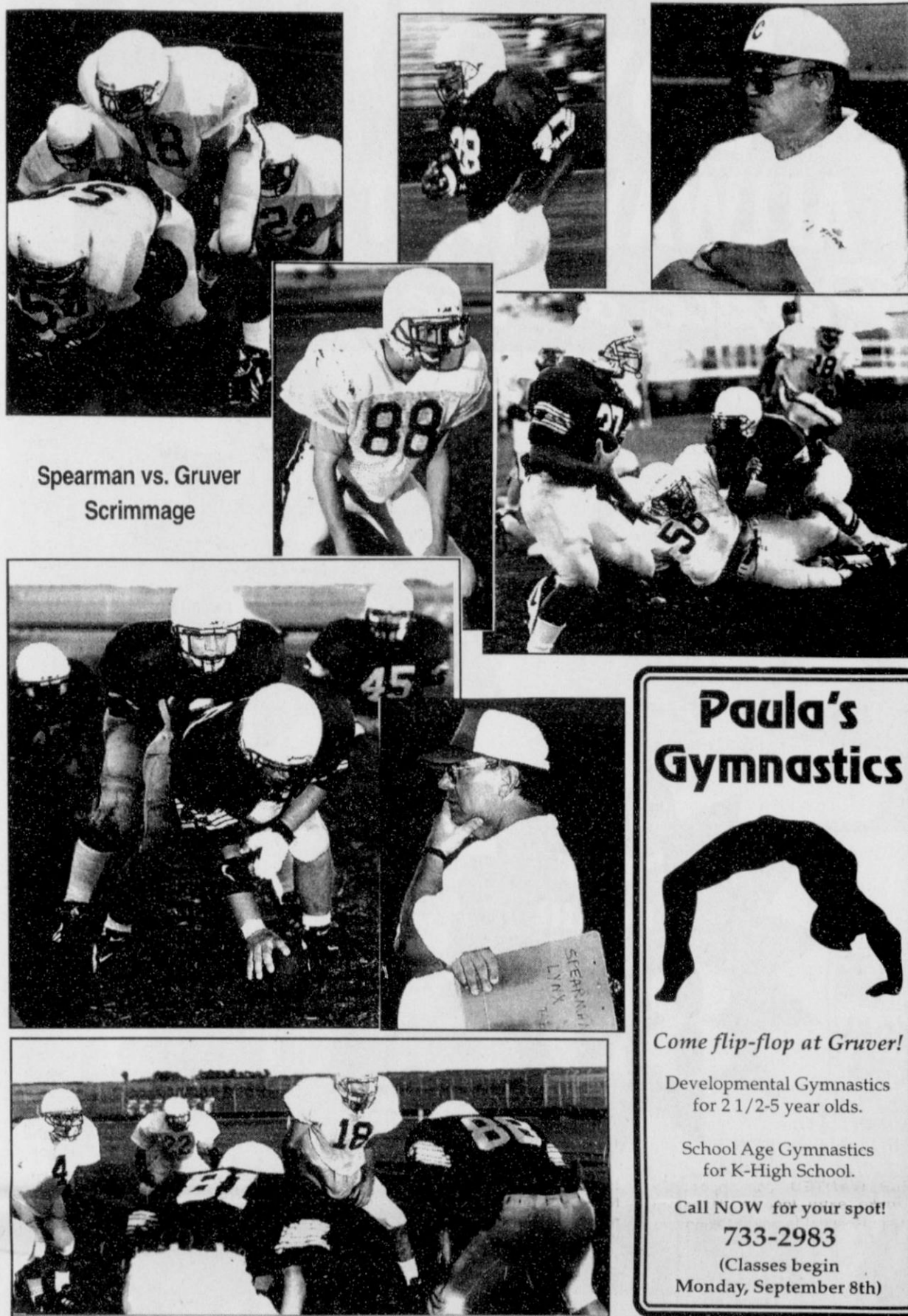
