Participants work an average of twenty hours per week at minimum wage. Wages and fringe benefits are paid by Green Thumb, Inc. Participants are provided work experience, training, skill assessment, counseling and supportive services to help them in obtaining permanent employment.

Ag Commissioner Reminds Producers About Linked Deposit Program

Farmers and ranchers who suffered agricultural losses from the December ice storms may be able to get help from the Texas Department of Agriculture's Linked Deposit Program, says Agriculture Commissioner Susan

To be eligible for the Linked Deposit Program, producers must have suffered an agricultural loss in a county that has received a Presidential or Secretarial Disaster Declaration due to a natural disaster. Those eligible must also have a loan approved by an eligible lender who then will submit the completed application to the Texas Agricultural Finance Authority for approval. If approved the rate on the bank's loan would be reduced to an interest rate that is established at the time of closing. The maximum loan amount financed for disaster relief under the Linked Deposit Program is

The Linked Deposit Program can also assist producers with water conservation projects such as brush control or for the purchase of water conservation

equipment.

Cost-Share Signup Deadline Nearing

The Natural Resources Conservation Service (NRCS) has set the signup deadline for the 2001 Environmental Quality Incentive Program (EQIP). The application deadline for the 2001 program year is March 30, 2001. Applications from individual landowners interested in participating in the EQIP during the 2001 program year received before March 30 will be ranked for program eligibility during the month of April. This will be the last cost-share funds available until approximately this same time part year.



Father, Son Remembered for Defending the Law

The Martin family knows a hero when they see one. Two in their family have given their lives to defend the law in the past century.

Sheriff R.E. Martin served Hansford County from 1908 until his death on February 11, 1911.

After his son, E. Clarence Martin lost all he had in the Depression and drought, he moved his family to Los Animas, Colorado from Hansford County. There he started working with the police force. He worked his way up, eventually taking the chief of police position in Los Animas.

A drunken brawl broke out on the night of April 20, 1947 to which the police responded. "They called it 'line of duty',"


said his daughter, Yvette McCammond of Spearman.

Soon after the fight was suspended, Mr. E. Clarence Martin suffered a heartattack.

This May 13, the National Law Enforcement Memorial Fund will honor Mr. Martin for his dedication and bravery in defending the law with his life. His name will be added to the memorial with other fallen law enforcement officers.

"He is being honored for exerting himself in trying to get some men from fighting," said Mrs. McCammond.

Mrs. McCammond and her brother, who moved back to Spearman after World War II in 1949 and 1947 respectively, still

Blowin' In The Wind

Time to get going on the Windmiller Trade Fair for June, 2002, to be hosted by Spearman and the Southwestern Pioneer Windmill Association. The first of many planning meetings was held this week for the convention, and also the landscape committee met to do its planning.

If you have an interest in convention plans, landscaping, windmill restoration, etc. please call Gina at the Chamber of Commerce 659-5555. June, 2002 seems a long way off, but it will be here very quickly.

The 2001 Windmillers' and Trade Fair is going to be in June in Comstock, Nebraska, a small town of 200 to 300 people. The literature from Comstock make it appear that we have a challenge ahead to have the best windmill convention ever.

We may anticipate that attendance at the Spearman convention will be higher than usual because of the J. B. Buchanan Windmill Collection and Mr. Buchanan himself. Windmillers that might pass up a convention will want to come to Spearman to see the collection and meet the man whose windmills are known to collectors worldwide and who has two mills in the Smithsonian.

The SPWA is going to need the help of everyone in Spearman, Hansford County and surrounding

area. The response to the windmill park, restoration of windmills, furnishing the windmill barn, adoption of windmills, etc. has been great, but more is going to be required in the next 14-15 months.

DEMPSTER #11

The Dempster No. 11, self-oiling 10 foot wooden wheel mill at First State Bank is number 8 in the brochure describing all the mills in

The Dempster No. 11 is a transitional windmill design of the The mill recognizes the need of self-oiling mills and takes a first step toward that goal.

The mill could be ordered with either a steel or wooden wheel. The FSB's mill is a wooden wheel beauty with white blades, tipped in red, and the trailing edge of the vane is outlined in red, and the lettering on the vane is in black.

The Dempster #11 is governed like other mills in that the wheel is set slightly to one side so that as the winds gets stronger, the wheel automatically turns toward the vane and out of the wind. The mill can be completely shut off by a friction brake operated by wire from the

The self-lubrication is unusual. A "dipper" lifts lubricant from the oil reservoir to special channels which feed the oil to the main bearings. It lubricates the bearings and the


excess flows back to the reservoir. The reservoir and the moving parts are protected by a distinctive galvanized steel hood which has a triangular profile when seen from front or rear.

Dempster Windmill The Company began in 1885 in Beatrice, Nebraska by C. B. Dempster. The company eventually became Dempster Industries and built windmills at least through


