



Throughout the United States, people recognize April as Sexual Assault Awareness Month. In the late 1980's, rape crisis centers throughout the nation agreed upon this date during a meeting of the membership of National Coalition Against Sexual Assault. The purpose was to coordinate at a nationwide level to educate and promote understanding about sexual assault and its prevention.

A recent survey of Texans by KRC Research found that more than half of all Texans are not even aware of the sexual assault services available to them in their communities. Moreover, according to Annette Burrhus-Clay, TAASA executive director, approximately 13% of Texas residents have been sexually assaulted.







LIPSCOMB COUNTY HISTORY

April 22, 1887 marks the date that the first issue of the Panhandle Interstate newspaper was published. The first issue had ads from a Surveyor and Land Agent, a Drugs and Sundries dealer, a Livery, Feed and Sale stable, the First State Bank of Kiowa, A Farm Implements co., the Southern Kansas Railroad, a lumber company, and a Dentist. Most of the companies were in Kiowa, Kansas. An Article "Kiowa to Lipscomb by Stage" tells us that a W.L. Brown has put on a hack between Lipscomb and "Buzzard Roost" making close connections with the stage between Kiowa, Kansas, and Mobeetie, Texas, thus giving through passage form Kiowa to Lipscomb without an lay over the entire distance.

This first issue described the weather, the first settlers, the railroad and our geography. Letters were published and a page of Items of interest were published. an example of interest was Woodson Bro's put up quite a quantity of ice last winter, with which they will supple the Lipscomb market when the hot days come.

On its 118th anniversary, we are still enjoying and learning from our first newspaper.






The Birdwell money of about 1.3 million dollars is being held as a contingency in the event of a cost overrun. Editor's Note: Spearman ISD Superintendent Rodney Sumner has agreed to answer questions regarding the Spearman ISD bond election. The following questions were sent in by a taxpayer in Spearman ISD.

funding of any type? If yes, what is the status of that? If no, why not?

A. In the past the district has applied for various types of grants; however, I am unaware of any grants out there that relate specifically to facility improvement. The only state program is the Instructional Facility Allotment (IFA). This program provides assis-

tance to school districts in making debt service payments. Districts can only apply for IFA funds after a bond election has passed and before bonds are purchased. The amount of state aid under the IFA program is based on the size of the district, its property values, the

Q. Have our school personnel .number of students in average daily applied for any grants or state attendance (ADA), and the amount of the annual debt service. It is important to note that the IFA program is not fully funded by the legislature and has limited funds available to assist school districts. Therefore, districts are ranked by need with property poor districts at the top of this list for available funds. Since we are considered by the state above average in terms of property wealth we will probably

not qualify for any state assistance. However, we will apply for the IFA funds anyway in the case that we might receive any amount of state assistance.

Q. We see the estimates are from an architect. Have any contractors of ANY type estimated these costs? I have spoken to two contractors who both state that every single time they have been involved in a job of this sort the architect's estimates have been at least 1/3 lower than the actual cost. My fear is that we will approve this bond assuming we will end up with everything that has been presented to us, but instead we will end up with a lot

going to get. Please clarify this.

A. As we started working on this project estimating cost was particularly difficult. In trying to develop the most accurate cost possible, we asked our architects to work with teachers and administration to identify as closely as possible all the space requirements needed for the project. The architects keep a data base of costs for every aspect to the project and regularly update this data base in order to give cost estimates based on most recent projects. NO contractors have been contacted. It costs significant money to design a project to the point that it is ready to bid. Before a contractor can give an estimate they would need actual architectur-

less than we thought we were al blue prints. Due to the cost of producing blue prints and since the district does not have authorization to complete this project, the district has not proceeded any further until final approval is given by the tax payers. However, not having enough money to complete the project due to cost overruns and the volatility of constructions costs is a concern we all fear. We hope that the architects cost estimates are on. the high side and in all actuality the cost will come in lower than the project price tag. Any money left. over could be used toward improvements at the high school or be used to lower the bond principal. In addition because of this fear, the board has set aside the Gus Birdwell fund as a contingency in

case there are cost overruns on the project.

Q. Are we asking for MORE facility improvement that what we actually need?

A. Both the Board of Trustees and the Citizen's Facility Committee identified the following facility needs:

1. New Junior High School

2. Additional room/space at the elementary school

3. Better parking and traffic flow at the elementary/ junior high campus

Texas business owners are subject to monetary penalties if they file their annual property tax rendition late, fail to render or file an incomplete or false rendition.

"If some businesses are not paying their fair share of property tax, honest, hardworking business owners and homeowners," Strayhorn said.

Rendering allows property owners to record their opinion of their property's value and ensures that their property. Owners do not have

Property owners who need more time to file their renditions may file a written request with the chief to receive an automatic extension to May 15. The chief appraiser may also grant an additional 15 days after the May 15 deadline if necessary.

"To stop a delinquent tax suit," Peddy said, "the age 65 and older or disabled homeowner files the deferral affidavit with the court in which the suit is pending."

Once a homeowner files a tax deferral affidavit with the appraisal district, no taxing unit can start or continue a lawsuit for delinquent taxes as long as that person owns and lives in that home.



Chief Appraiser Alice Peddy informs homeowners that Texas law allows them to file a one-time application for homestead exemptions. These exemptions reduce the appraised value of the home. "You do not have to pay a fee to file for a homestead exemption," said Peddy.

Property owners who have not received the general homestead exemption on their homes in which they were living on January 1, 2005, and those who became totally disabled or turn 65, must apply this year to receive their exemptions for 2005.

For the general homestead exemptions, homeowners must own and live in their homes on January 1, 2005. Homeowners 65 years of age and older and those who become disabled don't need to own their homes on January 1 to qualify for the age 65 and older or disabled homestead exemptions. State law provides that they may apply as soon as they turn 65 or become disabled, own the home of exemptions for homeowners. and live in the home as their princi- For school tax purposes, all homepal residence.

Peddy said that a property must improvement is taxed at its current meet four tests set by law to qualify for the residence homestead exemption. The person or persons claiming the exemption must own the property on January 1 (homeowners 65 and older or disabled need not own the property on January 1 for the age 65 and older or disabled homestead exemptions only); the property must be designed or adapted for human residence; the owner must use the property as a residence; and the property must be the principal residence of an owner who qualifies the same percentage of tax paid as for the exemption.

land, can qualify for the exemption if it meets the four tests.

'A property owner can still qualify for the homestead exemption if part of the residence is rented out or used for other purposes, such as a home business," Peddy said. "The home will not lose its exemption if the owner moves away temporarily for a period of less than two years, so long as he or she intends to return and doesn't claim another homestead exemption elsewhere."

Texas law provides several types owners may receive a \$15,000 general homestead exemption and homeowners 65 and older or disabled receive an additional \$10,000 exemption. The school tax exemption for those homeowners 65 and older or disabled provides a special property tax "ceiling" for school taxes. While the market value of an elderly or disabled person's home may fluctuate with the market, the school taxes cannot increase above the tax amount in the first year that person qualified for that homestead for the age 65 and older or disabled exemption.

Homeowners can reduce their long as the owner uses them for owner adds a new improvement, such as a room or garage, the new market value and the current tax rates. The new taxes are added to the previous tax ceiling to create a new ceiling.

> Homeowners 65 and older or disabled may transfer the same percentage of tax savings to a new home. The homeowner transfers the percentage of school tax paid on the former home, based on the last year the homeowner qualified that home for the tax ceiling, to the new home. The new tax ceiling is calculated to give the homeowner on the former home. The home-A mobile home, even on leased owner may not claim two different homes in the same year.

> > For example, if the homeowner had a school tax ceiling of \$100, but would pay \$400 in 2005 school taxes without the tax ceiling, the percentage of tax paid is 25 percent. If the 2005 school taxes on the new home are \$1,000, the new tax ceiling would be \$250, or 25 percent of \$1,000. The homeowner may request a certificate from the appraisal district where the former home was located that gives information about the tax ceiling. The homeowner gives this information

The county, city or junior college district may decide to set a tax ceiling provision for homeowners 65 and older or disabled. Each taxing unit's governing body may decide to grant the tax ceiling provision or the local citizens in a taxing unit may petition for an election to vote on granting the tax ceiling provision in that taxing unit.

Homeowners should notify the chief appraiser when they no longer qualify for the general, age 65 and older or disabled homestead exemptions. A 50-percent penalty is added to delinquent home taxes if homeowners fail to notify the appraisal district and receive homestead exemptions to which they are not entitled.

Different types of taxing unitscounties, cities and special districts-may offer different homestead exemptions. Counties must offer a \$3,000 general homestead exemption on the portion of the county tax levied for farm-to-market roads or flood control.

Any taxing unit's governing body may grant an additional optional exemption on the homesteads of disabled or elderly residents, or both. This optional exemption may be no less than \$3,000 from the home's appraised value and has no limit on the maximum amount.

Taxing units may also offer a local option exemption based on a percentage of a home's appraised value. In 2005, any taxing unit can exempt up to 20 percent of the

Don't get hit with a penalty! "Render" your taxable property by April 15th.

A "rendition" is a report to the appraisal district that lists all the taxable property you owned or controlled on January 1st of this year.

Who must file a rendition?

You must file a rendition if you own tangible personal property that is used to produce income-such as the inventory and equipment used by a business. If you render late, don't render or file an incomplete or false rendition, a 10% to 50% penalty may be imposed.

Are there any advantages to you?

The advantages of filing a rendition are:

- You give your opinion of your property's value. The appraisal district must notify you in writing of any value change and explain how you can protest that value to the appraisal review board.
- 138 You record your correct mailing address so your tax bills will go to the right address. If your bill is mailed to the wrong address, the law still holds you responsible for paying your taxes on time or paying extra charges for late payments.
- You can also file a "report of decreased value" to notify the appraisal district of significant depreciation of the value of your property in 2004. The district will look at your property before assigning a value in 2005.

What's the deadline?

The last day for filing 2005 renditions is April 15. You can get an automatic extension to May 15 if you ask for it in writing on or before the April 15 deadline. The chief appraiser may grant an additional 15 days after May 15 for an owner who shows good cause in writing.

State law also allows that if the age 65 and older spouse dies before applying for the age 65 and older exemption, the surviving spouse age 55 or older may apply for the age 65 and older exemption for the deceased spouse. The same filing deadlines apply.

If a homestead is located in a taxing unit that overlaps into two or more counties, the homeowner must apply at each county appraisal district.

A homeowner's principal house and yard are considered the residence homestead. It can include up to 20 acres of land and improvements. Improvements include the house, a swimming pool, greenhouse or any other structures, as

A variety of homestead exemptions could lower your property taxes!

A homestead exemption lowers the property taxes on your home by lowering its taxable value. If your home is valued at \$50,000 and you receive a \$15,000 homestead exemption, your home will be taxed as if it were worth \$35,000.

Who qualifies for an exemption?

Anyone who owns a home on January 1 and uses it as a primary residence on that date is entitled to a \$15,000 homestead exemption to lower school taxes this year ... and it doesn't matter if your home is a house, condominium or mobile home. Counties, cities and special taxing districts may also offer homestead exemptions.

Are other exemptions available?

If you're disabled-or if you're 65 years old or older-you are entitled to an additional \$10,000 school tax exemption on your home. And if you qualify for the over-65 or disabled exemption, you're also entitled to a permanent, locked-in "ceiling" on the school property taxes on your home. (The county, city or junior college may adopt a tax ceiling to lock in 2005 taxes as the highest amount for 65 and older or disabled homeowners.) The over-65 homeowner's school tax ceiling transfers to the surviving spouse, if the spouse is 55 years of age or older at the time of death and lives in and owns the home. The age 65 or older homeowners (or their surviving spouses 55 years of age or older) also may transfer the percentage of school tax paid, based on their former home's school tax ceiling, to a new home.

Do I have to apply each year?

No. If you had a homestead exemption on your home in 2004, you won't need to reapply for 2005 unless your chief appraiser requires it. However, if you haven't received an exemption on your present home-or if you've moved to a new home-you'll need to file for an exemption for 2005. If you are 65 this year, you may file for the age 65 or older exemption up to one year after the date you turned 65. And if you became disabled, you need to file for the disabled person's exemption.

When and where should I file?



Y si Ud. califica para la exención de 65 años de edad o más o está incapacitado, tambien tiene derecho a un "tope" permanente en sus impuestos escolares de residencia. El condado, la ciudad o una universidad de dos años también puede adoptar un tope de impuestos en los impuestos del 2005 como la cantidad más grande para los dueños de hogar de 65 años o más o incapacitados. La exención para los que ya cumplieron 65 años o más y el tope máximo se pueden transferir al esposo/esposa sobreviviente si el o ella tiene 55 ó más años de edad y es dueño/dueña de la casa en donde vive. Los dueños de 65 o más años de edad (o su esposo(a) sobreviviente de 55 años de edad más) también pueden transferir el porcentaje del impuesto escolar pagado, en base al tope de su casa pasada, a su nueva casa.

¿Debo solicitarla cada año?

No. Si Ud. recibió una exención de residencia en el 2004, no hay necesidad de solicitarla de nuevo en el 2005-al menos que se lo pida su jefe de valoraciones. Sin embargo, si no ha recibido una exención en su residencia actual-o si ha cambiado de domicilio tendrá que solicitar una exención para el 2005. Si cumple 65 años durante este año, tiene hasta un año de esa fecha para solicitar una nueva exención. Si resultó incapacitado, tendrá que solicitar la exención de personas incapacitadas.

Una "declaración de propiedad" es un reporte para el distrito de valoraciones en donde Ud. enlista toda la propiedad que poseyó o controló el día 1º de enero de este año.

¿Quién debe hacer una declaración de propiedad?

Debe hacer una declaración de propiedad si Ud. es dueño y gana ingresos de una propiedad personal-por ejemplo, el inventario y equipo utilizado en un negocio. Si usted no declara a tiempo, o si presenta una delaración incompleta o falsa, se le puede imponer una multa de un 10 hasta un 50 por ciento.

¿Que ventajas me da?

Las ventajas de hacer una declaración de propiedad son:

- Id. registra su opinión sobre la valoración de su propiedad. El distrito debe avisarle por escrito y explicarle como protestar el nuevo valor y el cambio ante su junta de revisión.
- Registra su dirección correcta para que le puedan mandar sus tarifas de impuestos. Según la ley, Ud. es responsable por pagar sus impuestos sin demora o de pagar cualquier multa que resulte por haberlos pagado tarde-aunque la tarifa se haya mandado a una dirección equivocada.
- ra También puede someter un "reporte de valoración disminuida" para avisar al distrito de cualquier reducción significativa en la valoración de su propiedad en el 2003. El distrito examinará su propiedad antes de designarle un valor en el 2004.

¿Cual es la fecha límite?

El 15 de abril es el último día para mandar sus declaraciones para el 2005. Puede obtener una extensión automática hasta el 15 de mayo si la pide por escrito en o antes del 15 de abril. El jefe de valoración/tasación puede extender su plazo otros 15 días despues del 15 de mayo si usted puede mostrar una razón justificada para la extensión.



Football Coach Jones Resigns Effective Immediately


West Texas A&M University head football coach Ronnie Jones resigned Tuesday, April 19 following a University investigation that concluded he used state and school resources for personal gain.
