Grand Jury Indicts Fox in Jones Slaying

After returning an indictment in the J. W. Fox case, the Grand Jury of the 69th Judicial District Court, now in session in Hereford, recessed on Monday to reconvene on Aug. 21 to consider other Grand Jury

The indictment returned states that "on or about the 12th day of July, 1944 . . J. W. Fox did then and there unlawfully, voluntarily and with malice aforethought kill C. F. Jones by shooting him with a pistol."

The case against Fox will probably come up in the current court session, and probably after a new judge has definitely accepted the appoinment to fill the unexpired term of Judge James W. Witherspoon.

Death Claims W. M. Cogdell, 44-Year Resident

W. M. Cogdell, 86 years old and one of the earliest residents of Hereford, died at his home here last Thursday night following a long illness.

Mr. Cogdell, 'who came to Hereford in 1900 and operated one of the first stores in the new town, had taken an active part in business, civic and religious activities of the community during his long residence. He served as county clerk for four years, beginning in 1908; and after his retirement from the office engaged in the hotel business for many years until failing health forced him to retire from active business life. He was a charter member of the Hereford Presbyterian Church and had served faithfully in many phases of church activities.

Born Mar. 12, 1858 in North Carolina, Mr. Cogdell came to Texas in 1870. He was married at Wichita Falls; and survivors besides his wife include three sons, C. B. and W. 



Edwin R. Skypala, son of Mr. and Mrs. V. Skypala, sent a copy of the letter to his mother-and among other facts of interest are included:

". . . I wish you could see the way they grow and sell fruit in India. They are not the kind of bananas we get in America . . but are smaller and sweeter.

Here you buy a ripe, juicy pineapple any time you want to. Venders sell them on the street. They peel them right before your eyes and lay slices out in a basket, which, however, isn't the best way to buy them. It's best to buy the whole pineapple and peel it yourself. This goes for cocoanuts also.

"Some things grown in India are considered delicacies, but they don't always appeal to Americans because you have to acquire a taste for them. In this class is a type of sweet potatoes, which doesn't taste like ours at home but isn't bad when you get used to it. We have fried chicken which nobody has any trouble


