The Panhandle Fair and Racing Association of Amarillo has been duly chartered and will hold its first race meeting May 11, 12, and 13. It will also conduct a fair sometime this summer or fall.

HEREFORD COLLEGE.

Board of Directors Order Property
Transferred to Christian Church
—Till Jan. 1, 1905, to complete Building.

At a meeting on Wednesday afternoon the Hereford School Association took final action in regard to the disposition of the College property. The following excerpt from the minutes of the association sets forth their action in detail:

"On motion the Directors of the Hereford School Association are hereby authorized to transfer all the property belonging to the Association, including the unfinished college building, all land donations, and all subscriptions of money, notes, and all other property of any description, whether mentioned herein or not, to such corporation as may be hereafter organized by the Christian church of Hereford, Texas, on condition that said corporation enter into written contract with the officers of this Association to assume all debts and obligations now due or to become due against this corporation, and a further obligation to complete the college building on or before January 1st, 1905, with a proviso that in the event of a failure on the part of said corporation to finish and complete said building for college purposes by said date, that then said building and all property belonging thereto be re-transferred to this Association, and be subject to their control after said date.

It is further ordered that C. G. Witherspoon and Ross W. Davis be and they are hereby authorized to

meet with a like committee to be appointed by said corporation and draft a contract under this agreement as a basis of this transfer."

The enterprise is a worthy one and should have generous encouragement. A military company, properly officered and equipped, will add a zest and interest to the life of the town, and will give the young men participating in it a valuable training in the tactics of military drill.

PAT NEFF ROBERTS.

A few weeks ago Representative J. C. Roberts announced to the House the birth of his twenty-first child. The House at once passed a resolution naming the boy Pat Neff Roberts, after the present Speaker, subject to the approval of Mrs. Roberts. The mother of No. 21 having assented to the name chosen, the House has passed another resolution as follows:

Whereas, It has come to the knowledge of the House by a written communication that Mrs. J. C. Roberts, wife of our distinguished member, Judge J. C. Roberts, has accepted, confirmed and ratified the name so generously and unanimously bestowed upon their infant son by this House, and that the said boy is now legally and with all due formality named, christened and entitled Pat Neff Roberts; now therefore, be it

Resolved, That it is the wish of the membership of the House that Pat Neff Roberts follow in the footsteps of the man for whom he is named, and that he make a useful citizen of the state.

Resolved further, That we all hope to live to see Hon. Pat Neff Roberts speaker of the Texas House of representatives.

We note with pleasure that the editor of the Quanah Tribune-Chief has been appointed as a delegate from the Northwest Texas Press Association to the National Editorial Convention, which is to meet in St. Louis this year.

IT will be noted that at the recent convention of the Panhandle Cattlemen's Association the time of their meeting was changed from the third week of March to the third week of April. This was done with the desire that more northern buyers may attend the convention, and that the meeting may thus be of more practical value to stockmen. The change is certainly a wise one. Few sales of cattle are made in the Panhandle in March, and buyers from the north hardly begin to come in before the last of April; hence the latter date is much preferable. The credit for the change is due largely to our fellow-townsman G. A. Sachse, who is a member of the executive committee of the association, and who represented to the convention the advisability of the change.

In a few weeks the Panhandle Teachers Institute will meet in Hereford. Is it not time that steps were being taken to provide the proper entertainment for the visiting teachers and others who attend? This convention should be an occasion of much interest and profit to the entire town, as well as to those immediately connected with the Association, and everything possible should be done to give the visitors a favorable impression of our town and people.

Our delegates to the Fifth Sunday meeting at Memphis came back very much encouraged at the prospect of Hereford's securing the Baptist College. They think that our chances are of the best. It is not wise to be over sanguine, nor to count the battle won before the fight is fairly on. On the other hand, it is well to hope much and to work much, believing that if we really want the College and want it bad enough, there is no reason why we shouldn't get it.

It is reported that Fort Worth is soon to have a new morning newspaper, of the most modern kind to compete with the Dallas News. A stock company with a capital of \$150,000 will be organized, and a large and complete newspaper plant installed. The new journal, it is said, will be the north Texas branch of the Houston Post. Its politics will be distinctly Democratic. Clarence Ousley, at present editor of the Post, is to occupy the cheif editor's chair. It is thought that John H. Kirby of Houston is backing the enterprise.

A BILL has been introduced in the State Senate to relieve fair associations from the operation of the anti-poolroom law recently passed. The bill, which has been reported favorably by the Senate judiciary committee, is as follows:

Section 1. Hereafter it shall be lawful to wager upon races between horses in this state when such races are conducted under the supervision of any fair association chartered under the laws of the state of Texas, and when such wager is made on the day the race is actually run, and within 200 feet of the track or grounds where such race is run; provided, that this act shall not be construed to at any time or place authorize the selling of pools on any horse race.



FIFTH SUNDAY MEETING.

The College Proposition Discussed. Next Meeting at Clarendon.

The Fifth-Sunday meeting of the Paloduro Canyon Baptist Association met at Memphis last Friday morning and remained in session until Sunday night, with the following visiting pastors and messengers in attendance: Rev. A. E. Baten of Amarillo, Rev. H. B. McGee and W. H. Rayzor of Hereford, John Moreman of Plano, Rev. Ballard of Canyon City, Rev. W. H. Youner of Channing, Revs. W. L. Skinner and A. H. Thronton of of Clarendon, Rev. Walter Hightower of Donley county, Rev. J. W. Whatley of Canadian, Rev. A. P. Collins of Wellington and Rev. D. E. Baker of Miami.

The attendance at the various services was large, the weather being exceptionally pleasant, and many questions of importance to the denomination were discussed, the leading topic being "Christian Education.

The movement to build a Baptist college in the Panhandle was given an impetus, and a resolution was passed inviting the Red Fork and Staked Plains Associations to cooperate in the work. Rev. A. E. Baten and J. L. Smith of Amarillo, Messrs. Moreman of Hereford and Oakes of Channing and Rev. J. B. Cole of Memphis were heretofore appointed a committee to examine into and recommend the best location for this college, and they will make their report to a meeting of

the association to be held at Clarendon next July.



A TERRIBLE BUGABOO.

The Bryan bill has passed its second reading. This means practically that the bill will pass the House. Our worthy representatives have elected to set prejudice above the fair claims of justice. They have chosen to yield to the insistent clamors of the selfish and acquisitive East and South for 'land, land, more land!" Mr. Ware and his colleagues made perhaps as good a fight against the bill as could have been made under the circumstances; but they had no argument to set against the terrible bugaboo of the Cattle Trust. When the fearsome orator from Abilene and his honorable colaborers arose upon the floor and told the assembled representatives their scary tale of how this vast expanse of territory west and north of the line was languishing in the clutches of a few greedy eastern and northern cattle barons who had secured the establishment of the quarantine line for their own protection, there was an end of the matter. The worthy gentlemen from the prairies and the sand dunes just shivered, and turned pale, and tumbled over each other in their eagerness to pass the bill. And most of them have never been west of Ft. Worth in their lives! It was of no importance that the whole people of the territory most vitally interested in the measure were strongly opposed to it. It was a trifling consideration that both reason and experience have proved the unwisdom of an open season. Here was an opportunity to strike another spectacular blow at the great bete noir. the Trust, which is continually disturbing the slumbers of every good democrat. Of course there is no such thing as a cattle trust that anybody knows anything about. But that was no matter; it was a good bluff, and it worked.

THE season has come again for the planting of trees. The good people of Hereford should not forget this, who are interested in seeing their town made pleasant and attractive. Nothing so beautifies and adorns a town as the presence of shade trees along the streets and in

the yards. And it has been demonstrated that trees of a number of different kinds will grow here and do well.

THERE is not so much talk and conjecture this week as there was last about prospective candidates for the sity offices. Everybody seems to be waiting until the process of incorporation shall be completed and the election ordered. We mentioned last week the names of several persone who have been suggested to fill the offices of mayor and aldermen. All of the gentlemen mentioned are enicently qualified to serve in publicoffice. It is very desirous, however, that the wishes and opinions of the officens may center upon certain ones of these gentlemen, that there may be no important controversies or contests. Personal or business differences should not be permitted to enter into this matter of selecting officers for the new city. Hereford is too small a town, and this is too critical a time in its history to permit of divisions and differences overmatters of small importance. The success of the new city government and the business prosperity of the town will be best assured by the combined and harmonious efforts of all the people.

Bryan bill passes

Its Second Reading by a Large Majority. It is Now up to the Senate.

After two days of warm discussion in the House, the Bryan Bill, amending the quarantine law, passed its second reading last Wednesday by a vote of 79 to 37. This may be taken as determining that the bill will be passed in the lower house, as the course of a bill after the second reading is purely formal. Representative Ware and other opponents of the measure made a stubborn fight against it, but all to no purpose. The most effective argument in favor of the bill seemed to be that the sanitary law is a measure devised to benefit a vague somebody or something which gentlemen were pleased to call the Cattle Trust, and that the interest of the great free people demand that the quarantine line be broken down. That such an argument could have weight with men of average intelligence is evidence of the large amount of ignorance that many members of the state legislature have managed somehow to accumulate.

The only hope for the country north of the line now is that the Senate will refuse to pass the bill. The upper house is a smaller body and consequently more amenable to educative influence. It is composed also of older men who are less likely to be swept off their feet by specious and scarecrow arguments. S. T. Howard, of this county, who is at Austin working with others against the bill, writes that they have a hard-proposition before them but they have hopes of getting a majority of senators to take a right view of the matter.

Petitions are still being sent in to the legislature against the bill from various parts of the state. The Fort Worth Board of Trade passed resolutions last week unanimously disapproving the measure, and asking that it be not passed. The Dallas News of Sunday contained a page devoted to a discussion of the tick theory, and to arguments setting forth the objections to an open season. All these things will have weight, and it is impossible to foresee what will be the final fate of he bill.

OKLAHOMA QUARANTINE.

Bill Passes The House-No Open Season for Southern Cattle at Any Time

The Matthews quarantine bil placing the whole of Oklahoma above the quarantine line, was passed by the lower house of the territoria legislature last week. The bil passed makes the outer boundaries of Oklahoma an impassable quarautine line, and prohibits cattle or other live stock liable to transient diseases being "led, drifted, driveh. moved or imported" across it at any time under penalty fines ranging from \$100 to \$5,000 and imprisonment for one month to one year, or both fine and imprisonment, for each offense, and renders the guilty party liable to civil action for damages. There is no open season and Southern cattle are absolutely barred at all times.

The bill is very drastic and consequently has aroused a great deal of opposition in some parts of the territory. It is thought that it will hardly meet with the approval of the territorial council, which it must have before it can become a law.

SPLENETIC FEVER.

Shipment of Tick-Infected Cattle Dangerous at Any Time.

Austin, Feb. 16 .- S. T. Howard has received a letter from M. Francis, deterinarian at the Tasses experienced to splenets. As a property of the Francis details the experiences. ducted at the station, and concludes his letter by saying:

"To answer your letter, in one sentence, I will say that, in my opinion, the shipment of cattle infected with ticks across the quarantine line. at any season of the year, is unsafe and dangerous."

This letter will be offered in evidence when the Bryan quarantine bill comes up again.

PANHANDLE ASSOCIATION.

An Interesting Meeting at Childress Report of Proceedings.

The fourth annual convention of the Panhandle Stockmen's Association met at Childress Tuesday and Wednesday, March 24 and 25. It was a success in every respect. More than five hundred visitors were present and the interest manifested was greater than at any previous meeting. The roll of the Association showed a membership of 431, fifty-two having been added since the meeting at Quanah a year ago.

The welcome address was delivered by Hon. J. B. Sneed, to which response was made by Hon. Cleve Coffee of Miami. Jerry Simpson of Roswell, and Walker Hall, of Vernon, who were to have been the chief orators of the occasion were prevented from being present, the former by pressing business, the latter by sickness. The principal addresses of the meeting

were delivered by Thos. S. Bugbee, president of the Association, and Hon. John H. Stevens, congressman from the Jumbo district. Mr. Stevens' address dealt mainly with matters of national legislation in which the Panhandle is interested. He paid a strong compliment to Senator D. E. Decker of Quanah and W. B. Ware, of Clarendon, for their valiant and successful opposition to the Bryan quarantine bill. He also offered the following resolutions, all of which were adopted by the Association:

Soliciting national legislation to take up the work of boring for artesian water at some point in the Panhandle, particularly Childress.

Approving action of asking for a joint state and national commission to establish boundry line of the Panhandle.

Favoring passsage of the 40-hour

Favoring lease of the public domain, subject to homestead laws. The annual address of President T. S. Bugbee was a worthy effort,

full of interesting and valuable sug-gestions. He stated the objects of the Association to be:

"First-To protect the honest citizens against the depredations of those who live by the efforts of their fellowmen. No industry is so much exposed to the ravages of thieves and marauders as that of raising range cattle, and consequently there is no business so much benefitted by thorough organization.

Second-To co-operate in the formation and execution of such plans as may be deemed conducive to the development of the livestock indus-

try of the great Panhandle.
Third—To cultivate a union of effort and to promote a harmonious exercise of such effort of the livestock industry."

He urged that everyone interested in the development of the livestock interests of the Panhandle join the association and assist in promoting its welfare.

The election of officers resulted in the choice of the following Thos. S. Bugbee, of Clarendon, president; T. J. Richards, of Paducah, first vice president; L. B. Watkins, of Quanah, second vice president; J. T. Holland, of Amarillo, treasurer; Ed H. Brainard, secretary. Amarillo was selected as the next place of meeting of the association.

The citizens of Childress entertained their guests in a royal manner. The hotels were overcrowded, but the people opened their homes to the visitors and everybody was well provided for. A number of interesting social features lent a pleasing diversity to the meeting, and all who attended counted themselves well repaid.
