Local Police Seize Field of Marijuana

The confiscation of 450 marijuana plants on the morning of October 12, was the culmination of six days' investigation and a stakeout which began at 10:30 a.m. October 11, and ended at 9 a.m. October 12.

The investigation was set in motion by a tip received by the Rising Star Police Department and after the determination that a field of marijuana did exist and was located in Brown Co., the Texas DPS Narcotics Division and Texas Ranger Gene Key from Eastland were called in to aid in the investigation and subsequent stakeout.

A 20' Skyline camper trailer at the site of the marijuana field, located 4 miles southwest of Rising Star, was also confiscated. The trailer contained dried marijuana. No arrests were made at the scene, but Police Chief Curtis McGlothlin expects the

continuing investigation to result in indictments to be handed down from the Brown County Grand Jury.

The estimated street value of the marijuana plants in \$100,000 to \$150,000. The plants ranged in height from one foot to 18 feet.

Chief McGlothlin and Patrolman Dennis Hall expressed gratitude to Ranger Key, the DPS Narcotics Division and Texas Highway Patrolman Larry Melson of Cross Plains for their assistance.

Chief McGlothlin invites area farmers, concerned citizens and parents who may not know what a marijuana plant looks like to come by his office and look at the one on display there. The office is in the building next to City Hall which used to house the fire engine.

McGlothlin joined the local police force June 1, 1982, and Hall was hired July 1, 1982.

Plan Ahead for Retirement Benefit Application

People in the Abilene area who are planning to apply for Social Security retirement benefits soon can help speed the application process if they get some information together first, Glyn Hammons, Social Security district manager in Abilene, said recently.

A person will need proof of his or her age. The best evidence is a public or church record of birth recorded before age 5. If this cannot be submitted, other evidence may be used. The best is often the oldest, Hammons said.

Other records that might be used include school, church, State or Federal census, insurance policies, marriage, passports, employment, military service, children's birth certificate, union, immigration and naturalization. There are other records as well that may prove acceptable.

A person needs his or her Social Security card or a record of the number. Also requested are

W-2 forms for the past 2 years, or, if self-employed, copies of self-employment tax returns and proof of filing for the past 2 years.

If the worker's wife or husband is also going to apply, she or he will need the same documents. In addition, it would be a good idea to have the marriage certificate available because they are sometimes required. Birth certificates should be available for any eligible, unmarried children as well as their Social Security numbers.

Other documents may be needed in some situations, but these will be enough in most cases, Hammons said. Only original documents or copies certified by the issuing agency can be used. Uncertified photocopies are not acceptable.

Today, Columbus Day, I am reminded of the little boy tripping home from school reciting the rhyme he had learned to help him remember the date of Columbus' discovery: "In 1492, Columbus sailed the ocean blue." When he arose after stumping his toe and falling, all he could remember was: "In 1493, Columbus sailed the deep blue sea." Either date is acceptable.

In 1892 President Benjamin Harrison called upon the public to celebrate Columbus Day as the four hundredth anniversary of the landing of Columbus in America. Among the several world-shaking discoveries and explorations recorded in history, the discoveries of Columbus are high on the list.

Columbus made four voyages to the New World, besides some early trips on Portuguese ships. As a result of these voyages he acquired a plan of exploration in which he thought he could sail west 2400 miles and reach an island near Japan where he hoped to establish a great trading post of exchange between East and West. His plan and requests were not popular with the more experienced Portuguese.

King Ferdinand and Queen Isabella of Spain granted him ships, titles and percentage of trade only after they had won a victory over the Moors at Granada. His first voyage with three ships and "dead sea reckoning" and 32 days time was successful. On October 12 at high noon, he and his crewmen landed on the Bahamas and took possession of the New World.

With only one ship, the Nina, he returned to Spain. Columbus made three more voyages to the New World with discoveries and explorations.

On May 20, 1506, Columbus died at the age of 53. He had a belief that God intended him to make discoveries in

order to spread Christianity. He prayed three times a day. He had great moral and physical courage. He not only discovered a New World, he opened windows to science and all knowledge. "To no man in modern history does the world owe a greater debt."

HOME CRAFT DIVISION GENERAL RULES

1. There will be no entry fee.
2. All entries (except baked goods) will be accepted from 9:00 a.m. to 6:00 p.m., Thursday, Oct. 21, with judging to be Friday morning. Baked goods entries will be accepted from 9:00 to 1:00 p.m. on Friday morning, with judging at 1:30 p.m. Friday, Oct. 22.
3. No entries will be accepted after 6 p.m. excluding baked goods.
4. Only one entry per class per contestant. Due to limited space, only one item will be accepted, i.e., one pillowcase, one book end, etc.
5. NO HOME CRAFT ENTRIES WILL BE PICKED UP BEFORE 6:00 P.M. SATURDAY IN ORDER THAT THE PUBLIC MAY VIEW ALL ENTRIES. ENTRIES MUST BE CHECKED OUT BY DIVISION WORKERS BEFORE BEING RELEASED TO OWNER.
6. Each division will have the following classes: Adult - 18 years and over; Youth - Kindergarten to 3rd grade; Youth - 4th to 7th grades; Youth - 8th to 12th grades.
7. Ribbons will be awarded to 1st, 2nd and 3rd places.
8. Best of show awards will be given to each division. Winners to be chosen from the 1st place winners in each class.
9. Regardless of number of entries, article must be worthy of rating before it is given a ribbon.
10. Decision of the judge will be FINAL.
11. All entries (excluding handicrafts) must have been prepared during the previous 12 months. Entries in the Handicrafts division must not have placed in any previous County Fair.
12. Entries need not be new but must be clean.
13. The Fair Association will not be responsible for any damages, loss, or injury to any person or article while participating in the Eastland County Fair. There will be a watchman on duty at night.
14. No name tags shall be on articles to be judged. Numbers will be assigned upon registration.
15. Names of winners will be posted in each division after judging is completed.

BAKED GOODS

- NOTICE: Baked entries become the property of the County Fair and will not be returned.

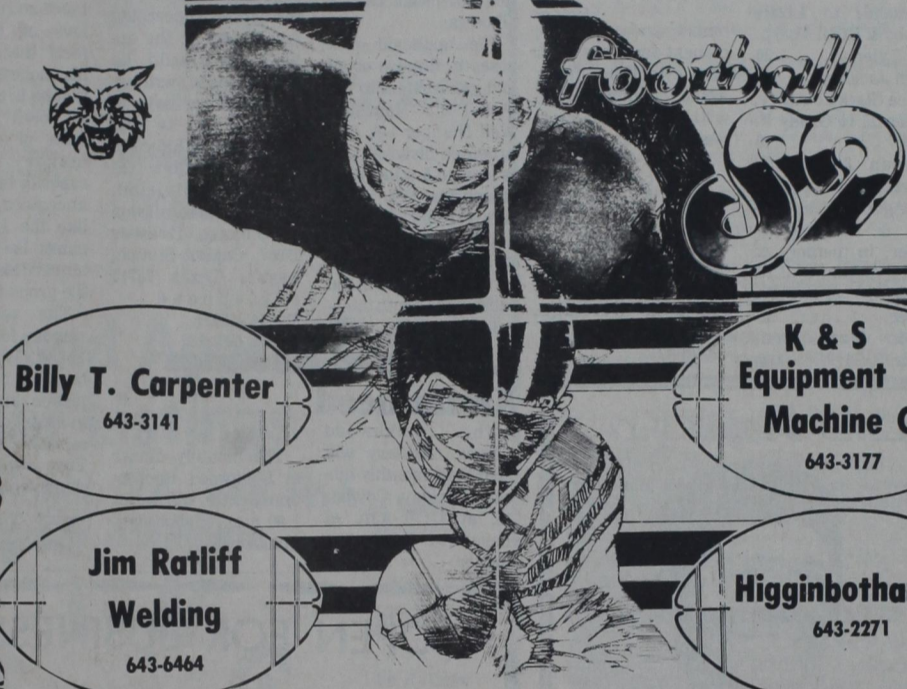

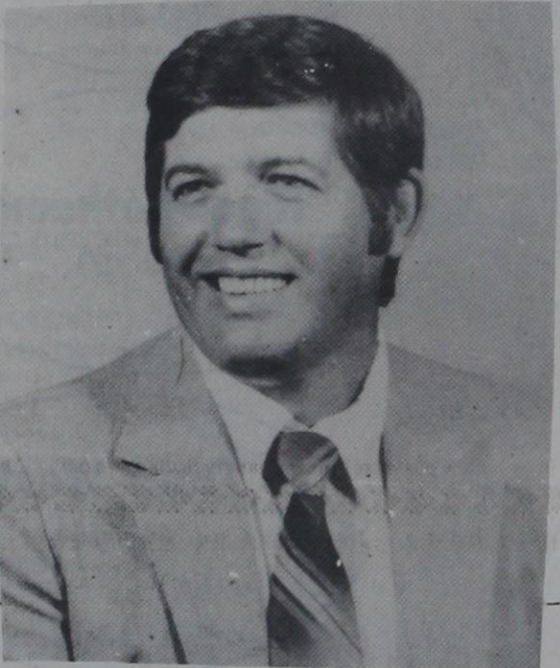

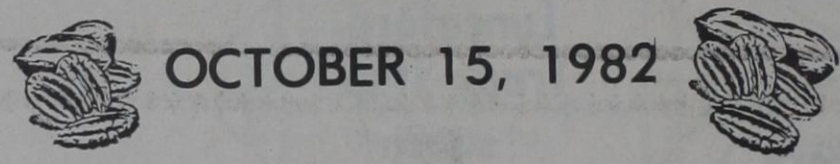

Rising Star Native Named Distinguished Alumni

Brownwood--Ruth Cole of Brownwood and Col. David Gaston Alford, USAF Ret., of Wichita Falls have been named Distinguished Alumni of Daniel Baker College, to be honored at the 1982 Homecoming Octoberr 23, announced Ross Ellis, alumni director for Howard Payne University.

They will be honored at a luncheon at 11:30 a.m. that day at the Adams Street Community Center, where a registration coffee also will be held beginning at 8 a.m.

Homecoming for Daniel Baker, now a part of Howard Payne, coincides with the Howard Payne Homecoming Weekend, and will also include the Homecoming Parade in downtown Brownwood at 9:30 a.m., the dedication of the Ralph A. Phelps Jr. Bible Building on the main HPU campus at 10:30 a.m., and the HPU vs. Angelo State University football game at 2 p.m. at Gordon Wood Stadium.

Miss Cole, who will be completing her term of office as president of the Daniel Baker Alumni Association, is a native of Brownwood, daughter

of pioneer Brown County settlers. She was valedictorian of the Brownwood High School Class of 1923, valedictorian of the Daniel Baker Class of 1928, received her master's degree in Spanish from the University of Texas in Austin and has done post graduate work at the National University of Mexico in Mexico and at Texas Technological University.

Col. Alford, who retired from the United States Air Force in 1965, is a native of Rising Star, where he was graduated from high school. He was graduated in 1939 from Daniel Baker where he was a member of the Hillbilly football squad four years and served one year as president of the student association.

After his graduation from Daniel Baker, Alford enlisted in the U.S. Air Corps and was called into service in December of 1939, graduating from Randolph Air Force Base in 1940. During World War II, he was a B17 pilot and flight commander, based in England. He flew 18 missions and was shot down on his 19th mis-

sion in February 1944. For eight months he was hidden by the Dutch, who later smuggled him back to England.

During the Korean War, Alford flew 36 B 29 missions for which he was awarded the United Nations ribbon with four clusters. He also has been awarded 11 citations, the Air Medal, Distinguished Flying Cross and various ribbons of the European Theatre of Operations USA, the Korean and African campaigns.

He received his master of business administration degree from East Texas State University in 1959 while assigned there as ROTC commandant. His last two assignments were as base commander at Athens, Greece, and base commander at Sheppard AFB in Wichita Falls.

After his retirement from the Air Force in December 1965, Alford worked for the city of Wichita Falls as public safety director and later was on the Nortex Regional Planning Commission as criminal justice planner, serving 12 North Texas counties.

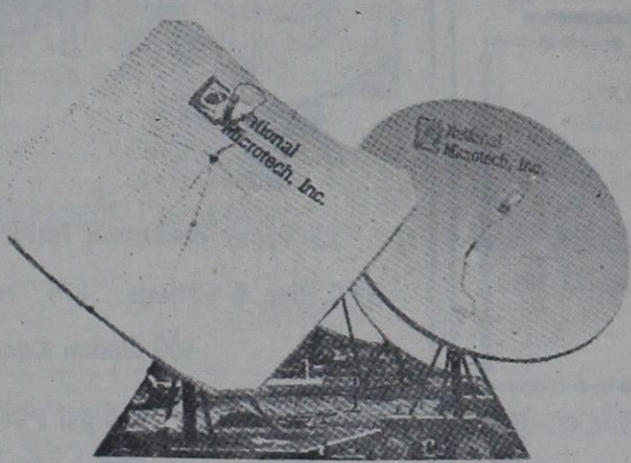

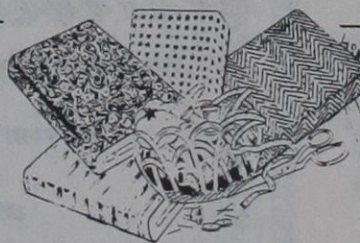

A Note To Parents

From Your School Counselor

The PSAT/NMSQT will be given to the Rising Star High School during the third week of October.

PSAT (Preliminary Scholastic Aptitude Test), simply described, is a practice test for future Seniors taking the SAT, the college entrance examination. NMSQT (National Merit Scholarship Qualifying Test) allows students an opportunity to qualify for a scholarship, although less than 2% of all nationwide juniors who take the test will be a participant.

Other reasons for taking the test are: 1) students will receive materials from various colleges that will assist them in

making long-range plans for a post-secondary education, 2) the scores that are made on the PSAT will be a good indication of their future SAT score and will assist them in making the decision whether or not to attend college.

Below are a few test-taking strategies to help prepare students for testing:

1. Answer the easy questions first. A power test such as this begins with easy questions and progresses to harder ones.
2. Use the process of elimination for questions you aren't sure of the answer. If you can narrow your answer down to two, then it might benefit you to guess.
3. If you know nothing

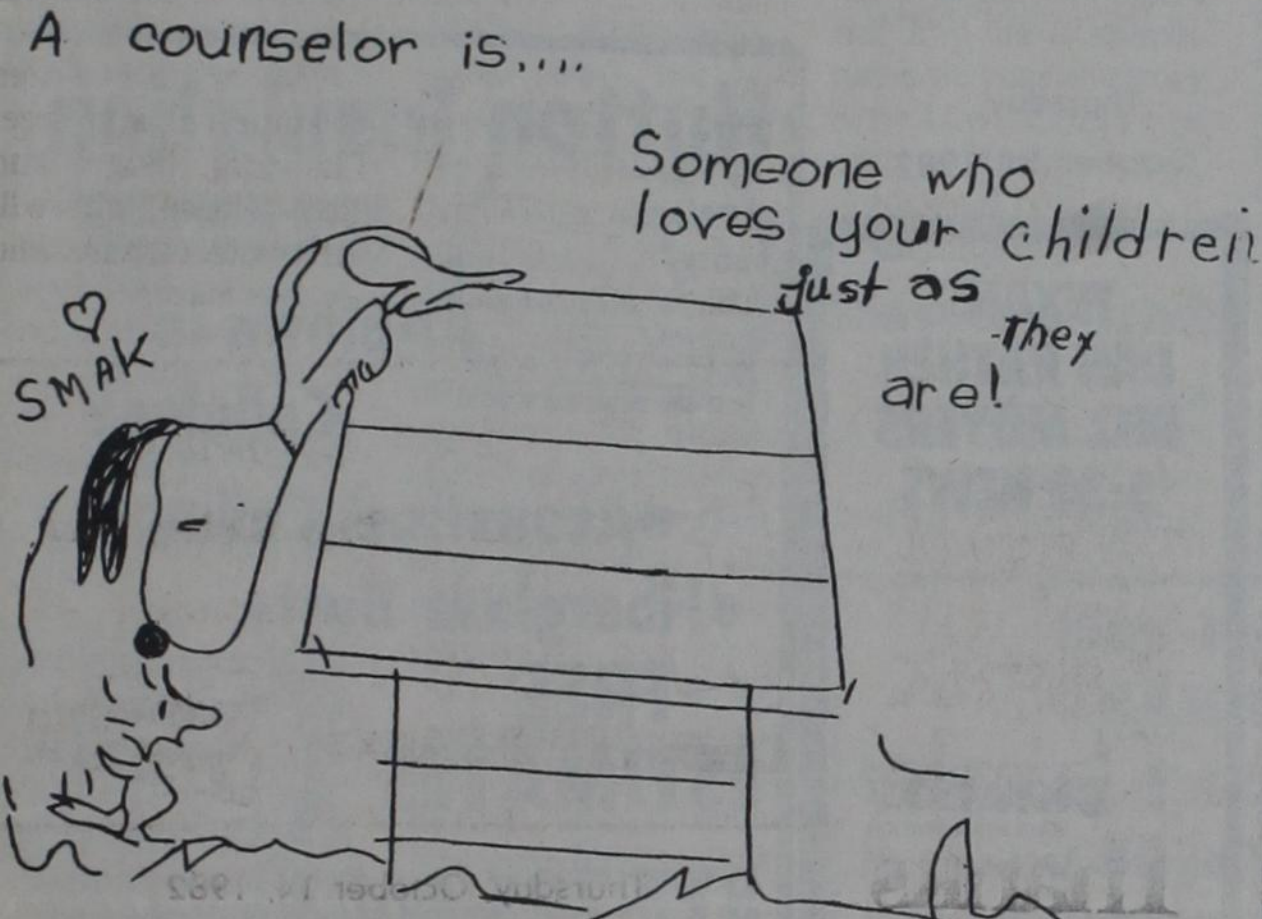
about the question, you would probably score as high or higher by not guessing, since a fraction of a point is subtracted from your raw score for each wrong answer.

4. If you know the answer to a question, don't look at all responses. Just mark the correct answer and move on.

5. Don't spend too much time on any one question.

Parents, encourage your Juniors to take the PSAT. The cost is \$4.25. In some schools it is mandatory that all Juniors participate.

Texas Excellence Award Offered

Outstanding high school seniors across the state will be interested in a \$10,000 scholarship to The University of Texas at Austin. The Texas Excellence Award for Scholarship and Leadership is the first of its kind in the state. Funded by alumni through The Foundation for Texas Excellence of The Ex-Students' Association, the award is based solely on academic accomplishment and leadership in extracurricular activities. Presented for the first time last year, five more such awards will be presented in March 1983, The University's Centennial Year. Each award will be granted over a four-year period (\$2500 per year).

Almost 100 years ago, the Texas Legislature established The University of Texas at Austin to serve the State of Texas as a "University of the first class". Today the Texas Excellence Award celebrates that tradition by emphasizing The University of Texas' alumni commitment to academic excellence.

Eligible high school seniors may obtain applications from their school counselors or from The Ex-Students' Association (P.O. Box 7278, Austin, TX 78712). Applications must be postmarked no later than November 1.
