Burkett Gives Ideas About Special Session

117 Barrels Daily Is Potential For New Scranton Well

Two developments in the new Scranton shallow district southwest of Cisco last week were regarded by oil men as highly indicative. One was a dry hole. The other was the potential test of the Little and Bennett No. 1 W. P. Ledbetter, a mile or more West of the Cozart discovery area.

The Ledbetter exceeded even the most optimistic predictions when it established a daily potential of 117 1/2 barrels on 21-hour pump test. The well is believed to have located a major shallow pool district correlated with the Cozart sector.

Between the two areas, however, the Warren, et al, Huff, 1320 feet West of the Cozart No. 1 discovery, was disappointing. With the formation running 21 feet lower, the well found water at the bottom of 40 feet in the Cathay sand, producing horizon. It was still in the same when further drilling was abandoned and preparations to plug made.

The thickness of the sand although dry, indicates presence of an enormous body of the pay in the district. Operators who noted it said it was quite possible that wells of 1,000 barrels or more would be drilled once the main saturation is found. The sand, operators said, as drilled in the Huff was without a shale break.

COTTON REPORT SHOWS 452,000 BALES LESS

The cotton market was influenced very little with government estimate Monday, in which it reduced the crop by about 400,000 bales. The indicated crop was placed at 11,928,000 as compared with 12,384,000 bales in the September estimate. Ginnings for the belt were 6,686,712 to October 1st, as compared with 6,577,109 bales in 1938. The indicated per acre yield for the belt 235.7 pounds as compared with 244.7 per acre in September. In 1938 the per acre yield was 269.9.

Governor W. Lee O'Daniel, Capital Station, Austin, Texas, Dear Governor:

This acknowledges receipt of your general letter to members of the House and Senate polling their views on certain proposed legislation, if a special session is called. Also we heard your broadcast Sunday which gave in full the text of your letter.

We are mindful of the emergency which exists in all of our Social Security set ups, and especially that of the Old Age Assistance fund. Needy Blind and Dependent Children.

I have consistently stated and still believe and my record will show the same, i.e. we have ample expense, if only rigid economy was enforced with all funds properly allocated. However, viewing the situation as affecting the Old People, Needy Blind and Dependent Children, as one of grave emergency, I reluctantly would support the proposed program as outlined in your letter and in your broadcast, possibly with certain restrictions and limitations.

I further desire to assure you that I will cooperate with you fully, looking to the best interests of our state as a whole.

DEATH KNELL SOUNDED TO TAX REMISSION LAW

Attorney General Mann has ruled a general tax remission bill which was passed by the last legislature as unconstitutional, and non enforceable. He states in his opinion that "A general tax remission bill granting Texas counties approximately \$5,000,000 annually from state ad valorem taxes for five years Tuesday ran into constitutional questions."

**Eastland Votes To Outlaw Beer Sales In Ballot Saturday**

Results of the local option election in Eastland county Saturday was a victory for the dries. Last reports were with 13 of the 27 boxes in the county accounted for Saturday night. The vote was 1,370 dry and 1,244 for the wets. All of the big boxes were in. Only Ranger, and Cisco going wet while Eastland returned a dry majority.

On the bases of the present vote the dries have a majority of 126 votes, with only rural boxes to hear from, and most of them will show a majority for the dries and increase their lead. In the 14 boxes unreported only 440 poll taxes had been paid this year.

**Williams Defeats Scranton 27 To 6**

The Williams High Bulldogs added another victory to their impressive record by defeating Scranton High, 27 to six, Friday night on the Cross Plains football field.

All of the scoring took place in the first half, with the Brown county boys counting first on a pass from Sid Pittman to Phillip Campbell, who caught the ball in the end zone for a total gain of 30 yards. Donald Looney kicked the extra point.

Scranton scored soon after receiving the next kick-off on a 54-yard end run. Verna Grady received the Scranton kick-off and took off on a 75-yard touchdown run.

The next two touchdowns were made in the second quarter, the first on a sustained drive down the field, with Pittman plunging across from the 4-yard line. The final counter came on a 10-yard pass, Pittman to Looney, who side-stepped several would-be tacklers and raced the remaining 40 yards to the goal line.

Neither team threatened in the last half. Both teams were weakened by injuries in the last two quarters.

**County H. D. Agent To Conduct School**

A millor cotton mattresses might be considered the Slogan of the Extension Service in putting on a campaign for the use of surplus cotton.

Restful sleep is a necessity for that vim and vitality feeling and a mattress is one of the aids to help an individual to feel his best. Not many homes in Texas that could not use an extra mattress or more. A million new mattresses, 50 pounds of cotton in each, less than one for each Texas family—would use up 100,000 bales of cotton.

To help with this campaign the home demonstration agent will give four training schools, one in each precinct during the later part of October in Callahan county, to train women and girls to make their own mattresses. The other 205 home demonstration agents in Texas will also give the four training schools each.

The Dressy and Eula communities have made request for the training school, other places will be selected as the requests are made.

"The autumn leaves are falling; They are falling everywhere; They are falling through the atmosphere, And also through the air."

Most interesting political development in recent months is the declaration by picturesque Jerry Sadler, State Railroad Commissioner that he either will enter the race for governor or will support some candidate against W. Lee O'Daniel if the Governor doesn't quit urging a sales tax. One can accord sincerity of purpose to O'Daniel but still lament that his lack of political experience has caused the great Eastern interests (who largely own the natural resources of Texas) to use him as a catspaw to rake their chestnuts out of the fire. Sadler favors old age pensions but doesn't believe that in a State with so much natural riches the poor ought to have to pay their own pensions.

Sitting in the beautiful, newly-built Public Library in Fort Worth one marvels that, though surrounded by tens of thousands of books, there are only 26 letters in the alphabet but that scant number of characters, can be used in endless combinations to produce words—there are 400,000 words, for example, in the English language, including the obsolete, obsolescent and some of the least objectionable of the absence. Those hundreds of thousands of words, in turn can be shuffled about the patterns as innumerable as the sands of the desert.

No man has even commanded all the keys of that mighty organ which is English speech. Even Shakespeare used only 25,000 different words but so effectively that it has been said of him, "He is an intellectual ocean, into which all the rivers run and from which all the isles and continents receive their dew and rain."

Thousands of books surround one in the public library and yet these are but a tiny fraction of the different volumes that have poured from the presses since the invention of moveable type. Poems, plays stories and novels that make you chuckle, laugh aloud, groan, grit your teeth in rage, and weep—all this magic achieved with just 26 mysterious letters. Lines that sing and blossom, words that bleed and burn, pages that make O. Henry, Mark Twain, Dickens, Tennyson and scores of other immortal.

A British officer in disgrace re-estimated under another name. He read and re-read Kipling's "If": "If you can bear to see the things you give your life to, broken And stoop and build 'em up with worn-out tools." He carried the poem, just a bit of paper, with a few smudges of ink, in his knapsack. It was the driving force, the inspiration, that won back the race he had lost.

Did you ever read Walter Malone's "Opportunity"? (This columnist knew Malone personally and saw him the day before his sudden death). The poem begins: "They do me wrong who say I come no more When once I knock and fall to find you in; For everyday I stand outside your door And bid you wake to rise and fight and win." One day, Malone was sitting at a table in a dining room in his home city of Memphis, Tennessee, when a bright-faced young man
